

RENORMALIZABILITY OF $\mathcal{N} = 1$ SUPER YANG-MILLS THEORY IN LANDAU GAUGE WITH A STUECKELBERG-LIKE FIELD

We construct a vector gauge invariant transverse field configuration V^H , consisting of the well-known superfield V and of a Stueckelberg-like chiral superfield Ξ . The renormalizability of the Super Yang Mills action in the Landau gauge is analyzed in the presence of a gauge invariant mass term $m^2 \int dV \mathcal{M}(V^H)$, with $\mathcal{M}(V^H)$ a power series in V^H . Unlike the original Stueckelberg action, the resulting action turns out to be renormalizable to all orders.

I. INTRODUCTION

In this work we study the renormalizability properties of a $\mathcal{N} = 1$ non-abelian gauge theory defined by a multiplet containing a massive vectorial excitation. The model we study is the supersymmetric version of a Stueckelberg-like action, in the sense that the massive gauge field is constructed by means of a compensating scalar field, thus preserving gauge invariance.

The history of Stueckelberg-like models is very well reviewed in [1]. Traditionally, most of the investigations have studied such models as potential alternative to the Higgs mechanism of mass generation, but as discussed in [2] there seems to be an unavoidable clash between renormalizability and unitarity in non-abelian Stueckelberg-like models. The original Stueckelberg model is abelian and has been rigorously proved [3] to be renormalizable and unitary, but its non-abelian version is known to be perturbatively non-renormalizable [4–6]. Physically, the problem is due to the high energy behavior of the longitudinal vector degree of freedom. In the abelian case it is perfectly compensated by the dynamics of the Stueckelberg field but in non-abelian theories this seems to be not so, resulting in incurable divergent interacting amplitudes or unbounded cross sections.

Nevertheless there have been recent interests in the study of massive vector models without the Higgs. The main motivation comes here from the continuous efforts to understand the low energy behavior of strongly interacting gauge theories, such as QCD. Confinement is a very important phenomenon in this context, but the physical mechanism behind it is still an open problem. A way to obtain information about this phenomenon is through lattice investigations which have revealed that the gluon propagator shows a massive behavior in the deep infrared non-perturbative region, while also displaying positivity violations which precludes a proper particle propagation interpretation [18–24]. Therefore, in a confining theory, the issue of the physical unitarity is a quite complex and difficult topic. Of course, physical unitarity must hold in terms of the physical excitations of the spectrum which are bound states of quarks and gluons like, for instance, mesons, baryons, glueballs, etc. Though, the positivity violation of the two-point gluon correlation functions is taken as a strong evidence of confinement, signalling that gluons are not excitations of the physical spectrum of the theory. Nevertheless, renormalizability should be expected to hold since one wants to recover the good UV behavior of QCD. This trend of investigations led to many works that proposed modifications of the Yang-Mills theory to accommodate the lattice results [25–29]. Recent developments along these lines involve the introduction of modified Stueckelberg-like models [30–34] constructed as a generalization of a class of confining effective theories known as Gribov-Zwanziger scenarios [35, 36], see [37] for a review. Unlike the standard Stueckelberg action, these modified models enjoy the pleasant property of being renormalizable to all orders, see [30–34] for a detailed account on the construction of these modified models and on their differences with the standard Stueckelberg theory. Let us also mention here that, recently, a BRST invariant reformulation of the Gribov-Zwanziger theory has been achieved [32, 34], allowing its extension from the Landau gauge to an arbitrary covariant gauge.

The present model is intended only to construct a renormalizable theory which generalizes the non-supersymmetric construction given in [33]. Issues like the perturbative unitarity of the models so obtained are not explicitly addressed. As far as we know, the non-supersymmetric model is not perturbative unitary. Though, it can be successfully employed as an effective renormalizable model in order to investigate the non-perturbative infrared region of confining Yang-Mills theories. So far, the prediction of the non-supersymmetric model are in good agreement with the actual lattice data on the correlation functions of the theory, like the two-point gluon propagator.

Our aim here is to construct a supersymmetric generalization of this model for a future investigation of the confinement aspects of pure STM, which is known to be a confining theory. This is the main purpose of the present model.

In a confining YM theory, the issue of the unitarity has to be faced through the study of suitable colorless bound-state, a topic which is still too far from the goal of the present work, whose aim is that of obtaining a renormalizable massive SPYM theory which generalizes the model of [33].

In this work we will carry out a supersymmetric generalization of the Stueckelberg-like model proposed in [30–34]. We prove that the present supersymmetric generalization is renormalizable, a task that will be done by means of a set of suitable Ward identities. Supersymmetric generalizations of Stueckelberg-like models was studied since very early [7] but mostly concentrated on the better behaved abelian models (see [8–10], for instance, for a proposal of an abelian Stueckelberg sector in MSSM), with some constructions of non-abelian theories with tensor multiplets [11, 12, 14] and also with composite gauge fields [13].

The work is organized as follows. In Section II we construct the $\mathcal{N} = 1$ Supersymmetric massive classical action. In Section III we discuss the gauge fixing and the ensuing BRST symmetry. Sections IV and V are devoted to the derivation of a set of suitable Ward identities and to the characterization of the most general invariant local counterterm following the setup of the algebraic renormalization. In Section VI we provide a detailed analysis of the counterterm by showing that it can be reabsorbed into the starting classical action through a redefinition of the fields and parameters, thus establishing the all orders renormalizability of the model. Section VII contains our conclusion. The final Appendices collect the conventions and a few additional technical details.

II. PURE $\mathcal{N} = 1$ SUSY STUECKELBERG-LIKE YANG-MILLS THEORY

In order to define the $\mathcal{N} = 1$ Supersymmetric Stueckelberg-like Yang-Mills theory, we start with a real abelian gauge superfield,

$$V(x, \theta, \bar{\theta}) = C + i\theta\chi - i\bar{\theta}\bar{\chi} + \theta\sigma^\mu\bar{\theta}A_\mu + \frac{i}{2}\theta\theta(M + iN) - \frac{i}{2}\bar{\theta}\bar{\theta}(M - iN) + i\theta\bar{\theta}\bar{\theta}\left(\bar{\lambda} + \frac{i}{2}\bar{\sigma}^\mu\partial_\mu\chi\right) - i\bar{\theta}\bar{\theta}\theta\left(\lambda - \frac{i}{2}\sigma^\mu\partial_\mu\bar{\chi}\right) + \frac{1}{2}\theta\bar{\theta}\bar{\theta}\bar{\theta}\left(D - \frac{1}{2}\partial^2C\right), \quad (1)$$

and with a massless chiral superfield that acts as a Stueckelberg field

$$\Xi(x, \theta, \bar{\theta}) = \xi(x) + \sqrt{2}\theta\psi(x) + i\theta\sigma^\mu\bar{\theta}\partial_\mu\xi(x) - \theta\theta f(x) - \frac{i}{\sqrt{2}}\theta\theta\partial_\mu\psi(x)\sigma^\mu\bar{\theta} - \frac{1}{4}\theta\bar{\theta}\bar{\theta}\partial^2\xi(x) \quad (2)$$

$$\bar{\Xi}(x, \theta, \bar{\theta}) = \bar{\xi}(x) + \sqrt{2}\bar{\theta}\bar{\psi}(x) - i\theta\sigma^\mu\bar{\theta}\partial_\mu\bar{\xi}(x) - \bar{\theta}\bar{\theta}\bar{f}(x) + \frac{i}{\sqrt{2}}\bar{\theta}\bar{\theta}\theta\partial_\mu\bar{\psi}(x) - \frac{1}{4}\theta\bar{\theta}\bar{\theta}\partial^2\bar{\xi}(x). \quad (3)$$

It is then possible to construct a gauge-invariant superfield

$$V^H(x, \theta, \bar{\theta}) = V(x, \theta, \bar{\theta}) + i\Xi(x, \theta, \bar{\theta}) - i\bar{\Xi}(x, \theta, \bar{\theta}), \quad (4)$$

which is invariant under the abelian gauge transformations

$$V \rightarrow V + i\phi - i\bar{\phi}, \quad \Xi \rightarrow \Xi - \phi, \quad \bar{\Xi} \rightarrow \bar{\Xi} - \bar{\phi}. \quad (5)$$

We now need a generalization of the definition of V^H to the non-abelian case. We start with the gauge-invariant superfield (4) with every component now in the adjoint representation of the gauge group G , $V^H \equiv V^{Ha}T^a$, ($a = 1, \dots, \dim G$) where the T^a are the generators in the adjoint. Now, the fundamental object is e^{V^H} instead of V^H . The non-abelian generalization of (4) is

$$e^{V^H} = \bar{H}e^V H, \quad (6)$$

where $H = e^{i\Xi}$, $U = e^{i\phi}$ and V is a usual gauge superfield. The gauge transformations then have to be

$$e^V \rightarrow \bar{U}e^V U, \quad H \rightarrow U^{-1}H, \quad \bar{H} \rightarrow \bar{H} \bar{U}^{-1}, \quad (7)$$

such that V^H is gauge invariant. For infinitesimal transformations, this explicitly yields

$$\begin{aligned} \delta_{gauge} V &= \frac{i}{2} L_V (\phi + \bar{\phi}) + \frac{i}{2} (L_V \coth(L_{V/2})) (\phi - \bar{\phi}) \\ &= i(\phi - \bar{\phi}) + \frac{i}{2} [V, \phi + \bar{\phi}] + \frac{i}{12} [V, [V, \phi - \bar{\phi}]] + \mathcal{O}(V^3), \end{aligned} \quad (8)$$

$$\begin{aligned} \delta_{gauge} \Xi &= \frac{i}{2} L_{\Xi} \phi - \frac{1}{2} (L_{\Xi} \cot(L_{\Xi/2})) \phi \\ &= -\phi + \frac{i}{2} [\Xi, \phi] + \frac{1}{12} [\Xi, [\Xi, \phi]] + \mathcal{O}(\Xi^3), \end{aligned} \quad (9)$$

$$\begin{aligned} \delta_{gauge} \bar{\Xi} &= -\frac{i}{2} L_{\bar{\Xi}} \bar{\phi} - \frac{1}{2} (L_{\bar{\Xi}} \cot(L_{\bar{\Xi}/2})) \bar{\phi} \\ &= -\bar{\phi} - \frac{i}{2} [\bar{\Xi}, \bar{\phi}] + \frac{1}{12} [\bar{\Xi}, [\bar{\Xi}, \bar{\phi}]] + \mathcal{O}(\bar{\Xi}^3), \end{aligned} \quad (10)$$

with $L_A X = [A, X]$. To first order (abelian gauge limit) in ϕ this reproduces (5).

Now, using all of the above definitions we can construct a gauge invariant $\mathcal{N} = 1$ Supersymmetric Stueckelberg-like Yang-Mills model

$$\mathcal{L}_{\text{SYM}} = -\frac{1}{128g^2} \text{tr} \int dS W^\alpha W_\alpha + m^2 \text{tr} \int dV \mathcal{M}(V^H), \quad (11)$$

with

$$W_\alpha \equiv \bar{D}^2 (e^{-V} D_\alpha e^V), \quad (12)$$

and

$$\mathcal{M} = V^{Ha} V^{Ha} + \sigma_1^{abc} V^{Ha} V^{Hb} V^{Hc} + \sigma_2^{abcd} V^{Ha} V^{Hb} V^{Hc} V^{Hd} + \dots, \quad (13)$$

where $\sigma_1^{abc}, \sigma_2^{abcd}, \dots$ are a set of infinite arbitrary dimensionless parameters. As one can figure out, the fact that the generalized mass term $\mathcal{M}(V^H)$ is an infinite power series V^H follows from the dimensionless character of V^H itself. Though, from the perturbative point of view, only the first quadratic terms of the series (13), *i.e.* $m^2 V^{Ha} V^{Ha}$ will enter the expression of the superfield propagator. The remaining terms represent an infinite set of interaction vertices, a feature which is typical of the non-abelian Stueckelberg-like theories.

Notice that the first term of the action, the pure supersymmetric Yang-Mills term $W^\alpha W_\alpha$, is invariant under $V \rightarrow V^H$. For more details about the $\mathcal{N} = 1$ supersymmetry and conventions, see [15, 39].

III. SUPERSYMMETRIC GAUGE INVARIANT STUECKELBERG-LIKE YANG-MILLS ACTION IN THE LANDAU GAUGE

The supersymmetric extension of the Landau gauge is [1]

$$\bar{D}^2 D^2 V = 0. \quad (14)$$

We thus need to add the following terms to the action

$$\mathcal{L}_{SGF} = \frac{1}{8} \text{Tr} \int dS A \bar{D}^2 D^2 V + c.c. = \frac{1}{8} \text{Tr} \int dV (A D^2 V + \bar{A} \bar{D}^2 V), \quad (15)$$

where we introduced the auxiliary chiral superfield A , with the following field equations

$$\frac{\delta}{\delta A} \mathcal{L}_{SGF} = \frac{1}{8} \bar{D}^2 D^2 V = 0, \quad \frac{\delta}{\delta \bar{A}} \mathcal{L}_{SGF} = \frac{1}{8} D^2 \bar{D}^2 V = 0. \quad (16)$$

Following the standard BRST procedure, the gauge fixing condition can be implemented in a BRST invariant way by defining the auxiliary field as the BRST variation of the anti-ghost field c' , namely $sc' = A$, so that we can add the following BRST invariant term to the action in order to fix the gauge.

$$\begin{aligned}\mathcal{L}_{SGF} &= s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 V + c.c.) \right] \\ &= \frac{1}{8} \text{tr} \int dS [(A \overline{D}^2 D^2 V - c' \overline{D}^2 D^2 sV + c.c.)].\end{aligned}\quad (17)$$

Looking at the gauge fixing (17), it is important to realize that for any local quantum field theory involving dimensionless fields, one has the freedom of performing arbitrary re-parametrization of these fields. Examples of this are the two-dimensional non-linear sigma model [42],[43] and quantum field theories with a Stueckelberg field entering the gauge fixing term [44]. In the case of the gauge fixing (17), this means that we have the freedom of replacing V^a by an arbitrary dimensionless function of V^a

$$V^a \rightarrow \mathcal{F}^a(V) = V^a + \alpha_1^{abc} V^b V^c + \alpha_2^{abcd} V^b V^c V^d + \alpha_3^{abcde} V^b V^c V^d V^e + \dots, \quad (18)$$

where $\alpha_1^{abc}, \alpha_2^{abcd}, \alpha_3^{abcde}, \dots$ are free dimensionless coefficients. This freedom, inherent to the dimensionless nature of V^a , is evident at the quantum level because of the fact that this field renormalizes in a non-linear way [38–41]. Therefore, (18) is expressing precisely the freedom one has in the choice of a re-parametrization for V^a .

In our case, this means that instead of equation (17) we could have just as well started with a term

$$s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 V + c.c.) \right] \rightarrow s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 \mathcal{F}(V) + c.c.) \right], \quad (19)$$

and this would not have affected the correlation functions of the gauge invariant quantities. The coefficients ($\alpha_1^{abc}, \alpha_2^{abcd}, \alpha_3^{abcde}, \dots$) are gauge parameters, not affecting the correlation functions of the gauge invariant quantities. The freedom that we have in the gauge fixing term will become apparent when performing the renormalization analysis. In fact, in section V, we will use a generalized gauge-fixing term

$$\begin{aligned}S_{gf}^{gen} &= s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 \mathcal{F}(V) + c.c.) \right] \\ &= \frac{1}{8} \text{tr} \int dS \left[A \overline{D}^2 D^2 \mathcal{F}(V) - c' \overline{D}^2 D^2 \frac{\partial \mathcal{F}(V)}{\partial V} sV \right] + c.c.,\end{aligned}\quad (20)$$

and by employing the corresponding Ward identities, we can handle the ambiguity that is inherent to the gauge fixing. The counterterm will then correspond to a renormalization of the gauge parameters ($\alpha_1^{abc}, \alpha_2^{abcd}, \alpha_3^{abcde}, \dots$), as will become clear in section VI.

One of the striking features ensuring the renormalizability of the non-supersymmetric modified Stueckelberg-like models introduced in [30–34, 44] was the implementation of a transversality constraint on the analogue of the gauge invariant field V^H . This transversality constraint gives rise to a deep difference between the modified models constructed in [30–34, 44] and the conventional non-renormalizable Stueckelberg model. It is precisely the implementation of this transversality constraint which ensures the UV renormalizability of the modified model. We remind here the reader to reference [44] for a detailed account on the differences between the conventional and the modified Stueckelberg action. We then pursue here the same route outlined in [30–34, 44] and impose the transversality constraint also in the supersymmetric case. More precisely, this amounts to require that the superfield V^H obeys the constraint

$$\overline{D}^2 D^2 V^H = 0, \quad (21)$$

which, at the level of the action, can be implemented by introducing the following terms

$$\mathcal{L}_T = \frac{1}{8} \int dS \left(B \overline{D}^2 D^2 V^H - \eta'^a \overline{D}^2 D^2 G_{V^H}^a(\eta, \overline{\eta}) \right) + c.c., \quad (22)$$

with $G_{V^H}^a(\eta, \bar{\eta}) = (\eta^a - \bar{\eta}^a) + \frac{i}{2} f^{abc} V^{H,b} (\eta^c + \bar{\eta}^c) - \frac{i}{12} f^{amr} f^{mpq} (\eta^p - \bar{\eta}^p) V^{Hq} V^{Hr} + \mathcal{O}(V^{H3})$. The field B is a Lagrange multiplier implementing the transversality constraint (21), while the fields $\eta, \bar{\eta}$ are a set of ghost fields needed to compensate the Jacobian which arises from the functional integral over B and Ξ in order to get a unity, see [30–34, 44] for the non-supersymmetric case.

Thus, adopting the Landau gauge, as well as the transversality condition, the total action becomes

$$\begin{aligned}
\Sigma_{SPYM} &= \int d^4x (\mathcal{L}_{\text{SYM}} + \mathcal{L}_{\text{SP}} + \mathcal{L}_{\text{SGF}} + \mathcal{L}_T) \\
&= -\frac{1}{128g^2} \text{tr} \int dS W^a W_a + \frac{m^2}{2} \text{tr} \int dV \mathcal{M}(V^H) \\
&+ \left[s \left(\frac{1}{8} \text{tr} \int dS (c' \bar{D}^2 D^2 V) \right) + \frac{1}{8} \int dS \left(B \bar{D}^2 D^2 V^H - \eta'^a \bar{D}^2 D^2 G_{V^H}^a(\eta, \bar{\eta}) \right) + c.c. \right] \\
&= -\frac{1}{128g^2} \text{tr} \int dS W^a W_a + \frac{m^2}{2} \text{tr} \int dV \mathcal{M}(V^H) \\
&+ \left[\frac{1}{8} \int dS \left(A^a \bar{D}^2 D^2 V^a - c'^a \bar{D}^2 D^2 G_V^a \right) + \frac{1}{8} \int dS \left(B \bar{D}^2 D^2 V^H - \eta'^a \bar{D}^2 D^2 G_{V^H}^a(\eta, \bar{\eta}) \right) + c.c. \right].
\end{aligned} \tag{23}$$

This action enjoys the exact BRST nilpotent symmetry

$$\begin{aligned}
sV^a &= G_V^a(c, \bar{c}), \\
sV^{Ha} &= 0, \\
s\Xi^a &= G_{\Xi}^a(c), \\
s\bar{\Xi}^a &= G_{\bar{\Xi}}^a(\bar{c}), \\
sc^a &= -\frac{i}{2} f^{abc} c^b c^c, \\
s\eta^a &= 0 \\
s\bar{c}^a &= -\frac{i}{2} f^{abc} \bar{c}^b \bar{c}^c \\

IV. RENORMALIZABILITY ANALYSIS

In order to analyze the renormalizability of the action (23), we start by establishing the set of Ward identities that will be employed for the study of the quantum corrections. Following the algebraic renormalization procedure

[38], we have first to add some external sources coupling to non-linear BRST transformations of the fields and of the composite operators entering the classical action. Therefore, we need to introduce a set of external BRST invariant sources $(\Omega^a, \Lambda^a, \overline{\Lambda}^a, L^a, \overline{L}^a)$ coupled to the non-linear BRST variations of $(V^a, \Xi^a, \overline{\Xi}^a, c^a, \overline{c}^a)$ as well as sources (Π^a, Ψ^a) coupled to the BRST invariant composite operators $(V^H, G_{V^H}^a)$,

$$s\Omega^a = s\Psi^a = s\Pi^a = s\Lambda^a = s\overline{\Lambda}^a = sL^a = s\overline{L}^a = 0. \quad (26)$$

We shall thus start with the BRST invariant complete action Σ defined by

$$\begin{aligned} \Sigma_{SPYM} &= \Sigma_{\text{SYM}} + \Sigma_{\text{SP}} + \Sigma_{\text{SGF}} + \Sigma_T + \Sigma_{\text{EXT}} \quad (27) \\ \Sigma_{\text{SPYM}} &= -\frac{1}{128g^2} \text{tr} \int dS W^a W_a + \frac{m^2}{2} \int dV \mathcal{M}(\mathcal{V}^{\mathcal{H}}) \\ &+ \frac{1}{8} \int dS \left\{ A^a \overline{D}^2 D^2 V^a - c'^a \overline{D}^2 D^2 G_V^a \right\} + c.c. \\ &+ \frac{1}{8} \int dS \left\{ B \overline{D}^2 D^2 V^H - \eta'^a \overline{D}^2 D^2 G_{V^H}^a \right\} + c.c. \\ &+ \int dV \left\{ \Omega^a G_V^a + \Pi^a V^{H,a} + \Psi^a G_{V^H}^a \right\} \\ &+ \int dS \left\{ -\Lambda^a G_{\Xi}^a - \frac{i}{2} f^{acb} L^a c^b c^c \right\} + c.c.. \quad (28) \end{aligned}$$

All quantum numbers, dimensions and R -weights of all fields and sources are displayed in tables IV A and IV B.

A. Ward identities and algebraic characterization of the invariant counterterm

The complete action Σ_{SPYM} obeys a large set of Ward identities, being:

- The Slavnov-Taylor identity:

$$\mathcal{S}(\Sigma) = \int dV \frac{\delta \Sigma}{\delta \Omega^a} \frac{\delta \Sigma}{\delta V^a} + \left[\int dS \left(\frac{\delta \Sigma}{\delta \Lambda^a} \frac{\delta \Sigma}{\delta \Xi^a} + \frac{\delta \Sigma}{\delta L^a} \frac{\delta \Sigma}{\delta c^a} + A^a \frac{\delta \Sigma}{\delta c'^a} \right) + c.c. \right] = 0 \quad (29)$$

- The gauge-fixing equations:

- The η Ward identities

$$\mathcal{F}_-^a \Sigma = 0, \quad \bar{\mathcal{F}}_-^a \Sigma = 0, \quad (34)$$

with

$$\mathcal{F}_-^a = \frac{\delta}{\delta \eta'^a} + \frac{1}{8}\bar{D}^2 D^2 \frac{\delta}{\delta \Psi^a} \quad \text{and} \quad \bar{\mathcal{F}}_-^a = \frac{\delta}{\delta \bar{\eta}'^a} + \frac{1}{8}D^2 \bar{D}^2 \frac{\delta}{\delta \Psi^a} \quad (35)$$

- The linearly broken ghost equation [16]

$$\mathcal{G}_+ \Sigma = \Delta_{clas}, \quad (36)$$

with

$$\mathcal{G}_+ = \int dS \left(\frac{\delta}{\delta c^c} - i f^{abc} c'^a \frac{\delta}{\delta A^b} \right) + \int d\bar{S} \left(\frac{\delta}{\delta \bar{c}^c} - i f^{abc} \bar{c}'^a \frac{\delta}{\delta \bar{A}^b} \right), \quad (37)$$

and

Notice that the breaking term Δ_{clas} is purely linear in the quantum fields. As such, it will be not affected by the quantum corrections [16, 38].

- The linear symmetries under supersymmetry, translations, R -transformations and rigid transformations are expressed by the Ward identities

$$W_X \Sigma = -i \sum_{\phi} \int \delta_X \phi \frac{\delta}{\delta \phi} \Sigma = 0, \quad X = Q_{\alpha}, P_{\mu}, R \text{ and rigid transformations} \quad (39)$$

such that δ_{μ}^P , δ_{α}^Q , $\delta_{\dot{\alpha}}^{\bar{Q}}$, δ^R are defined by appendix B. Thus, we can see that the covariant action Σ satisfy the Ward identities and Lorentz invariance.

V. THE ALGEBRAIC CHARACTERIZATION OF THE INVARIANT COUNTERTERM AND RENORMALIZABILITY

In order to characterize the most general invariant counterterm which can be freely added to all order in perturbation theory, we follow the setup of the algebraic renormalization [38] and perturb the classical action (23), by adding an integrated local quantity in the fields and sources, Σ_{CT} , that has R -weight 0, ghost number (0,0), is hermitian and has dimension 3 in case of a chiral superfield, or 2 in case of a vector superfield. We demand thus that the perturbed action, $(\Sigma + \varepsilon \Sigma_{CT})$, where ε is an expansion parameter, fulfills, to the first order in ε , the same Ward identities obeyed by the classical action Σ , i.e. equations (29) to (39). This amounts to impose the following constraints on Σ_{CT} :

$$\frac{\delta \Sigma_{ct}}{\delta A^a} = \frac{\delta \Sigma_{ct}}{\delta \bar{A}^a} = 0 \quad (41)$$

$$\frac{\delta \Sigma_{CT}}{\delta B^a} = \frac{1}{8} \bar{D}^2 D^2 \frac{\delta \Sigma}{\delta \Pi^a}, \quad \frac{\delta \Sigma_{CT}}{\delta \bar{B}^a} = \frac{1}{8} D^2 \bar{D}^2 \frac{\delta \Sigma}{\delta \Pi^a} \quad (42)$$

$$\mathcal{G}_-^a \Sigma_{CT} = \bar{\mathcal{G}}_-^a \Sigma_{CT} = 0 \quad (43)$$

$$\mathcal{F}_-^a \Sigma_{CT} = \bar{\mathcal{F}}_-^a \Sigma_{CT} = 0 \quad (44)$$

$$\mathcal{G}_+^a \Sigma_{CT} = 0, \quad (45)$$

where \mathcal{B}_Σ is the so-called nilpotent linearized Slavnov-Taylor operator [38], defined as

$$\mathcal{B}_\Sigma = \int dV \left\{ \frac{\delta \Sigma}{\delta \Omega^a} \frac{\delta}{\delta V^a} + \frac{\delta \Sigma}{\delta V^a} \frac{\delta}{\delta \Omega^a} \right\} + \int dS \left\{ \frac{\delta \Sigma}{\delta \Lambda^a} \frac{\delta}{\delta \Xi^a} + \frac{\delta \Sigma}{\delta \Xi^a} \frac{\delta}{\delta \Lambda^a} + \frac{\delta \Sigma}{\delta L^a} \frac{\delta}{\delta c^a} + \frac{\delta \Sigma}{\delta c^a} \frac{\delta}{\delta L^a} + A^a \frac{\delta}{\delta c'^a} + c.c. \right\}, \quad (46)$$

with $\mathcal{B}_\Sigma \mathcal{B}_\Sigma = 0$. From equation (40) one learns that Σ_{CT} belongs to the cohomology [38] of the linearized Slavnov-Taylor operator \mathcal{B}_Σ in the space of the integrated local quantities in the fields and sources with ghost number (0,0), R -weight 0 and dimension 3 in case of a chiral superfield, or 2 in case of a vector superfield. Therefore, we can set

$$\Sigma_{CT} = \Delta_{cohom} + \mathcal{B}_\Sigma \Delta^{-1}, \quad (47)$$

where $\Delta^{(-1)}$ denotes a zero-dimensional integrated quantity in the fields and sources with ghost number (-1,0) and R -weight 0. The term $\mathcal{B}_\Sigma \Delta^{(-1)}$ in equation (47) corresponds to the trivial solution, i.e. to the exact part of the cohomology of \mathcal{B}_Σ . On the other hand, the quantity Δ_{cohom} identifies the non-trivial solution, i.e. the cohomology of \mathcal{B}_Σ , meaning that $\Delta_{cohom} \neq \mathcal{B}_\Sigma Q$, for any local integrated Q .

In its most general form, Δ_{cohom} is given by

$$\begin{aligned} \Delta_{cohom} = & \int dS \frac{a_0(V^H)}{128g^2} W^\alpha W_\alpha + \int dV \frac{m^2}{2} \tilde{\mathcal{M}}(V^H) \\ & + \left(\int dS b_1^{ab}(V^H) B^a \bar{D}^2 D^2 V^{H,b} + \int dS b_2^{ab}(V^H) V^{H,b} \bar{D}^2 D^2 B^a + \int dS B^a V^{H,b} \bar{D}^2 D^2 b_3^{ab}(V^H) \right. \\ & + \int dS d_1^{ab} \eta'^a \bar{D}^2 D^2 \eta^b + \int dS c_1^{abc}(V^H) \eta'^a V^{H,b} \bar{D}^2 D^2 \eta^c + \int dS c_2^{abc}(V^H) \eta'^a \eta^b \bar{D}^2 D^2 V^{H,c} \\ & + \int dS c_3^{abc}(V^H) \eta^a V^{H,b} \bar{D}^2 D^2 \eta^c + \int dS \eta'^a \eta^b V^{H,c} \bar{D}^2 D^2 c_4^{abc}(V^H) + \int dS c_5^{abc}(V^H) \eta'^a \bar{\eta}^b \bar{D}^2 D^2 V^{H,c} \\ & + \int dS c_6^{abc}(V^H) \bar{\eta}^a V^{H,b} \bar{D}^2 D^2 \eta^c + \int dS \eta'^a \bar{\eta}^b V^{H,c} \bar{D}^2 D^2 c_7^{abc}(V^H) + c.c. \left. \right) \\ & + \int dV b_4^{ab}(V^H) \Pi^a V^{H,b} + \int dV d_2^{ab} \Psi^a \eta^b \\ & + \int dV c_8^{abc}(V^H) V^{H,c} \Psi^a \eta^b + \int dV d_3^{ab} \Psi^a \bar{\eta}^b + \int dV c_9^{abc}(V^H) V^c \Psi^a \bar{\eta}^b, \end{aligned} \quad (48)$$

with

$$\tilde{\mathcal{M}} = b_0 V^{Ha} V^{Ha} + \tilde{\sigma}_1^{abc} V^{Ha} V^{Hb} V^{Hc} + \tilde{\sigma}_2^{abcd} V^{Ha} V^{Hb} V^{Hc} V^{Hd} + \dots, \quad (49)$$

and $(a_0(V^H), b_i^{ab}(V^H), c_i^{abc}(V^H), d_i^{ab})$ arbitrary coefficients. Then, after implementing the constraints (42) and (43) we find

&+ \int dV d_2^{ab} \Psi^a \overline{\eta}^b + \left(\frac{1}{8} \int dS d_2^{ab} \overline{\eta}^a \overline{D}^2 D^2 \eta^b + c.c. \right) \\
&+ \int dV c_1^{abc}(V^H) \Psi^a V^{Hb} \eta^c + \left(\frac{1}{8} \int dS c_1^{abc}(V^H) \eta^a V^{Hb} \overline{D}^2 D^2 \eta'^c + c.c. \right) \\
&+ \int dV c_2^{abc}(V^H) \Psi^a V^{Hb} \overline{\eta}^c + \left(\frac{1}{8} \int dS c_2^{abc}(V^H) \overline{\eta}^a V^{Hb} \overline{D}^2 D^2 \eta'^c + c.c. \right) \\
&+ \int dV b_1^{ab}(V^H) V^{Hb} \Pi^a + \left(\frac{1}{8} \int dS b_1^{ab}(V^H) V^{Hb} \overline{D}^2 D^2 B^a + c.c. \right). \tag{50}
\end{aligned}$$

Let us now discuss the trivial part of the counterterm, $\mathcal{B}_\Sigma \Delta^{(-1)}$. The term $\Delta^{(-1)}$, taking into account the quantum numbers of the fields and sources, can be parametrized in its most general form as:

$$\begin{aligned}
\Delta^{-1} &= \int dV \left(F_1^{ab} V^b \Omega^a + F_2^{ab} V^b D^2 c'^a + F_3^{ab} D^2 V^b c'^a + D^2 F_4^{ab} V^b c'^a + c.c. \right) \\
&+ \left[\int dS (a_1^{ab} L^a c^b + a_2^{ab} \Xi^b \Lambda^a) + c.c. \right], \tag{51}
\end{aligned}$$

where,

$$\begin{aligned}
F_{1,\dots,4}^a &= F_{1,\dots,4}^a [V, \Xi, \overline{\Xi}] \\
a_1^{ab} &= a_1^{ab} [\Xi] \\
a_2^{ab} &= a_2^{ab} [\Xi]. \tag{52}
\end{aligned}$$

Imposing the constraint (41)

$$\frac{\delta}{\delta A^a} \mathcal{B}_\Sigma \Delta^{(-1)} = \frac{\delta}{\delta \overline{A}^a} \mathcal{B}_\Sigma \Delta^{(-1)} = 0, \tag{53}$$

and observing from eq. (51) that

we can use the relation

From eq. (56) we find the relations

We can further reduce the number of parameters in Σ_{CT} by noticing that if we set [33]

in (28), the resulting action is

$$\begin{aligned} \Sigma_{SPYM} = & -\frac{1}{128g^2} tr \int dS W^a W_a \\ & + \frac{1}{8} \left[\int dS \left(A^a \overline{D}^2 D^2 V^a - c'^a \overline{D}^2 D^2 G_V^a \right) + c.c. \right] \\ & + \frac{1}{8} \left[\int dS \left(B^a \overline{D}^2 D^2 V^{H,a} - \eta'^a \overline{D}^2 D^2 G_{V^H}^a \right) + c.c. \right] \\ & + \int dV \Omega^a G_V^a + \left[\int dS \left(-\frac{i}{2} f^{acb} L^a c^b c^c \right) + c.c. \right], \end{aligned} \quad (60)$$

which is nothing but the Super Yang-Mills gauge-fixed action in the Landau gauge (see appendix C), with the addition of the following terms

$$\Sigma_B = \frac{1}{8} \left[\int dS \left(B \overline{D}^2 D^2 V^H - \eta'^a \overline{D}^2 D^2 G_{V^H}^a \right) + c.c. \right]. \quad (61)$$

However, upon integration over $(B, \eta, \overline{\eta}, \Xi)$, these terms give rise to a unity. Thus, in the limit (59) the starting action takes the following form:

Let us consider now the correlation functions of the Yang-Mills superfield V , namely

where $[D\Phi]$ stands for integration over all fields. Though, since $m^2 = 0$, one can directly perform in (63) the integration over $(H, B, \eta, \overline{\eta})$, i.e. of the fields appearing in Σ_B .

This integration is easily seen to give a unity. It is in fact nothing but a Super Faddeev-Popov term (see [39]) which, due to $m^2 = 0$, gives a unity.

Therefore, in the limit, $m^2 = 0$, it follows that

$$\langle V(1) \dots V(n) \rangle = \frac{\int [D\Phi] \langle V(1) \dots V(n) \rangle \exp(-\Sigma_{SPYM})}{\int [D\Phi] \exp(-\Sigma_{SPYM})}, \quad (64)$$

meaning that the correlator $\langle V(1) \dots V(n) \rangle$ reduces to that of standard SPYM. As consequence, the dimensionless, and thus m -independent, coefficients appearing in the counterterm Σ_{CT} are subject to the following additional conditions

and for equation (51)

$$\begin{aligned} F_{1,\dots,4}^a [V, \Xi, \bar{\Xi}] &= F_{1,\dots,4}^a [V] \\ a_1^{ab} [\Xi] &= a_1^{ab} \\ a_2^{ab} [\Xi] &= a_2^{ab} [\Xi], \end{aligned} \quad (66)$$

so that

$$\begin{aligned} \Delta_{\text{cohom}} &= \int dS \frac{a_0}{128g^2} W^\alpha W_\alpha + \int dV \frac{m^2}{2} \widetilde{\mathcal{M}}(V^H) \\ &+ \int dV b_1 V^{Ha} \Pi^a + \frac{1}{8} \left[\int dS b_1 \left(V^{Ha} \bar{D}^2 D^2 B^a - \eta'^a \bar{D}^2 D^2 G_{V^H}^a(\eta, \bar{\eta}) \right) + c.c. \right] \\ &+ \int dV b_1 \Psi^a G_{V^H}^a(\eta, \bar{\eta}), \end{aligned} \quad (67)$$

and

$$\begin{aligned} \Delta^{-1} &= \int dV \left(F_1^{ab}(V) V^b \left(\Omega^a - \frac{1}{8} D^2 c'^a - \frac{1}{8} \bar{D}^2 \bar{c}'^a \right) \right. \\ &\left. + \left[\int dS \left(a_1^{ab} L^a c^b + a_2^{ab}(\Xi) \Xi^b \Lambda^a \right) + c.c. \right] \right). \end{aligned} \quad (68)$$

For the purpose of the analysis of the renormalization factors at the end of this section, we will rewrite the counterterm Σ_{CT} of the action in its parametrized form, namely as contact terms written in terms of the starting classical action Σ , being given by the following expression

$$\begin{aligned} \Sigma_{CT} &= \int dS a_0 g^2 \frac{\delta \Sigma}{\delta g^2} + \int dV b_0 m^2 \frac{\delta \Sigma}{\delta m^2} + b_1 \left[\int dS \left(B^a \frac{\partial \Sigma}{\partial B^a} \right) + c.c. \right] + b_1 \int dV \Pi^a \frac{\partial \Sigma}{\partial \Pi^a} \\ &+ \frac{1}{2} b_1 \int dV \Psi^a \frac{\partial \Sigma}{\partial \Psi^a} + \frac{1}{2} b_1 \left[\int dS \left(\eta^a \frac{\partial \Sigma}{\partial \eta^a} \right) + c.c. \right] + \frac{1}{2} b_1 \left[\int dS \left(\eta'^a \frac{\partial \Sigma}{\partial \eta'^a} \right) + c.c. \right] \\ &+ \int dV \left(\tilde{\sigma}_1^{abc} \frac{\delta \Sigma}{\delta \sigma_1^{abc}} + \tilde{\sigma}_2^{abcd} \frac{\delta \Sigma}{\delta \sigma_2^{abcd}} + \tilde{\sigma}_3^{abcde} \frac{\delta \Sigma}{\delta \sigma_3^{abcde}} + \dots \right) \\ &+ \int dV \left(\left(\frac{\delta F_1^{ab}}{\delta V^c} V^b + F_1^{ab} \delta^{bc} \right) \Omega^a \frac{\delta \Sigma}{\delta \Omega^c} + F_1^{ab} V^b \frac{\delta \Sigma}{\delta V^a} \right) \\ &+ \left[\int dS \left(a_2^{ab} \Xi^b \frac{\delta \Sigma}{\delta \Xi^a} - \left(\frac{\delta a_2^{ab}(V)}{\delta \Xi^c} \Xi^b + a_2^{ab}(\Xi) \delta^{bc} \right) \Lambda^a \frac{\delta \Sigma}{\delta \Lambda^c} \right) + c.c. \right] \\ &- \frac{1}{8} \left(\frac{\delta F_1^{ab}(V)}{\delta V^c} V^b + F_1^{ab}(V) \delta^{bc} \right) G_V^c (D^2 c'^a + \bar{D}^2 \bar{c}'^a) - \frac{1}{8} A^a D^2 (F_1^{ab} V^b) - \frac{1}{8} \bar{A}^a \bar{D}^2 (F_1^{ab} V^b). \end{aligned} \quad (69)$$

VI. ANALYSIS OF THE COUNTERTERM AND RENORMALIZATION FACTORS

Having determined the most general form of the local invariant counterterm, eq.(69), we observe, however, that the terms on the last line,

$$\begin{aligned} &- \frac{1}{8} S_\Sigma (c'^a D^2 (F_1^{ab} V^b) + \bar{c}'^a \bar{D}^2 (F_1^{ab} V^b)) \\ &= -\frac{1}{8} \left(\frac{\delta F_1^{ab}(V)}{\delta V^c} V^b + F_1^{ab}(V) \delta^{bc} \right) G_V^c (D^2 c'^a + \bar{D}^2 \bar{c}'^a) - \frac{1}{8} A^a D^2 (F_1^{ab} V^b) - \frac{1}{8} \bar{A}^a \bar{D}^2 (F_1^{ab} V^b), \end{aligned} \quad (70)$$

cannot be rewritten in an exact parametric form in terms of the starting action Σ . This feature is due to dependence of the gauge fixing on the dimensionless field V . As a consequence, the renormalization of the gauge fixing itself is determined up to an ambiguity of the type of eq.(18). As was mentioned before, this term can be handled by starting

with the generalized gauge fixing of eq.(18). This means that we could have equally started with a term in the action like

$$s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 V + \bar{c}' \bar{D}^2 V) \right] \rightarrow s \left[\frac{1}{8} \text{tr} \int dV (c' D^2 \mathcal{F}(V) + \bar{c}' \bar{D}^2 \mathcal{F}^a(V)) \right], \quad (71)$$

with \mathcal{F}^a given by eq.(18). Since \mathcal{F}^a is now a composite field, we need to introduce it into the starting action through a suitable external source. In order to maintain BRST invariance, we make use of a BRST doublet of external sources (R^a, P^a) , of dimension 2, R-weight 0 and ghost number $(-1, 0)$

$$sR^a = P^a, \quad sP^a = 0 \quad (72)$$

and introduce the term

$$\int dV s(R^a \mathcal{F}^a(V)) = \int dV \left(P^a \mathcal{F}^a(V) - R^a \frac{\partial \mathcal{F}^a}{\partial V^c} G^c(V) \right), \quad (73)$$

so that the full action is now given by

$$\begin{aligned} \Sigma_{\text{SPYM}} = & -\frac{1}{128g^2} \text{tr} \int dS \left(W^a W_a \right) + \frac{m^2}{2} \int dV \mathcal{M}(V^H) \\ & + \frac{1}{8} \int dS \left\{ A^a \bar{D}^2 D^2 \mathcal{F}^a(V) - c'^a \bar{D}^2 D^2 \left[\frac{\partial \mathcal{F}^a}{\partial V^c} G_V^c \right] + c.c. \right\} \\ & + \frac{1}{8} \int dS \left\{ B \bar{D}^2 D^2 V^H - \eta'^a \bar{D}^2 D^2 G_{V^H}^a + c.c. \right\} \\ & + \int dS \left\{ -\Lambda^a G_{\Xi}^a + \frac{i}{2} f^{abc} L^a c^b c^c + c.c. \right\} \\ & + \int dV \left(\Omega^a G_V^a + \Pi^a V^{H,a} + \Psi^a G_{V^H}^a + P^a \mathcal{F}^a(V) - R^a \frac{\partial \mathcal{F}^a(V)}{\partial V^c} G_V^c \right). \end{aligned} \quad (74)$$

The action Σ_{SPYM} obeys the following Ward identities:

- The Slavnov-Taylor identity:

$$\mathcal{S}(\Sigma) = \int dV \left\{ \frac{\delta \Sigma}{\delta \Omega^a} \frac{\delta \Sigma}{\delta V^a} + P^a \frac{\delta \Sigma}{\delta R^a} \right\} + \left(\int dS \frac{\delta \Sigma}{\delta \Lambda^a} \frac{\delta \Sigma}{\delta \Xi^a} + \frac{\delta \Sigma}{\delta L^a} \frac{\delta \Sigma}{\delta c^a} + A^a \frac{\delta \Sigma}{\delta c'^a} + c.c. \right) = 0 \quad (75)$$

- The gauge-fixing equations:

$$\frac{\delta \Sigma}{\delta A^a} = \frac{1}{8} \bar{D}^2 D^2 \frac{\delta \Sigma}{\delta P^a}, \quad \frac{\delta \Sigma}{\delta \bar{A}} = \frac{1}{8} D^2 \bar{D}^2 \frac{\delta \Sigma}{\delta P^a}$$

- The equation for the Lagrange multiplier B^a :

$$\frac{\delta \Sigma}{\delta B^a} = \frac{1}{8} \bar{D}^2 D^2 \frac{\delta \Sigma}{\delta \Pi^a}, \quad \frac{\delta \Sigma}{\delta \bar{B}^a} = \frac{1}{8} D^2 \bar{D}^2 \frac{\delta \Sigma}{\delta \Pi^a} \quad (76)$$

- The anti-ghost equations:

$$\mathcal{G}_-^a \Sigma = 0, \quad \bar{\mathcal{G}}_-^a \Sigma = 0, \quad (77)$$

with

$$\mathcal{G}_-^a = \frac{\delta}{\delta c'^a} - \frac{1}{8} \bar{D}^2 D^2 \frac{\delta}{\delta R^a} \quad \text{and} \quad \bar{\mathcal{G}}_-^a = \frac{\delta}{\delta \bar{c}'^a} - \frac{1}{8} D^2 \bar{D}^2 \frac{\delta}{\delta R^a} \quad (78)$$

- The η Ward identities

$$\mathcal{F}_-^a \Sigma = 0, \quad \overline{\mathcal{F}}_-^a \Sigma = 0, \quad (79)$$

with

$$\mathcal{F}_-^a = \frac{\delta}{\delta \eta'^a} + \frac{1}{8} \overline{D}^2 D^2 \frac{\delta}{\delta \Psi^a} \quad \text{and} \quad \overline{\mathcal{F}}_-^a = \frac{\delta}{\delta \overline{\eta}'^a} + \frac{1}{8} D^2 \overline{D}^2 \frac{\delta}{\delta \overline{\Psi}^a} \quad (80)$$

- The linear symmetries under supersymmetry, translations, R -transformations and rigid transformations are expressed by the Ward identities in (39).

Since R and P are a pair of BRST doublet, they do not appear in the non-trivial part of the counterterm [38], so this will remain as in equation (67). On the other hand, the $\Delta^{(-1)}$ -term becomes

$$\begin{aligned} \Delta^{-1} = & \int dV \left(F_1^{ab} V^b \Omega^a + F_2^{ab} V^b D^2 c'^a + F_3^{ab} D^2 V^b c'^a + D^2 F_4^{ab} V^b c'^a \right. \\ & \left. + F_8^{ab} V^b R^a + c.c. \right) + \left[\int dS (a_1^{ab} L^a c^b + a_2^{ab} \Xi^a \Lambda^b) + c.c. \right]. \end{aligned} \quad (81)$$

In a similar fashion as in the analysis of eqs.(53)–(56), we can use the relation $[\frac{\partial}{\partial A^a} - \frac{1}{8} \overline{D}^2 D^2 \frac{\delta}{\delta P^a}, S_\Sigma] = \frac{\delta}{\delta c'^a} - \frac{1}{8} \overline{D}^2 D^2 \frac{\delta}{\delta R}$, to find

$$\left(\frac{\delta}{\delta c'^a} - \frac{1}{8} \overline{D}^2 D^2 \frac{\delta}{\delta R} \right) \Delta^{-1} = \overline{D}^2 D^2 (F_2^{ab} V^b) + \overline{D}^2 (F_3^{ab} D^2 V^b) + \overline{D}^2 ((D^2 F_4^{ab}) V^b) - \frac{1}{8} \overline{D}^2 D^2 (F_8^{ab} V^b) = 0, \quad (82)$$

from which we obtain the relations

$$\begin{aligned} F_2^{ab} &= \frac{1}{8} F_8^{ab} \\ F_3^{ab} &= 0 \\ F_4^{ab} &= a \delta^{ab}, \end{aligned} \quad (83)$$

so that (81) becomes

$$\begin{aligned} \Delta^{-1} = & \int dV \left(F_1^{ab} V^b \Omega^a + F_2^{ab} V^b (R^a + \frac{1}{8} D^2 c'^a + \frac{1}{8} \overline{D}^2 \overline{c}'^a) \right) \\ & + \left[\int dS (a_1 L^a c^a + a_2^{ab} \Xi^b \Lambda^a) + c.c. \right]. \end{aligned} \quad (84)$$

We now set

$$\begin{aligned} F_2^{ab}(V) &= F_2^{ab}(0) + \tilde{F}_2^{ab}(V), \\ \tilde{F}_2^{ab}(V) &= \tilde{\alpha}_1^{abc} V^c + \tilde{\alpha}_2^{abcd} V^c V^d + \tilde{\alpha}_2^{abcde} V^c V^d V^e + \dots, \end{aligned} \quad (85)$$

where $F_2^{ab}(0) = F_2(0) \delta^{ab}$ is the first, V -independent term of the Taylor expansion of $F_2^{ab}(V)$ in powers of V , and $\tilde{F}_2^{ab}(V)$ denotes the remaining V -dependent terms. We find that $F_2^{ab}(0)$ is connected to the renormalization of the fields within the gauge-fixing, while $\tilde{F}_2^{ab}(V)$ renormalizes the gauge parameters in eq.(18). Employing the generalized

gauge-fixing (71), we can now write the full counterterm in a complete parametric form, namely

& + \frac{1}{2} b_1 \int dV \Psi^a \frac{\delta \Sigma}{\delta \Psi^a} + \frac{1}{2} b_1 \left[\int dS \left(\eta^a \frac{\delta \Sigma}{\delta \eta^a} \right) + c.c. \right] + \frac{1}{2} b_1 \left[\int dS \left(\eta'^a \frac{\delta \Sigma}{\delta \eta'^a} \right) + c.c. \right] \\
& + \int dV \left(\tilde{\sigma}_1^{abc} \frac{\delta \Sigma}{\delta \sigma_1^{abc}} + \tilde{\sigma}_2^{abcd} \frac{\delta \Sigma}{\delta \sigma_2^{abcd}} + \tilde{\sigma}_3^{abcde} \frac{\delta \Sigma}{\delta \sigma_3^{abcde}} + \dots \right) \\
& - \int dV \left(\left(\frac{\delta F_1^{ab}}{\delta V^c} V^b + F_1^{ab} \delta^{bc} \right) \Omega^a \frac{\delta \Sigma}{\delta \Omega^c} + F_1^{ab} V^b \frac{\delta \Sigma}{\delta V^a} + F_2(0) P^a \frac{\delta \Sigma}{\delta P^a} + F_2(0) \bar{A}^a \frac{\delta \Sigma}{\delta \bar{A}^a} \right. \\
& + \left. F_2(0) A^a \frac{\delta \Sigma}{\delta A^a} + F_2(0) R^a \frac{\delta \Sigma}{\delta R^a} + F_2(0) c'^a \frac{\delta \Sigma}{\delta c'^a} + F_2(0) \bar{c}'^a \frac{\delta \Sigma}{\delta \bar{c}'^a} \right) \\
& + \left[\int dS \left(a_1^{ab} L^a \frac{\delta \Sigma}{\delta L^b} - a_1^{ab} c^a \frac{\delta \Sigma}{\delta c^b} - \left(\frac{\delta a_2^{ab}(\Xi)}{\delta \Xi^c} \Xi^b + a_2^{ab}(\Xi) \delta^{bc} \right) \Lambda^a \frac{\delta \Sigma}{\delta \Lambda^c} + a_2^{ab}(\Xi) \Xi^b \frac{\delta \Sigma}{\delta \Xi^a} \right) + c.c. \right] \\
& + \int dV \left(\tilde{\alpha}_1^{abc} - F_2(0) \alpha_1^{abc} \right) \frac{\delta \Sigma}{\delta \alpha_1^{abc}} + \left(\tilde{\alpha}_2^{abcd} - F_2(0) \alpha_2^{abcd} \right) \frac{\delta \Sigma}{\delta \alpha_2^{abcd}} + \left(\tilde{\alpha}_3^{abcde} - F_2(0) \alpha_3^{abcde} \right) \frac{\delta \Sigma}{\delta \alpha_3^{abcde}} + \dots, \quad (86)
\end{aligned}$$

where the dots ... in the last line denote the infinite set of terms of the kind

$$\sum_j \left(\tilde{\alpha}_j^{abcde\dots} - F_2(0) \alpha_j^{abcde\dots} \right) \frac{\delta \Sigma}{\delta \alpha_j^{abcde\dots}}, \quad j = 4, \dots, \infty. \quad (87)$$

The usefulness of rewriting the counterterm (86) in the parametric form becomes clear by casting it into the form

$$\mathcal{R}\Sigma = 0, \quad (88)$$

with

$$\begin{aligned}
\mathcal{R} = & \int dS a_0 g^2 \frac{\delta}{\delta g^2} + b_0 \int dV m^2 \frac{\delta}{\delta m^2} + b_1 \left[\int dS \left(B^a \frac{\delta}{\delta B^a} \right) + c.c. \right] + b_1 \int dV \Pi^a \frac{\delta}{\delta \Pi^a} \\
& + \frac{1}{2} b_1 \int dV \Psi^a \frac{\delta}{\delta \Psi^a} + \frac{1}{2} b_1 \left[\int dS \left(\eta^a \frac{\delta}{\delta \eta^a} \right) + c.c. \right] + \frac{1}{2} b_1 \left[\int dS \left(\eta'^a \frac{\delta}{\delta \eta'^a} \right) + c.c. \right] \\
& + \int dV \left(\tilde{\sigma}_1^{abc} \frac{\delta}{\delta \sigma_1^{abc}} + \tilde{\sigma}_2^{abcd} \frac{\delta}{\delta \sigma_2^{abcd}} + \tilde{\sigma}_3^{abcde} \frac{\delta}{\delta \sigma_3^{abcde}} + \dots \right) \\
& - \int dV \left(\left(\frac{\delta F_1^{ab}}{\delta V^c} V^b + F_1^{ab} \delta^{bc} \right) \Omega^a \frac{\delta}{\delta \Omega^c} + F_1^{ab} V^b \frac{\delta}{\delta V^a} + F_2(0) P^a \frac{\delta}{\delta P^a} + F_2(0) \bar{A}^a \frac{\delta}{\delta \bar{A}^a} \right. \\
& + \left. F_2(0) A^a \frac{\delta}{\delta A^a} + F_2(0) R^a \frac{\delta}{\delta R^a} + F_2(0) c'^a \frac{\delta}{\delta c'^a} + F_2(0) \bar{c}'^a \frac{\delta}{\delta \bar{c}'^a} \right) \\
& + \left[\int dS \left(a_1^{ab} L^a \frac{\delta}{\delta L^b} - a_1^{ab} c^a \frac{\delta}{\delta c^b} - \left(\frac{\delta a_2^{ab}(\Xi)}{\delta \Xi^c} \Xi^b + a_2^{ab}(\Xi) \delta^{bc} \right) \Lambda^a \frac{\delta}{\delta \Lambda^c} + a_2^{ab}(\Xi) \Xi^b \frac{\delta}{\delta \Xi^a} \right) + c.c. \right] \\
& + \int dV \left(\tilde{\alpha}_1^{abc} - F_2(0) \alpha_1^{abc} \right) \frac{\delta}{\delta \alpha_1^{abc}} + \left(\tilde{\alpha}_2^{abcd} - F_2(0) \alpha_2^{abcd} \right) \frac{\delta}{\delta \alpha_2^{abcd}} + \left(\tilde{\alpha}_3^{abcde} - F_2(0) \alpha_3^{abcde} \right) \frac{\delta}{\delta \alpha_3^{abcde}} + \dots \quad (89)
\end{aligned}$$

Now, in order to determine the renormalization factors we can use that

$$\Sigma(\Phi) + \varepsilon \Sigma_{CT}(\Phi) = \Sigma(\Phi) + \varepsilon \mathcal{R}\Sigma(\Phi) = \Sigma(\Phi_0) + \mathcal{O}(\varepsilon^2), \quad (90)$$

with

$$\Phi_0 = Z_\Phi \Phi = (1 + \varepsilon \mathcal{R})\Phi + \mathcal{O}(\varepsilon^2), \quad (91)$$

where Φ_0 is a short-hand notation for all renormalized quantities: fields, parameters and external sources. We thus find the the following renormalization factors

as well as a multiplicative renormalization of the infinite set of gauge parameters $(\sigma_1^{abc}, \sigma_2^{abcd}, \sigma_3^{abcde})$ and $(\alpha_1^{abc}, \alpha_2^{abcd}, \alpha_3^{abcde})$ of equations (13) and (18), being

$$\begin{aligned}
(\sigma_1^{abc})_0 &= (1 + \varepsilon \tilde{\sigma}_1^{abc}) \sigma_1^{abc} \\
(\sigma_2^{abcd})_0 &= (1 + \varepsilon \tilde{\sigma}_2^{abcd}) \sigma_2^{abcd} \\
(\sigma_3^{abcde})_0 &= (1 + \varepsilon \tilde{\sigma}_3^{abcde}) \sigma_3^{abcde} \\
&\dots \tag{93}
\end{aligned}$$

and

$$\begin{aligned}
(\alpha_1^{abc})_0 &= (1 + F_2(0)) \alpha_1^{abc} + \varepsilon \tilde{\alpha}_1^{abc} \\
(\alpha_2^{abcd})_0 &= (1 + F_2(0)) \alpha_2^{abcd} + \varepsilon \tilde{\alpha}_2^{abcd} \\
(\alpha_3^{abcde})_0 &= (1 + F_2(0)) \alpha_3^{abcde} + \varepsilon \tilde{\alpha}_3^{abcde} \\
&\dots \tag{94}
\end{aligned}$$

This shows that the inclusion of the generalized field $\mathcal{F}(V)$ in the gauge fixing leads to the standard renormalization of the fields, parameters and sources. The renormalization of $\mathcal{F}(V)$ itself is encoded in the renormalization of the infinite set of gauge parameters $(\alpha_1^{abc}, \alpha_2^{abcd}, \alpha_3^{abcde}, \dots)$, as in eq. (94).

Note that both V and Ξ , as well as their sources Ω and Λ , are renormalized in a non-linear way through a power series in V and Ξ , respectively. This is expected, due to the fact that both superfields are dimensionless. However, one has to note that the dimensionless superfield V contains a massive supermultiplet (A_μ, λ) . Despite the fact that V itself renormalizes in a non-linear way due to its dimensionless nature, the component fields (A_μ, λ) do renormalize in fact in a standard multiplicative way through a constant (*i.e.* field independent) renormalization factors, a feature which can be checked out by employing the the Wess-Zumino gauge.

VII. CONCLUSION

In this work we took a first step towards the understanding of Stueckelberg-like models in supersymmetric non-abelian gauge theories. The gauge invariant transverse field configuration V^H has been investigated in supersymmetric Yang-Mills theory with the Landau gauge. An auxiliary chiral superfield Ξ was introduced that compensates the gauge variation of the vector superfield V , thus preserving gauge invariance of the composite field V^H . This gauge invariant composite field allows the construction of a local BRST-invariant massive model, summarized by the action (23). Both V and Ξ are dimensionless, which leads to ambiguities in defining both the mass term and the gauge fixing term. However, working with a generalized gauge fixing term, we find that the model turns out to be renormalizable to all orders of perturbation theory, as was discussed in sections V and VI.

As a possible future application of the present result, let us mention that the possibility of having constructed a

manifestly BRST invariant supersymmetric renormalizable version of the modified Stueckelberg models introduced in [30–34, 44] can open the possibility to investigate the important issue of the non-perturbative phenomenon of the Gribov copies directly in superspace, by generalizing to $\mathcal{N} = 1$ the Gribov-Zwanziger setup. This would enable us to study aspects of the non-perturbative region of $\mathcal{N} = 1$ confining supersymmetric theories, see also [45] for a preliminary attempt in this direction.

Appendix B: N=1 Superfields

In the $\mathcal{N} = 1$ case, we have a Poincaré algebra with spinor charges that anticommutes as

and commutes

$$[Q_\alpha, P_\mu] = 0, \quad [\bar{Q}_{\dot{\alpha}}, P_\mu] = 0, \tag{B3}$$

and to

$$[Q_\alpha, R] = -Q_\alpha, \quad [\bar{Q}_{\dot{\alpha}}, R] = \bar{Q}_{\dot{\alpha}} \tag{B4}$$

The R is a symmetry transforming different charges in a theory into each other and that is isomorphic to a global $U(1)$ group.

Using the supersymmetry transformations as a Lie algebra we can define objects

$$G(x, \theta, \bar{\theta}) = e^{i(-x^\mu P_\mu + \theta Q + \bar{\theta} \bar{Q})} \tag{B5}$$

called superfields which transform covariantly under supersymmetry transformations. Superfields can be of the general type, or chiral type. A chiral superfield $A(x, \theta, \bar{\theta})$ and anti-chiral superfield $A(x, \theta, \bar{\theta})$, is a superfield obeying the constraint

where

are the covariant superspace derivatives. The superfields are functions of superspace which should be understood in components by series power in θ and $\bar{\theta}$. The transformation laws (translation, supersymmetry and R-symmetry) of a superfield ϕ are respectively defined

$$\delta_\mu^P \phi = \partial_\mu \phi, \quad (\text{B8})$$

$$\delta_\alpha^Q \phi = \left(\frac{\partial}{\partial \theta^\alpha} + i\sigma_{\alpha\dot{\alpha}}^\mu \bar{\theta}^{\dot{\alpha}} \partial_\mu \right) \phi, \quad (\text{B9})$$

$$\delta_{\dot{\alpha}}^{\bar{Q}} \phi = \left(-\frac{\partial}{\partial \bar{\theta}^{\dot{\alpha}}} - i\theta^\alpha \sigma_{\alpha\dot{\alpha}}^\mu \partial_\mu \right) \phi, \quad (\text{B10})$$

and

$$\delta^R \phi = i \left(n + \theta^\alpha \frac{\partial}{\partial \theta^\alpha} - \bar{\theta}^{\dot{\alpha}} \frac{\partial}{\partial \bar{\theta}^{\dot{\alpha}}} \right) \phi. \quad (\text{B11})$$

The n number in (B11) is the ‘‘R-weight’’ of the superfield ϕ . The R-weights are opposite to each other in complex conjugates superfields. These operators obey the super-Poincaré algebra

$$\{\delta_\alpha^Q, \delta_{\dot{\alpha}}^{\bar{Q}}\} = -2i\sigma_{\alpha\dot{\alpha}}^\mu \delta_\mu^P, \quad (\text{B12})$$

$$[\delta_\alpha^Q, \delta^R] = i\delta_\alpha^Q, \quad [\delta_{\dot{\alpha}}^{\bar{Q}}, \delta^R] = -i\delta_{\dot{\alpha}}^{\bar{Q}}. \quad (\text{B13})$$

Appendix C: $\mathcal{N} = 1$ Supersymmetric Yang-Mills

For the benefit of the reader, we provide in this appendix a short overview of the well known renormalizability of pure $\mathcal{N} = 1$ standard massless Super Yang-Mills in the Landau gauge. Let us start by giving the complete BRST invariant action, namely

$$\begin{aligned} \Sigma_{\text{SYM}} &= \Sigma_{\text{SYM}} + \Sigma_{\text{SGF}} + \Sigma_{\text{EXT}} \\ &= -\frac{1}{128g^2} \text{tr} \int dS (W^a W_a) + s \left[\frac{1}{8} \int dV (c'^a D^2 V^a + \bar{c}'^a \bar{D}^2 V^a) \right] \\ &\quad + \int dV \Omega^a G_V^a(c, \bar{c}) + \frac{i}{2} \int dS f^{abc} L^a c^b c^c + \frac{i}{2} \int d\bar{S} f^{abc} \bar{L}^a \bar{c}^b \bar{c}^c. \end{aligned} \quad (\text{C1})$$

The full action Σ_{SPYM} obeys the Ward identities (30),(32),(36),(39) as well as the Slavnov-Taylor identity:

$$\mathcal{S}(\Sigma) = \int dV \left\{ \frac{\delta \Sigma}{\delta \Omega^a} \frac{\delta \Sigma}{\delta V^a} \right\} + \left[\int dS \left(\frac{\delta \Sigma}{\delta L^a} \frac{\delta \Sigma}{\delta c^a} + A^a \frac{\delta \Sigma}{\delta c'^a} \right) + c.c. \right] = 0. \quad (\text{C2})$$

As usual, the counterterm Σ_{CT} can be written as

$$\Sigma_{\text{CT}} = \Delta + \mathcal{B}_\Sigma \Delta^{(-1)}, \quad (\text{C3})$$

with

$$\Delta = a_0 \text{Tr} \int dS W^a W_a, \quad (\text{C4})$$

and

$$\Delta^{-1} = \int dV \left(F_1^{ab}(V) V^b \Omega^a - \frac{1}{8} F_1^{ab}(V) V^b (D^2 c'^a + \bar{D}^2 \bar{c}'^a) \right) + \left[\int dS (a_1^{ab} L^a c^b) + c.c. \right]. \quad (\text{C5})$$

When constructing the counterterm, we will run into to same parametrizing problem as in section V. Repeating the procedure of section VI, we introduce a doublet (R^a, P^a) and the full action is now given by

$$\Sigma_{\text{SPYM}} = -\frac{1}{128g^2} \text{tr} \int dS (W^a W_a) + \left[\int dS \left(\frac{i}{2} f^{abc} L^a c^b c^c \right) + c.c. \right] \quad (\text{C6})$$

$$+ \frac{1}{8} \int dV \left\{ A^a D^2 \mathcal{F}^a - c'^a D^2 \left[\frac{\partial \mathcal{F}^a}{\partial V^c} G_V^c \right] + c.c. \right\} \\ + \int dV \left(\Omega^a G_V^a(c, \bar{c}) + P^a \mathcal{F}^a(V) - R^a \frac{\partial \mathcal{F}^a}{\partial V^c} G_V^c(c, \bar{c}) \right). \quad (\text{C7})$$

The action obeys the Ward identities (76),(77),(??) as well as the Slavnov-Taylor identity:

$$\mathcal{S}(\Sigma) = \int dV \left\{ \frac{\delta \Sigma}{\delta \Omega^a} \frac{\delta \Sigma}{\delta V^a} + P^a \frac{\delta \Sigma}{\delta R^a} \right\} + \left[\int dS \left(\frac{\delta \Sigma}{\delta L^a} \frac{\delta \Sigma}{\delta c^a} + A^a \frac{\delta \Sigma}{\delta c'^a} \right) + c.c. \right] = 0. \quad (\text{C8})$$

Making use of the relation $[\frac{\partial}{\partial A^a} - \frac{1}{8} \bar{D}^2 D^2 \frac{\delta}{\delta P^a}, \mathcal{S}\Sigma] = \frac{\delta}{\delta c'^a} - \frac{1}{8} \bar{D}^2 D^2 \frac{\delta}{\delta R}$, we find

$$\Delta^{-1} = \int dV \left(F_1^{ab} V^b \Omega^a + F_2^{ab} V^b (R^a + \frac{1}{8} D^2 c'^a + \frac{1}{8} \bar{D}^2 \bar{c}'^a) \right) + \left[\int dS (a_1^{ab} L^a c^b) + c.c. \right]. \quad (\text{C9})$$

Defining

$$F_2^{ab}(V) = F_2(0) \delta^{ab} + \tilde{F}_2^{ab}(V) \\ \tilde{F}_2^{ab}(V) = \tilde{\alpha}_1^{abc} V^c + \tilde{\alpha}_2^{abcd} V^d + \tilde{\alpha}_3^{abcde} V^e + \dots, \quad (\text{C10})$$

we find the counterterm to be

$$\Sigma_{CT} = \int dS a_0 g^2 \frac{\delta \Sigma}{\partial g^2} + \int dV \left(F_2(0) P^a \frac{\delta \Sigma}{\delta P^a} + F_2(0) \bar{A}^a \frac{\delta \Sigma}{\delta \bar{A}^a} \right. \\ + F_2(0) A^a \frac{\delta \Sigma}{\delta A^a} + F_2(0) R^a \frac{\delta \Sigma}{\delta R^a} + F_2(0) c'^a \frac{\delta \Sigma}{\delta c'^a} + F_2(0) \bar{c}'^a \frac{\delta \Sigma}{\delta \bar{c}'^a} \left. \right) \\ + \int dV \left(F_1^{ab} V^b \frac{\delta \Sigma}{\delta V^a} - \left(\frac{\delta F_1^{ab}}{\delta V^c} V^b + F_1^{ac} \right) \Omega^a \frac{\delta \Sigma}{\delta \Omega^c} \right) \\ + \left[\int dS \left(\alpha_1 L^a \frac{\partial \Sigma}{\partial L^a} - \alpha_1 c^a \frac{\partial \Sigma}{\partial c^a} \right) + c.c. \right] \\ + \int dV \left((\tilde{\alpha}_1^{abc} - F_2(0)) \frac{\delta \Sigma}{\partial \alpha_1^{abc}} + (\tilde{\alpha}_2^{abcd} - F_2(0)) \frac{\delta \Sigma}{\partial \alpha_2^{abcd}} + (\tilde{\alpha}_3^{abcde} - F_2(0)) \frac{\delta \Sigma}{\partial \alpha_3^{abcde}} + \dots \right). \quad (\text{C11})$$

Following the analysis at the end of section VI, for the renormalization factors we obtain

$$Z_g = 1 + a_0 \\ Z_\Omega^{ab} = \delta^{ab} - \left(\frac{\delta F_1^{ac}}{\delta V^b} V^c + F_1^{ab} \right) \\ Z_V^{ab} = \delta^{ab} + F_1^{ab} \\ Z_P = Z_A = Z_{\bar{A}} = Z_R = Z_{c'} = Z_{c'^a} = 1 + F_2(0) \\ Z_L^{ab} = Z_{\bar{L}}^{ab} = Z_c^{ab} = Z_{\bar{c}}^{ab} = \delta^{ab} + a_1^{ab}. \quad (\text{C12})$$

Thereby concluding the proof of the renormalizability of $\mathcal{N} = 1$ pure massless Super Yang-Mills action.
