On the ideals of some sumset semigroups

Abstract

A sumset semigroup is a non-cancellative commutative monoid obtained from the sumset of finite non-negative integer sets. In this work, an algorithm for computing the ideals associated with some sumset semigroups is provided. Using these ideals, we study some factorization properties of sumset semigroups and some additive properties of sumsets. This approach links computational commutative algebra with additive number theory.

Introduction

Additive number theory is the subfield of number theory concerning the study of subsets of integers and their behaviour under addition. More abstractly, the field of additive number theory includes the study of abelian groups and commutative semigroups with an operation of addition. The principal objects of study are (i) the sumset of two subsets A and B of elements from an abelian group G, $A + B = \{a + b \mid a \in A, b \in B\}$, and (ii) to determine the structure and properties of the h-fold sumset hA when the set A is known. In an inverse problem, we start with the sumset hA and try to deduce information about the underlying set A. An up-to-date reference for inverse problems can be found in [15, Chapter 5]. There is a beautiful and straightforward solution of the direct problem of describing the structure of the h-fold sumset hA for any finite set A of integers and for all sufficiently large h (see [8, Theorem 1.1]). This result has implications for the study of Weierstrass semigroups, such as is shown in [3].

Here, we consider the commutative semigroup whose elements are the finite subsets of \mathbb{N} , denoted by $(FS(\mathbb{N}), +)$ with + the operation defined as before. This

semigroup is the power monoid of \mathbb{N} (see [4], [5] and the references therein). A sumset semigroup is a semigroup generated by a finite number of elements of FS(\mathbb{N}). We show that the sumset semigroups are atomic reduced semigroups with finite elasticity. It is well known that finitely generated semigroups are finitely presented (see [7]). That is, there exists $p \in \mathbb{N}$ and a congruence σ in $\mathbb{N}^p \times \mathbb{N}^p$ such that the semigroup S is isomorphic to \mathbb{N}^p/σ . Equivalently, there exists a binomial ideal I_S in the polynomial ring $\mathbf{k}[x_1,\ldots,x_p]$ such that S is isomorphic to the set of monomials in $\mathbf{k}[x_1,\ldots,x_p]/I_S$ with the product operation. The presentation of S (or a system of generators of the semigroup ideal I_S) provides us with a way to obtain the expressions of an element of the semigroup in terms of its generators. This can be done with Gröbner bases and related techniques. For instance, we can check whether the h-fold of any $A \in S$ can be expressed as a sumset of other elements. By using these techniques, we can build a bridge between computational commutative algebra and additive number theory.

We also present a new Python library [6] that includes an implementation of our algorithms and the examples that illustrate it.

In this work, we show some properties of the semigroup $FS(\mathbb{N})$ and give the ideals of some types of sumset semigroups. The work is organized as follows. In Section 1, we present some definitions and results on Gröbner bases. In Section 2, we introduce the sumset semigroups and study some of their properties. In Sections 3 and 4, by using algebraic commutative algebra tools, we study the ideals of some families of sumset semigroups, thereby allowing us to introduce Algorithm 1 and provide some examples.

1 Some results on commutative algebra

For a field **k** and a set of indeterminates $\{x_1,\ldots,x_t\}$, the polynomial ring $\mathbf{k}[x_1,\ldots,x_t]$ (also denoted by $\mathbf{k}[X]$) is the set of polynomials in $\{x_1,\ldots,x_t\}$ with coefficients in **k**, that is, the set $\{\sum_{i=1}^m a_i x_1^{\alpha_1} \cdots x_t^{\alpha_t} \mid m \in \mathbb{N}, a_i \in \mathbf{k}, \alpha_1,\ldots,\alpha_t \in \mathbb{N}\}$. We denote by X^{α} the monomial $x_1^{\alpha_1}\cdots x_t^{\alpha_t}$, with $\alpha=(\alpha_1,\ldots,\alpha_t)\in\mathbb{N}^t$. In this work, some results use Gröbner basis theory and the Elimination Theorem. The necessary background can be found in [2, §2 and §3] but is also provided here so that the present work is self-contained.

It is well known that any ideal in a polynomial ring is finitely generated. In particular, there exists a special generating set associated with the ideals, namely a Gröbner basis. This concept depends on the election of an order on the monomials. A monomial order \prec on $\mathbf{k}[X]$ is a multiplicative total order on the set of monomials if for each two monomials X^{α}, X^{β} such that $X^{\alpha} \prec X^{\beta}$, then $X^{\alpha}X^{\gamma} \prec X^{\beta}X^{\gamma}$ for every monomial X^{γ} .

For a fixed monomial order \prec on $\mathbf{k}[X]$, $\operatorname{In}_{\prec}(I)$ denotes the set of leading terms of non-zero elements of I, and $\langle \operatorname{In}_{\prec}(I) \rangle$ the monomial ideal generated by $\operatorname{In}_{\prec}(I)$. A subset G of I is a Gröbner basis of I if $\langle \operatorname{In}_{\prec}(I) \rangle = \langle \{\operatorname{In}_{\prec}(g) \mid g \in G\} \rangle$, where $\operatorname{In}_{\prec}(g)$ is the leading term of g. An algorithm for computing a Gröbner basis for I is given in [2, Chapter 2, §7]. It is also well known that Gröbner bases of binomial ideals are sets of binomials.

Given two polynomials f and g, their S-polynomial is defined by $S(f,g) = \frac{aX^{\alpha}}{\ln_{\prec}(f)}f - \frac{aX^{\alpha}}{\ln_{\prec}(g)}g$, where aX^{α} is the least common multiple of $\ln_{\prec}(f)$ and $\ln_{\prec}(g)$. Also, for k non-zero polynomials f_1, \ldots, f_k , we say that $S(f_i, f_j) = \sum_{l=1}^k g_l f_l$

has an lcm representation if the least common multiple of the monomial leaders of f_i and f_j is bigger than $\operatorname{In}_{\prec}(g_lf_l)$ (respect \prec) whenever $g_lf_l\neq 0$. Thus, we obtain another equivalent definition of a Gröbner basis.

Theorem 1. [2, Chapter 2, §9, Theorem 6] A basis $\{f_1, \ldots f_k\}$ of an ideal I is a Gröbner basis if and only if for every $i \neq j$, the S-polynomial $S(f_i, f_j)$ has an lcm representation.

The above theorem allows us to prove the next result. We use this lemma in the following sections.

Lemma 2. Let $I \subset \mathbf{k}[X,Y]$ and $J \subset \mathbf{k}[Z,X,Y]$ be two binomial ideals with J generated by $G = \{z_1 - M_1, \ldots, z_t - M_t\}$, where each M_i is a monomial in $\mathbf{k}[X,Y]$. Fix \prec a monomial order on $\mathbf{k}[Z,X,Y]$ such that $x_j,y_k \prec z_i$, for every x_j,y_k and z_i . Then, the union of G and a Gröbner basis of I respect \prec is a Gröbner basis of I + J respect \prec . Moreover, if a binomial L - T belongs to $(I + J) \cap \mathbf{k}[X,Y]$, then $L - T \in I$.

Proof. Note that G is a Gröbner basis of J respect \prec , and consider $G' = \{g_1, \ldots, g_h\} \subset \mathbf{k}[X, Y]$ a Gröbner basis of I. Thus, S(f, f') and S(g, g') have an lcm representation for every $f, f' \in G$ and $g, g' \in G'$. Let L - T be a binomial in G', $z_i - M_i \in G$, and assume $L \succ T$. Hence, $S(z_i - M_i, L - T) = L(z_i - M_i) - z_i(L - T) = T(z_i - M_i) - M_i(L - T)$; that is to say, $S(z_i - M_i, L - T)$ has an lcm representation. Therefore, $G \cup G'$ is a Gröbner basis of I + J.

Consider any $L - T \in I + J$ with $L - T \in \mathbf{k}[X, Y]$. By [2, Chapter 2, §3, Theorem 3] and [2, Chapter 2, §6, Corollary 2], we have that $L - T = \sum_{i=1}^{h} f_i g_i$, with $\operatorname{In}_{\prec}(L - T) \succeq \operatorname{In}_{\prec}(f_i g_i)$, for $i = 1, \ldots, h$. Hence, every f_i belongs to $\mathbf{k}[X, Y]$.

A method for computing the ideal $I \cap \mathbf{k}[x_{l+1}, \dots, x_t]$ (for $t > l \ge 1$) is called the *Elimination Theorem*.

Theorem 3. [2, Chapter 3] Let $I \subset \mathbf{k}[x_1, \ldots, x_t]$ be an ideal and let G be a Gröbner basis of I with respect to lex order where $x_1 > x_2 > \cdots > x_t$. Then, for every $0 \le l \le t$, the set $G \cap \mathbf{k}[x_{l+1}, \ldots, x_t]$ is a generating set of the ideal $I \cap \mathbf{k}[x_{l+1}, \ldots, x_t]$. Furthermore, $G \cap \mathbf{k}[x_{l+1}, \ldots, x_t]$ is a Gröbner basis of $I \cap \mathbf{k}[x_{l+1}, \ldots, x_t]$.

We introduce the semigroup ideal as an important object in this work. A monoid/semigroup is a non-empty set equipped with an associative and commutative binary operation (denoted by +), and an identity element. A semigroup is finitely generated if there exists a finite set $A = \{a_1, \ldots, a_t\} \subset S$ such that $S = \langle A \rangle := \{\alpha_1 a_1 + \cdots + \alpha_t a_t \mid \alpha_1, \ldots, \alpha_t \in \mathbb{N}\}$ (αa denotes $\sum_{i=1}^{\alpha} a$). For a field \mathbf{k} , S has associated the binomial ideal in $\mathbf{k}[x_1, \ldots, x_t]$,

$$I_S = \left\langle \left\{ X^{\alpha} - X^{\beta} \mid \sum_{i=1}^t \alpha_i a_i = \sum_{i=1}^t \beta_i a_i \right\} \right\rangle.$$

This ideal is usually called the semigroup ideal of S, and it has an important role in studying some properties of the semigroup. Note that I_S codifies the relationships among the elements of S. Associated to these ideals we have the lattice M of \mathbb{Z}^t generated by the elements $\{\alpha - \beta \mid X^{\alpha} - X^{\beta} \in I_S\}$. We say that

 I_S is strongly reduced whenever $M \cap \mathbb{N}^t = \{0\}$ (this concept was introduced in [14]). Define \mathcal{I}_M the finitely generated cancellative subsemigroup of $\mathbb{N}^t \times \mathbb{N}^t$ all of whose elements (α, β) verify $\alpha - \beta \in M$. Let $\mathcal{A}(\mathcal{I}_M)$ be the minimal system of generators of the subsemigroup \mathcal{I}_M . This minimal generating set can be computed performing the following steps:

- 1. Compute a system of linear homogeneous equations Ax = 0 of M from its system of generators [10, Chapter 2].
- 2. The Hilbert basis of (A|-A)(x,y)=0 is the set $\mathcal{A}(\mathcal{I}_M)$. That basis can be computed by using [9].

When the semigroup S is a subset of \mathbb{N} such that $\mathbb{N} \setminus S$ is finite, S is called a numerical semigroup, and it is finitely generated. In [11], the authors introduce some algorithms for computing the ideals of numerical semigroups.

2 Sumset semigroups

Let us begin this section by recalling some standard definitions in semigroup theory. Assume S is a commutative semigroup, S is cancellative if x+z=y+z for some $x,y,z\in S$, implies x=y. An element $x\in S$ is a unit if x+y=0 for some $y\in S$. The set of units of S is denoted by $\mathcal{U}(S)$. When $S\cap (-S)=\{0\}$, S is named reduced. An atom in S is any non-unit $x\in S$ such that there do not exist two non-units $y,z\in S$ with x=y+z. The semigroup is atomic if $S\setminus \mathcal{U}(S)$ is generated by its atoms. The set of atoms of S is denoted by $\mathcal{A}(S)$.

Let $FS(\mathbb{N})$ be the set whose elements are the finite non-empty subsets of \mathbb{N} . Recall that on $FS(\mathbb{N})$, the binary operation + is defined as $A+B=\{a+b\mid a\in A,b\in B\}$ for all $A,B\in FS(\mathbb{N})$. The pair $(FS(\mathbb{N}),+)$ is a commutative monoid with identity element equal to $\{0\}$. Every finitely generated submonoid of $(FS(\mathbb{N}),+)$ is called a sumset semigroup. If $A\in FS(\mathbb{N})$ and $\alpha\in\mathbb{N}$, denote by $\alpha\otimes A$ the sumset $\sum_{i=1}^{\alpha}A$.

The monoid $FS(\mathbb{N})$ satisfies the following interesting properties:

- since $\{1,3\} + \{1,2,3\} = \{1,2,3\} + \{1,2,3\}$, it is non-cancellative;
- it is a reduced monoid;
- since $2 \otimes \{1, 2, 4, 5\} = 2 \otimes \{1, 2, 3, 4, 5\}$, it is not torsion free;
- \bullet by Proposition 3.2 of [5], this monoid is atomic.

The operation \otimes has good properties, as shown in the following lemma.

Lemma 4. Let A, B be in $FS(\mathbb{N})$ and $\alpha, \beta \in \mathbb{N}$, then:

1.
$$\alpha \otimes (\beta \otimes A) = (\alpha \beta) \otimes A$$
;

2.
$$\alpha \otimes (A+B) = \alpha \otimes A + \alpha \otimes B$$
.

Let S be a sumset semigroup minimally generated by $\{A_1,\ldots,A_t\}$. By definition, the elasticity of a non-unit $A\in S$ is $\rho(A)=\sup\big\{m/n\mid \exists a_1,\ldots,a_m,b_1,\ldots,b_n\in\mathcal{A}(S)$ with $A=\sum_{i=1}^m a_i=\sum_{i=1}^n b_i\big\}$, and the elasticity of S is $\rho(S)=\sup\{\rho(A)\mid A\in S\setminus\{0\}\}$. If there is an element in the monoid whose elasticity "reaches" that of the whole monoid, we say that the monoid has acceptable elasticity.

Note that the ideal associated to S is

$$I_S = \left\langle \left\{ X^{\alpha} - X^{\beta} \mid \sum_{i=1}^t \alpha_i \otimes A_i = \sum_{i=1}^t \beta_i \otimes A_i \right\} \right\rangle \subset \mathbf{k}[x_1, \dots, x_t].$$

Let $\alpha \in M \cap \mathbb{N}^t$ be a non-zero element, thus there exists $\beta \in \mathbb{N}^t$ such that $X^{\alpha+\beta} - X^{\beta} = X^{\beta}(X^{\alpha} - 1) \in I_S$, and then $\sum_{i=1}^{t} (\alpha_i + \beta_i) A_i = \sum_{i=1}^{t} \beta_i A_i$. Therefore, $\max \sum_{i=1}^{t} (\alpha_i + \beta_i) A_i = \sum_{i=1}^{t} (\alpha_i + \beta_i) \max A_i > \sum_{i=1}^{t} \beta_i \max A_i = \max \sum_{i=1}^{t} \beta_i A_i$, which it is not possible. Hence, $M \cap \mathbb{N}^t$ is $\{0\}$, and the ideal I_S is strongly reduced.

Since I_S is strongly reduced, we have that S is an atomic reduced semigroup with finite elasticity (see Theorem 15 in [13]). Moreover,

$$\rho(S) = \max \left\{ \frac{\sum_{i=1}^{t} \alpha_i}{\sum_{i=1}^{t} \beta_i} \mid (\alpha, \beta) \in \mathcal{A}(\mathcal{I}_M) \right\}.$$
 (1)

If $A = \{a_1 < \dots < a_n\} \in FS(\mathbb{N})$, then $A = \{a_1\} + \{0, a_2 - a_1, \dots, a_n - a_1\}$ (denote $\{0, a_2 - a_1, \dots, a_n - a_1\}$ by \tilde{A}). The semigroup $S = \langle A_1, \dots, A_t \rangle$, with $A_i = \{a_{i1} < \dots < a_{it_i}\}, \text{ is a submonoid of } (\{a_{11}\}, \dots, \{a_{1t}\}, A_1, \dots, A_t). \text{ Triv-}$ ially, the sumset semigroup $\langle \{a_{11}\}, \ldots, \{a_{1t}\} \rangle$ is isomorphic to the semigroup $\langle a_{11}, \ldots, a_{1t} \rangle$, thus $I_{\langle a_1, \ldots, a_s \rangle} = I_{\langle \{a_{11}\}, \ldots, \{a_{1t}\} \rangle}$.

Proposition 5. For every $\tilde{S} = \{\{a_1\}, \dots, \{a_s\}, \tilde{A}_1, \dots, \tilde{A}_t\}, \text{ with } a_i \neq 0 \text{ and }$ $\min \tilde{A}_i = 0, \text{ we have } I_{\tilde{S}} = I_{\langle a_1, \dots, a_s \rangle} + I_{\langle \tilde{A}_1, \dots, \tilde{A}_t \rangle}, \text{ where } I_{\langle a_1, \dots, a_s \rangle} \subset \mathbf{k}[x_1, \dots, x_s]$ and $I_{\langle \tilde{A}_1, \dots, \tilde{A}_t \rangle} \subset \mathbf{k}[y_1, \dots, y_t].$

Proof. Trivially, $I_{\langle a_1, \dots, a_s \rangle}$, $I_{\langle \tilde{A}_1, \dots, \tilde{A}_t \rangle} \subset I_{\tilde{S}}$. Let $X^{\alpha}Y^{\beta} - X^{\gamma}Y^{\delta} \in I_{\tilde{S}}$, then $\sum_{i=1}^{s} \alpha_i \otimes \{a_i\} + \sum_{i=1}^{t} \beta_i \otimes \tilde{A}_i = \sum_{i=1}^{s} \gamma_i \otimes \{a_i\} + \sum_{i=1}^{t} \delta_i \otimes \tilde{A}_i$. Since $\min \tilde{A}_i = 0$, we then have $\sum_{i=1}^{s} \alpha_i \otimes \{a_i\} = \sum_{i=1}^{s} \gamma_i \otimes \{a_i\}$, and $\sum_{i=1}^{t} \beta_i \otimes \tilde{A}_i = \sum_{i=1}^{t} \delta_i \otimes \tilde{A}_i$. That is to say, $X^{\alpha} - X^{\gamma} \in I_{\langle a_1, \dots, a_s \rangle}$, and $Y^{\beta} - Y^{\delta} \in I_{\langle \tilde{A}_1, \dots, \tilde{A}_t \rangle}$. Note that $X^{\alpha}Y^{\beta} - X^{\gamma}Y^{\delta} = Y^{\beta}(X^{\alpha} - X^{\gamma}) + X^{\gamma}(Y^{\beta} - X^{\gamma}Y^{\delta}) = I_{\langle a_1, \dots, a_s \rangle}$. Y^{δ}) $\in I_{\langle a_1, \dots, a_s \rangle} + I_{\langle \tilde{A}_1, \dots, \tilde{A}_t \rangle} \subset \mathbf{k}[x_1, \dots, x_s, y_1, \dots, y_t]$

Since the semigroup $\langle a_1, \ldots, a_s \rangle$ is isomorphic to a numerical semigroup, there exist algorithms for computing $I_{\langle a_1,\ldots,a_s\rangle}$. Thus, to compute a presentation of \tilde{S} we need an algorithm to calculate $I_{\langle \tilde{A}_1,...,\tilde{A}_t \rangle}$. In the next sections, we provide some algorithms for computing the ideals of some families of sumset semigroups.

$\mathbf{3}$ Ideals of a fundamental family of sumset semigroups

In this section, we give explicitly the ideals associated with the sumset semigroups generated by the elements $\{0, k\mathbf{a}\}$ and $\{0, k\mathbf{b}\}$, where $\mathbf{a} < \mathbf{b}$ are two positive co-prime integers, and $k \in \mathbb{N} \setminus \{0\}$. These semigroups are key to provide an algorithm to compute the semigroup ideals of more types of sumset semigroups.

Fix $\mathbf{a} < \mathbf{b}$ as two positive co-prime integers and $k \in \mathbb{N} \setminus \{0\}$, and consider the semigroup $\overline{S} = \langle k\mathbf{a}, k\mathbf{b} \rangle$ and the sumset semigroup \widetilde{S} minimally generated by $\{0, k\mathbf{a}\}$ and $\{0, k\mathbf{b}\}$. We prove that $I_{\widetilde{S}} \subset \mathbf{k}[x, y]$ is a principal ideal providing its generator. Note that $I_{\widetilde{S}} \subset I_{\overline{S}} = \langle x^{\mathbf{b}} - y^{\mathbf{a}} \rangle$.

Lemma 6. Set $x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} \in I_{\widetilde{S}} \setminus \{0\}$. Then, $\alpha \neq \gamma$, $\beta \neq \delta$ and $\alpha \cdot \beta \cdot \gamma \cdot \delta \geq 1$.

Proof. Note that, since $f = x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} \in I_{\widetilde{S}}$, $\alpha \otimes \{0, k\mathbf{a}\} + \beta \otimes \{0, k\mathbf{b}\} = \gamma \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}$.

Suppose $\alpha = \gamma$, then we have $\alpha k\mathbf{a} + \beta k\mathbf{b} = \max \{\alpha \otimes \{0, k\mathbf{a}\} + \beta \otimes \{0, k\mathbf{b}\}\} = \max \{\alpha \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}\} = \alpha k\mathbf{a} + \delta k\mathbf{b}$, and $\beta = \delta$. Since $f \neq 0$, this is not possible, and therefore $\alpha \neq \gamma$. Analogously, it can be proved that $\beta \neq \delta$.

Suppose $\alpha = 0$, then we have $k\mathbf{b} = \min \{\beta \otimes \{0, k\mathbf{b}\} \setminus \{0\}\} = \min \{(\gamma \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}) \setminus \{0\}\}$. If γ is non-zero, then $k\mathbf{b} = \min \{(\gamma \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}) \setminus \{0\}\} = k\mathbf{a}$. Therefore, the integers γ , β , and δ are zero and f = 0. Similarly, β , γ , $\delta \geq 1$ can be proved.

In the sequel, we assume $\alpha > \gamma \geq 1$, and $x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} \in I_{\widetilde{S}} \setminus \{0\}$. Since $I_{\widetilde{S}} \subset \langle x^{\mathbf{b}} - y^{\mathbf{a}} \rangle$, $\alpha \geq \mathbf{b}$ and $\delta \geq \mathbf{a}$.

Lemma 7. If $\alpha > \gamma$, then $\delta > \beta$. Additionally, there exists a positive integer n such that $\alpha = n\mathbf{b} + \gamma$ and $\delta = n\mathbf{a} + \beta$.

Proof. Since $x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} \in I_{\widetilde{S}}$, $\alpha \otimes \{0, k\mathbf{a}\} + \beta \otimes \{0, k\mathbf{b}\} = \gamma \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}$, and $\alpha k\mathbf{a} + \beta k\mathbf{b} = \max \left\{\alpha \otimes \{0, k\mathbf{a}\} + \beta \otimes \{0, k\mathbf{b}\}\right\} = \max \left\{\gamma \otimes \{0, k\mathbf{a}\} + \delta \otimes \{0, k\mathbf{b}\}\right\} = \gamma k\mathbf{a} + \delta k\mathbf{b}$. So, $(\delta - \beta)k\mathbf{b} = (\alpha - \gamma)k\mathbf{a} > 0$. Furthermore, $(\alpha - \gamma)/(\delta - \beta) = \mathbf{b}/\mathbf{a}$. Since $\gcd(\mathbf{a}, \mathbf{b}) = 1$, there exist two positive integers n and m such that $\alpha = n\mathbf{b} + \gamma$ and $\delta = m\mathbf{a} + \beta$. From the equality $\alpha k\mathbf{a} + \beta k\mathbf{b} = \gamma k\mathbf{a} + \delta k\mathbf{b}$, we deduce that n = m.

Lemma 8. Let $x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} \in I_{\widetilde{S}} \setminus \{0\}$. Then, $\gamma \geq \mathbf{b} - 1$, $\beta \geq \mathbf{a} - 1$, and there is a positive integer $n \in \mathbb{N}$ such that $x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} = x^{\gamma}y^{\beta}(x^{n\mathbf{b}} - y^{n\mathbf{a}})$.

Proof. Assume $\gamma < \mathbf{b} - 1$. Take $(\gamma + 1)k\mathbf{a} + \beta k\mathbf{b}$ in $\alpha \otimes \{0, k\mathbf{a}\} + \beta \otimes \{0, k\mathbf{b}\}$ (recall $\alpha > \gamma$). For that element, there exist two integers $i \in [0, \gamma]$ and $j \in [0, \delta]$ such that $(\gamma + 1)k\mathbf{a} + \beta k\mathbf{b} = (\gamma - i)k\mathbf{a} + (\delta - j)k\mathbf{b} \in \gamma\{0, k\mathbf{a}\} + \delta\{0, k\mathbf{b}\}$, hence $(1+i)k\mathbf{a} = (\delta - \beta - j)k\mathbf{b}$. Since $\gcd(\mathbf{a}, \mathbf{b}) = 1$, $i + 1 \ge \mathbf{b}$ and $i \ge \mathbf{b} - 1 > \gamma$, but $i \le \gamma$, which is a contradiction. Analogously, the fact $\beta \ge \mathbf{a} - 1$ can be proved.

By Lemma 7, there exists $n \in \mathbb{N} \setminus \{0\}$ such that

$$x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} = x^{n\mathbf{b} + \gamma}y^{\beta} - x^{\gamma}y^{n\mathbf{a} + \beta} = x^{\gamma}y^{\beta}(x^{n\mathbf{b}} - y^{n\mathbf{a}}).$$

Theorem 9. Let $1 \leq \mathbf{a} < \mathbf{b}$ be two co-prime integers, $k \in \mathbb{N} \setminus \{0\}$, and \widetilde{S} be the sumset semigroup $\langle \{0, k\mathbf{a}\}, \{0, k\mathbf{b}\} \rangle$. The ideal $I_{\widetilde{S}} \subset \mathbf{k}[x, y]$ is principal and is generated by $x^{\mathbf{b}-1}y^{\mathbf{a}-1}(x^{\mathbf{b}}-y^{\mathbf{a}})$.

Proof. Observe that $x^{\mathbf{b}-1}y^{\mathbf{a}-1}(x^{\mathbf{b}}-y^{\mathbf{a}})=x^{2\mathbf{b}-1}y^{\mathbf{a}-1}-x^{\mathbf{b}-1}y^{2\mathbf{a}-1}$. To prove this theorem, we describe explicitly the sets $A=(2\mathbf{b}-1)\otimes\{0,k\mathbf{a}\}+(\mathbf{a}-1)\otimes\{0,k\mathbf{b}\}$ and $B=(\mathbf{b}-1)\otimes\{0,k\mathbf{a}\}+(2\mathbf{a}-1)\otimes\{0,k\mathbf{b}\}$ associated with the monomials $x^{2\mathbf{b}-1}y^{\mathbf{a}-1}$ and $x^{\mathbf{b}-1}y^{2\mathbf{a}-1}$ (respectively), to achieve A=B.

Note that the first set $A = (2\mathbf{b} - 1) \otimes \{0, k\mathbf{a}\} + (\mathbf{a} - 1) \otimes \{0, k\mathbf{b}\}$ is equal to

$$\{0, k\mathbf{a}, \dots, (2\mathbf{b} - 1)k\mathbf{a}\} + \{0, k\mathbf{b}, \dots, (\mathbf{a} - 1)k\mathbf{b}\} = \\ = k\Big(\{0, \mathbf{a}, \dots, (2\mathbf{b} - 1)\mathbf{a}\} \cup \{0, \mathbf{b}, \dots, (\mathbf{a} - 1)\mathbf{b}\} \cup \\ \{\mathbf{a} + \mathbf{b}, \dots, \mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \{2\mathbf{a} + \mathbf{b}, \dots, 2\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \dots \\ \cup \{(2\mathbf{b} - 1)\mathbf{a} + \mathbf{b}, \dots, (2\mathbf{b} - 1)\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\}\Big) \\ = k\Big(\{0, \mathbf{a}, \dots, (\mathbf{b} - 1)\mathbf{a}, \mathbf{b}\mathbf{a}, (\mathbf{b} + 1)\mathbf{a}, \dots, (2\mathbf{b} - 1)\mathbf{a}\} \cup \\ \{0, \mathbf{b}, \dots, (\mathbf{a} - 1)\mathbf{b}\} \cup \{\mathbf{a} + \mathbf{b}, \dots, \mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \dots \\ \cup \{(\mathbf{b} - 1)\mathbf{a} + \mathbf{b}, \dots, (\mathbf{b} - 1)\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \\ \{\mathbf{b}\mathbf{a} + \mathbf{b}, \dots, \mathbf{b}\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \dots \\ \cup \{(2\mathbf{b} - 1)\mathbf{a} + \mathbf{b}, \dots, (2\mathbf{b} - 1)\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\} \cup \dots \\ \cup \{(2\mathbf{b} - 1)\mathbf{a} + \mathbf{b}, \dots, (2\mathbf{b} - 1)\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\}\Big).$$

We denote $C_1 = \{0, \mathbf{a}, \dots, (\mathbf{b} - 1)\mathbf{a}\}, C_2 = \{0, \mathbf{b}, \dots, (\mathbf{a} - 1)\mathbf{b}\}, C_3 = \bigcup_{i=1}^{\mathbf{b} - 1} \{i\mathbf{a} + \mathbf{b}, \dots, i\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\}, C_4 = \{\mathbf{a}\mathbf{b}\} \cup \{\mathbf{b}\mathbf{a} + \mathbf{b}, \dots, \mathbf{b}\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\}, C_5 = \{(\mathbf{b} + 1)\mathbf{a}, \dots, (2\mathbf{b} - 1)\mathbf{a}\}, \text{ and } C_6 = \bigcup_{i=\mathbf{b}+1}^{2\mathbf{b}-1} \{i\mathbf{a} + \mathbf{b}, \dots, i\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}\}.$ The set A is the union $\bigcup_{i=1}^{6} kC_i$.

The set $B = ({\bf b} - 1) \otimes \{0, k{\bf a}\} + (2{\bf a} - 1) \otimes \{0, k{\bf b}\}$ is

$$\{0, k\mathbf{a}, \dots, (\mathbf{b} - 1)k\mathbf{a}\} + \{0, k\mathbf{b}, \dots, (2\mathbf{a} - 1)k\mathbf{b}\} =$$

$$= k\Big(\{0, \mathbf{a}, \dots, (\mathbf{b} - 1)\mathbf{a}\} \cup \{0, \mathbf{b}, \dots, (\mathbf{a} - 1)\mathbf{b}, \mathbf{a}\mathbf{b}, \dots, (2\mathbf{a} - 1)\mathbf{b}\} \cup$$

$$\{\mathbf{a} + \mathbf{b}, \dots, \mathbf{a} + (\mathbf{a} - 1)\mathbf{b}, \mathbf{a} + \mathbf{a}\mathbf{b}, \dots, \mathbf{a} + (2\mathbf{a} - 1)\mathbf{b}\} \cup \cdots$$

$$\cup \{(\mathbf{b} - 1)\mathbf{a} + \mathbf{b}, \dots, (\mathbf{b} - 1)\mathbf{a} + (\mathbf{a} - 1)\mathbf{b}, (\mathbf{b} - 1)\mathbf{a} + \mathbf{a}\mathbf{b}, \dots, (\mathbf{b} - 1)\mathbf{a} + (2\mathbf{a} - 1)\mathbf{b}\}\Big)$$

$$= \bigcup_{i=1}^{6} kC_i.$$

Thus, A = B, and $x^{\mathbf{b}-1}y^{\mathbf{a}-1}(x^{\mathbf{b}} - y^{\mathbf{a}}) \in I_S$.

To finish the proof, we use Lemma 8. If n=1, then $x^{\alpha}y^{\beta}-x^{\gamma}y^{\delta}=x^{\gamma-\mathbf{b}+1}y^{\beta-\mathbf{a}+1}x^{\mathbf{b}-1}y^{\mathbf{a}-1}(x^{\mathbf{b}}-y^{\mathbf{a}})$. In case n>1, by factorizing the binomial $x^{n\mathbf{b}}-y^{n\mathbf{a}}$, we obtain

$$x^{\alpha}y^{\beta} - x^{\gamma}y^{\delta} =$$

$$x^{\gamma - \mathbf{b} + 1}y^{\beta - \mathbf{a} + 1}(x^{(n-1)\mathbf{b}} + x^{(n-2)\mathbf{b}}y + \dots + xy^{(n-2)\mathbf{a}} + y^{(n-1)\mathbf{a}})x^{\mathbf{b} - 1}y^{\mathbf{a} - 1}(x^{\mathbf{b}} - y^{\mathbf{a}}).$$
In any case, $I_{\widetilde{S}} = \langle x^{\mathbf{b} - 1}y^{\mathbf{a} - 1}(x^{\mathbf{b}} - y^{\mathbf{a}}) \rangle.$

Corollary 10. Let a_1, \ldots, a_s be positive integers, and S be the sumset semi-group generated by $\{\{a_1\}, \ldots, \{a_s\}, \{0, k\mathbf{a}\}, \{0, k\mathbf{b}\}\}$. Then,

$$I_S = I_{\langle a_1, \dots, a_s \rangle} + \langle x^{\mathbf{b} - 1} y^{\mathbf{a} - 1} (x^{\mathbf{b}} - y^{\mathbf{a}}) \rangle \subset \mathbf{k}[x_1, \dots, x_s, x, y].$$

Proof. From Proposition 5 and Theorem 9, we obtain the result. \Box

4 Computing the ideals of sumset semigroups

The aim of this section is to determine an algorithm for computing the ideals associated with some families of sumset semigroups. As in the previous section, we consider two positive co-prime integers $\mathbf{a} < \mathbf{b}, k \in \mathbb{N} \setminus \{0\}$, the semigroup $\overline{S} = \langle k\mathbf{a}, k\mathbf{b} \rangle$, and the sumset semigroup $\widetilde{S} = \langle \{0, k\mathbf{a}\}, \{0, k\mathbf{b}\} \rangle$.

For any two non-negative integers n and m, A_{nm} denotes $\{\alpha k\mathbf{a} + \beta k\mathbf{b} \mid \alpha \in A_{nm}\}$ $\{0,\ldots,n\}, \beta \in \{0,\ldots,m\}\} = n \otimes k\{0,\mathbf{a}\} + m \otimes k\{0,\mathbf{b}\}.$

Theorem 11. Let $\{(n_i, m_i) \mid n_i, m_i \in \mathbb{N}, n_i + m_i > 0, i = 1, ..., t\}$ be a nonempty subset of \mathbb{N}^2 , $b_1, \ldots, b_p, a_1, \ldots, a_s \in \mathbb{N} \setminus \{0\}$ with $s \leq t$, and consider S the sumset semigroup generated by

$$\{\{b_1\},\ldots,\{b_p\},\{a_1\}+A_{n_1m_1},\ldots,\{a_s\}+A_{n_sm_s},A_{n_{s+1}m_{s+1}},\ldots,A_{n_tm_t}\},$$

and the sumset semigroup $S' = \langle \{b_1\}, \dots, \{b_p\}, \{a_1\}, \dots, \{a_s\}, \{0, k\mathbf{a}\}, \{0, k\mathbf{b}\} \rangle$. Then, $I_S \in \mathbf{k}[x_1, \dots, x_p, z_1, \dots, z_t]$ is

$$\left(I_{S'} + \langle z_1 - w_1 x^{n_1} y^{m_1}, \dots, z_s - w_s x^{n_s} y^{m_s}, z_{s+1} - x^{n_{s+1}} y^{m_{s+1}}, \dots, z_t - x^{n_t} y^{m_t} \rangle\right)$$

$$\bigcap \mathbf{k}[x_1, \dots, x_p, z_1, \dots, z_t],$$

with $I_{S'} \subset \mathbf{k}[x_1, \dots, x_p, w_1, \dots, w_s, x, y]$.

Proof. Denote J to the ideal

$$\langle z_1 - w_1 x^{n_1} y^{m_1}, \dots, z_s - w_s x^{n_s} y^{m_s}, z_{s+1} - x^{n_{s+1}} y^{m_{s+1}}, \dots, z_t - x^{n_t} y^{m_t} \rangle$$

Any monomials Z^{β} and Z^{δ} can be rewritten as follows. Denote f_i $\prod_{k=i}^{t} z_{i}^{\beta_{j}}, \ \hat{f}_{i} = \prod_{k=i}^{t} z_{i}^{\delta_{j}}, \ g_{i}^{j} = \prod_{k=i}^{j} (w_{k} x^{n_{k}} y^{m_{k}})^{\beta_{k}}, \ \hat{g}_{i}^{j} = \prod_{k=i}^{j} (w_{k} x^{n_{k}} y^{m_{k}})^{\delta_{k}}, \ h_{i}^{j} = \prod_{k=i}^{j} (x^{n_{k}} y^{m_{k}})^{\delta_{k}}, \ \text{and suppose } \beta_{0} = \delta_{0} = 0, \ \text{then}$

$$Z^{\beta} = z_1^{\beta_1} \cdots z_t^{\beta_t} = \sum_{i=0}^{s-1} f_{i+2} g_0^i \left(z_{i+1}^{\beta_{i+1}} - g_{i+1}^{i+1} \right) + \sum_{i=s+1}^t f_{i+1} g_1^s h_{s+1}^{i-1} \left(z_i^{\beta_i} - h_i^i \right) + g_1^s h_{s+1}^t$$

and

$$Z^{\delta} = z_1^{\delta_1} \cdots z_t^{\delta_t} = \sum_{i=0}^{s-1} \hat{f}_{i+2} \hat{g}_0^i \left(z_{i+1}^{\delta_{i+1}} - \hat{g}_{i+1}^{i+1} \right) + \sum_{i=s+1}^t \hat{f}_{i+1} \hat{g}_1^s \hat{h}_{s+1}^{i-1} \left(z_i^{\delta_i} - \hat{h}_i^i \right) + \hat{g}_1^s \hat{h}_{s+1}^t.$$

Denote $F = X^{\alpha}g_1^sh_{s+1}^t - X^{\gamma}\hat{g}_1^s\hat{h}_{s+1}^t$. Since any binomial $u^n - v^n$ is equal to $(u-v)(u^{n-1} + u^{n-2}v + \cdots + uv^{n-2} + \cdots + uv^{n-2})$ v^{n-1}), the binomials $z_i^n - (w_i x^{n_i} y^{m_i})^n$ and $z_j^n - (x^{n_j} y^{m_j})^n$ belong to J for every non-negative integer n and all $i = 1, \ldots, s$ and $j = s + 1, \ldots, t$.

Let $X^{\alpha}Z^{\beta} - X^{\gamma}Z^{\delta}$ be a binomial belonging to $I_{S'} + J$, so $F = X^{\alpha}Z^{\beta} - I_{S'}$ $X^{\gamma}Z^{\delta} + q \in I_{S'} + J$, with $q \in J$. By Lemma 2, we have $F \in I_{S'}$, hence

$$\sum_{i=1}^{p} \alpha_{i} \otimes \{b_{i}\} + \sum_{i=1}^{s} \beta_{i} \otimes \{a_{i}\} + \sum_{i=1}^{t} \left(\beta_{i} \otimes \left(n_{i} \otimes \{0, k\mathbf{a}\}\right) + \beta_{i} \otimes \left(m_{i} \otimes \{0, k\mathbf{b}\}\right)\right) =$$

$$\sum_{i=1}^{p} \gamma_{i} \otimes \{b_{i}\} + \sum_{i=1}^{s} \delta_{i} \otimes \{a_{i}\} + \sum_{i=1}^{t} \left(\delta_{i} \otimes \left(n_{i} \otimes \{0, k\mathbf{a}\}\right) + \delta_{i} \otimes \left(m_{i} \otimes \{0, k\mathbf{b}\}\right)\right).$$

Therefore,

$$\sum_{i=1}^{p} \alpha_{i} \otimes \{b_{i}\} + \sum_{i=1}^{s} \beta_{i} \otimes (\{a_{i}\} + A_{n_{i}m_{i}}) + \sum_{i=s+1}^{t} \beta_{i} A_{n_{i}m_{i}} =$$

$$\sum_{i=1}^{p} \gamma_{i} \otimes \{b_{i}\} + \sum_{i=1}^{s} \delta_{i} \otimes (\{a_{i}\} + A_{n_{i}m_{i}}) + \sum_{i=1}^{t} \delta_{i} A_{n_{i}m_{i}},$$

and $X^{\alpha}Z^{\beta} - X^{\gamma}Z^{\delta} \in I_S$.

Analogously, if $X^{\alpha}Z^{\beta} - X^{\gamma}Z^{\delta} \in I_S$, then $F \in I_{S'}$, and $X^{\alpha}Z^{\beta} - X^{\gamma}Z^{\delta} \in I_S$ $I_{S'} + J$. This completes the proof.

The above proof can also be done by using [12, Proposition 4]. In our proof, we employ the language of polynomials, ideals and Gröbner bases, avoiding congruences.

We show how this algorithm works with an example.

Example 12. Let S be the sumset semigroup generated by

$$\{\{3\}, \{4\}, \{6, 12\}, \{7, 10, 13\}, \{0, 3, 6, 9\}\}.$$

Then, from the first steps of Algorithm 1,

- $S' = \{\{3\}, \{4\}, \{6\}, \{7\}, \{0, 3\}, \{0, 6\}\},\$
- $S_1 = \{\{3\}, \{4\}, \{6\}, \{7\}\}.$

If we compute a generating set of the ideal of S_1 , then we get the following one, $G_1 = \{w_1^7 - w_2^6, w_2^2 x_2 - w_1^3, w_1^4 x_2 - w_2^4, w_1 x_2^2 - w_2^2, x_2^3 - w_1^2, w_2 x_1 - w_1 x_2, w_1^2 x_1 - w_2 x_2^2, x_1 x_2 - w_2, x_1^2 - w_1\}$. Therefore, $G' = G_1 \cup \{x(x^2 - y)\}$ and $G_2 = G' \cup \{z_1 - w_1 y, z_2 - w_2 x^2, z_3 - x^3\}$. Now, we compute a Gröbner basis of G_2 respect to the lexicographical order

where $x > y > w_i > x_i > z_k$ for all i, j, and k, and we obtain

The following example introduces an algorithm to obtain an expression for an integer set as a sum of other given integer sets, if possible. In particular, the *i*-fold sumset of a set is studied.

Example 13. We now use the above presentation of S to check whether the element $i \otimes \{7, 10, 13\}$ can be expressed in terms of the other generators of the semigroup S. We compute the Gröbner basis with respect to the order given by the matrix

$$A = \left(\begin{array}{ccccc} 0 & 0 & 0 & 1 & 0 \\ 1 & 1 & 1 & 0 & 1 \\ 1 & 0 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 & 0 \\ 0 & 0 & 1 & 0 & 0 \end{array}\right),$$

and we obtain the set

$$G_A = \left\{ x_1^4 - x_2^3, x_1^2 x_2^3 z_3^3 - z_1^3 z_3, x_2^6 z_3^3 - x_1^2 z_1^3 z_3, z_1^2 z_2 - x_1 x_2^4 z_3^2, \\ x_1 z_2 z_3 - x_2 z_1 z_3, x_2^2 z_2 z_3 - x_1^3 z_1 z_3, z_1 z_2^2 - x_2^5 z_3^2, x_1 z_2^2 - x_2 z_1 z_2, \\ x_2 z_2^2 z_3 - x_1^2 z_1^2 z_3, x_2^2 z_2^2 - x_1^3 z_1 z_2, z_3^3 - x_1^3 x_2^3 z_3^2 \right\}.$$

In Table 1, we show some elements z_2^i that when reduced with respect to the basis G_A are expressed by using only the variables x_1 , x_2 , z_1 , and z_3 , and the expression of $i \otimes \{7, 10, 13\}$ in terms of the elements of the set $\{\{3\}, \{4\}, \{6, 12\}, \{0, 3, 6, 9\}\}$.

In general, the reduction of z_2^i with respect to G_A is

$$x_1^{(2-i) \bmod 4} \, x_2^{\lfloor \frac{i+1}{4} \rfloor + 2 + \left((i-3) \bmod 4 \right)} z_1^{i-3} z_3^2.$$

Therefore, for every $i \geq 3$,

$$i \otimes \{7, 10, 13\} = ((2 - i) \bmod 4) \otimes \{3\} + \left(\left\lfloor \frac{i + 1}{4} \right\rfloor + 2 + ((i - 3) \bmod 4)\right) \otimes \{4\} + (i - 3) \otimes \{6, 12\} + 2 \otimes \{0, 3, 6, 9\}.$$

The last examples are dedicated to study the elasticity of a sumset semi-group.

Example 14. Again, consider the semigroup S given in example 12. From its ideal, we compute a generating set of its associated lattice M,

$$\begin{aligned} \big\{ \{0,0,21,-18,-2\}, \{0,1,-17,14,2\}, \{0,1,4,-4,0\}, \{0,2,-13,10,2\}, \\ &\{0,3,-9,6,2\}, \{0,4,-5,2,2\}, \{0,5,-1,-2,2\}, \{1,-1,-1,1,0\}, \\ &\{1,0,3,-3,0\}, \{1,4,-2,-1,2\}, \{2,-1,2,-2,0\}, \{2,3,-3,0,2\}, \\ &\{3,-2,1,-1,0\}, \{3,3,0,-3,2\}, \{4,-3,0,0,0\}\}, \end{aligned}$$

and its system of linear homogeneous equations,

$$Ax = \begin{pmatrix} -3 & -4 & 2 & 1 & 12 \\ -6 & -8 & 2 & 0 & 21 \end{pmatrix} x = 0.$$

We already know that S is strongly reduced, but this fact is far for being clear from the above equations. We can check it by computing with Normaliz [1] its Hilbert basis:

```
>>> c1=Cone(equations=[[-3,-4,2,1,12],[-6,-8,2,0,21]])
>>> c1.HilbertBasis()
[]
```

Since the above output is the empty list, we have $M \cap \mathbb{N}^5 = \{0\}$. The Hilbert basis of $(A \mid -A)(x,y) = 0$ has 109 elements:

Now, using the formula (1), we conclude that the elasticity of S is 3.

To know if S has acceptable elasticity, we use Algorithm 28 of [13] which is implemented in https://github.com/D-marina/CommutativeMonoids/blob/master/Sumsetssemigroups/of [6]. Running the commands,

```
>>> gb14=computationIS([3],[4],[6,12],[7,10,13],[0,3,6,9])
>>> hasAcceptableElasticity(gb14, debug=True)

Once removed the variables [x2, z1], we obtain
GroebnerBasis([x1**7*z3**2 - z2**3], x1, z2, z3, domain='ZZ',
order='lex')

we obtain that the monoid has acceptable elasticity. Moreover, from the above output, we see that the binomial $x_1^7x_3^2 - z_2^3$ belongs to I_S . Since the quotient of the addition of the exponents of these two monomials is $(7+2)/3 = 3 = \rho(S)$, the element $7 \otimes \{3\} + 2 \otimes \{0, 3, 6, 9\} = 3 \otimes \{7, 10, 13\}$ reaches the elasticity.

We see now an example of sumset semigroup without acceptable elasticity. Example 15. Let S be the semigroup

```
\langle \{0,3\}, \{0,4\}, \{7,10,11,13,14,15,17,18,19,1,22,25\} \rangle.
```

Analogously as in the preceding example, we use function ${\tt hasAcceptableElasticity}$ to check if S has acceptable elasticity. The display output of this function shows some steps of Algorithm 28 of [13] and returns ${\tt False}$, that is, the semigroup has not acceptable elasticity.
