

# Mechanism Design under Approximate Incentive Compatibility

A fundamental assumption in classical mechanism design is that buyers are perfect optimizers. However, in practice, buyers may be limited by their computational capabilities or a lack of information, and may not be able to perfectly optimize their response to a mechanism. This has motivated the introduction of approximate incentive compatibility (IC) as an appealing solution concept for practical mechanism design. While most of the literature has focused on the analysis of particular approximate IC mechanisms, this paper is the first to study the design of *optimal* mechanisms in the space of approximate IC mechanisms and to explore how much revenue can be garnered by moving from exact to approximate incentive constraints. In particular, we study the problem of a seller facing one buyer with private values and analyze optimal selling mechanisms under  $\varepsilon$ -incentive compatibility. We establish that an optimal mechanism needs to randomize as soon as  $\varepsilon > 0$  and that no mechanism can garner gains higher than order  $\varepsilon^{2/3}$ . This improves upon state-of-the-art results which imply maximum gains of  $\varepsilon^{1/2}$ . Furthermore, we construct a mechanism that is guaranteed to achieve order  $\varepsilon^{2/3}$  additional revenues, leading to a tight characterization of the revenue implications of approximate IC constraints. Our study sheds light on a novel class of optimization problems and the challenges that emerge when relaxing IC constraints. In particular, it brings forward the need to optimize not only over allocations and payments but also over best responses, and we develop a new framework to address this challenge.

## 1. Introduction

From housing allocation to online advertising, market design is having a profound impact on the design, implementation, and operations of markets. An idea fundamental to good market design is the correct assessment of participants' incentives, usually through an exact equilibrium concept. Indeed, most of the literature in mechanism design has assumed that agents make decisions by perfectly optimizing their utility functions, even when facing arbitrarily complex mechanisms. This idea has impacted how practitioners design and operationalize their market solutions, and it has led to a long line of research that has provided a good understanding of optimal mechanism design with *exact* incentive compatibility constraints. However, in real-world applications, markets are complex and participants are not always able to best respond to market conditions. Lack of information or experience, technological limitations, or even behavioral biases might prevent buyers from accurately assessing their utility from a transaction, and thus buyers might make only near-optimal decisions. Our focus in this paper is to explore the consequences of these limitations, and to understand the potential value that market designers can derive from them. In particular, the main question we tackle is:

*What is an optimal or near-optimal selling mechanism when buyers are not perfect optimizers, and what level of additional revenue performance can be gained?*

There has been significant interest in studying specific mechanisms and quantifying the extent to which they are incentive compatible or not (see Section 1.1). This line of work studies specific instances in the space of feasible mechanisms under relaxed incentive compatibility constraints. In addition, many studies have shown how to transform an approximately incentive-compatible mechanism into an exactly incentive compatible one while controlling for the loss in revenues. However, to the best of our knowledge, the study of the *optimization* of mechanisms under relaxed incentive compatibility constraints is new. As we will see, this leads to a new class of optimization problems that is fundamentally different in nature than classical mechanism design. Furthermore, we will derive new insights into the relationship between the perturbation of IC constraints and the revenue performance that can be achieved.

To make progress toward this question, we anchor our analysis around the classical Myerson setting with a single buyer. To capture that the buyer is not a perfect optimizer, we allow the incentive compatibility (IC) constraints to be satisfied up to a “small”  $\varepsilon > 0$ , i.e., the buyer is satisficing and near-optimizer, and he can select a reporting strategy that is  $\varepsilon$  away from optimal. We will refer to this constraint as  $\varepsilon$ -IC. Essentially, we study a classical mechanism design problem in which the IC constraint is slightly relaxed.

It is worth noting that the classical setting with IC constraints is an *infinite-dimensional linear program* that admits a very simple solution through a posted price (see, e.g., Riley and Zeckhauser 1983). The problem with  $\varepsilon$ -IC constraints is also an infinite-dimensional linear program, but, as we will see, it leads to a rich new class of problems. In light of the question above, we are interested in quantifying the difference between the values of the two problems as a function of  $\varepsilon$ , but also in understanding the underlying structure of near-optimal mechanisms in the  $\varepsilon$ -IC setting.

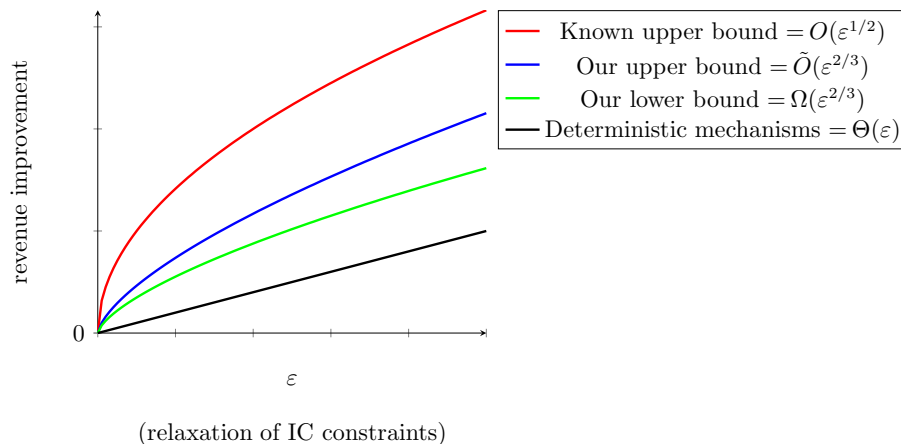
*Existing benchmarks* A naïve comparison might lead one to expect the difference between the values of these two linear programs to scale (at most) in a piecewise linear fashion (as a function of  $\varepsilon$ ) based on intuition gleaned from finite dimensional linear programs. However, in the class of mechanism design problems, we will see that the picture is more subtle and rich, since we are relaxing an *infinite number of constraints*. On another hand, an application of the powerful rounding argument of Nisan, which allows to transform an  $\varepsilon$ -IC mechanism into an IC mechanism while bounding the revenue loss (see Section 4.1), enables one to readily obtain an upper bound on the maximal additional revenues that could be garnered of order  $\varepsilon^{1/2}$ . As we will see, this argument, while very general, does not yield a tight bound for our problem.

*Contributions* Our main contribution is to initiate the study of the implications of  $\varepsilon$ -IC constraints from an optimization perspective. While most of the related literature has focused on measuring deviations from IC constraints, on studying mechanisms that are  $\varepsilon$ -IC, or on reductions from  $\varepsilon$ -IC to IC, our focus is instead on understanding the structure of *optimal*  $\varepsilon$ -IC mechanisms and their revenue guarantees.

Noting that the optimal mechanism with exact IC constraints is deterministic, we start our analysis in the space of deterministic mechanisms. In that space, we establish in Theorem 1 that the gains are of order  $\varepsilon$  and derive an optimal mechanism. While this characterizes exactly the performance of deterministic mechanisms, this leaves open the question of the performance of randomized mechanisms.

Next, we focus on the general space of randomized mechanisms. As articulated above, we first review how Nisan’s classical rounding argument enables one to readily obtain an impossibility result through upper bound on the maximal additional revenues that could be garnered, given by order  $\varepsilon^{1/2}$  (Proposition 1). Our first main result is a fundamental upper bound on the revenue gains that can be obtained when relaxing the IC constraints. In particular, we establish in Theorem 2 that no (randomized) mechanism can yield revenue gains of order more than  $\varepsilon^{2/3}$ . We achieve this through a novel duality argument that also highlights the different nature of objects that emerge in this class of problems, and the interplay between  $\varepsilon$ -IC and revenues. Our approach involves guessing a best response for the buyer and then relaxing, for each value, the IC constraints of all reports except to the one corresponding to the report made by the best response. Because these pairs of values and reports induce a path in the two-dimensional Euclidean space, we dub the resulting problem as the *path-based relaxation*. We further upper bound the path-based relaxation by considering the Lagrangian dual problem obtained for dualizing the remaining constraints. The most challenging part of our analysis involves bounding the objective value of the Lagrangian dual problem. Here, our choice of the best response ends up playing a key role.

Our second main result pertains to achievability. We establish in Theorem 3 that there exists a mechanism that leads to gains of at least order  $\varepsilon^{2/3}$ . Notably, our approach is constructive in that we exhibit a family of mechanisms that delivers such supra-linear gains. These are an appropriately constructed perturbation of the optimal mechanism when  $\varepsilon = 0$ . The construction of this family is also instructive in that it highlights the special nature of the problem at hand. In particular, the mechanism is randomized and its allocations are characterized by a set of ordinary and delayed

differential equations. Such delayed differential equations appear critical for understanding the class of  $\varepsilon$ -IC mechanism design problems.

We summarize in Figure 1 some of the results in the present paper. Notably, the upper and lower bounds provide a characterization of the performance implications of approximate incentive compatibility. The gains stemming from it are exactly of order  $\varepsilon^{2/3}$ . Furthermore, our results imply that an optimal mechanism *has to randomize*. This is true even if, for example, the underlying distribution is regular. This unveils an interesting phase transition. For  $\varepsilon = 0$  the optimal allocation is deterministic—a posted-price mechanism—but as soon as  $\varepsilon$  becomes positive, the optimal mechanism requires randomization. Our results also shed light on the geometry of the set of incentive-compatible mechanisms. Because mechanism design problems are linear programs, by Bauer’s maximum principle they attain their maximum at an extreme point of the feasible set. Interestingly, in the case of exact IC constraints, extreme points are deterministic posted-price mechanisms (Manelli and Vincent 2007). A takeaway from our results is that as soon as  $\varepsilon > 0$ , the set of extreme points becomes richer as optimal mechanisms must randomize.

From a methodological perspective, an important and novel takeaway emerges. While in classical mechanism design with exact IC constraints, the problem can be formulated as an optimization over

allocations and payments, now, as one relaxes the IC constraints to be approximately satisfied, an additional endogenous object emerges in the optimization, through the best response of the buyer (we discuss this in Section 2 after we introduce the problem formally). In the same way that the allocation pins down payments for an exactly IC mechanism, we show that the best response can be the central object that can be used to optimize over  $\varepsilon$ -IC mechanisms. For example, in our path-based relaxation, a best response fully determines an upper bound on the achievable performance. Similarly, in constructing our proposed mechanisms, our choice of the best response (together with some reasonable assumptions on the mechanism) pins down both the allocation and payments. Optimizing over best responses, and the associated methodology, might have implications beyond the exact problem studied in the present paper.

### 1.1. Literature Review

Our paper builds on the classical mechanism design literature for revenue maximization under exact IC constraints, e.g., Myerson (1979) and Myerson (1981). More specifically, the setting of selling to a single buyer relates to the work of Riley and Zeckhauser (1983). Under an exact IC constraint, Riley and Zeckhauser (1983) establish that an optimal mechanism is simply a posted price. In contrast, as soon as IC is relaxed to hold approximately, we establish that any deterministic allocation mechanism is suboptimal.

There has recently been a surge of interest in measuring IC and relaxing IC in the context of selling mechanisms. Milgrom (2011) highlights that understanding notions of approximate IC and their implications for performance is one of the four critical issues in the practice of market design. In the present paper, for a class of selling problems, we study the implications of relaxing IC constraints for both the structure of optimal mechanisms and the associated performance, while also shedding light on the rich structure of the associated optimization problems that emerge.

There are various studies that analyze mechanisms that are approximately IC in various contexts. Hartline and Lucier (2010) study a black-box reduction that turns any approximation

algorithm into a Bayesian incentive-compatible mechanism with a parallel approximation factor, while allowing the IC constraint to hold only approximately. Nazerzadeh et al. (2013) and Kanoria and Nazerzadeh (2017) consider approximately IC mechanisms in a dynamic context with learning. Balseiro et al. (2015) and Balseiro et al. (2019) focus on such an environment in the context of multi-period settings with cumulative budget constraints. Gorokh et al. (2017) also exhibits a mechanism that satisfies some form of approximate IC when converting one-shot monetary mechanisms to dynamic mechanisms with artificial currencies. While the studies above use related notions of approximate IC, they differ in their focus. In these studies, the main motivation for the introduction of approximate IC is computational and analytical tractability since, in many settings, even computing a near-optimal, exactly IC mechanism is not possible. To overcome this challenge, these papers consider tractable mechanisms that are approximately IC and whose performance is close to that of an optimal, exactly IC mechanism. By contrast, in the present study, we ask what should be an *optimal* mechanism if one optimizes over the space of approximate IC mechanisms. An interesting and novel takeaway of our work is that relaxing the IC constraint leads to supralinear gains.

The relaxation of IC has also emerged in other general market design settings. We refer the reader to Lubin and Parkes (2012) and Azevedo and Budish (2018) as well as references therein for an overview of such other applications. At a high level, these studies view approximate IC as a desirable property of a mechanism being studied.

With the emergence of black-box mechanisms in practice, another related line of research has focused on measuring the extent to which these mechanisms are IC. Examples of recent work in this area include Lahaie et al. (2018), Balcan et al. (2019), Deng and Lahaie (2019), Feng et al. (2019), Deng et al. (2020), and Colini-Baldeschi et al. (2020).

Finally, our work expands the set of techniques and ideas that have been used in the literature to analyze approximate incentive-compatible mechanisms. A central approach is the rounding argument often attributed to Noam Nisan and, to the best of our knowledge, first used by

Balcan et al. (2005) to turn any  $\varepsilon$ -IC mechanism into an exactly IC mechanism while, at the same time, limiting the revenue losses. This idea and the associated guarantees have been extended by Daskalakis and Weinberg (2012) and Rubinstein and Weinberg (2015) to multiple bidders settings using ideas developed in Hartline and Lucier (2010), Hartline et al. (2011), Bei and Huang (2011). Cai et al. (2021) have made these arguments computationally efficient. The rounding argument applied to our setting delivers an impossibility result, which, unfortunately, it is not tight for our problem.

## 2. Problem Formulation

We consider the classical setting developed in Myerson (1981) with a seller (she) selling a single item to one buyer (he). The buyer’s value for the item is drawn from a distribution  $F$  with support  $\mathcal{S}$ . The distribution  $F$  is common knowledge. The buyer’s set of messages is denoted by  $\Theta$ . The seller aims to design an indirect selling mechanism given by  $\hat{x} : \Theta \rightarrow \mathbb{R}$  and  $\hat{t} : \Theta \rightarrow \mathbb{R}$ , where  $\hat{x}$  denotes the allocation probability and  $\hat{t}$  the transfers. The buyer’s strategic response to the mechanism is a function  $\hat{\theta} : \mathcal{S} \rightarrow \Theta$ . Given a particular mechanism and response, the buyer’s utility is given by  $v \cdot \hat{x}(\hat{\theta}(v)) - \hat{t}(\hat{\theta}(v))$ . Our critical modeling assumption is that the buyer is not a perfect optimizer. We capture this by imposing that the incentive compatibility constraints are satisfied up to  $\varepsilon$ . More precisely, the buyer aims to select a reporting strategy that ensures that he collects non-negative utility from participating, and the buyer is satisficing in that he aims to collect the maximum surplus up to  $\varepsilon$ , i.e., for all  $v \in \mathcal{S}$ ,  $v \cdot \hat{x}(\hat{\theta}(v)) - \hat{t}(\hat{\theta}(v)) \geq \sup_{\hat{\theta}' \in \Theta} \{v \cdot \hat{x}(\hat{\theta}') - \hat{t}(\hat{\theta}')\} - \varepsilon$ . When there are multiple  $\varepsilon$ -optimal best responses for the buyer, we assume that the buyer chooses the one that is the most favorable to the principal. An implication of this assumption, which is pervasive in the mechanism design literature, is that the seller’s problem reduces to simultaneously choosing a mechanism together with a best response for the buyer, which together are individually rational and approximately incentive compatible. The seller aims to maximize the expected revenues from trade  $\mathbb{E}_v[\hat{t}(\hat{\theta}(v))]$  subject to the above constraints.



*Reformulation via the revelation principle.* The key change compared to a classical mechanism design problem is that the buyer is not a perfect optimizer. However, one may use classical arguments (see Myerson 1979) to reduce attention to direct revelation mechanisms. In particular, without loss of optimality, one may restrict attention to the following seller’s problem

$$\sup_{x(\cdot), t(\cdot)} \mathbf{E}_v[t(v)] \tag{\mathcal{P}_\varepsilon}$$

$$\text{s.t. } v \cdot x(v) - t(v) \geq 0, \quad \forall v \in \mathcal{S} \tag{IR}$$

$$v \cdot x(v) - t(v) \geq v \cdot x(v') - t(v') - \varepsilon, \quad \forall v \in \mathcal{S}, \quad v' \in \mathcal{S}, \tag{IC_\varepsilon}$$

$$x : \mathcal{S} \rightarrow [0, 1] \quad \text{and} \quad t : \mathcal{S} \rightarrow \mathbb{R}.$$

Problem  $(\mathcal{P}_\varepsilon)$  will be our main focus of analysis. Our goal is to shed-light on the structure of an optimal or near-optimal solution to  $(\mathcal{P}_\varepsilon)$  and provide a comprehensive characterization of the added value of  $(\text{IC}_\varepsilon)$  compared to imposing exact IC.

Note that when  $\varepsilon = 0$ ,  $(\mathcal{P}_\varepsilon)$  corresponds to the standard mechanism design problem. In the remainder of the paper we will use  $(\mathcal{P}_0)$  to refer to the latter problem. We denote by  $\mathcal{M}(\varepsilon)$  the set of feasible mechanisms for problem  $(\mathcal{P}_\varepsilon)$  and use  $m$  to denote an element of this set. For a mechanism  $m = (x, t) \in \mathcal{M}(\varepsilon)$ , we denote by  $\Pi(m)$  the corresponding revenues. Note that for any  $\varepsilon > 0$ ,  $\mathcal{M}(0) \subset \mathcal{M}(\varepsilon)$ .

In what follows we will be interested in quantifying the revenue implications associated with relaxing the set of feasible mechanisms from  $\mathcal{M}(0)$  to  $\mathcal{M}(\varepsilon)$ . Let

$$\Pi^*(\mathcal{M}(\varepsilon)) \triangleq \sup_{m \in \mathcal{M}(\varepsilon)} \Pi(m)$$

denote the optimal revenue under constraints  $\mathcal{M}(\varepsilon)$ . We are interested in quantifying the difference in revenues

$$\Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0)), \tag{1}$$

and how it changes as a function  $\varepsilon$  when the latter is small. It is worth noting that by comparing  $\Pi^*(\mathcal{M}(\varepsilon))$  to  $\Pi^*(\mathcal{M}(0))$ , we are essentially comparing the values of two infinite-dimensional linear

programs, where in one of these, the right-hand side of the incentive compatibility constraint is relaxed. As noted in the introduction, a naïve comparison, based on the intuition gleaned from finite dimensional linear programs, may lead one to expect that the difference above scales (at most) in a piecewise linear fashion. However, we will see that this not the case, as we are relaxing an infinite number of constraints.

*Assumptions and notation.* We next state an assumption and introduce some notation that will be used in the rest of the paper. Throughout, we will use  $\bar{F}(v)$  to denote  $1 - F(v)$ .

ASSUMPTION 1. *The distribution  $F$  admits a density,  $f$ , and has support in  $\mathcal{S} = [0, \bar{v}]$  with  $0 \leq \bar{v} < \infty$ . Furthermore,*

1. *The density is Lipschitz continuous with constant  $C_f > 0$ .*
2. *The density is lower bounded. That is, there exists  $\underline{f} > 0$  such that  $\underline{f} \leq f(v)$  for all  $v \in [0, \bar{v}]$ .*
3. *The revenue function,  $R(v) \triangleq v \cdot \bar{F}(v)$ , has a unique global maximizer  $p^* \in (0, \bar{v})$ .*

These assumptions are mild and are satisfied by a broad set of distributions commonly studied in the literature. We assume that the lower bound of the support is zero to simplify the analysis, but our result could be extended to distributions whose support does not include zero. Note that from the Lipschitz condition, there exists  $\bar{f} < \infty$  such that  $f(v) \leq \bar{f}$  for all  $v \in \mathcal{S}$ .

In what follows we will be interested in quantities as  $\varepsilon \downarrow 0$ . Let  $g$  and  $h$  be two functions, we write  $g(\varepsilon) = \mathcal{O}(h(\varepsilon))$  if there exists a positive constant  $C$  and  $\varepsilon_0 > 0$  such that  $g(\varepsilon) \leq C \cdot h(\varepsilon)$  for all  $\varepsilon \in (0, \varepsilon_0]$ . Additionally,  $g(\varepsilon) = \tilde{\mathcal{O}}(h(\varepsilon))$  if there exists a positive constant  $C$  and  $\varepsilon_0 > 0$  such that  $g(\varepsilon) \leq C \cdot h(\varepsilon) \cdot \log(1/\varepsilon)$  for all  $\varepsilon \in (0, \varepsilon_0]$ . We write  $g(\varepsilon) = \Omega(h(\varepsilon))$  if there exists a positive constant  $C$  and  $\varepsilon_0 > 0$  such that  $C \cdot h(\varepsilon) \leq g(\varepsilon)$  for all  $\varepsilon \in (0, \varepsilon_0]$ .

## 2.1. Initial Remarks on the Impact of Relaxing IC Constraints.

Before we proceed with our main analysis we elaborate on the challenges associated with the  $\varepsilon$ -IC mechanism design problem. The coming discussion will also allow to lay down the main distinctive features of  $(\mathcal{P}_\varepsilon)$  compared to  $(\mathcal{P}_0)$ . In particular, we will highlight how the arguments and reductions from classical mechanism design no longer apply as soon as  $\varepsilon$  becomes positive.

The classical mechanism design problem,  $(\mathcal{P}_0)$ , is amenable to a reformulation that greatly simplifies its analysis and that leads to a simple posted-price solution. Fundamentally, there are three key properties that enable this:

(P1) The allocation  $x(\cdot)$  is monotone non-decreasing. This is a consequence of  $(IC_0)$ .

(P2) By  $(IC_0)$ , truthful reporting is an optimal reporting strategy. This obviates the need to keep track of the buyer’s optimal reporting strategy.

(P3) The transfers  $t(\cdot)$  can be expressed as a linear functional of the allocation  $x(\cdot)$ . This is obtained by leveraging  $(IC_0)$  in conjunction with an application of the envelope theorem.

These three properties lead to a reduction of  $(\mathcal{P}_0)$  as

$$\max_{x(\cdot)} \left\{ \int_{\mathcal{S}} x(v)\psi(v)f(v)dv : \text{s.t. } x(\cdot) \text{ is non-decreasing} \right\}, \quad (2)$$

where we denote the *virtual value* function by  $\psi : \mathcal{S} \rightarrow \mathbb{R}$  with  $\psi(v) \triangleq v - (1 - F(v))/f(v)$  for all  $v \in \mathcal{S}$ . This reformulation was developed and solved using ironing in Myerson (1981). A more direct approach (without ironing) can be found in Riley and Zeckhauser (1983). It can be shown that the optimal allocation is a posted-price mechanism  $p^*$  that maximizes the revenue function

$$p^* \in \arg \max_{v \in \mathcal{S}} R(v). \quad (3)$$

Let us now consider the case  $\varepsilon > 0$  and consider the impact on the three properties above. First,  $(IC_0)$  implies that the allocation is a non-decreasing function, see property (P1). However, as soon as  $\varepsilon > 0$ , a feasible allocation is not necessarily a non-decreasing function. The incentive compatibility constraint  $(IC_\varepsilon)$  only implies the following “approximate” monotonicity property

$$(v - v')(x(v) - x(v')) \geq -2\varepsilon, \quad \forall v, v' \in \mathcal{S}.$$

Second,  $(IC_0)$  implies that it is optimal for the buyer to report her type, see property (P2). When  $\varepsilon > 0$ , this is no longer necessarily true. Let  $u(v) = \max_{w \in \mathcal{S}} \{vx(w) - t(w)\}$  be the optimal utility of a buyer with value  $v$ , and  $v^*(v) : \mathcal{S} \rightarrow \mathcal{S}$  be a *best reporting mapping* of the buyer defined by

$$v^*(v) \in \arg \max_{w \in \mathcal{S}} \left\{ v \cdot x(w) - t(w) \right\}. \quad (4)$$

While  $(IC_0)$  implies that  $v^*(v) = v$  is a best reporting strategy,  $(IC_\varepsilon)$  only implies

$$v \cdot x(v) - t(v) \geq u(v) - \varepsilon, \quad \forall v \in \mathcal{S}. \quad (5)$$

That is, one only knows that truthful reporting leads to a utility in the interval  $[u(v) - \varepsilon, u(v)]$ .

Consequentially, in the  $\varepsilon$ -IC setting, from an optimization perspective, the need to account for the endogenous object  $v^*(\cdot)$  is not obviated. As a matter of fact, we will see that this object plays a crucial role in both deriving impossibility results but also in optimizing over mechanisms.

Finally, another important difference that emerges relates to the transfers  $t(\cdot)$ , and the lack of a strong characterization readily available such as in property (P3). In particular, when  $\varepsilon > 0$ , according to the envelope theorem (see e.g., Milgrom and Segal (2002)) we have

$$u(v) = u(0) + \int_0^v x(v^*(s))ds, \quad \forall v \in \mathcal{S}. \quad (6)$$

By combining eq. (5) and eq. (6) we only obtain an inequality for  $t(\cdot)$  as a function of  $x(\cdot)$ ,  $u(0)$  and  $v^*(\cdot)$ , as opposed to a full characterization of  $t(\cdot)$ . That is, we have

$$t(v) \leq v \cdot x(v) - u(0) - \int_0^v x(v^*(s))ds + \varepsilon, \quad \forall v \in \mathcal{S}. \quad (7)$$

As the above illustrates, as soon as  $\varepsilon > 0$ , the seller's problem becomes one of a different nature. In particular, in the  $\varepsilon$ -IC case, one must solve jointly for the allocation and transfers by also tracking a best reporting mapping. As we shall see, the latter will play a critical role in our approach.

### 3. Performance of deterministic mechanisms

In this section we study the class of deterministic  $\varepsilon$ -IC mechanisms, i.e., the class

$$\mathcal{M}_d(\varepsilon) = \{m \in \mathcal{M}(\varepsilon) : x(\cdot) : \mathcal{S} \rightarrow \{0, 1\}\}.$$

Deterministic mechanisms are appealing in practice because the buyer can always expect the same outcome from the same report. It is important to note that when  $\varepsilon = 0$ , an optimal mechanism is deterministic and hence included in  $\mathcal{M}_d(0)$ . The next result characterizes the best performance of deterministic mechanisms.

**THEOREM 1 (Deterministic mechanisms).** *Suppose Assumption 1 holds. An optimal deterministic mechanism,  $m_a = (x_a, t_a)$ , is given by the hard/soft floor mechanism:*

$$x_a(v) = \mathbf{1}\{v \in [p, \bar{v}]\},$$

$$t_a(v) = v \mathbf{1}\{v \in [p, s]\} + s \mathbf{1}\{v \in [s, \bar{v}]\},$$

where the hard floor  $p$  and soft floor  $s$  satisfy  $s = p + \epsilon$  and are chosen to maximize revenue.

Furthermore, the optimal performance satisfies

$$\Pi^*(\mathcal{M}_a(\epsilon)) - \Pi^*(\mathcal{M}(0)) = \Theta(\epsilon).$$

The theorem establishes that over the entire class of  $\epsilon$ -IC deterministic mechanisms, the seller cannot exploit the relaxation of the IC constraints to yield more than linear gains in  $\epsilon$ . Furthermore, this bound is shown to be tight for deterministic mechanisms as one can exhibit a mechanism that yields such gains in performance.

*Discussion and proof ideas.* The proof is organized around two main steps. We first establish that an optimal deterministic mechanism must take the form of a hard/soft floor mechanism, i.e., a mechanism characterized by a pair  $(p, s)$  with  $p \leq s \leq \bar{v}$  such that the allocation and payments are as in the statement of the theorem. In this family of mechanisms, if the buyer's bid is between the hard and soft floor then he pays his own bid and is allocated the item. If the buyer's bid is above the soft floor then he pays the soft floor and is allocated the item. Otherwise the item is not allocated and the buyer does not incur any payment. Incidentally, this class of mechanisms that naturally emerges in the  $\epsilon$ -IC setting has been used by some online advertising platforms in the past to extract revenue from buyers with high values (MoPub 2013).

In the second step of the proof, we show that there exists  $r \in [0, \bar{v}]$  such that the optimal hard/soft floor mechanism is characterized by  $p = r$  and  $s = r + \epsilon$ . Note that this is an alternative way to show that when  $\epsilon = 0$  the optimal deterministic mechanism must be the optimal posted price  $p^*$ . Importantly, from this characterization one can readily obtain the upper bound in the theorem.

Indeed, using integration by parts, we obtain that the revenue of  $m_d$  with hard/soft floors as above satisfies

$$\Pi(m_d) = r \cdot \bar{F}(r) + \int_r^{r+\varepsilon} \bar{F}(v) dv \leq R(r) + \varepsilon \leq \Pi^*(\mathcal{M}(0)) + \varepsilon,$$

where the first inequality follows because  $\bar{F}(v) \leq 1$  and the second by optimizing over  $r$ . The lower bound is derived in a similar fashion except that we replace  $r$  with  $p^*$  and bound the integral above from below by  $\bar{F}(p^* + \varepsilon)$ , which is positive for small enough  $\varepsilon > 0$  because the optimal posted price is interior.

Interestingly, for hard/soft floor mechanisms, truthful reporting is not a best reporting strategy. A best reporting strategy is given by

$$v_d^*(v) = \begin{cases} 0 & \text{if } v \in [0, r); \\ r & \text{if } v \in [r, \bar{v}]. \end{cases} \quad (8)$$

See Figure 4 (b) for an illustration. For  $v \in [r, \bar{v}]$  the best reporting strategy for the buyer is always to report a lower type, namely,  $v_d^*(v) = r$  and gain a utility of  $v - r$ . Nevertheless, since the buyer is  $\varepsilon$ -optimizer he will be willing to bid  $v$  and take a loss of at most  $\varepsilon$ . The mechanism exploits this fact to obtain an extra revenue of  $\int_r^{r+\varepsilon} \bar{F}(v) dv = \mathcal{O}(\varepsilon)$  compared to the optimal posted-price mechanism.

The main departure point of  $(\mathcal{P}_\varepsilon)$  from  $(\mathcal{P}_0)$  is that in the former the reporting function is not necessarily determined by the incentive constraints and, therefore, one can perform the optimization in  $(\mathcal{P}_\varepsilon)$  by searching over the space of reporting functions. In the space of deterministic mechanisms, if we fix the allocation to  $x_d(\cdot)$  and choose as a reporting function  $v_d^*(\cdot)$  as described above, then from  $(IC_\varepsilon)$  and  $(IR)$  it is possible to infer that the transfer  $t_d(\cdot)$  must be zero below  $r$  and bounded above by  $\min\{t_d(r) + \varepsilon, v\}$  with  $t_d(r) \leq r$ . Therefore, if we optimize over the transfer, we will end up with  $t_d(\cdot)$  as in the statement of Theorem 1. In other words, in mechanism design with approximate incentive compatibility we have two degree of freedoms when designing mechanisms: allocations and reporting functions. In the following sections, we will exploit this observation to analyze the richer class of randomized mechanisms.

Theorem 1 establishes that there exists mechanisms that yield a linear improvements when relaxing the IC constraints. This sets a lower bound on the performance that can be achieved in the approximate-IC setting. An optimal approximate-IC mechanism should deliver at least linear gains compared to the optimal performance with IC constraints. Furthermore, we know that it is impossible to break the linear barrier with deterministic mechanisms. The key questions we aim to answer are whether this linear guarantee can be surpassed, and if so, how much more performance gain can be achieved and what mechanisms guarantee such improved performance. In the next section, we will expand to broader families of *randomized* mechanisms and see that significant additional revenues can be garnered.

## 4. Upper Bound

We begin our analysis of  $(\mathcal{P}_\varepsilon)$  for general mechanisms by developing an upper bound for eq. (1). As an initial benchmark, we review a known upper bound of  $\mathcal{O}(\varepsilon^{1/2})$ . This known upper bound together with the result for deterministic mechanisms provide an initial range for the optimal gains on the the revenue improvement when the buyer is not a perfect optimizer. Then, we establish our first main result: a new upper bound of a different order  $\tilde{\mathcal{O}}(\varepsilon^{2/3})$  on the revenue improvement that is based on a novel approach and techniques.

### 4.1. An Initial Upper Bound via Nisan’s Rounding Argument

We first present an upper bound that follows directly from a classical rounding argument, attributed to Noam Nisan (we are grateful to Anonymous for this reference). In mechanism design, the rounding argument has been used extensively to show that an approximate incentive-compatible mechanism can be transformed into an exact incentive-compatible mechanism (see e.g., Balcan et al. (2005)). Here, one may use it to bound the maximal revenues one could gain when solving under approximate, as opposed to exact, incentive compatibility. We provide a proof in the appendix for completeness.

PROPOSITION 1 (**Upper Bound via Rounding**).

$$\Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0)) = \mathcal{O}(\varepsilon^{1/2}).$$

The rounding argument provides a first step towards gauging the impact of imperfect optimizers on the seller’s revenue. It provides an impossibility result on the incremental revenues that can be garnered by the seller. In the present paper, we aim at understanding optimal performance, and, in turn, a natural question is whether the bound above is tight. Furthermore, we are also interested in *how* to achieve optimal or near-optimal performance. We next develop a novel path-based duality approach to obtain a new impossibility result that leads to an improved upper bound for eq. (1).

## 4.2. Upper Bound via Path-Based Duality Approach

Our second main theorem provides a new impossibility result.

**THEOREM 2 (Performance Upper Bound).** *Suppose Assumption 1 holds,  $R(v)$  is unimodal, and twice differentiable with second derivative bounded away from zero in an open ball around  $p^*$ . Then,*

$$\Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0)) = \tilde{O}(\varepsilon^{2/3}).$$

This result shows that the seller can benefit by at most  $\varepsilon^{2/3}$  up to polylogarithmic terms by offering a mechanism that is  $\varepsilon$ -incentive compatible. (We conjecture that the polylogarithmic terms are suboptimal and that it might be possible to remove them from the upper bound.) Theorem 2 is a new and sharper impossibility result for the seller’s revenue in the presence of imperfect optimizer.

**4.2.1. Main proof ideas** Our upper bound is based on an appropriate relaxation that can be analyzed through a duality argument. For our duality approach, we will relax most IC constraints except those that go through a carefully constructed path. This is one of our critical observations and it is what makes the Proof of Theorem 2 of a different nature than previous approaches for classical mechanism design problems. Indeed, constructing the path is analogous to choosing a best reporting function for the  $\varepsilon$ -IC problem. As we will see, this is an intricate task that requires going beyond approaches that consider local deviations in the incentive compatibility constraints and, instead, entails optimizing over best-response functions. Next, we explain our approach in detail.



*Path-based relaxation of IC constraints* To construct the path, let us first fix  $\mu$  and  $\nu_0$  such that  $0 < \mu < \nu_0 < \bar{v}$ . The values of  $\mu$  and  $\nu_0$  will parametrize the path. Define the function  $v^* : [\mu, \bar{v}] \rightarrow [0, \nu_0]$  such that  $v^*(v)$  is strictly increasing and continuous,  $v^*(\mu) = 0$  and  $v^*(\bar{v}) = \nu_0$ . We also assume that  $v^*(v) < v$  for all  $v$  so that the best response always under-reports. The function  $w : [0, \nu_0] \rightarrow [\mu, \bar{v}]$  is the inverse of  $v^*(\cdot)$ . We note that  $v^*(\cdot)$  is constructed to have all the properties that are desirable on a reporting function. Later, we will optimize over choices of the parameters that satisfies the aforementioned properties.

Given  $\mu$  and  $\nu_0$ , we consider the following relaxed version of  $(\mathcal{P}_\varepsilon)$  in which the IR constraint is only imposed on  $[0, \mu]$  and the  $\varepsilon$ -IC constraint is imposed on the path given by  $v^*(\cdot)$ :

$$\begin{aligned} \max_{x(\cdot), t(\cdot)} \mathbb{E}_v[t(v)] & \tag{\mathcal{P}_{\text{path}}} \\ \text{s.t. } v \cdot x(v) - t(v) & \geq 0, \quad v \in [0, \mu] & \tag{\text{IR}_\mu} \\ v \cdot x(v) - t(v) & \geq v \cdot x(v^*(v)) - t(v^*(v)) - \varepsilon, \quad \forall v \in [\mu, \bar{v}], & \tag{\text{IC}_\mu} \\ x : \Theta & \rightarrow [0, 1] \quad \text{and} \quad t : \Theta \rightarrow \mathbb{R}. \end{aligned}$$

We let  $\mathcal{M}_{\text{path}}(\varepsilon)$  denote the set of feasible mechanisms. Clearly,  $\Pi^*(\mathcal{M}(\varepsilon)) \leq \Pi^*(\mathcal{M}_{\text{path}}(\varepsilon))$ . The first set of constraints in  $(\mathcal{P}_{\text{path}})$  come from the individual rationality constraints in the original problem. However, we only consider (IR) for types with low values (below  $\mu$ ). Intuitively, individual rationality constraints are always binding for low value buyers. Meanwhile, incentive compatibility constraints are in general binding for high value buyers. This leads to the second set of constraints which come from the original approximate incentive compatibility constraints. Here we consider the pairs  $(v, v^*(v))$  for  $v \geq \mu$ . That is, for any type  $v \geq \mu$  we consider a downward misreport of size  $v - v^*(v)$ . The latter choice captures an essential property of most optimal contracts in mechanism design, namely, higher types have an incentive to report low values and so the mechanism should prevent such deviations. We note that there are many choices for an upper bound problem such as  $(\mathcal{P}_{\text{path}})$ . However, the above problem strikes a balance in the sense that it captures key properties of optimal mechanisms (we keep the constraints that are most likely to bind), and it also parametrizes these properties in a simple and, as we will shortly see, tractable way.

For each constraint  $(\text{IR}_\mu)$  and  $(\text{IC}_\mu)$ , we introduce dual variables  $\lambda^{\text{IR}} : [0, \mu] \rightarrow \mathbb{R}_+$  and  $\lambda^{\text{IC}} : [\mu, \bar{v}] \rightarrow \mathbb{R}_+$ , respectively. After dualizing these constraints and optimizing over  $(x, t)$  we obtain the following result.

LEMMA 1 (**Weak duality**). *Consider the dual problem*

$$\begin{aligned} \Pi^*(\mathcal{D}) &\triangleq \min_{\lambda^{\text{IC}} : [\mu, \bar{v}] \rightarrow \mathbb{R}_+} \Phi_1(\lambda^{\text{IC}}) + \Phi_2(\lambda^{\text{IC}}) & (\mathcal{D}) \\ \text{s.t. } &\lambda^{\text{IC}}(v) = f(v), \quad \text{a.e on } [\nu_0, \bar{v}], \\ &\lambda^{\text{IC}}(v) = f(v) + \dot{w}(v)\lambda^{\text{IC}}(w(v)), \quad \text{a.e on } [\mu, \nu_0], \end{aligned}$$

where

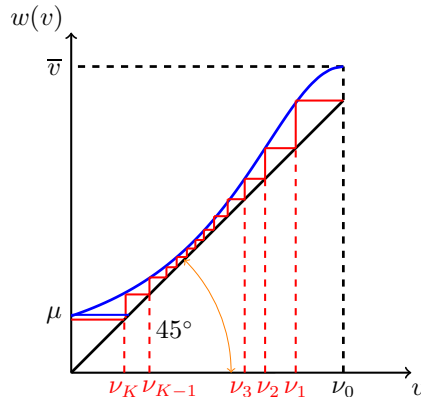
$$\Phi_1(\lambda^{\text{IC}}) = \varepsilon \int_{\mu}^{\bar{v}} \lambda^{\text{IC}}(v) dv \quad \text{and} \quad \Phi_2(\lambda^{\text{IC}}) = \int_0^{\bar{v}} \left( v f(v) - \dot{w}(v)(v - w(v)) \lambda^{\text{IC}}(w(v)) \mathbf{1}_{\{v \in [0, \nu_0]\}} \right)^+ dv.$$

Then,

$$\Pi^*(\mathcal{M}_{\text{path}}(\varepsilon)) \leq \Pi^*(\mathcal{D}).$$

The result above is obtained by first forming the Lagrangian for  $(\mathcal{P}_{\text{path}})$ . Since the transfer  $t(\cdot)$  is a free variable, all terms that multiply  $t(v)$  must equal zero for (almost) every realization of the values. This leads to a set of conditions the dual variables should satisfy which, in turn, completely pin down the dual variable of the IR constraint  $\lambda^{\text{IR}}$  and given a functional equation that determines the dual variable  $\lambda^{\text{IC}}$ . Therefore, in the dual problem we can eliminate  $\lambda^{\text{IR}}$  and state the problem in terms of  $\lambda^{\text{IC}}$  directly. Our dual problem is an infinite-dimensional mathematical program with constraints given by functional equations.

The new upper bound objective has two terms. The first,  $\Phi_1(\lambda^{\text{IC}})$ , comes from the approximate incentive constraint  $(\text{IC}_\mu)$  while the second term,  $\Phi_2(\lambda^{\text{IC}})$ , comes from optimizing  $x(v) \in [0, 1]$ . Due to the functional equation that defines  $\lambda^{\text{IC}}$ , problem  $(\mathcal{D})$  does not have a straightforward solution. Moreover, its solution depends on our choice of  $w(\cdot)$  which we have not explicitly defined yet. In order to circumvent this, we provide further bounds for the dual problem. In what follows, we develop structural properties for  $(\mathcal{D})$ . These properties will provide guidelines for how to choose  $w(\cdot)$  and will lead us to develop a tight bound for  $\Pi^*(\mathcal{D})$ .

In our relaxation  $(\mathcal{P}_{\text{path}})$ , we drop all IC constraints except for the pairs  $(v, v^*(v))_{v \in [\mu, \bar{v}]}$  or, equivalently,  $(w(v), v)_{v \in [0, \nu_0]}$ .

*Structural properties.* We need some definitions and a lemma that simplifies  $\lambda^{\text{IC}}(\cdot)$ . We define a sequence of thresholds  $\{\nu_k\}$  iteratively by

$$\nu_k = w(\nu_{k+1}), \quad k \geq 0, \quad \nu_{-1} = \bar{v}.$$

We let  $K$  be the first index such that  $\nu_K \leq \mu$  and  $\nu_{K-1} \geq \mu$ . Since  $w(\cdot)$  is strictly increasing, this sequence is well defined. Also, because  $w(x) \geq x$  we have that  $\nu_k \geq \nu_{k+1}$ . We will refer to  $K$  as the number of steps while every interval of the form  $[\nu_k, \nu_{k-1}]$  will be referred to as a step. Intuitively,  $K$  gives the number of times we need to iterate  $w(\cdot)$  to reach the origin starting from  $\nu_0$ . Geometrically, this sequence is constructed by repeatedly moving leftward and downward until we touch the best response and the  $45^\circ$  line, respectively. See Figure 2 for a graphical representation of  $\{\nu_k\}$ .

The purpose of defining the thresholds  $\{\nu_k\}$  is that they allow to look at the functional equation that defines  $\lambda^{\text{IC}}$  in  $(\mathcal{D})$  from a different perspective. In particular, we can obtain a quasi-closed form solution for  $\lambda^{\text{IC}}$  that depends on these thresholds by iteratively solving for  $\lambda^{\text{IC}}$  in each step.

**LEMMA 2 (Solution to Functional Equation).** *A solution  $\lambda^{\text{IC}}(\cdot)$  to Problem  $(\mathcal{D})$  satisfies, for any  $k \in \{0, \dots, K\}$ , for any  $v \geq \mu$*

$$\lambda^{\text{IC}}(v) = \frac{d}{dv} \sum_{j=0}^k F(w^j(v)), \quad \text{a.e on } [\nu_k, \nu_{k-1}]. \quad (9)$$

where  $w^j(x)$  is the  $j$ th composition of  $w$  and  $w^0(x) = x$ .

Armed with Lemma 2 we can derive upper bounds for  $\Phi_1(\lambda^{\text{IC}})$  and  $\Phi_2(\lambda^{\text{IC}})$  that depend solely on properties of  $w(\cdot)$ .

**LEMMA 3 (Bound on Number of Steps).** *There exists a constant  $C > 0$  such that*

$$\Phi_1(\lambda^{\text{IC}}) \leq C \cdot \varepsilon \cdot K. \quad (10)$$

Lemma 3 asserts that  $\Phi_1(\lambda^{\text{IC}})$  is bounded above by  $\varepsilon \cdot K$  where  $K$  is the number of steps. We prove the result by using our formula for  $\lambda^{\text{IC}}$  given in Lemma 2, which allows us to easily integrate the dual variable in each step, and then telescoping the resulting sums.

**LEMMA 4 (Dual Virtual Value Bound).** *Define the integrand of  $\Phi_2(\lambda^{\text{IC}})$  by*

$$\Delta(v) \triangleq vf(v) - \dot{w}(v)(w(v) - v)\lambda^{\text{IC}}(w(v))\mathbf{1}_{\{v \in [0, \nu_0]\}}. \quad (11)$$

*Suppose that  $\Delta(v)$  is non-negative in  $[x, \nu_0]$  for some  $x \in [0, \nu_0]$  then*

$$\Phi_2(\lambda^{\text{IC}}) = \int_x^{\bar{v}} \Delta(v)dv \leq R(x) + 2 \cdot (w(x) - x). \quad (12)$$

Lemma 4 is reminiscent of the analysis in classical mechanism design where it is shown that the integral of the virtual value times the density in an interval  $[x, \bar{v}]$  equals the revenue function  $R(x) = x \cdot \bar{F}(x)$ . However, in our dual problem, we do not have the standard virtual value  $\psi(v)$  in the objective but a modified “dual virtual value” given by  $\Delta(v)$ , whose integral can be bounded in terms of the revenue function and an additional correction term proportional to  $w(x) - x$ .

*Designing a best-response mapping.* We leverage the structural properties developed in Lemma 3 and Lemma 4 to build a candidate  $w(\cdot)$  that is both easy to manipulate—it allows for a closed-form approximation for  $\lambda^{\text{IC}}$ —and that yields a tight upper bound. The previous lemmas provide two guidelines for choosing  $w(\cdot)$ . First, from Lemma 3,  $w(\cdot)$  must be such that the number of steps scales, at most, with order  $1/\varepsilon^{1/3}$  to yield a revenue improvement of  $\varepsilon^{2/3}$ . This implies that, as  $\varepsilon$  goes to zero, the inverse reporting function must get closer to the 45° line, but it should approach the 45° line slow enough so that the number of steps grows slower than  $1/\varepsilon^{1/3}$ . Second, to apply

Lemma 4 we need to design the inverse reporting such that  $\Delta(v)$  crosses zero only once and that, at the point it crosses, its distance to the 45° line is of the order  $\varepsilon^{2/3}$ . The two lemmas present a trade off. We would like to set  $w(x) - x$  small but not too small otherwise  $K$  may be too large.

A first, natural approach would be to choose  $w(x) = x + \delta$  with  $\delta > 0$ , i.e., the buyer is under-reporting by an amount of  $\delta$ . This choice would converge to the truthful reporting function as  $\delta$  decreases. Because the number of steps is proportional to  $1/\delta$ , assuming that we can use the lemmas above it is possible to show that

$$\Phi_1(\lambda^{\text{IC}}) + \Phi_2(\lambda^{\text{IC}}) \leq \frac{C \cdot \varepsilon}{\delta} + \Pi^*(\mathcal{M}(0)) + 2 \cdot \delta,$$

where we have used that, for any  $x$ ,  $R(x) \leq \Pi^*(\mathcal{M}(0))$ . With this choice of  $w$  it is optimal to set  $\delta \approx \varepsilon^{1/2}$ , which yields the upper bound  $\mathcal{O}(\varepsilon^{1/2})$ . (Choosing a smaller value of  $\delta$  would necessarily lead to a too-large number of steps.) This simple choice of  $w(\cdot)$  is, unfortunately, not tight but provides an alternative proof to Proposition 1 using our duality based approach. The strength of our approach is that it provides the flexibility to design the best-response function and choose a  $w(\cdot)$  that leads to an improved bound. To do so, we need  $w(\cdot)$  to be closer to the 45° line while, at the same time, preventing the number of steps from growing too fast. The previous analysis shows this is impossible to achieve with a linear  $w(\cdot)$ . We address this challenge by making  $w(\cdot)$  piecewise linear with a kink at  $p^*$ . By carefully adjusting the slope of  $w(\cdot)$  we can guarantee that the number of steps does not grow too fast while approaching the 45° line at the right rate.

Our choice of  $w(\cdot)$  is given by

$$w(v) = \begin{cases} m \cdot (v - p^*) + p^* + \varepsilon^{2/3} & \text{if } v \leq p^*; \\ (2 - m) \cdot (v - p^*) + p^* + \varepsilon^{2/3} & \text{if } v \geq p^*, \end{cases} \quad m = \frac{\bar{v} - (p^* + \varepsilon^{2/3})}{\nu_0 - p^*}, \quad \nu_0 = \bar{v} - \varepsilon^{1/3}. \quad (13)$$

Geometrically,  $w(\cdot)$  is piecewise linear with a kink at  $p^*$ . The closest point of  $w(\cdot)$  to the 45° line is at  $p^*$  where the distance is  $\varepsilon^{2/3}$ . The slopes of  $w(\cdot)$  are  $m > 1$  and  $2 - m < 1$  to the right and left of  $p^*$ , respectively. This choice of  $w(\cdot)$  trades off tractability and tightness of our bound. Indeed, because  $w(\cdot)$  is a piecewise linear function we can obtain a simple approximation for  $\lambda^{\text{IC}}$  and,

ultimately, analyze  $\Delta(v)$  in a tractable way. In order to obtain a tight bound, we constructed  $w(\cdot)$  such that as  $\varepsilon \downarrow 0$ ,  $w(\cdot)$  approaches the  $45^\circ$  line in two ways: the slope converges to one and the distance converges to zero. By doing so, as we explain next, we can guarantee that  $w(\cdot)$  balances the number of steps  $K$  and the difference  $w(x) - x$  in Lemma 3 and Lemma 4.

For  $w(\cdot)$  defined above, we leverage Lemma 3 and Lemma 4 to obtain closed form bounds in terms of  $\varepsilon$  for the dual problem. We begin by bounding the number of steps.

**PROPOSITION 2 (Number of Steps).** *Under  $w(\cdot)$  given by eq. (13) the number of steps,  $K$ , satisfies  $K = \mathcal{O}(\log(1/\varepsilon)/\varepsilon^{1/3})$ .*

The intuition behind the proposition is simple. For ease of exposition, consider the number of steps above  $p^*$ . Since  $w(\cdot)$  is linear with slope  $m$ , it must be that  $(w(\nu_k) - w(\nu_{k+1})) / (\nu_k - \nu_{k+1}) = m$ . But by the definition of  $\nu_k$  this equivalent to  $(w(\nu_{k+1}) - \nu_{k+1}) = (w(\nu_k) - \nu_k) / m$ . That is, the distance between  $w(\cdot)$  and the  $45^\circ$  degree line decreases by a factor of  $1/m$  in every step. In general, we have that  $(w(\nu_k) - \nu_k) = (\bar{v} - \nu_0) / m^k$ . Because  $w(p^*) - p^* = \varepsilon^{2/3}$ , the number of steps above  $p^*$  is the value of  $K$  such that  $(w(\nu_K) - \nu_K) \approx \varepsilon^{2/3}$  and, therefore,

$$K \approx \frac{\log((\bar{v} - \nu_0) / \varepsilon^{2/3})}{\log(m)} = \mathcal{O}(\log(1/\varepsilon) / \varepsilon^{1/3}),$$

where the last equality comes from a Taylor series around  $\varepsilon = 0$  and from  $m - 1 \approx \varepsilon^{1/3}$ . By combining this result and Lemma 3, we deduce that  $\Phi_1(\lambda^{\text{IC}})$  is upper bounded by a term proportional to  $\log(1/\varepsilon) \cdot \varepsilon^{2/3}$ .

Next, we use Lemma 4 to bound  $\Phi_2(\lambda^{\text{IC}})$ . The key idea of our argument is to show that, given our choice of  $w(\cdot)$ , there exists a vanishing neighborhood  $(p_U^*, p_L^*)$  of size  $\varepsilon^{1/3}$  around  $p^*$  such the integrand in  $\Delta(v)$  is negative below and positive above the neighborhood. Below the neighborhood, the integral is zero because we take the positive part of  $\Delta(v)$ . Inside the neighborhood, the integral of  $\Delta(v)$  is at most  $\mathcal{O}(\varepsilon^{2/3})$  because both the integrand and the size of neighborhood are small. Above the neighborhood, we can use Lemma 4 to obtain an upper bound for  $\Phi_2(\lambda^{\text{IC}})$  which, together with the fact that  $w(v) - v \approx \varepsilon^{2/3}$  for  $v \approx p^*$ , obtains the desired upper bound of  $\mathcal{O}(\varepsilon^{2/3})$ .

For simplicity let us just consider the situation above  $p^*$ . By developing an approximation for  $\lambda^{\text{IC}}$ , we can establish that

$$\Delta_L(v) \triangleq vf(v) - \bar{F}(v) - K_1 \cdot \varepsilon^{1/3} \leq \Delta(v) \leq vf(v) - \bar{F}(v) + K_2 \cdot \varepsilon^{1/3} \triangleq \Delta_U(v),$$

almost everywhere, that is,  $\Delta(v)$  converges uniformly (almost everywhere) to the negative of the derivative of the revenue function  $-R'(v) = vf(v) - \bar{F}(v)$ . Note that we can not simply use  $\Delta_U(v)$  to bound  $\Phi_2(\lambda^{\text{IC}})$  because that would lead to a bound of  $\mathcal{O}(\varepsilon^{1/3})$ . Instead, we can use  $\Delta_L(v)$  and  $\Delta_U(v)$  to approximate where  $\Delta(v)$  crosses zero and then apply Lemma 4.

Using the lower bound above and our assumptions on the revenue function  $R(v)$ , we can determine the right endpoint of our neighborhood to be  $p_L^* \approx p^* + \varepsilon^{1/3}$  above which  $\Delta_L(v)$  is non-negative and, therefore,  $\Delta(v)$  is non-negative above  $p_L^*$ . By Lemma 4, we have

$$\int_{p_L^*}^{\bar{v}} \Delta(v) dv \leq R(p_L^*) + 2(w(p_L^*) - p_L^*). \quad (14)$$

The left endpoint of the neighborhood is similarly determined to be  $p_U^* \approx p^* - \varepsilon^{1/3}$  below which  $\Delta(v)$  can be guaranteed to be non-positive. Now, within the neighborhood we cannot control the sign of  $\Delta(v)$ ; however, we can make use of  $\Delta_U(v)$  as follows:

$$\int_{p_U^*}^{p_L^*} \Delta(v)^+ dv \leq \int_{p_U^*}^{p_L^*} \Delta_U(v) dv = R(p_U^*) - R(p_L^*) + \mathcal{O}(\varepsilon^{2/3}), \quad (15)$$

by integrating the derivative of the revenue function and using that the neighborhood has size  $\varepsilon^{1/3}$ .

We obtain Theorem 2 by combining (14) and (15):

$$\int_0^{\bar{v}} \Delta(v)^+ dv \leq R(p_U^*) + 2(w(p_L^*) - p_L^*) + \mathcal{O}(\varepsilon^{2/3}) \leq \Pi^*(\mathcal{M}(0)) + \mathcal{O}(\varepsilon^{2/3}),$$

where we have used that  $R(p_U^*) \leq \Pi^*(\mathcal{M}(0))$  and the definition of  $w(\cdot)$ .

## 5. Near Optimal Mechanisms

In the previous section, we saw that the relaxation to  $\varepsilon$ -IC mechanisms can lead to at most  $\tilde{\mathcal{O}}(\varepsilon^{2/3})$  revenue gains compared to  $(\mathcal{P}_0)$ . In this section, we establish that our upper bound is tight by developing a lower bound for the growth rate of  $\Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0))$  as a function of  $\varepsilon$ . We

also present some of the main proof ideas as they highlight new techniques and arguments that are critical for the understanding of  $\varepsilon$ -IC mechanism design problems. We present the main result of this section next.

**THEOREM 3 (Performance Lower Bound).** *Suppose assumption 1 holds. Then*

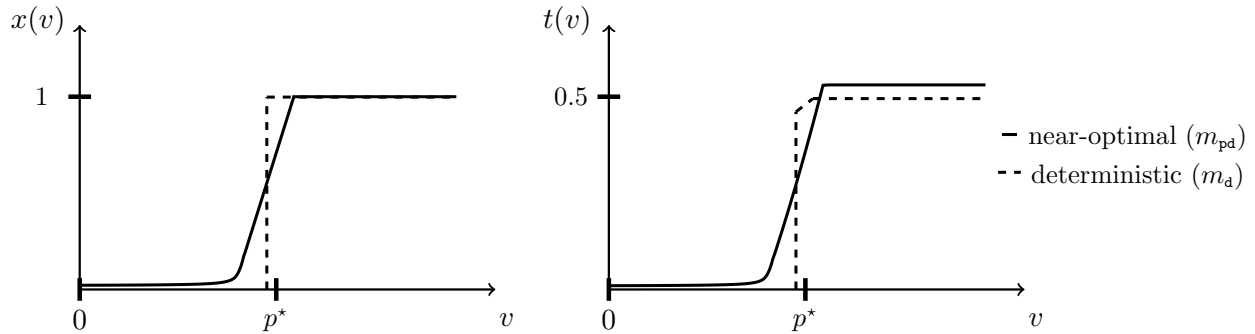
$$\Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0)) = \Omega(\varepsilon^{2/3}).$$

This result has multiple implications. First, it shows that the seller can benefit by at least  $\Omega(\varepsilon^{2/3})$  by offering a mechanism that is  $\varepsilon$ -IC as opposed to IC. That is, when we search in the entire class of  $\varepsilon$ -IC mechanisms,  $\mathcal{M}(\varepsilon)$ , quite notably, it is indeed possible to achieve *supralinear* gains compared to when we restrict attention to  $\mathcal{M}(0)$ . In conjunction with Theorem 3, we obtain there exist constants  $\underline{C}, \bar{C} > 0$  such that for all  $\varepsilon$  small enough

$$\underline{C}\varepsilon^{2/3} \leq \Pi^*(\mathcal{M}(\varepsilon)) - \Pi^*(\mathcal{M}(0)) \leq \bar{C}\varepsilon^{2/3} \log(1/\varepsilon).$$

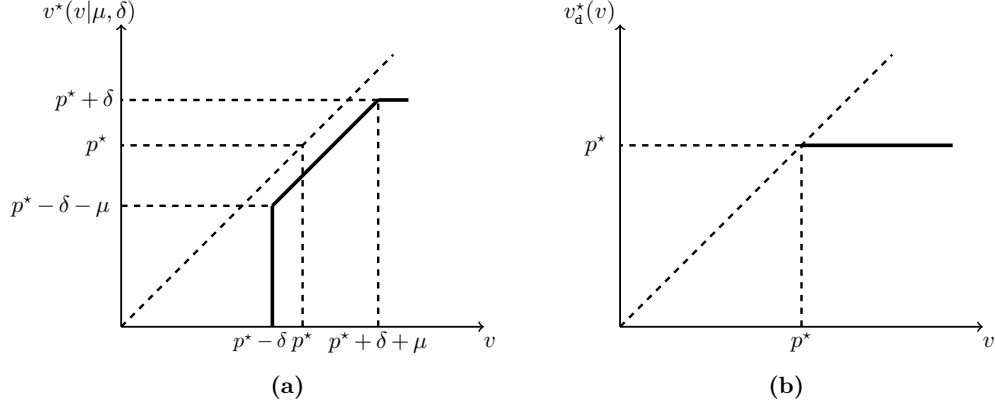
**Figure 3** Allocations and transfers of the lower bound mechanism and the optimal deterministic mechanism when  $F$  is uniform in  $[0, 1]$  and  $\varepsilon = 0.001$ . Because  $\varepsilon$  is small, the optimal posted-price mechanism when  $\varepsilon = 0$  is almost indistinguishable from  $m_d$ .

In other words, we have established that it is possible to achieve supralinear growth and characterized the types of supralinear growths that are possible. Interestingly, in contrast to classical linear programming, a linear perturbation to the infinite-dimensional linear program  $(\mathcal{P}_\varepsilon)$  leads to a *nonlinear* gain in the objective. In conjunction with Theorem 1, this result also establishes the crucial role that randomization takes in the class of  $\varepsilon$ -IC problems: *An optimal mechanism has to randomize as soon as  $\varepsilon > 0$ .* This implies that the extreme points in  $(\mathcal{P}_\varepsilon)$  and  $(\mathcal{P}_0)$  are of a very different nature. In  $(\mathcal{P}_0)$  the extreme points are posted-price mechanisms; however, Theorem 3 establishes that perturbing the IC constraints in a mechanism design problem fundamentally changes the feasible region and the set of extreme points is richer. In Figure 3, we depict a near optimal  $\varepsilon$ -IC mechanism that exhibits randomization. This highlights the subtle and deep impact of relaxing IC constraints on the nature of the optimization problem, and the significant impact it has on the performance that can be achieved (see Martin et al. 2016 and Basu et al. 2017 for other examples of properties that are true in finite dimension but fail in infinite-dimensional optimization problems).

The Proof of Theorem 3 is constructive in that we judiciously construct a feasible mechanism that yields said performance. The proof also sheds light on what are the key forces at play when optimizing over  $\mathcal{M}(\varepsilon)$ , and showcases important departures from the classical mechanism design approach. We next detail the proof and its main building blocks.

### 5.1. Proof of Theorem 3

The proof has three main components. First we propose a family of mechanisms through an endogenous characterization. This characterization critically depends on a carefully designed parametric family of best reporting mappings which indirectly induce the mechanisms. In particular, we establish that for our proposed family, the allocation is fully characterized by a system of ordinary and delayed differential equations. We then solve this system and establish that the induced mechanisms are feasible for  $(\mathcal{P}_\varepsilon)$ . Finally, we characterize the performance of these mechanisms and, by optimizing over their defining parameters, we obtain the  $\Omega(\varepsilon^{2/3})$  revenue gains.

**5.1.1. Step 1: A Proposed Family of Mechanisms** Our main challenge is to exhibit a feasible mechanism that is simple enough so that we can analyze its performance, but rich enough so that it can garner additional  $\varepsilon^{2/3}$  revenue gains. We accomplish this in two steps. First, we propose a suitable family of best reporting functions  $v^*(\cdot|\mu, \delta)$  parametrized by  $(\mu, \delta)$  (see eq. (16)). Second, we establish a consistency property of  $v^*(\cdot|\mu, \delta)$  (see Proposition 3). It coincides with the best reporting function of a family of mechanisms that we coin *perturbed delayed mechanisms* (pd).

*Best reporting function.* In Section 2, we saw that standard reductions no longer apply when  $\varepsilon > 0$ . In particular, after selecting a mechanism  $m \in \mathcal{M}(\varepsilon)$  the seller must also account for the best reporting mappings  $v^*(\cdot)$  (c.f., eq. (4)). Consequently, the optimization must be indirectly performed over the triplet  $(x, t, v^*)$ . One possible approach to come up with a feasible solution for  $(\mathcal{P}_\varepsilon)$  is to define a pair  $(x, t)$  that is both IR and  $\varepsilon$ -IC. However, such an approach is challenging given the lack of control on  $v^*(\cdot)$ . To bypass this issue, the approach we take is to define  $v^*(\cdot)$  as a natural perturbation of  $v_d^*(\cdot)$ , defined in Equation (8) and depicted in Figure 4 (b). Then we use the fact that  $v^*(v)$  must maximize  $v \cdot x(w) - t(w)$  for some  $m = (x, t) \in \mathcal{M}(\varepsilon)$  to reverse engineer the mechanism  $m$  that is consistent with  $v^*(\cdot)$ . The perturbation of the reporting function will lead to randomization in the mechanisms that induces it. We define the best reporting mappings  $v^*(\cdot|\mu, \delta)$ —a perturbation of  $v_d^*(\cdot)$ —parametrized by some positive constants  $(\mu, \delta)$  as follows

$$v^*(v|\mu, \delta) \triangleq \begin{cases} 0 & \text{if } v \in [0, p^* - \delta); \\ v - \mu & \text{if } v \in [p^* - \delta, p^* + \delta + \mu]; \\ p^* + \delta & \text{if } v \in [p^* + \delta + \mu, \bar{v}]. \end{cases} \quad (16)$$

We assume that  $\delta < p^*$  and  $p^* + \delta + \mu < \bar{v}$ , which is possible because the optimal posted price  $p^*$  is assumed to be interior.

For a graphical illustration of  $v^*(v|\mu, \delta)$  see Figure 4 (a). In what follows, when clear from context, we drop the dependence on  $(\mu, \delta)$  and use  $v^*(v)$  to denote  $v^*(v|\mu, \delta)$ . The definition of  $v^*(\cdot)$  implies

that under the associated mechanism the optimal best strategy always misreports the value in a downward fashion,  $v^*(v) \leq v$ . It equals 0 for small enough valuations (below  $p^* - \delta$ ),  $v - \mu$  for intermediate valuations (in  $[p^* - \delta, p^* + \delta + \mu]$ ) and  $p^* + \delta$  for large valuations (above  $p^* + \delta$ ).

Note that  $v^*(\cdot)$  generalizes the best reporting functions of the hard/soft floor mechanism  $(p^*, p^* + \varepsilon)$ . Indeed, for  $\delta = 0$  both functions coincide, except in  $[p^*, p^* + \mu]$  where  $v^*(\cdot)$  is linear. However, as  $\mu$  becomes smaller the functions become indistinguishable, i.e.,  $\lim_{\mu \downarrow 0} v^*(v|\mu, 0) = v_d^*(v)$ .

*Perturbed delayed mechanisms.* We first establish that it is possible to characterize the allocation and payments associated to  $v^*(\cdot)$  through a set of ordinary and delayed differential equations. Before stating the result, we let  $w(\cdot)$  denote the generalized inverse of  $v^*(\cdot)$ , which is given by

$$w(v) \triangleq \begin{cases} p^* - \delta & \text{if } v \in [0, p^* - \delta - \mu]; \\ v + \mu & \text{if } v \in [p^* - \delta - \mu, p^* + \delta]. \end{cases}$$

**PROPOSITION 3 (Perturbed delayed mechanisms).** *Let  $x_{\text{pd}} : [0, p^* + \delta] \rightarrow \mathbb{R}$  be a solution of the system*

$$\dot{x}_{\text{pd}}(v) = \frac{x_{\text{pd}}(v)}{w(v) - v}, \quad \forall v \in [0, p^* - \delta], \quad x_{\text{pd}}(0) = \frac{\varepsilon}{p^* - \delta}, \quad (\text{ODE})$$

$$\dot{x}_{\text{pd}}(v) = \frac{x_{\text{pd}}(v) - x_{\text{pd}}(v^*(v))}{w(v) - v}, \quad \forall v \in [p^* - \delta, p^* + \delta]. \quad (\text{DDE})$$

Moreover, let  $x_{\text{pd}}(v) = 1$  for all  $v \in (p^* + \delta, \bar{v}]$  and let  $t_{\text{pd}} : [0, \bar{v}] \rightarrow \mathbb{R}$  be given by

$$t_{\text{pd}}(v) = \begin{cases} v \cdot x_{\text{pd}}(v) & \text{if } v < p^* - \delta; \\ v \cdot x_{\text{pd}}(v) - \int_0^v x_{\text{pd}}(v^*(s)) ds + \varepsilon & \text{if } v \geq p^* - \delta. \end{cases}$$

If  $\lim_{v \uparrow p^* + \delta} x_{\text{pd}}(v) = 1$ , then  $v^*(\cdot)$  is a best reporting function for  $m_{\text{pd}} = (x_{\text{pd}}, t_{\text{pd}})$ .

This result provides a partial characterization of the family of mechanisms that lead to  $v^*(\cdot)$ . This is a strong characterization in that the allocation, and as a consequence the transfers, are determined by a set of ordinary (ODE) and *delayed differential equations* (DDE). That is, Proposition 3 equips us with a precise methodology to generate mechanisms. (In the next section we will show that there is a range of values  $(\mu, \delta)$  for which  $m_{\text{pd}}$  is indeed an  $\varepsilon$ -IC mechanism.) Given that  $x_{\text{pd}}$  must

be found by solving a delayed differential equation and that it depends on  $v^*(\cdot)$  (a perturbation of  $v_d^*(\cdot)$ ), we name the family of mechanisms in Proposition 3 the *perturbed delayed mechanisms*.

Another important implication of Proposition 3 is that it showcases the relationship between the allocations and transfers as a function of the best reporting function they induce via (ODE)-(DDE). This highlights that the class of  $\varepsilon$ -IC mechanisms is of a different nature compared to the class of IC mechanism.

To obtain Proposition 3 we establish necessary conditions for the the allocations and transfers that induce the postulated best reporting mapping. Under differentiability conditions, this leads to the set of ordinary and delayed differential equations for the allocation. Next we provide a heuristic derivation of the differential equations for  $x_{pd}$  and transfers. A formal proof of the proposition can be found in the appendix.

Any mechanism  $m = (x, t)$  that is compatible with  $v^*(\cdot)$  must satisfy condition (4), i.e., the best response function should maximize the buyer's utility. If we further assume that the allocations and transfers are differentiable, and impose that the first order conditions are satisfied at every  $v^*(v)$ , we deduce that  $v \cdot \dot{x}(v^*(v)) = \dot{t}(v^*(v))$  for all  $v \in [0, \bar{v}]$ . Recalling that  $w(\cdot)$  is the generalized inverse of  $v^*(\cdot)$ , we then have

$$w(v) \cdot \dot{x}(v) = \dot{t}(v), \quad \forall v \in [0, p^* + \delta], \quad (17)$$

(note that because  $v^*(v) = 0$  for  $v \leq p^* - \delta$  this equation is valid only for  $v \in [p^* - \delta + \mu, p^* + \delta]$ . By extending the equation for  $v \leq p^* - \delta + \mu$ , we are simply imposing more structure on  $(x, t)$ ). The equation above characterizes the transfers (up to a constant) in  $[0, p^* + \delta]$  as a function of  $w(\cdot)$  (or, equivalently, as a function of  $v^*(\cdot)$ ) and  $x(\cdot)$ . We would like, however, to obtain a characterization of both transfers and allocations as a function of solely  $v^*(\cdot)$ . Using the structure of the optimal deterministic mechanism and the upper bound derived in Section 4.2 as motivation, we impose two additional conditions that will enable us to accomplish this goal. First, we assume that (IR) binds for all low types  $v \in [0, p^* - \delta]$ , that is,  $v \cdot x(v) - t(v) = 0$ . By differentiating, we obtain  $x(v) + v \cdot \dot{x}(v) = \dot{t}(v)$  for all  $v \in [0, p^* - \delta]$ . Combining this with Eq. (17) yields

$$x(v) + (v - w(v)) \cdot \dot{x}(v) = 0, \quad \forall v \in [0, p^* - \delta]. \quad (18)$$

Second, we assume that  $(IC_\varepsilon)$  binds for high types  $v \in [p^* - \delta, \bar{v}]$ . When  $(IC_\varepsilon)$  holds, condition (7) holds with equality and we obtain

$$v \cdot x(v) - t(v) = u(0) + \int_0^v x(v^*(s)) ds - \varepsilon, \quad \forall v \in [p^* - \delta, \bar{v}].$$

Differentiating both sides above obtains  $x(v) + v\dot{x}(v) - \dot{t}(v) = x(v^*(v))$  for all  $v \in [p^* - \delta, \bar{v}]$ , which in conjunction with eq. (17) implies

$$x(v) + (v - w(v))\dot{x}(v) = x(v^*(v)), \quad \forall v \in [p^* - \delta, p^* + \delta]. \quad (19)$$

In summary, eq. (18) and eq. (19) together provide a characterization (up to a constant) for the allocation as a function of our choice of best reporting function  $v^*(\cdot)$ . Note that the solution to these equations only yields the allocation in  $[0, p^* + \delta]$ . However, since we are assuming that (IR) and  $(IC_\varepsilon)$  bind in  $[0, p^* - \delta]$  and  $[p^* - \delta, \bar{v}]$ , respectively, we also obtain the transfers in  $[0, p^* + \delta]$ . Finally, observe that combining (IR) and  $(IC_\varepsilon)$  at  $p^* - \delta$  implies that  $x(0) = \varepsilon / (p^* - \delta)$ . This leads to the systems of ordinary and delayed differential equations in Proposition 3.

**5.1.2. Step 2: Feasibility of proposed mechanisms** In this section, we establish that the perturbed delayed mechanism from Proposition 3 is feasible, that is,  $m_{\text{pd}} \in \mathcal{M}(\varepsilon)$ . To do so, we take two steps. We first argue that the system (ODE)-(DDE) admits a unique solution and that the solution is monotone. Then, we establish that for a range of parameters  $(\mu, \delta)$  the mechanism is feasible.

**PROPOSITION 4 (Well-posedness).** *The perturbed delayed mechanism  $m_{\text{pd}}$  from Proposition 3 is well defined, that is, the system (ODE)-(DDE) has a unique solution. In addition,  $x_{\text{pd}}$  is strictly positive, monotone non-decreasing in  $[0, p^* + \delta]$ , and admits a closed-form representation.*

We establish the proposition by analyzing the system of differential equations. Note that (ODE) can be solved by simple integration. However, (DDE) is a delayed differential equation for which standard methods of ordinary differential equations do not apply. Performing a change of variables and using the method of steps (see, e.g., Driver 2012), we can derive a closed-form solution for the allocation. We provide the closed-form solution in the proof.

Figure 3 provides an example when  $F$  is a uniform distribution. There are several interesting observations. First, note that  $x_{\text{pd}}(\cdot)$  is a non-decreasing and randomized allocation. Second, both allocations and transfers represent a perturbation of the optimal hard/soft floor mechanism  $m_{\text{pd}} = (0.5 \cdot (1 - \varepsilon), 0.5 \cdot (1 + \varepsilon))$ . Indeed, one can establish that as  $\varepsilon \downarrow 0$ ,  $m_{\text{pd}}$  becomes  $m_{\text{d}}$ . Now that we have proved that  $m_{\text{pd}}$  can be explicitly determined, we can leverage Proposition 3 to show that  $m_{\text{pd}}$  is an  $\varepsilon$ -IC mechanism.

**PROPOSITION 5 (Feasibility).** *Fix  $\varepsilon > 0$  and  $\mu > \varepsilon \cdot e$  then there exists  $\delta(\mu, \varepsilon) > 0$  such that  $\lim_{v \uparrow p^* + \delta} x_{\text{pd}}(v) = 1$ . For  $\mu$  small such that  $(p^* - \delta, p^* + \delta + \mu) \subset [0, \bar{v}]$  the perturbed delayed mechanism is feasible, i.e.,  $m_{\text{pd}} \in \mathcal{M}(\varepsilon)$ . Moreover,  $\delta(\mu, \varepsilon) = \frac{\varepsilon \mu^2}{2\varepsilon} \cdot \frac{1}{L(\delta(\mu, \varepsilon)/\mu)}$ , where  $L$  is a function such that  $L(x) \in [2e^{-1}, 2]$  for all  $x$  large. If we select  $\mu = \mu(\varepsilon)$  such that  $\lim_{\varepsilon \downarrow 0} \mu(\varepsilon)/\varepsilon = +\infty$ , then  $\lim_{\varepsilon \downarrow 0} \delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon) = +\infty$ .*

Proposition 3 provides a sufficient condition for  $v^*(\cdot)$  to be a best reporting function for  $m_{\text{pd}}$ . Under this condition one can readily verify that  $m_{\text{pd}} \in \mathcal{M}(\varepsilon)$ . To see why  $(\text{IC}_\varepsilon)$  holds, note that because  $v^*(\cdot)$  is a best reporting function we have that  $\max_w \{v \cdot x_{\text{pd}}(w) - t_{\text{pd}}(w)\} = v \cdot x_{\text{pd}}(v^*(v)) - t_{\text{pd}}(v^*(v))$ . This, together with the envelope theorem (see (6)), implies that  $(\text{IC}_\varepsilon)$  can be cast as

$$v \cdot x_{\text{pd}}(v) - t_{\text{pd}}(v) \geq \int_0^v x_{\text{pd}}(v^*(s)) ds - \varepsilon, \quad \forall v \in [0, \bar{v}].$$

If  $v \leq p^* - \delta$  then the left hand-side above is 0; while the right hand-side is  $v x_{\text{pd}}(0) - \varepsilon$  which, by the boundary condition of  $x_{\text{pd}}(\cdot)$ , is non-negative. If  $v \geq p^* - \delta$  then the inequality above is binding. That is,  $m_{\text{pd}}$  verifies  $(\text{IC}_\varepsilon)$ . The  $(\text{IR})$  constraint can be verified in a similar fashion. We note that the condition  $(p^* - \delta, p^* + \delta + \mu) \subset [0, \bar{v}]$  is needed to ensure that  $v^*(\cdot)$  is properly defined in  $[0, \bar{v}]$  and, from the characterization of  $\delta(\mu, \varepsilon)$ , it is satisfied when  $\mu$  is small. In Section 5.1.3, we show how to properly choose  $\mu$ .

Therefore, the crucial step to establish Proposition 5 is to show that the sufficient condition in Proposition 3 can be met. To do so, we show it is always possible to find  $(\mu, \delta)$  such that  $x_{\text{pd}}((p^* + \delta)^-) = 1$ . Using that  $x_{\text{pd}}(\cdot)$  is non-decreasing and that it belongs to  $[0, 1]$ , yields the desired

conclusion. We note that establishing that  $x_{\text{pd}}((p^* + \delta)^-) = 1$  requires to carefully choose  $(\mu, \delta)$  so the solution to (ODE)-(DDE) hits 1 at  $p^* + \delta$ . The proof involves an elegant application of Eulerian polynomials and complex analysis—we provide more details in the appendix.

The last part in the statement of Proposition 5 provides a detailed characterization of how the parameters  $(\mu, \delta)$  must be chosen so that  $m_{\text{pd}}$  is feasible. In the next section, we leverage this characterization to determine the revenue performance of  $m_{\text{pd}}$ .

**5.1.3. Step 3: Performance characterization** From Proposition 5, we have derived a feasible mechanism. Next, we analyze its performance. The following result derives an explicit form for the performance of a perturbed delayed mechanism.

**PROPOSITION 6 (Performance Analysis).** *Fix  $\mu, \delta > 0$  and  $\varepsilon > 0$  such that the mechanism  $m_{\text{pd}}$  is feasible. Then the revenues garnered under  $m_{\text{pd}}$  are given by*

$$\Pi(m_{\text{pd}}) = \int_0^{p^* + \delta} x_{\text{pd}}(v) \psi(v|w(\cdot)) f(v) dv + \int_{p^* + \delta}^{p^* + \delta + \mu} v f(v) dv + R(p^* + \delta + \mu),$$

where

$$\psi(v|w(\cdot)) = v - \frac{\bar{F}(v + \mu)}{f(v)} \cdot \dot{w}(v), \quad \forall v \in [0, p^* + \delta].$$

The result above provides an expression for the revenues that highlights the different forces at play. A particular term is notable in the objective above, the first integral. This integral resembles the classical objective reformulation for the (IC<sub>0</sub>) problem (see Section 2, eq. (2)). Naïvely, one may be tempted to try to optimize point-wise (as in a classical argument), but such an approach fails here as  $x_{\text{pd}}(v)$  depends on the entire profile of the best reporting strategy  $v^*(\cdot)$  and its inverse. The latter,  $w(\cdot)$ , comes into play in the term  $\psi(v|w(\cdot))$  that, due to its resemblance to the standard virtual value, we coin “*delayed virtual value*.” This further highlights the difference between the class of  $\varepsilon$ -IC problems and the standard IC ones. Even when values are regular, the presence of  $\varepsilon$ -IC demands a global optimization approach, while in the IC setting local optimization is enough to characterize an optimal mechanism.

Next, we analyze and lower bound each term in  $\Pi(m_{\text{pd}})$ . Consider the second and third terms in  $\Pi(m_{\text{pd}})$ . Because distributions are monotone, we have

$$\begin{aligned} \int_{p^*+\delta}^{p^*+\delta+\mu} v f(v) dv + R(p^* + \delta + \mu) &= \int_{p^*+\delta}^{p^*+\delta+\mu} \bar{F}(v) dv + R(p^* + \delta) \geq \bar{F}(p^* + \delta) \cdot \mu + R(p^* + \delta) \\ &\geq (\bar{F}(p^*) + \mathcal{O}(\delta)) \cdot \mu + R(p^*) - K_R \delta^2 := (A), \end{aligned}$$

where the last inequality follows from performing Taylor which shows that  $\bar{F}(p^* + \delta) = \bar{F}(p^*) + \mathcal{O}(\delta)$ . Moreover, by the mean value theorem, there exists  $\xi \in [p^*, p^* + \delta]$  such that  $R(p^* + \delta) = R(p^*) + \delta \dot{R}(\xi)$ . Also, since  $f(\cdot)$  is Lipschitz (by Assumption 1) so is  $\dot{R}(\cdot)$  and, therefore,  $|\dot{R}(p^*) - \dot{R}(\xi)| \leq K_R \delta$  for some constant  $K_R > 0$  (that depends only on the model primitives). This together with  $\dot{R}(p^*) = 0$  (by Assumption 1) yields the additional term  $-K_R \delta^2$  in (A).

If we choose  $\mu = \mu(\varepsilon) = K \cdot \varepsilon^{2/3}$  for some positive constant  $K > 0$ , we can apply Proposition 5 which implies that  $\delta(\mu(\varepsilon), \varepsilon) = \varepsilon^{1/3} e K^2 / (2L(\delta/\mu))$ . This delivers,

$$(A) \geq \Pi^*(\mathcal{M}(0)) + K \left( \bar{F}(p^*) - \frac{e^4}{16} K_R \cdot K^3 \right) \cdot \varepsilon^{2/3} + \mathcal{O}(\varepsilon),$$

where we have used that  $L(\delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon)) \geq 2e^{-1}$  when  $\delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon)$  is large (which holds because  $\mu(\varepsilon)/\varepsilon \uparrow +\infty$  as  $\varepsilon \downarrow 0$ ). In the equation above  $K$  is taken small enough so that  $\bar{F}(p^*) - \frac{e^4}{16} K_R \cdot K^3 > 0$  (which is possible because  $\bar{F}(p^*) > 0$  by Assumption 1). This argument shows that the last two terms in Proposition 6 already deliver the desired  $\varepsilon^{2/3}$  rate. We highlight that this choice of  $\mu(\varepsilon)$  as in Proposition 5 is optimal. That is,  $\Omega(\varepsilon^{2/3})$  is the best guarantee that can be achieved in the class of perturbed delayed mechanisms. We still need to show, however, that the first term in Proposition 6 does not negatively affect the order of magnitude of the performance gains. We provide a complete, and more formal, analysis of  $\Pi(m_{\text{pd}})$  in the proof of Theorem 3.

We note that for the family of perturbed delayed mechanisms—which generalizes optimal deterministic ones—allocations not only exhibit randomization, but they also randomize even the smallest type,  $x_{\text{pd}}(0) > 0$ . A sharp departure from the standard IC mechanism design literature.



*Discussion.* Interestingly, the second and third terms of  $\Pi(m_{\text{pd}})$  which, as we have seen, provide the  $\varepsilon^{2/3}$  gains in revenue, coincide with the expected revenue of a hard/soft floor mechanism with hard floor  $p^* + \delta$  and soft floor  $p^* + \delta + \mu$ . Because the revenue function  $R(\cdot)$  is smooth around its interior optimizer  $p^*$ , shifting the hard floor by an amount  $\delta$  from the optimal price  $p^*$  leads to a loss of order  $-\delta^2 \approx -\varepsilon^{2/3}$ . The seller's gains are introduced by offering a region of size  $\mu$  in which the hard/soft floor mechanism charges the bid. Note that in the deterministic case, this region can have length at most  $\varepsilon$ , because otherwise  $(\text{IC}_\varepsilon)$  would be violated. Interestingly, randomization allows one to offer a region of larger size  $\mu \approx \varepsilon^{2/3}$ . By carefully choosing the parameters, we can guarantee that the benefits of the region in which bids are paid outweigh the loss of picking a suboptimal hard floor. These terms combined lead to the  $\varepsilon^{2/3}$  revenue gains.

## 6. Conclusion

In the present paper, we have initiated the study of the *optimization* of mechanisms under  $\varepsilon$ -IC constraints. We have highlighted the rich structure underlying this class of optimization problems and characterized the gains in performance that are achievable. These are, to the best of our knowledge, the first results of this nature in the literature.

This paper opens up various avenues for future research. First, characterizing the structure of an optimal mechanism in this setting is an open question. While the results in the paper establish the need for randomization and construct mechanisms with supralinear gains, various arguments developed are fairly general and may prove useful in characterizing an optimal mechanism. Another important avenue of research pertains to studying settings with an arbitrary number of buyers and analyzing how the gains grow as a function of this number.

Another possible implication of our analysis is that the classical rounding argument discussed in Section 4.1 might not be tight for all mechanisms. This argument provides an approach to construct an exactly IC mechanism from an  $\varepsilon$ -IC mechanisms while losing an optimal revenue of  $\varepsilon^{1/2}$ . Because the revenue gains of our near-optimal  $\varepsilon$ -IC mechanism are  $\varepsilon^{2/3}$ , this suggests that the rounding argument might introduce revenue losses that are higher than necessary for some mechanisms. We

hope that the ideas developed in this paper also open the door to developing new techniques to construct exactly IC mechanisms from  $\varepsilon$ -IC ones.

Finally, while we have focused on a static setting, the present analysis also opens up possibilities for the design and optimization of dynamic mechanisms under (dynamic)  $\varepsilon$ -IC constraints. In such settings, an IC mechanism may often be intractable, however, under  $\varepsilon$ -IC constraints, many potentially “simple” mechanisms become feasible. The present analysis may suggest local perturbations to mechanisms to improve performance while maintaining  $\varepsilon$ -IC. Additionally, the present paper suggests a refined metric to assess near-optimality of mechanisms when relaxing to  $\varepsilon$ -IC constraints. The performance of an  $\varepsilon$ -IC mechanism should not be judged just by whether it approaches the performance of an optimal IC mechanism (first order optimality), but also by the order of magnitude of the gap between the performance of the  $\varepsilon$ -IC mechanism and an optimal IC mechanism (second order optimality).

## Appendix A: Proofs for Section 3

**Proof of Theorem 1** We first establish that the optimal mechanism in  $m_a \in \mathcal{M}_a(\varepsilon)$  is hard/soft mechanism. We then analyze the quantity  $\Pi(m_a) - \Pi^*(\mathcal{M}(0))$ , and prove parts *i.*) and *ii.*)

Let  $m_a = (x_a, t_a)$  be the optimal deterministic mechanism. We show that  $m_a$  is a hard/soft floor mechanism, that is,

$$\begin{aligned} x_a(v) &= \mathbf{1}\{v \in [p, \bar{v}]\}, \\ t_a(v) &= v \mathbf{1}\{v \in [p, s]\} + s \mathbf{1}\{v \in [s, \bar{v}]\}, \end{aligned}$$

for some appropriately chosen  $(p, s)$ .

Without loss of generality assume that  $x_a(\cdot)$  is right-continuous (this is possible because  $F$  is absolutely continuous). Define

$$r \triangleq \inf\{v \in [0, \bar{v}] : x_a(v) = 1\}.$$

Note that  $r < \infty$ . Indeed, if this is not true then  $x_a(\cdot) \equiv 0$  which, together with (IR), implies that  $t_a(v) \leq 0$  for all  $v \in [0, \bar{v}]$ . This gives  $\Pi(m_a) \leq 0$  which is suboptimal because the associated mechanism to the posted price  $p^*$  is feasible in  $\mathcal{M}_a(\varepsilon)$  and  $\Pi^*(\mathcal{M}(0)) > 0$ . Moreover, note that because  $x_a(\cdot)$  is right-continuous we have that  $x_a(r) = 1$ , and  $x_a(v) = 0$  for all  $v < r$ .

Next we show that

$$t_a(v) \leq \begin{cases} 0 & \text{if } v \in [0, r); \\ v \cdot x_a(v) & \text{if } v \in [r, r + \varepsilon); \\ r + \varepsilon & \text{if } v \in [r + \varepsilon, \bar{v}]. \end{cases} \quad (20)$$

For  $v < r$ , (IR) and the definition of  $r$  imply that  $t_a(v) \leq v \cdot x_a(v) = 0$ . For  $v \in [r, r + \varepsilon)$  the inequality follows from (IR). For  $v \in [r + \varepsilon, \bar{v}]$ , (IC $_\varepsilon$ ) yields

$$t_a(v) \leq t_a(r) + v \cdot (x_a(v) - x_a(r)) + \varepsilon \leq r + \varepsilon,$$

where the second inequality follows from  $t_a(r) \leq r \cdot x_a(r) = r$  and  $(x_a(v) - x_a(r)) \leq 0$ .

Since  $(x_a, t_a)$  is optimal, all the inequalities in eq. (20) must bind. Moreover, we must have  $x_a(v) = 1$  for  $v \in [r, r + \varepsilon)$ . This means that  $m_a$  is a hard/soft floor mechanism with  $p = r$  and  $s = r + \varepsilon$ . Note that this mechanism is also feasible. Indeed, the mechanism satisfies (IR) because the transfers are never larger than buyers valuations. It also satisfies (IC $_\varepsilon$ ). A best reporting function is

$$v_a^*(v) = \begin{cases} 0 & \text{if } v \in [0, r); \\ r & \text{if } v \in [r, \bar{v}]. \end{cases}$$

With this, we can see that  $u(v) = (v - r)\mathbf{1}\{v \in [r, \bar{v}]\}$ . Using the characterization in eq. (5) of  $(IC_\varepsilon)$  and the definition of  $m_d$ , it is not hard to check that  $m_d$  verifies  $(IC_\varepsilon)$ . This shows that among the deterministic mechanisms, the hard/soft floor mechanisms are optimal. In turn, the optimal solution can be found by optimizing over  $r$ .

Next we analyze the quantity  $\Pi(m_d) - \Pi^*(\mathcal{M}(0))$ . We use  $m_d(r)$  instead of  $m_d$  to highlight the dependence on  $r$ . We have

$$\Pi(m_d(r)) = \int_r^{r+\varepsilon} v f(v) dv + (r + \varepsilon) \cdot \bar{F}(r + \varepsilon) = r \cdot \bar{F}(r) + \int_r^{r+\varepsilon} \bar{F}(v) dv,$$

where in the second inequality we used integration by parts. Hence,

$$\Pi(m_d(r)) = r \cdot \bar{F}(r) + \int_r^{r+\varepsilon} \bar{F}(v) dv \leq r \cdot \bar{F}(r) + \varepsilon \leq \Pi^*(\mathcal{M}(0)) + \varepsilon,$$

where in the first inequality we used that  $\bar{F}(v) \leq 1$  and in the second we used that  $\Pi^*(\mathcal{M}(0)) = p^* \cdot \bar{F}(p^*)$ . This shows that  $\Pi(m_d) - \Pi^*(\mathcal{M}(0))$  is  $\mathcal{O}(\varepsilon)$ .

We next show a lower bound on performance. By assumption 1,  $p^* \in (0, \bar{v})$ . Hence we can always find  $\varepsilon_0 > 0$  such that for all  $\varepsilon \leq \varepsilon_0$ ,  $p^* + \varepsilon \in (0, \bar{v})$ . Now, by the mean value theorem, we have that  $\bar{F}(p^* + \varepsilon) - \bar{F}(p^*) = -f(\xi(\varepsilon)) \cdot \varepsilon$  for  $\xi(\varepsilon) \in [p^*, p^* + \varepsilon]$ . Therefore,

$$\begin{aligned} \Pi^*(\mathcal{M}_d(\varepsilon)) &\geq \Pi(m_d(p^*)) \\ &= \Pi^*(\mathcal{M}(0)) + \int_{p^*}^{p^*+\varepsilon} \bar{F}(v) dv \\ &= \Pi^*(\mathcal{M}(0)) + \bar{F}(p^* + \varepsilon) \cdot \varepsilon \\ &\geq \Pi^*(\mathcal{M}(0)) + \bar{F}(p^*) \cdot \varepsilon - \bar{f} \cdot \varepsilon^2, \end{aligned}$$

where in the last inequality we used that  $f(v) \leq \bar{f}$  for all  $v \in [0, \bar{v}]$  (Assumption 1). This completes the proof of the theorem.

## Appendix B: Proofs for Section 4

**Proof of Proposition 1** The following argument follows from a classic rounding argument attributed to Nisan. Let  $m = (x, t)$  be an  $\varepsilon$ -IC mechanism. Define an alternative mechanism  $\tilde{m}$  as follows. For  $\delta \in (0, 1)$ , we let

$$v_\delta^*(v) \in \arg \max_{w \in \mathcal{S}} \left\{ v \cdot x(w) - (1 - \delta)t(w) \right\}.$$

Then we define the mechanism  $\tilde{m} \triangleq (\tilde{x}, \tilde{t}) = (x(v_\delta^*(\cdot)), (1 - \delta)t(v_\delta^*(\cdot)))$ . Therefore,  $\tilde{m}$  is a 0-IC mechanism and for  $v' = v_\delta^*(v)$  we have that

$$\begin{aligned} v \cdot x(v) - t(v) &\geq v \cdot x(v') - t(v') - \varepsilon, \\ v \cdot x(v') - (1 - \delta)t(v') &\geq v \cdot x(v) - (1 - \delta)t(v), \end{aligned}$$

where the first inequality holds because  $(x, t)$  is  $\varepsilon$ -IC, and the second comes from the definition of  $v_\delta^*(v)$ . Combining the inequalities above we obtain

$$t(v') \geq t(v) - \frac{\varepsilon}{\delta}.$$

Now since  $\tilde{m}$  is 0-IC, we have

$$\Pi^*(\mathcal{M}(0)) \geq \Pi(\tilde{m}) = \mathbf{E}_v[\tilde{t}(v)] = (1 - \delta)\mathbf{E}_v[t(v_\delta^*(v))] \geq (1 - \delta) \left( \mathbf{E}_v[t(v)] - \frac{\varepsilon}{\delta} \right).$$

The latter can be rearranged to yields the following

$$\Pi(m) - \Pi^*(\mathcal{M}(0)) \leq \frac{\delta}{1 - \delta} \Pi^*(\mathcal{M}(0)) + \frac{\varepsilon}{\delta} \leq 2\delta \Pi^*(\mathcal{M}(0)) + \frac{\varepsilon}{\delta},$$

where in the last inequality considered  $\delta \leq 1/2$ . Choosing  $\delta = \sqrt{\varepsilon}$  delivers the result.

**Proof of Lemma 1** Given the definitions preceding the lemma, the Lagrangian is:

$$\begin{aligned} L &= \int_0^{\bar{v}} t(v) f(v) dv + \int_0^\mu \lambda^{\text{IR}}(v) (vx(v) - t(v)) dv + \int_\mu^{\bar{v}} \lambda^{\text{IC}}(v) (vx(v) - t(v) - vx(v^*(v)) + t(v^*(v)) + \varepsilon) dv \\ &= \varepsilon \int_\mu^{\bar{v}} \lambda^{\text{IC}}(v) dv + \int_0^{\bar{v}} t(v) \left( f(v) - \lambda^{\text{IR}}(v) \mathbf{1}_{\{v \in [0, \mu]\}} - \lambda^{\text{IC}}(v) \mathbf{1}_{\{v \in [\mu, \bar{v}]\}} + \lambda^{\text{IC}}(w(v)) \dot{w}(v) \mathbf{1}_{\{v \in (0, \nu_0)\}} \right) dv \\ &\quad + \int_0^{\bar{v}} x(v) \left( \lambda^{\text{IR}}(v) v \mathbf{1}_{\{v \in [0, \mu]\}} + \lambda^{\text{IC}}(v) v \mathbf{1}_{\{v \in [\mu, \bar{v}]\}} - \lambda^{\text{IC}}(w(v)) w(v) \dot{w}(v) \mathbf{1}_{\{v \in (0, \nu_0)\}} \right) dv, \end{aligned}$$

where we have used the change of variables  $u = v^*(v)$ , the fact that  $w$  is the inverse of  $v^*$ , that  $v^*$  is continuous and increasing (hence almost everywhere differentiable). Since  $t(v)$  is a free variable, we must have that

$$f(v) - \lambda^{\text{IR}}(v) \mathbf{1}_{\{v \in [0, \mu]\}} - \lambda^{\text{IC}}(v) \mathbf{1}_{\{v \in [\mu, \bar{v}]\}} + \lambda^{\text{IC}}(w(v)) \dot{w}(v) \mathbf{1}_{\{v \in (0, \nu_0)\}} = 0, \quad \text{a.e on } [0, \bar{v}].$$

From this, we can deduce the following

$$\begin{aligned} \lambda^{\text{IC}}(v) &= f(v), \quad \text{a.e on } [\nu_0, \bar{v}] \\ \lambda^{\text{IC}}(v) &= f(v) + \dot{w}(v) \lambda^{\text{IC}}(w(v)), \quad \text{a.e on } [\mu, \nu_0] \\ \lambda^{\text{IR}}(v) &= f(v) + \dot{w}(v) \lambda^{\text{IC}}(w(v)), \quad \text{a.e on } [0, \mu] \end{aligned}$$

Note that since  $w$  is increasing then it is differentiable with positive derivative almost everywhere. As a consequence,  $\lambda^{\text{IC}}$  and  $\lambda^{\text{IR}}$  are non-negative and are well defined almost everywhere in their domains.

Going back to the Lagrangian, we find that

$$L = \varepsilon \int_\mu^{\bar{v}} \lambda^{\text{IC}}(v) dv + \int_0^{\bar{v}} (vf(v) - \dot{w}(v)(w(v) - v) \lambda^{\text{IC}}(w(v)) \mathbf{1}_{\{v \in [0, \nu_0]\}})^+ dv.$$

Since we have relaxed the constraints outside the path  $(v, v^*(v))$ , only considered the IR constraints for  $v \leq \mu$ , and the dual variables are non-negative, the above provides an upper bound for the primal problem. This concludes the proof.

**Proof of Lemma 2** It is easy to see that this is true for  $k = 0$ . Consider  $v \in [\nu_k, \nu_{k-1}]$  for some arbitrary  $k \geq 1$ , in this case,  $w(v) \in [\nu_{k-1}, \nu_{k-2}]$ . Hence, by induction, we have (a.e)

$$\begin{aligned}
\lambda(v) &= f(v) + \lambda(w(v))\dot{w}(v) \\
&= f(v) + \frac{d}{dx} \sum_{j=0}^{k-1} F(w^j(x)) \Big|_{x=w(v)} \\
&= f(v) + \sum_{j=0}^{k-1} f(w^j(w(v))) (\dot{w}^j)(w(v)) \dot{w}(v) \\
&= f(v) + \frac{d}{dv} \sum_{j=0}^{k-1} F(w^{j+1}(v)) \\
&= \frac{d}{dv} \sum_{j=0}^k F(w^j(v)).
\end{aligned}$$

### Proof of Lemma 3

$$\begin{aligned}
\int_{\mu}^{\bar{v}} \lambda(v) dv &= \int_{\mu}^{\nu_0} \lambda(v) dv + \int_{\nu_0}^{\bar{v}} \lambda(v) dv \\
&= \int_{\mu}^{\nu_0} \lambda(v) dv + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} \int_{\nu_k}^{\nu_{k-1}} \lambda(v) dv + \int_{\mu}^{\nu_{K-1}} \lambda(v) dv + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} \int_{\nu_k}^{\nu_{k-1}} \left( \frac{d}{dv} \sum_{j=0}^k F(w^j(v)) \right) dv + \int_{\mu}^{\nu_{K-1}} \left( \frac{d}{dv} \sum_{j=0}^K F(w^j(v)) \right) dv + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} \left( \sum_{j=0}^k F(w^j(v)) \Big|_{\nu_k}^{\nu_{k-1}} \right) + \left( \sum_{j=0}^K F(w^j(v)) \Big|_{\mu}^{\nu_{K-1}} \right) + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} \left( \sum_{j=0}^k F(w^j(\nu_{k-1})) - F(w^j(\nu_k)) \right) + \left( \sum_{j=0}^K F(w^j(\nu_{K-1})) - F(w^j(\mu)) \right) + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} \left( \sum_{j=0}^k (F(\nu_{k-j-1}) - F(\nu_{k-j})) \right) + \left( \sum_{j=0}^K (F(\nu_{K-1-j}) - F(w^j(\mu))) \right) + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&\leq \sum_{k=1}^{K-1} (1 - F(\nu_k)) + \left( \sum_{j=0}^K (F(\nu_{K-1-j}) - F(\nu_{K-j})) \right) + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&= \sum_{k=1}^{K-1} (1 - F(\nu_k)) + (1 - F(\nu_K)) + \int_{\nu_0}^{\bar{v}} f(v) dv \\
&\leq K + 1,
\end{aligned}$$

where in the above we used the property that  $w^j(\nu_k) = \nu_{k-j}$  and Lemma 2. In the first inequality, we used that  $w^j(\mu) \geq \nu_{K-j}$  which is true because  $\mu \geq \nu_K$ . In the last inequality, we used that  $\int_{\nu_0}^{\bar{v}} f(v) dv \leq 1$ . This concludes the proof.

**Proof of Lemma 4** We separate the computation of the integral  $\int_x^{\bar{v}} \Delta(v)dv$  into three pieces. We do the computation for each piece for an arbitrary interval,  $[a, b]$ , first. We then combine all the pieces and intervals.

We will make the following definitions. Since  $\lambda(v)$  is defined differently in different interval of the form  $[\nu_k, \nu_{k-1}]$  (see Lemma 2), we will consider first  $[a, b] \subset [\nu_k, \nu_{k-1}]$  for some  $k \geq 1$ . We also define

$$H_k(v) \triangleq \sum_{j=0}^k F(w^j(v)), \quad \text{for } v \in [\nu_k, \nu_{k-1}]. \quad (21)$$

Note that from Lemma 2 for  $v \in [\nu_k, \nu_{k-1}]$ , we have that  $\lambda(v) = \dot{H}_k(v)$  a.e.

First piece.

$$A_1 = \int_a^b v f(v)dv = vF(v) \Big|_a^b - \int_a^b F(v)dv. \quad (22)$$

Second piece.

$$\begin{aligned} A_2 &= \int_a^b w(v)\dot{w}(v)\lambda(w(v))dv \\ &= \int_{w(a)}^{w(b)} v\lambda(v)dv \\ &= \int_{w(a)}^{w(b)} v\dot{H}_{k-1}(v)dv \\ &= vH_{k-1}(v) \Big|_{w(a)}^{w(b)} - \int_{w(a)}^{w(b)} H_{k-1}(v)dv \\ &= w(b)H_{k-1}(w(b)) - w(a)H_{k-1}(w(a)) - \int_{w(a)}^{w(b)} H_{k-1}(v)dv, \end{aligned}$$

where in the second equality we used the change of variables  $u = w(v)$ . In the third equality, we used that because  $[a, b] \subset [\nu_k, \nu_{k-1}]$  we must have  $[w(a), w(b)] \subset [\nu_{k-1}, \nu_{k-2}]$  and, therefore,  $\lambda(v) = \dot{H}_{k-1}(v)$  a.e.

Third piece.

$$\begin{aligned} A_3 &= \int_a^b v\dot{w}(v)\lambda(w(v))dv \\ &= \int_a^b v\dot{w}(v)\dot{H}_{k-1}(w(v))dv \\ &= vH_{k-1}(w(v)) \Big|_a^b - \int_a^b H_{k-1}(w(v))dv \\ &= bH_{k-1}(w(b)) - aH_{k-1}(w(a)) - \int_a^b H_{k-1}(w(v))dv \end{aligned}$$

Using the expressions above we can compute the integrals in  $[x, \nu_0]$ . We will need the following properties

$$H_k(\nu_{k-1}) = \sum_{j=0}^k F(w^j(\nu_{k-1})) = \sum_{j=0}^k F(\nu_{k-1-j}) = \sum_{j=0}^k F(\nu_{j-1}), \quad (23)$$

and

$$H_k(\nu_k) = \sum_{j=0}^k F(w^j(\nu_k)) = \sum_{j=0}^k F(\nu_{k-j}) = \sum_{j=0}^{k+1} F(\nu_{j-1}) - 1, \quad (24)$$

and

$$H_k(w(v)) = \sum_{j=0}^k F(w^j(w(v))) = \sum_{j=0}^k F(w^{j+1}(v)) = \sum_{j=1}^{k+1} F(w^j(v)) = H_{k+1}(v) - F(v) \quad (25)$$

Next we exploit the properties above to compute the three integrals in  $[x, \nu_0]$ . Let  $k$  be such that  $\nu_k \leq x \leq \nu_{k-1}$ . For the second piece we have

$$\begin{aligned} \int_x^{\nu_0} w(v)\dot{w}(v)\lambda(w(v))dv &= \sum_{j=1}^{k-1} \int_{\nu_j}^{\nu_{j-1}} w(v)\dot{w}(v)\lambda(w(v))dv + \int_x^{\nu_{k-1}} w(v)\dot{w}(v)\lambda(w(v))dv \\ &= \sum_{j=1}^{k-1} w(\nu_{j-1})H_{j-1}(w(\nu_{j-1})) - w(\nu_j)H_{j-1}(w(\nu_j)) - \int_{w(\nu_j)}^{w(\nu_{j-1})} H_{j-1}(v)dv \\ &\quad + w(\nu_{k-1})H_{k-1}(w(\nu_{k-1})) - w(x)H_{k-1}(w(x)) - \int_{w(x)}^{w(\nu_{k-1})} H_{k-1}(v)dv \\ &= \sum_{j=1}^{k-1} \nu_{j-2}H_{j-1}(\nu_{j-2}) - \nu_{j-1}H_{j-1}(\nu_{j-1}) - \int_{\nu_{j-1}}^{\nu_{j-2}} H_{j-1}(v)dv \\ &\quad + \nu_{k-2}H_{k-1}(\nu_{k-2}) - w(x)H_{k-1}(w(x)) - \int_{w(x)}^{\nu_{k-2}} H_{k-1}(v)dv \end{aligned}$$

For the third piece we have

$$\begin{aligned} \int_x^{\nu_0} v\dot{w}(v)\lambda(w(v))dv &= \sum_{j=1}^{k-1} \int_{\nu_j}^{\nu_{j-1}} v\dot{w}(v)\lambda(w(v))dv + \int_x^{\nu_{k-1}} v\dot{w}(v)\lambda(w(v))dv \\ &= \sum_{j=1}^{k-1} \nu_{j-1}H_{j-1}(\nu_{j-2}) - \nu_jH_{j-1}(\nu_{j-1}) - \int_{\nu_j}^{\nu_{j-1}} H_{j-1}(w(v))dv \\ &\quad + \nu_{k-1}H_{k-1}(\nu_{k-2}) - xH_{k-1}(w(x)) - \int_x^{\nu_{k-1}} H_{k-1}(w(v))dv \end{aligned}$$

Combining the second and third pieces and using properties (23), (24) and (25) yields

$$\begin{aligned} \int_x^{\nu_0} (w(v) - v)\dot{w}(v)\lambda(w(v))dv &= \sum_{j=1}^{k-1} (\nu_{j-2} - \nu_{j-1})H_{j-1}(\nu_{j-2}) - (\nu_{j-1} - \nu_j)H_{j-1}(\nu_{j-1}) \\ &\quad - \left( \int_{\nu_{j-1}}^{\nu_{j-2}} H_{j-1}(v)dv - \int_{\nu_j}^{\nu_{j-1}} H_{j-1}(w(v))dv \right) \\ &\quad + (\nu_{k-2} - \nu_{k-1})H_{k-1}(\nu_{k-2}) - (w(x) - x)H_{k-1}(w(x)) \\ &\quad - \left( \int_{w(x)}^{\nu_{k-2}} H_{k-1}(v)dv - \int_x^{\nu_{k-1}} H_{k-1}(w(v))dv \right) \\ &= \sum_{j=1}^{k-1} (\nu_{j-2} - \nu_{j-1}) \sum_{i=0}^{j-1} F(\nu_{i-1}) - (\nu_{j-1} - \nu_j) \left( \sum_{i=0}^j F(\nu_{i-1}) - 1 \right) \end{aligned}$$



$$\begin{aligned}
 & - \left( \int_{\nu_{j-1}}^{\nu_{j-2}} H_{j-1}(v)dv - \int_{\nu_j}^{\nu_{j-1}} (H_j(v) - F(v)) dv \right) \\
 & + (\nu_{k-2} - \nu_{k-1})H_{k-1}(\nu_{k-2}) - (w(x) - x)H_{k-1}(w(x)) \\
 & - \left( \int_{w(x)}^{\nu_{k-2}} H_{k-1}(v)dv - \int_x^{\nu_{k-1}} (H_k(v) - F(v)) dv \right).
 \end{aligned}$$

Note that

$$\begin{aligned}
 \sum_{j=1}^{k-1} (\nu_{j-2} - \nu_{j-1}) \sum_{i=0}^{j-1} F(\nu_{i-1}) - (\nu_{j-1} - \nu_j) \left( \sum_{i=0}^j F(\nu_{i-1}) - 1 \right) &= -(\nu_{k-1} - \nu_0) + (\bar{v} - \nu_0) \\
 & - (\nu_{k-2} - \nu_{k-1}) \sum_{i=0}^{k-1} F(\nu_{i-1}) \\
 & = (\bar{v} - \nu_{k-1}) - (\nu_{k-2} - \nu_{k-1}) H_{k-1}(\nu_{k-2}).
 \end{aligned}$$

We also have that

$$\begin{aligned}
 \sum_{j=1}^{k-1} \left( \int_{\nu_{j-1}}^{\nu_{j-2}} H_{j-1}(v)dv - \int_{\nu_j}^{\nu_{j-1}} (H_j(v) - F(v)) dv \right) &= \int_{\nu_0}^{\bar{v}} H_0(v)dv - \int_{\nu_{k-1}}^{\nu_{k-2}} H_{k-1}(v)dv + \int_{\nu_{k-1}}^{\nu_0} F(v)dv \\
 &= \int_{\nu_{k-1}}^{\bar{v}} F(v)dv - \int_{\nu_{k-1}}^{\nu_{k-2}} H_{k-1}(v)dv.
 \end{aligned}$$

In turn, we have that

$$\begin{aligned}
 \int_x^{\nu_0} (w(v) - v)\dot{w}(v)\lambda(w(v))dv &= (\bar{v} - \nu_{k-1}) - (\nu_{k-2} - \nu_{k-1}) H_{k-1}(\nu_{k-2}) - \int_{\nu_{k-1}}^{\bar{v}} F(v)dv + \int_{\nu_{k-1}}^{\nu_{k-2}} H_{k-1}(v)dv \\
 &+ (\nu_{k-2} - \nu_{k-1})H_{k-1}(\nu_{k-2}) - (w(x) - x)H_{k-1}(w(x)) \\
 &- \left( \int_{w(x)}^{\nu_{k-2}} H_{k-1}(v)dv - \int_x^{\nu_{k-1}} (H_k(v) - F(v)) dv \right) \\
 &= (\bar{v} - \nu_{k-1}) - \int_x^{\bar{v}} F(v)dv + \int_x^{w(x)} H_{k-1}(v)dv - (w(x) - x)H_{k-1}(w(x)) \\
 &+ \int_x^{\nu_{k-1}} H_k(v)dv.
 \end{aligned}$$

Therefore,

$$\begin{aligned}
 \int_x^{\nu_0} \Delta(v)dv + \int_{\nu_0}^{\bar{v}} v f(v)dv &= \nu_{k-1} - xF(x) - \int_x^{w(x)} H_{k-1}(v)dv + (w(x) - x)H_{k-1}(w(x)) - \int_x^{\nu_{k-1}} H_k(v)dv \\
 &= (\nu_{k-1} - x) + x\bar{F}(x) - \int_x^{w(x)} H_{k-1}(v)dv + (w(x) - x)H_{k-1}(w(x)) \\
 &- \int_x^{\nu_{k-1}} H_k(v)dv.
 \end{aligned}$$

Now, we have that  $H_{k-1}(w(x)) = H_k(x) - F(x) = H_{k-1}(x) + F(w^k(x)) - F(x)$ . Therefore,

$$\begin{aligned}
 (w(x) - x)H_{k-1}(w(x)) &= (w(x) - x)H_{k-1}(x) + (w(x) - x)(F(w^k(x)) - F(x)) \\
 &\leq \int_x^{w(x)} H_{k-1}(v)dv + (w(x) - x)(F(w^k(x)) - F(x)),
 \end{aligned}$$

where the inequality follows from  $H_{k-1}(v)$  being non-decreasing (composition of non-decreasing functions). So finally, we deduce

$$\begin{aligned} \int_x^{\nu_0} \Delta(v)dv + \int_{\nu_0}^{\bar{v}} vf(v)dv &\leq (\nu_{k-1} - x) + x\bar{F}(x) + (w(x) - x)(F(w^k(x)) - F(x)) \\ &\leq (w(x) - x) + x\bar{F}(x) + (w(x) - x) \\ &= x\bar{F}(x) + 2(w(x) - x), \end{aligned}$$

where in the second inequality we used that  $\nu_{k-1} \leq w(x)$  and that  $(F(w^k(x)) - F(x)) \leq 1$ .

**Proof of Proposition 2** First, let us consider counting the number of steps in  $[p^*, \nu_0]$ . Consider an arbitrary value  $v \geq p^*$  such that  $v \in [\nu_k, \nu_{k-1}]$ . We will determine bounds for  $k$ . Note that  $\nu_k \leq v$  if and only if

$$\nu_k = p^* - \left(\frac{1}{m^k} - \frac{1}{m}\right) \frac{m}{1-m} \varepsilon^{2/3} + \frac{\nu_0 - (p^* + \varepsilon^{2/3})}{m^k} \leq v, \quad (26)$$

where the expression for  $\nu_k$  above can be derived by iteratively computing  $\nu_1 = v^*(\nu_0)$ ,  $\nu_2 = v^*(\nu_1)$ , and finally  $\nu_k = v^*(\nu_{k-1})$ . We can rearrange the above to obtain

$$m^k \geq \frac{\nu_0 - p^* + \frac{\varepsilon^{2/3}}{m-1}}{v - p^* + \frac{\varepsilon^{2/3}}{m-1}}. \quad (27)$$

Similarly, using that  $\nu_{k-1} \geq v$  we deduce that

$$m^k \leq m \frac{\nu_0 - p^* + \frac{\varepsilon^{2/3}}{m-1}}{v - p^* + \frac{\varepsilon^{2/3}}{m-1}}. \quad (28)$$

When  $v = p^*$ , the above expressions simplify and we obtain

$$\frac{1}{\varepsilon^{1/3}} \leq m^k \leq \frac{m}{\varepsilon^{1/3}}. \quad (29)$$

Hence,

$$\frac{\log\left(\frac{1}{\varepsilon^{1/3}}\right)}{\log(m)} \leq k \leq \frac{\log\left(\frac{m}{\varepsilon^{1/3}}\right)}{\log(m)}. \quad (30)$$

This implies that the number of steps in  $[p^*, \nu_0]$  satisfies

$$K_1 = O(\log(1/\varepsilon)/\log(m)) = O(\log(1/\varepsilon)/\varepsilon^{1/3}), \quad (31)$$

where in the last equality we use that  $\log(m) = \log(m-1+1) = \Theta(\varepsilon^{1/3})$ , which can be derived from a Taylor series and using the definition of  $m$  in eq. (13).

Now we consider counting the number of steps in  $[0, p^*]$ . Let  $k^*$  be such that  $p^* \in [\nu_{k^*}, \nu_{k^*-1}]$ . Note that  $w(\nu_{k^*+j}) = \nu_{k^*+j-1}$  for all  $j \geq 0$ . Hence,

$$\nu_{k^*+j} = p^* + \frac{\nu_{k^*+j-1} - (p^* + \varepsilon^{2/3})}{(2-m)}, \quad j \geq 0. \quad (32)$$

And we have

$$\nu_{k^*+j} = p^* + \frac{\varepsilon^{2/3}}{m-1} - \frac{1}{(2-m)^{j+1}} \left( \frac{\varepsilon^{2/3}}{m-1} + p^* - \nu_{k^*-1} \right), \quad j \geq 0. \quad (33)$$

Let  $v \leq p^*$  be such that  $v \in [\nu_{k^*+j}, \nu_{k^*+j-1}]$  for some  $j \geq 0$ . Then, the following must hold

$$\nu_{k^*+j} \leq v \Leftrightarrow (2-m)^{j+1} \leq \frac{p^* + \frac{\varepsilon^{2/3}}{m-1} - \nu_{k^*-1}}{p^* + \frac{\varepsilon^{2/3}}{m-1} - v}, \quad (34)$$

and

$$\nu_{k^*+j-1} \geq v \Leftrightarrow (2-m)^j \geq \frac{p^* + \frac{\varepsilon^{2/3}}{m-1} - \nu_{k^*-1}}{p^* + \frac{\varepsilon^{2/3}}{m-1} - v}. \quad (35)$$

Note that  $\nu_{k^*-1} = w(\nu_{k^*}) \leq w(p^*) = p^* + \varepsilon^{2/3} \leq p^* + \frac{\varepsilon^{2/3}}{m-1}$  and, therefore, the numerator in the expressions above is non-negative.

To obtain the number of steps, we set  $v = \mu = w(0)$  and bound the corresponding  $j$  from above.

We have that

$$(2-m)^j \geq \frac{p^* + \frac{\varepsilon^{2/3}}{m-1} - \nu_{k^*-1}}{p^* + \frac{\varepsilon^{2/3}}{m-1} - w(0)} \Leftrightarrow j \leq \frac{\log \left( \frac{p^* + \frac{\varepsilon^{2/3}}{m-1} - \nu_{k^*-1}}{(2-m)(p^* + \frac{\varepsilon^{2/3}}{m-1})} \right)}{\log(2-m)} \quad (36)$$

Hence,

$$\begin{aligned} j &\leq \frac{\log \left( \frac{p^* + \frac{\varepsilon^{2/3}}{m-1} - \nu_{k^*-1}}{(2-m)(p^* + \frac{\varepsilon^{2/3}}{m-1})} \right)}{\log(2-m)} \\ &\leq \frac{\log \left( \frac{\frac{\varepsilon^{2/3}}{m-1}}{(2-m)(p^* + \frac{\varepsilon^{2/3}}{m-1})} \right)}{\log(2-m)} \\ &\leq \frac{\log \left( \frac{\varepsilon^{2/3}}{(m-1)(2-m)p^*} \right)}{\log(2-m)} \\ &= O \left( \frac{\log(1/\varepsilon)}{\varepsilon^{1/3}} \right), \end{aligned}$$

where in the second inequality we used that  $\nu_{k^*-1} \geq p^*$ . In the last equality we performed a Taylor expansion for the term  $\varepsilon^{2/3}/((m-1)(2-m))$  which gives

$$\frac{\varepsilon^{2/3}}{(m-1)(2-m)} = (\bar{v} - p^*)\varepsilon^{1/3} + \mathcal{O}(\varepsilon^{2/3}),$$

and for the term  $\log(2-m)$  which gives

$$\log(2-m) = -\frac{\varepsilon^{1/3}}{\bar{v} - p} + \mathcal{O}(\varepsilon^{2/3}).$$

This concludes the proof.

**Proof of Theorem 2** We show that

$$\Pi^*(\mathcal{D}) \leq \Pi^*(\mathcal{M}(0)) + \tilde{\mathcal{O}}(\varepsilon^{2/3}). \quad (37)$$

By combining Lemma 3 and Proposition 2, we can deduce that  $\Pi^*(\mathcal{D}) - \Phi_2(\lambda^{\text{IC}}) = \tilde{\mathcal{O}}(\varepsilon^{2/3})$ . It remains to provide an upper bound for  $\Phi_2(\lambda^{\text{IC}})$ .

We separate the proof into two cases:  $v \geq p^*$  and  $v \leq p^*$ . In both cases we provide bounds for  $\lambda^{\text{IC}}(w(v))$  which we then use to further bound  $\Phi_2(\lambda^{\text{IC}})$ . For  $v \geq p^*$ , we will provide an upper and a lower bound for  $\lambda^{\text{IC}}(w(v))$ . For  $v < p^*$ , we will provide an upper bound for  $\lambda^{\text{IC}}(w(v))$ . These bounds will be tight and will enables us to use Lemma 4 to bound  $\Phi_2(\lambda^{\text{IC}})$ .

Case 1: We consider the case  $v \geq p^*$ . From Lemma 2 and our choice of  $w(\cdot)$ , we have

$$\lambda(w(v)) = \sum_{i=1}^k m^{i-1} f(w^i(v)), \quad \text{a.e in } [\nu_k, \nu_{k-1}] \cap [p^*, \bar{v}]. \quad (38)$$

First, note that the following holds for  $v \in [\nu_k, \nu_{k-1}] \cap [p^*, \bar{v}]$

$$\sum_{i=1}^k m^{i-1} f(w^i(v)) = m^{k-1} \sum_{i=0}^{k-1} m^{-i} f(w^{k-i}(v)).$$

In order to bound the expression above, we make use of the mean value theorem for integrals. We have that since  $v \in [\nu_k, \nu_{k-1}]$  then  $w^{k-i}(v) \in [\nu_i, \nu_{i-1}]$  and there exists  $\xi \in [\nu_i, \nu_{i-1}]$  such that

$$\begin{aligned} \int_{\nu_i}^{\nu_{i-1}} f(v) dv &= f(\xi)(\nu_{i-1} - \nu_i) \\ &= (f(\xi) - f(w^{k-i}(v)) + f(w^{k-i}(v))) (\nu_{i-1} - \nu_i) \\ &\leq C_f \cdot (\nu_{i-1} - \nu_i)^2 + f(w^{k-i}(v))(\nu_{i-1} - \nu_i) \\ &= C_f \cdot \frac{\varepsilon^{2/3}}{m^{2i}} + f(w^{k-i}(v)) \frac{\varepsilon^{1/3}}{m^i}, \end{aligned}$$

where in the inequality we used that the density  $f$  is Lipschitz. In last equality we used that  $\nu_{i-1} - \nu_i = \varepsilon^{1/3}/m^i$  when  $\nu_i \geq p^*$ . Using a similar argument delivers a lower bound by replacing  $C_f$  with  $-C_f$ . Hence,

$$\frac{1}{\varepsilon^{1/3}} \int_{\nu_i}^{\nu_{i-1}} f(v) dv - C_f \cdot \frac{\varepsilon^{1/3}}{m^{2i}} \leq \frac{f(w^{k-i}(v))}{m^i} \leq \frac{1}{\varepsilon^{1/3}} \int_{\nu_i}^{\nu_{i-1}} f(v) dv + C_f \cdot \frac{\varepsilon^{1/3}}{m^{2i}}. \quad (39)$$

We add the equation above over  $i = 0, \dots, k-1$  to obtain the following upper bound

$$\begin{aligned} m^{k-1} \sum_{i=0}^{k-1} m^{-i} f(w^{k-i}(v)) &\leq \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) + C_f \cdot \varepsilon^{1/3} \cdot \frac{m^2(1 - 1/(m^k)^2)}{m^2 - 1} \\ &\leq \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) + C_f \cdot \varepsilon^{1/3} \cdot \frac{m^2}{m^2 - 1} \\ &\leq \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) + C_f \cdot \frac{(\bar{v} - p^*)}{2} + C_1 \cdot \varepsilon^{1/3}, \end{aligned} \quad (40)$$

where in the last inequality above we have used the following bound

$$\frac{m^2}{m^2 - 1} - \frac{\bar{v} - p^*}{2\varepsilon^{1/3}} \leq (\bar{v} - p^*) + \frac{1}{2} \triangleq C_1,$$

which is true for  $\varepsilon > 0$  small enough.

Now, let us consider the left-hand side of (39). We obtain the following lower bound

$$\begin{aligned} m^{k-1} \sum_{i=0}^{k-1} m^{-i} f(w^{k-i}(v)) &\geq \frac{m^{k-1}}{\varepsilon^{1/3}} (\bar{F}(v) - \bar{f} \cdot (w(v) - v)) - C_f \cdot \varepsilon^{1/3} \cdot \frac{m^2(1 - 1/(m^k)^2)}{m^2 - 1} \\ &\geq \frac{m^{k-1}}{\varepsilon^{1/3}} (\bar{F}(v) - \bar{f} \cdot (w(v) - v)) - C_f \cdot \varepsilon^{1/3} \cdot \frac{m^2}{m^2 - 1} \\ &\geq \frac{m^{k-1}}{\varepsilon^{1/3}} (\bar{F}(v) - \bar{f} \cdot (w(v) - v)) - C_f \cdot \frac{(\bar{v} - p^*)}{2} - C_1 \cdot \varepsilon^{1/3} \\ &\geq \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) - \frac{\nu_0 - p^* + \frac{\varepsilon^{2/3}}{m-1}}{\varepsilon^{1/3}} \bar{f} \cdot (w(v) - v) - C_f \cdot \frac{(\bar{v} - p^*)}{2} - C_1 \cdot \varepsilon^{1/3} \\ &= \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) - \frac{(m-1)(\nu_0 - p^*) + \varepsilon^{2/3}}{\varepsilon^{1/3}} \bar{f} - C_f \cdot \frac{(\bar{v} - p^*)}{2} - C_1 \cdot \varepsilon^{1/3} \\ &= \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) - \bar{f} - C_f \cdot \frac{(\bar{v} - p^*)}{2} - C_1 \cdot \varepsilon^{1/3} \end{aligned}$$

In the first equality above we have used

$$\sum_{i=0}^{k-1} \int_{\nu_i}^{\nu_{i-1}} f(x) dx = \bar{F}(\nu_{k-1}) = \bar{F}(v) - \int_v^{\nu_{k-1}} f(x) dx \geq \bar{F}(v) - \bar{f} \cdot (\nu_{k-1} - v) \geq \bar{F}(v) - \bar{f} \cdot (w(v) - v).$$

In the second and third bounds we apply the same bound we developed in eq. (40). In the fourth inequality we use eq. (28) from the Proof of Proposition 2.

In turn, this delivers an upper and a lower bound for  $\lambda(w(v))$  a.e in  $[\nu_k, \nu_{k-1}] \cap [p^*, \bar{v}]$ .

Using this, we can derive upper a lower bound for  $\Delta(v)$ . Indeed, using the upper bound just developed, we have

$$\begin{aligned} \Delta(v) &\geq v f(v) - m \cdot (w(v) - v) \cdot \frac{m^{k-1}}{\varepsilon^{1/3}} \bar{F}(v) - m \cdot (w(v) - v) \cdot C_f \cdot \frac{(\bar{v} - p^*)}{2} - m \cdot (w(v) - v) \cdot C_1 \cdot \varepsilon^{1/3} \\ &\geq v f(v) - (w(v) - v) \cdot \frac{m^k}{\varepsilon^{1/3}} \bar{F}(v) - \tilde{C} \varepsilon^{1/3} \\ &\geq v f(v) - m \frac{(m-1)(\nu_0 - p^*) + \varepsilon^{2/3}}{(m-1)(v - p^*) + \varepsilon^{2/3}} (w(v) - v) \cdot \frac{1}{\varepsilon^{1/3}} \bar{F}(v) - \tilde{C} \varepsilon^{1/3} \\ &= v f(v) - m \frac{(m-1)(\nu_0 - p^*) + \varepsilon^{2/3}}{(m-1)(v - p^*) + \varepsilon^{2/3}} ((m-1)(v - p^*) + \varepsilon^{2/3}) \cdot \frac{1}{\varepsilon^{1/3}} \bar{F}(v) - \tilde{C} \varepsilon^{1/3} \\ &= v f(v) - m((m-1)(\nu_0 - p^*) + \varepsilon^{2/3}) \cdot \frac{1}{\varepsilon^{1/3}} \bar{F}(v) - \tilde{C} \varepsilon^{1/3} \\ &\geq v f(v) - \bar{F}(v) - C_L \varepsilon^{1/3} \\ &\triangleq \Delta_L(v), \end{aligned}$$

where in the second inequality we used that  $w(v) - v$  is bounded above by  $\varepsilon^{1/3}$  is  $[p^*, \nu_0]$  (by definition). The constant  $\tilde{C}$  is positive. In the third inequality we have used (28) from the Proof of Proposition 2. In the final inequality we have used that  $\bar{F}$  is bounded, that  $m - 1$  is of order  $\varepsilon^{1/3}$  and then we have collected all the constant terms into the positive constant  $C_L$ .

Now using the lower bound that we derived from (39), we can obtain an upper bound for  $\Delta(v)$  in a similar fashion that we did for  $\Delta_L(v)$ . The only difference is that now we need to use (27) from the Proof of Proposition 2 to lower bound  $m^k$ . We obtain

$$\Delta(v) \leq vf(v) - \bar{F}(v) + C_U \varepsilon^{1/3} \triangleq \Delta_U(v).$$

To conclude, note that  $\Delta_L(v) = -\dot{R}(v) - C_L \varepsilon^{1/3}$ , where  $R(v) = v \cdot \bar{F}(v)$ . By assumption, we can find  $M > 0$  such for all  $v \in [p^*, p^* + M]$  we have  $-\dot{R}(v) > L$  for some constant  $L > 0$ . Moreover, for  $\varepsilon > 0$  small enough, we must have that  $\Delta_L(v) > 0$  for  $v \geq p^* + M$ . Indeed,  $-\dot{R}(v) = \psi(v)f(v) \geq \psi(v)\underline{f}$  where  $\psi(v)$  is the virtual value function which by assumption is increasing and has unique zero at  $p^*$ . This implies that away from  $p^*$  we must have  $\Delta_L(v) > 0$ . Now let  $p_L^* \triangleq p^* + \frac{C_L}{L} \varepsilon^{1/3}$ . Consider  $\varepsilon > 0$  small such that  $p_L^* < p^* + M$ , then for  $v \in [p_L^*, p^* + M]$  we have that

$$v \geq p_L^* \Leftrightarrow v \geq p^* + \frac{C_L}{L} \varepsilon^{1/3} \Rightarrow v \geq p^* + \frac{C_L}{-\ddot{R}(\xi)} \varepsilon^{1/3} \Leftrightarrow -(v - p^*)\ddot{R}(\xi) - C_L \varepsilon^{1/3} \geq 0 \Leftrightarrow \Delta_L(v) \geq 0, \quad (41)$$

where  $\xi \in [p^*, v]$  exists by virtue of the mean value theorem. Hence, we have proved that  $\Delta_L(v) \geq 0$  for  $v \geq p_L^*$ . In turn, by Lemma 4, we have

$$\int_{p_L^*}^{\bar{v}} \Delta(v) dv \leq p_L^* \bar{F}(p_L^*) + 2(w(p_L^*) - p_L^*) = R(p_L^*) + \mathcal{O}(\varepsilon^{2/3}), \quad (42)$$

where we have used the definition of  $w(\cdot)$  and that  $m - 1 = \mathcal{O}(\varepsilon^{1/3})$ .

Now we need to bound the integral of  $\Delta(v)^+$  in  $[p^*, p_L^*]$ . We use  $\Delta_U(v)$ . We have

$$\int_{p^*}^{p_L^*} \Delta(v)^+ dv \leq \int_{p^*}^{p_L^*} \Delta_U(v) dv = R(p^*) - R(p_L^*) + \mathcal{O}(\varepsilon^{2/3}), \quad (43)$$

by integrating the derivative of the revenue function and using that the neighborhood has size  $\varepsilon^{1/3}$ .

Case 2: We consider the case  $v \leq p^*$ . For this case we can proceed in a similar fashion as in the previous case to obtain an upper of  $\Delta(v)$ . The only difference is that now we need to consider the definition of  $w(v)$  below  $p^*$ . Regardless, using similar arguments as before obtains

$$\Delta(v) \leq vf(v) - \bar{F}(v) + C \cdot \varepsilon^{1/3} \triangleq \Delta_U(v), \quad \text{a.e in } [0, p^*],$$

for some positive constant  $C$ . Similar to what we did with  $\Delta_L(v)$  in case 1, we can define  $p_U^* = p^* - \tilde{C}_U \varepsilon^{1/3}$  below which  $\Delta_U(v)$  can be guaranteed to be non-positive. In turn,

$$\int_0^{p^*} \Delta(v)^+ dv \leq \int_{p_U^*}^{p^*} \Delta_U(v) dv = R(p_U^*) - R(p^*) + \mathcal{O}(\varepsilon^{2/3}), \quad (44)$$

Similar to the term  $R(p^*) - R(p_L^*)$ , the term  $R(p_U^*) - R(p^*)$  is  $\mathcal{O}(\varepsilon^{2/3})$ .

To conclude then proof we combine the bounds for both cases. From eqs. (42) to (44) we have

$$\int_0^{\bar{v}} \Delta^+(v) dv \leq R(p_U^*) + \mathcal{O}(\varepsilon^{2/3}) \leq \Pi^*(\mathcal{M}(0)) + \mathcal{O}(\varepsilon^{2/3}), \quad (45)$$

where we have used that  $R(p_U^*) \leq \Pi^*(\mathcal{M}(0))$ . This completes the proof.

### Appendix C: Proofs for Section 5

**Proof of Proposition 3** For ease of notation we use  $(x, t)$  in lieu of  $(x_{\text{pd}}, t_{\text{pd}})$ . Let  $u(v) = \max_{w \in \mathcal{S}} \{v \cdot x(w) - t(w)\}$ , we want to show that

$$u(v) = v \cdot x(v^*(v)) - t(v^*(v)). \quad (46)$$

First observe that the generalize inverse of  $v^*(\cdot)$ ,  $w(\cdot)$ , is

$$w(v) = \begin{cases} p^* - \delta & \text{if } v \in [0, p^* - \delta - \mu]; \\ v + \mu & \text{if } v \in [p^* - \delta - \mu, p^* + \delta]. \end{cases}$$

In turn, we have that  $w(v) \geq v$  for all  $v \in [0, p^* + \delta]$ . Let us analyze two cases,  $v \leq p^* - \delta$  (case 1) and  $v \geq p^* - \delta$  (case 2).

**Case 1.** Suppose that  $v \leq p^* - \delta$ . Define the function

$$g(v') = v \cdot x(v') - t(v'), \quad v' \in [0, \bar{v}],$$

We need to show that  $g(v^*(v)) = g(0) \geq g(v')$  for all  $v' \in [0, \bar{v}]$ . To prove this, we argue that  $g(\cdot)$  is non-increasing. If  $v' \in [0, p^* - \delta]$  we have

$$g(v') = (v - v') \cdot x(v'), \quad \text{and} \quad \dot{g}(v') = -x(v') + (v - v') \cdot \dot{x}(v').$$

In  $[0, p^* - \delta]$  the allocation  $x(\cdot)$  satisfies the differential equation  $(w(v') - v')\dot{x}(v') = x(v')$ . In turn,

$$\dot{g}(v') = -(w(v') - v')\dot{x}(v') + (v - v') \cdot \dot{x}(v') = (v - w(v')) \cdot \dot{x}(v').$$

Note that  $w(\cdot)$  is non-decreasing and  $v \leq p^* - \delta = w(0)$  hence we have that  $v \leq w(v')$  for all  $v' \in [0, p^* - \delta]$ . Moreover,  $x$  is non-decreasing (see Lemma 5 in Section C.1) which implies that  $\dot{g}(v') \leq 0$  for all  $v' \in [0, p^* - \delta]$ . We have thus verified that  $g$  is decreasing in  $[0, p^* - \delta]$ .

If  $v' \in [p^* - \delta, p^* + \delta]$  we have that

$$g(v') = (v - v') \cdot x(v') + \int_0^{v'} x(v^*(s)) ds - \epsilon, \quad \text{and} \quad \dot{g}(v') = -x(v') + (v - v') \cdot \dot{x}(v') + x(v^*(v')).$$

In this interval the allocation  $x$  is a solution to the delayed differential equation  $x(v') + (v' - w(v'))\dot{x}(v') = x(v^*(v'))$ . As before this implies that  $\dot{g}(v') = (v - w(v')) \cdot \dot{x}(v')$ . Note that because  $x$

is non-decreasing (see Lemma 5 in Section C.1) we have that  $\dot{x}(v') \geq 0$ , and because  $w(v') \geq v'$  and  $v' \geq p^* - \delta \geq v$ , we can conclude that  $\dot{g}(v') \leq 0$ . We have thus verified that  $g$  is non-increasing in  $[p^* - \delta, p^* + \delta]$ .

If  $v' \in [p^* + \delta, \bar{v}]$  we have

$$g(v') = (v - v') + \int_0^{v'} x(v^*(s)) ds - \epsilon, \quad \text{and} \quad \dot{g}(v') = -1 + x(v^*(v')),$$

where to derive  $\dot{g}(v')$  we have used that  $x(v') = 1$  for all  $v' \in [p^* + \delta, \bar{v}]$ . Note that since  $v^*(\cdot)$  is non-decreasing, we have that  $v^*(v') \leq p^* + \delta$  for all  $v'$ . In turn, because  $x(\cdot)$  is non-decreasing (see Lemma 5 in Section C.1) we conclude that  $x(v^*(v')) \leq x(p^* + \delta) = 1$ . That is,  $\dot{g}(v') \leq 0$ , equivalently,  $g$  is decreasing in  $[p^* + \delta, \bar{v}]$ .

Finally, since  $x$  and  $t$  are continuous functions,  $g$  is also a continuous function. This, together with  $g$  being decreasing in each of the intervals  $[0, p^* - \delta]$ ,  $[p^* - \delta, p^* + \delta]$  and  $[p^* + \delta, \bar{v}]$ , implies that  $g$  is decreasing in  $[0, \bar{v}]$ , as desired.

**Case 2.**  $v \geq p^* - \delta$ : In the previous case we already computed the derivative of  $g(\cdot)$  at different intervals. In particular, we have

$$\dot{g}(v') = \begin{cases} (v - w(v')) \cdot \dot{x}(v') & \text{if } v' \leq p^* + \delta \\ -1 + x(v^*(v')) & \text{if } v' \geq p^* + \delta \end{cases}$$

Note that the sign of the derivative at  $v' \in [0, p^* + \delta]$  depends on how  $v$  compares to  $w(v')$ . Observe that  $w(\cdot)$  is a non-decreasing continuous function taking values in  $[p^* - \delta, p^* + \delta + \mu]$ . Therefore, for any  $v \in [p^* - \delta, p^* + \delta + \mu]$  we have that if  $v' < v^*(v)$  then  $w(v') \leq v$ , and if  $v' > v^*(v)$  then  $w(v') \geq v$ . Moreover, as we argued before  $x(v^*(v')) \leq 1$ . That is, for any  $v \in [p^* - \delta, p^* + \delta + \mu]$  the function  $g(v')$  is first increasing for  $v' < v^*(v)$  and then decreasing for  $v' > v^*(v)$ . Hence, for any  $v \in [p^* - \delta, p^* + \delta + \mu]$  the maximum of  $g$  is attained at  $v^*(v)$ .

If  $v \geq p^* + \delta + \mu$  then  $v^*(v) = p^* + \delta$ , and for any  $v' \leq p^* + \delta$  we have that  $w(v') \leq p^* + \delta + \mu \leq v$ . In turn, in this case  $g(v')$  is increasing for all  $v' \leq p^* + \delta$ . Since we already saw that  $g$  is decreasing for  $v' \geq p^* + \delta$  we conclude that  $v^*(v)$  attains the maximum of  $g$ . Thus the maximum is still achieved at  $v^*(v)$ , as desired.

**Proof of Proposition 4** Consider the change of variables

$$y_{\text{pd}}(v) = x_{\text{pd}}(v) \cdot \frac{\mu}{\epsilon} \cdot \exp\left(-\frac{v - p^* + \delta + \mu}{\mu}\right).$$

To prove the statement, we solve the resulting ordinary and delayed differential equations for  $y_{\text{pd}}(v)$ .

Under this change of variables, (ODE) for  $v \in [0, p^* - \delta - \mu]$  becomes

$$\dot{y}_{\text{pd}}(v) = y_{\text{pd}}(v) \left( \frac{1}{w(v) - v} - \frac{1}{\mu} \right), \quad y_{\text{pd}}(0) = \frac{\mu}{p^* - \delta} \cdot e^{\frac{p^* - \delta - \mu}{\mu}}, \quad v \in [0, p^* - \delta - \mu]. \quad (47)$$



This have solution,

$$y_{\text{pd}}(v) = \frac{\mu}{p^* - \delta - v} \exp\left(-\frac{v - p^* + \delta + \mu}{\mu}\right). \quad (48)$$

For  $v \in [p^* - \delta - \mu, p^* - \delta]$  (ODE) becomes  $\dot{y}_{\text{pd}}(v) = 0$  with  $y_{\text{pd}}(p^* - \delta - \mu) = 1$ . Hence, in this interval  $y_{\text{pd}}(v) = 1$ .

(DDE) becomes

$$\dot{y}_{\text{pd}}(v) + \frac{e^{-1}}{\mu} \cdot y_{\text{pd}}(v - \mu) = 0, \quad v \in [p^* - \delta, p^* + \delta]; \quad y_{\text{pd}}(v) = 1, \quad \forall v \in [p^* - \delta - \mu, p^* - \delta]. \quad (49)$$

The delayed differential equation in (49) is a linear delayed differential equation with constants coefficients. Its solution is unique and it can be found in Norkin et al. (1973) p.8 and is given by

$$y_{\text{pd}}(v) = \sum_{j=0}^{\lfloor \frac{v-p^*+\delta}{\mu} \rfloor + 1} \frac{(-1)^j e^{-j}}{j!} \left( \frac{v - p^* + \delta}{\mu} + 1 - j \right)^j, \quad v \in [p^* - \delta, p^* + \delta].$$

This solution can also be verified by an inductive argument. In summary, we have that

$$y_{\text{pd}}(v) = \begin{cases} \frac{\mu}{p^* - \delta - v} \exp\left(-\frac{v - p^* + \delta + \mu}{\mu}\right) & \text{if } v \leq p^* - \delta - \mu; \\ 1 & \text{if } v \in [p^* - \delta - \mu, p^* - \delta]; \\ \sum_{j=0}^{\lfloor \frac{v-p^*+\delta}{\mu} \rfloor + 1} \frac{(-1)^j e^{-j}}{j!} \left( \frac{v - p^* + \delta}{\mu} + 1 - j \right)^j & \text{if } v \in [p^* - \delta, p^* + \delta]. \end{cases} \quad (50)$$

Finally, we argue that  $x_{\text{pd}}$  is strictly positive and monotone non-decreasing in  $[0, p^* + \delta]$ . Lemma 5 in Section C.1 establishes that  $x_{\text{pd}}$  is non-decreasing in  $[0, p^* + \delta]$ . Since  $x_{\text{pd}}(0) = \varepsilon / (p^* - \delta) > 0$  and  $x_{\text{pd}}(\cdot)$  is non-decreasing, we deduce that  $x_{\text{pd}}(\cdot)$  is strictly positive.

**Proof of Proposition 5** First fix  $\varepsilon > 0$  and  $\mu > \varepsilon \cdot e$ . To show that  $\lim_{v \uparrow p^* + \delta} x_{\text{pd}}(v) = 1$  it suffices to prove  $x_{\text{pd}}(p^* + \delta)$  must equal one. Given the change of variables (see the proof of Proposition 4) the latter condition is equivalent to:

$$\varepsilon = \frac{1}{y_{\text{pd}}(p^* + \delta)} \frac{\mu}{e} e^{-\frac{2\delta}{\mu}}. \quad (51)$$

We use this equation to establish a relationship between  $\varepsilon$  and  $(\mu, \delta)$ . From eq. (51), to do so, we need to study  $y_{\text{pd}}(p^* + \delta)$ . Note that from eq. (50), we have that

$$y_{\text{pd}}(p^* + \delta) = \sum_{j=0}^{\lfloor \frac{2\delta}{\mu} \rfloor + 1} \frac{(-1)^j e^{-j}}{j!} \left( \frac{2\delta}{\mu} + 1 - j \right)^j \triangleq \Gamma\left(\frac{2\delta}{\mu}\right).$$

The function  $\Gamma(\cdot)$  satisfies the following properties that we state and prove in Section C.1:

- (i)  $\Gamma(\cdot)$  is decreasing and  $\Gamma(0) = 1$ . This follows from Lemma 7.

(ii) There exists  $x_0 > 0$  such that for all  $x \geq x_0$  we have  $\frac{\Gamma(x)}{xe^{-x}} \in [2e^{-1}, 2]$ . This follows from Lemma 7.

(iii)  $\Gamma\left(\frac{2\delta}{\mu}\right) \geq \exp\left(-\frac{2\delta}{\mu}\right)$ , for any  $\mu, \delta > 0$ . This follows from Lemma 6.

We now combine these properties to show that we can always find  $\delta = \delta(\mu, \varepsilon) > 0$  such that (51) holds. Define the function  $L$  by

$$L(x) \triangleq \frac{\Gamma(x)}{xe^{-x}}.$$

Then we can cast (51) as

$$\varepsilon \cdot L\left(\frac{2\delta}{\mu}\right) = \frac{\mu^2}{2e\delta}. \quad (52)$$

For fixed  $\mu$  and  $\varepsilon$ , we have that  $L\left(\frac{2\delta}{\mu}\right) \in [2e^{-1}, 2]$  for  $\delta$  large enough (by property (ii)). Also,  $\frac{\mu^2}{2e\delta} \rightarrow 0$  as  $\delta \uparrow +\infty$ . Clearly, as  $\delta \downarrow 0$  we have that  $L\left(\frac{2\delta}{\mu}\right) \rightarrow +\infty$  and that  $\frac{\mu^2}{2e\delta} \rightarrow +\infty$ . We also have that for all  $\delta$  small enough  $\varepsilon \cdot L\left(\frac{2\delta}{\mu}\right) < \frac{\mu^2}{2e\delta}$ . Indeed, consider  $\delta > 0$  such that  $2\delta < \mu$ , this implies that  $\left\lfloor \frac{2\delta}{\mu} \right\rfloor = 0$  and, therefore,  $\Gamma\left(\frac{2\delta}{\mu}\right) = 1 - \left(\frac{2\delta}{\mu e}\right)$ . Hence,  $\varepsilon \cdot L\left(\frac{2\delta}{\mu}\right) < \frac{\mu^2}{2e\delta}$  if and only if

$$\varepsilon \frac{1 - \left(\frac{2\delta}{\mu e}\right)}{\left(\frac{2\delta}{\mu}\right) \exp\left(-\frac{2\delta}{\mu}\right)} < \frac{\mu^2}{2e\delta} \Leftrightarrow \varepsilon \left(1 - \left(\frac{2\delta}{\mu e}\right)\right) < \frac{\mu}{e} \exp\left(-\frac{2\delta}{\mu}\right), \quad (53)$$

note that at  $\delta = 0$  the last expression above becomes  $\varepsilon \cdot e < \mu$ , which is assumed to be true. By continuity, we deduce that for  $\delta > 0$  small enough we have  $\varepsilon \cdot L\left(\frac{2\delta}{\mu}\right) < \frac{\mu^2}{2e\delta}$ . All these properties together imply that there must exist  $\delta(\mu, \varepsilon)$  that solves (52). Consequentially, we have found the solution  $\delta(\mu, \varepsilon)$  to (51), as desired.

To prove that  $\delta(\mu, \varepsilon) = \frac{e\mu^2}{2\varepsilon} \cdot \frac{1}{L(\delta(\mu, \varepsilon)/\mu)}$ . Just note that it directly follows from (52).

Next, we show that if we choose  $\mu = \mu(\varepsilon) > \varepsilon \cdot e$  such that  $\lim_{\varepsilon \downarrow 0} \mu(\varepsilon)/\varepsilon = +\infty$  then  $\lim_{\varepsilon \downarrow 0} \delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon) = +\infty$ . Note that  $\delta(\mu(\varepsilon), \varepsilon)$  solves (51), that is,

$$\Gamma\left(\frac{2\delta(\mu(\varepsilon), \varepsilon)}{\mu(\varepsilon)}\right) = \frac{\mu(\varepsilon)}{e\varepsilon} e^{-\frac{2\delta(\mu(\varepsilon), \varepsilon)}{\mu(\varepsilon)}}.$$

However, from property (i), we know that  $\Gamma(0) = 1$  and  $\Gamma$  is non-decreasing. In turn, for  $\varepsilon$  small we have

$$1 \geq \Gamma\left(\frac{2\delta(\mu(\varepsilon), \varepsilon)}{\mu(\varepsilon)}\right) = \frac{\mu(\varepsilon)}{e\varepsilon} e^{-\frac{2\delta(\mu(\varepsilon), \varepsilon)}{\mu(\varepsilon)}},$$

which implies that

$$e^{\frac{2\delta(\mu(\varepsilon), \varepsilon)}{\mu(\varepsilon)}} \geq \frac{\mu(\varepsilon)}{e\varepsilon}.$$

From the above equation, we can deduce that because  $\lim_{\varepsilon \downarrow 0} \mu(\varepsilon)/\varepsilon = +\infty$ , it must be the case that  $\lim_{\varepsilon \downarrow 0} \delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon) = +\infty$ .

Next, we show that  $m_{\text{pd}} \in \mathcal{M}(\varepsilon)$ . First, note by assumption  $v^*$  is well defined. Now from Proposition 3 and since  $\delta(\mu(\varepsilon), \varepsilon)$  solves (51), we know that  $v^*(\cdot)$  is a best reporting function for  $m_{\text{pd}}$ .

Given this property, we can verify that  $m_{\text{pd}}$  is feasible. To see why  $(\text{IC}_\varepsilon)$  holds, note that because  $v^*(\cdot)$  is a best reporting function we have that  $\max_w \{v \cdot x_{\text{pd}}(w) - t_{\text{pd}}(w)\} = v \cdot x_{\text{pd}}(v^*(v)) - t_{\text{pd}}(v^*(v))$ . This, together with the envelope theorem (see eq. (6)), implies that  $(\text{IC}_\varepsilon)$  can be cast as

$$v \cdot x_{\text{pd}}(v) - t_{\text{pd}}(v) \geq \int_0^v x_{\text{pd}}(v^*(s)) ds - \varepsilon, \quad \forall v \in [0, \bar{v}].$$

If  $v \leq p^* - \delta$  then the left hand-side above is 0; while the right hand-side is  $v x_{\text{pd}}(0) - \varepsilon$  which, by the boundary condition of  $x_{\text{pd}}(\cdot)$ , is non-negative. If  $v \geq p^* - \delta$  then the inequality above is binding. That is,  $m_{\text{pd}}$  verifies  $(\text{IC}_\varepsilon)$ . The  $(\text{IR})$  constraint can be verified in a similar fashion. This concludes the proof.

**Proof of Proposition 6** We exploit the characterization of  $m_{\text{pd}} = (x_{\text{pd}}, t_{\text{pd}})$  given in proposition 3. For ease of exposition we use  $(x, t)$  instead of  $(x_{\text{pd}}, t_{\text{pd}})$ . We have

$$\begin{aligned} \Pi(m_{\text{pd}}) &= \int_0^{\bar{v}} t_{\text{pd}}(v) f(v) dv \\ &= \int_0^{\bar{v}} v x(v) f(v) dv + \varepsilon \bar{F}(p^* - \delta) - \int_{p^* - \delta}^{\bar{v}} \int_0^v x(v^*(s)) f(v) ds dv \\ &= \int_0^{\bar{v}} v x(v) f(v) dv + \varepsilon \bar{F}(p^* - \delta) - \int_0^{p^* - \delta} \int_{p^* - \delta}^{\bar{v}} x(v^*(s)) f(v) dv ds \\ &\quad - \int_{p^* - \delta}^{\bar{v}} \int_s^{\bar{v}} x(v^*(s)) f(v) dv ds \\ &= \int_0^{\bar{v}} v x(v) f(v) dv + \varepsilon \bar{F}(p^* - \delta) - (p^* - \delta) x(0) \bar{F}(p^* - \delta) - \int_{p^* - \delta}^{\bar{v}} x(v^*(v)) \bar{F}(v) dv \\ &\stackrel{(a)}{=} \int_0^{\bar{v}} v x(v) f(v) dv - \int_{p^* - \delta}^{p^* + \delta + \mu} x(v - \mu) \bar{F}(v) dv - x(p^* + \delta) \int_{p^* + \delta + \mu}^{\bar{v}} \bar{F}(v) dv \\ &= \int_0^{\bar{v}} v x(v) f(v) dv - \int_{p^* - \delta - \mu}^{p^* + \delta} x(v) \bar{F}(v + \mu) dv - \int_{p^* + \delta + \mu}^{\bar{v}} \bar{F}(v) dv \\ &\stackrel{(b)}{=} \int_0^{p^* + \delta} x(v) \left( v - \frac{\bar{F}(v + \mu)}{f(v)} \dot{w}(v) \right) f(v) dv + \int_{p^* + \delta}^{\bar{v}} v x(v) f(v) dv - \int_{p^* + \delta + \mu}^{\bar{v}} \bar{F}(v) dv \\ &= \int_0^{p^* + \delta} x(v) \left( v - \frac{\bar{F}(v + \mu)}{f(v)} \dot{w}(v) \right) f(v) dv + \int_{p^* + \delta}^{p^* + \delta + \mu} v f(v) dv + \int_{p^* + \delta + \mu}^{\bar{v}} (v f(v) - \bar{F}(v)) dv \\ &\stackrel{(c)}{=} \int_0^{p^* + \delta} x(v) \left( v - \frac{\bar{F}(v + \mu)}{f(v)} \dot{w}(v) \right) f(v) dv + \int_{p^* + \delta}^{p^* + \delta + \mu} v f(v) dv + (p^* + \delta + \mu) \bar{F}(p^* + \delta + \mu), \end{aligned}$$

where (a) holds because  $x(0) = \varepsilon / (p^* - \delta)$ ; (b) holds because  $\dot{w}(v) = 0$  if  $v < p^* - \delta - \mu$  and  $\dot{w}(v) = 1$  if  $v \in (p^* - \delta - \mu, p^* + \delta)$ ; and (c) holds because the derivative of  $v \bar{F}(v)$  equals  $\bar{F}(v) - v f(v)$ . This concludes the proof.

**Proof of Theorem 3** We rely on the characterization for  $\Pi(m_{\text{pd}})$  provided in Proposition 6. We analyze the order of  $\Pi(m_{\text{pd}})$ . To simplify exposition we let  $\Pi(m_{\text{pd}}) = \Pi_1 + \Pi_2 + \Pi_3$  where

$$\Pi_1 = \int_0^{p^* - \delta - \mu} v \frac{\varepsilon}{p^* - \delta - v} f(v) dv;$$

$$\begin{aligned}\Pi_2 &= \int_{p^*-\delta-\mu}^{p^*+\delta} \left( v - \frac{\overline{F}(v+\mu)}{f(v)} \right) x(v) f(v) dv; \\ \Pi_3 &= \int_{p^*+\delta}^{p^*+\delta+\mu} v f(v) dv + (p^* + \delta + \mu) \overline{F}(p^* + \delta + \mu).\end{aligned}$$

We also use  $x(\cdot)$  instead of  $x_{\text{pd}}(\cdot)$ . Note that in  $\Pi_1$  above we use the solution  $x_{\text{pd}}$  derived in eq. (50) in the proof of Proposition 4. We set  $\mu(\varepsilon) = K\varepsilon^{2/3}$  for  $\varepsilon > 0$  small enough such that  $\mu(\varepsilon) > \varepsilon \cdot e$ . In turn, the conditions in Proposition 5 are met so that we can find  $\delta(\varepsilon)$  such that:

- (i)  $\delta(\varepsilon) = \varepsilon^{1/3} \cdot \frac{eK^2}{2L(\delta(\varepsilon)/\mu(\varepsilon))}$ , where  $L$  is a function such that  $L(x) \in [2e^{-1}, 2]$  for all  $x$  large.
- (ii)  $\lim_{\varepsilon \downarrow 0} \delta(\varepsilon)/\mu(\varepsilon) = +\infty$ .

We next study each of the terms above separately. We begin with  $\Pi_3$ . Because distributions are monotone, we have

$$\begin{aligned}\int_{p^*+\delta}^{p^*+\delta+\mu} v f(v) dv + R(p^* + \delta + \mu) &= \int_{p^*+\delta}^{p^*+\delta+\mu} \overline{F}(v) dv + R(p^* + \delta) \geq \overline{F}(p^* + \delta) \cdot \mu + R(p^* + \delta) \\ &\geq (\overline{F}(p^*) + \mathcal{O}(\delta)) \cdot \mu + R(p^*) - K_R \delta^2 := (A),\end{aligned}$$

where the last inequality follows from performing Taylor which shows that  $\overline{F}(p^* + \delta) = \overline{F}(p^*) + \mathcal{O}(\delta)$ . Moreover, by the mean value theorem, there exists  $\xi \in [p^*, p^* + \delta]$  such that  $R(p^* + \delta) = R(p^*) + \delta \dot{R}(\xi)$ . Also, since  $f(\cdot)$  is Lipschitz (by Assumption 1) so is  $\dot{R}(\cdot)$  and, therefore,  $|\dot{R}(p^*) - \dot{R}(\xi)| \leq K_R \delta$  for some constant  $K_R > 0$  (that depends only on the model primitives). This together with  $\dot{R}(p^*) = 0$  (by Assumption 1) yields the additional term  $-K_R \delta^2$  in (A).

For  $\mu = \mu(\varepsilon) = K \cdot \varepsilon^{2/3}$  for some positive constant  $K > 0$ , we can apply Proposition 5 which implies that  $\delta(\mu(\varepsilon), \varepsilon) = \varepsilon^{1/3} e K^2 / (2L(\delta/\mu))$ . This delivers,

$$(A) \geq \Pi^*(\mathcal{M}(0)) + K \left( \overline{F}(p^*) - \frac{e^4}{16} K_R \cdot K^3 \right) \cdot \varepsilon^{2/3} + \mathcal{O}(\varepsilon), \quad (54)$$

where we have used that  $L(\delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon)) \geq 2e^{-1}$  when  $\delta(\mu(\varepsilon), \varepsilon)/\mu(\varepsilon)$  is large (which holds because  $\mu(\varepsilon)/\varepsilon \uparrow +\infty$  as  $\varepsilon \downarrow 0$ ).

Next, we analyze the first term  $\Pi_1$ , we simply have

$$\Pi_1 = \int_0^{p^*-\delta-\mu} v \frac{\varepsilon}{p^* - \delta - v} f(v) dv \geq 0. \quad (55)$$

Finally, we analyze the second term  $\Pi_2$ . By the mean value theorem, we can always find  $\xi \in [v, v + \mu]$  such that

$$v - \frac{\overline{F}(v+\mu)}{f(v)} = \psi(v) + \frac{f(\xi)}{f(v)} \mu \geq \psi(v).$$

Then

$$\begin{aligned}\Pi_2 &= \int_{p^*-\delta-\mu}^{p^*+\delta} \left( v - \frac{\overline{F}(v+\mu)}{f(v)} \right) x(v) f(v) dv \\ &\geq \int_{p^*-\delta-\mu}^{p^*+\delta} \psi(v) x(v) f(v) dv\end{aligned}$$

Let us bound the term above. Because the density is Lipschitz continuous and the support is bounded, there exists  $\bar{f} \in (0, \infty)$  such that  $f(v) \leq \bar{f}$  for all  $v \in [0, \bar{v}]$ . We use this upper bound throughout our proofs. Since  $p^*$  is an interior solution that maximizes  $v \cdot \bar{F}(v)$  (Assumption 1), we have that  $\psi(p^*) = 0$ . Then

$$\begin{aligned}
 \int_{p^* - \delta - \mu}^{p^* + \delta} \psi(v)x(v)f(v)dv &= \int_{p^* - \delta - \mu}^{p^* + \delta} (\psi(v) - \psi(p^*))x(v)f(v)dv \\
 &\stackrel{(a)}{\geq} -C_\psi \int_{p^* - \delta - \mu}^{p^* + \delta} |v - p^*|x(v)f(v)dv \\
 &\geq -C_\psi \cdot x(p^* + \delta) \cdot \bar{f} \int_{p^* - \delta - \mu}^{p^* + \delta} |v - p^*|dv \\
 &= -C_\psi \cdot \bar{f} \left[ \int_{p^* - \delta - \mu}^{p^*} (p^* - v)dv + \int_{p^*}^{p^* + \delta} (v - p^*)dv \right] \\
 &= -C_\psi \cdot \bar{f} \left[ -\frac{(p^* - v)^2}{2} \Big|_{p^* - \delta - \mu}^{p^*} + \frac{(v - p^*)^2}{2} \Big|_{p^*}^{p^* + \delta} \right] \\
 &= -C_\psi \cdot \bar{f} \left[ \frac{(\delta + \mu)^2}{2} + \frac{\delta^2}{2} \right] \\
 &= -C_\psi \cdot \bar{f} \delta^2 + o(\varepsilon^{2/3}),
 \end{aligned}$$

where in (a) we use that  $\psi(\cdot)$  is Lipschitz with constant  $C_\psi$ , see Lemma 8 (which we prove and state in Section C.1). We thus obtain the following lower bound for  $\Pi_2$  (for  $\varepsilon > 0$  small enough)

$$\Pi_2 \geq -C_\psi \cdot \bar{f} \cdot \left( \varepsilon^{1/3} \cdot \frac{e^2 K^2}{4} \right)^2 + o(\varepsilon^{2/3}). \quad (56)$$

To conclude note that from eq. (54), eq. (55) and eq. (56) we can deduce that

$$\Pi(m_{\text{pd}}) - \Pi^*(\mathcal{M}(0)) \geq K \cdot \left( \bar{F}(p^*) - \frac{e^4 K^3}{16} (K_R + C_\psi \cdot \bar{f}) \right) \cdot \varepsilon^{2/3} + o(\varepsilon^{2/3}) \quad (57)$$

Note that because  $\bar{F}(p^*) > 0$  we can always choose  $K$  such that the term in the parenthesis above is positive. This implies that

$$\Pi(m_{\text{pd}}) - \Pi^*(\mathcal{M}(0)) = \Omega(\varepsilon^{2/3}) + o(\varepsilon^{2/3}).$$

This concludes the proof.

### C.1. Auxiliary results for Section 5

LEMMA 5. *Let  $x(\cdot)$  be a solution to (ODE)-(DDE). Then  $x(\cdot)$  is non-decreasing in  $[0, p^* + \delta]$ .*

**Proof of Lemma 5** To see why  $x(\cdot)$  is non-decreasing we show that if  $x(\cdot)$  is non-decreasing in  $[p^* - \delta + (n-1) \cdot \mu, p^* - \delta + n \cdot \mu]$  then it is also non-decreasing in  $[p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$  for all  $n \geq 0$ . Indeed, fix  $n$  and denote by  $x_0$  to  $x(\cdot)$  in  $[p^* - \delta + (n-1) \cdot \mu, p^* - \delta + n \cdot \mu]$ . Suppose

that  $x_0$  is non-decreasing. Now consider  $v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$ ,  $x(\cdot)$  must satisfy the following equation

$$x(v) = x_0(p^* - \delta + n \cdot \mu), \quad \dot{x}(v) = \frac{x(v) - x_0(v - \mu)}{\mu}, \quad \forall v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]. \quad (58)$$

Consider the alternative ordinary differential equation

$$r(v) = x_0(p^* - \delta + n \cdot \mu), \quad \dot{r}(v) = \frac{r(v) - x_0(p^* - \delta + n \cdot \mu)}{\mu}, \quad \forall v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]. \quad (59)$$

Let  $f(v, x)$  and  $g(v, r)$  be the right-hand side of eq. (58) and eq. (59), respectively. Note because  $x_0(\cdot)$  is non-decreasing in  $[p^* - \delta + (n-1) \cdot \mu, p^* - \delta + n \cdot \mu]$  we have that  $f(v, x) \geq g(v, x)$ . In turn, a standard comparison argument for ordinary differential equations implies that  $x(v) \geq r(v)$  for all  $v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$ . Since the solution to eq. (59) is  $r(v) = x_0(p^* - \delta + n \cdot \mu)$ , we can conclude that  $x(v) \geq x_0(p^* - \delta + n \cdot \mu)$  for all  $v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$ . Therefore, from eq. (58) we deduce that  $\mu \dot{x}(v) \geq x_0(p^* - \delta + n \cdot \mu) - x_0(v - \mu) \geq 0$  for all  $v \in [p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$ . That is,  $x(\cdot)$  is non-decreasing in  $[p^* - \delta + n \cdot \mu, p^* - \delta + (n+1) \cdot \mu]$ . To conclude, note that in  $[p^* - \delta - \mu, p^* - \delta]$   $x(\cdot)$  is the solution to an ordinary differential equation for which it can be easily verified that the solution is strictly increasing.

LEMMA 6. For any  $\mu, \delta > 0$  consider the delayed differential equation

$$\dot{y}(v) + \frac{e^{-1}}{\mu} \cdot y(v - \mu) = 0, \quad v \geq p^* - \delta; \quad y(v) = 1, \quad \forall v \in [p^* - \delta - \mu, p^* - \delta]. \quad (60)$$

There exists a unique and positive solution to the delayed differential equation for all  $v \geq p^* - \delta - \mu$ . Moreover, the solution is strictly decreasing for  $v \geq p^* - \delta$ , converges to zero and

$$\exp\left(-\frac{(v - p^* + \delta)}{\mu}\right) \leq y(v) \leq \exp\left(-e^{-1} \frac{(v - p^* + \delta)}{\mu}\right), \quad \forall v \geq p^* - \delta.$$

**Proof of Lemma 6** The existence and uniqueness follow from Theorem 26-C in Driver (2012). The non-negativity of the solution is a more subtle point. To prove it, consider a solution of the form

$$y(v) = \begin{cases} 1 & \text{if } v \in [p^* - \delta - \mu, p^* - \delta]; \\ \exp\left(\int_{p^* - \delta}^v \alpha(s) ds\right) & \text{if } v \geq p^* - \delta, \end{cases}$$

where  $\alpha(\cdot)$  is some function that we will define momentarily. Given  $\alpha(\cdot)$  note that for  $v \geq p^* - \delta$  we have

$$\dot{y}(v) = \alpha(v)y(v) \quad \text{and} \quad y(v - \mu) = \exp\left(-\int_{\max\{v - \mu, p^* - \delta\}}^v \alpha(s) ds\right) y(v),$$

in turn, if  $\alpha(\cdot)$  solves the equation

$$\alpha(v) = -\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v - \mu, p^* - \delta\}}^v \alpha(s) ds\right), \quad (61)$$

then  $y(\cdot)$  will be a solution to the delayed differential equation (60). Since we know that the solution to the equation is unique, this implies that  $y$  is in fact the solution. Moreover, from the definition of  $y$  we see that  $y(v) > 0$  for all  $v \geq p^* - \delta - \mu$ . Therefore, we only need to show that Eq. (61) has a solution. In doing so will show that the solution to (60) is strictly decreasing to zero at exponential rate.

Let  $\mathcal{C}([p^* - \delta, \infty), \mathbb{R})$  denote the set of continuous functions defined in  $[p^* - \delta, \infty)$ , and taking values in  $\mathbb{R}$ . Define the functional  $T : \mathcal{C}([p^* - \delta, \infty), \mathbb{R}) \rightarrow \mathbb{R}$  by

$$(T\alpha)(v) \mapsto -\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha(s) ds\right). \quad (62)$$

Consider  $\alpha_0 \in \mathcal{C}([p^* - \delta, \infty), \mathbb{R})$  such that  $\alpha_0(v) \in [-1/\mu, -e^{-1}/\mu]$  for all  $v \geq p^* - \delta$ . Next define a sequence  $\alpha_k$  by the recursion

$$\alpha_k(v) = (T\alpha_{k-1})(v), \quad \forall k \geq 0, \quad v \geq p^* - \delta.$$

Fix  $v_1 \in (p^* - \delta, \infty)$ , we show that  $\alpha_k$  converges uniformly in this interval to some  $\alpha \in \mathcal{C}([p^* - \delta, \infty), \mathbb{R})$ . We next argue that  $\alpha_k(v) \in [-1/\mu, -e^{-1}/\mu]$  for all  $v \geq p^* - \delta$  for all  $k \geq 0$ . For  $k = 0$  this immediate. Suppose this is true for  $k - 1$  then

$$0 \leq \frac{e^{-1}}{\mu} (v - \max\{v - \mu, p^* - \delta\}) \leq -\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_{k-1}(s) ds \leq \frac{(v - \max\{v - \mu, p^* - \delta\})}{\mu} \leq 1,$$

taking exponential on both sides and multiplying by  $-e^{-1}/\mu$  delivers

$$-\frac{1}{\mu} \leq \underbrace{-\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_{k-1}(s) ds\right)}_{(T\alpha_{k-1})(v)} \leq -\frac{e^{-1}}{\mu},$$

that is,  $\alpha_k(v) \in [-1/\mu, -e^{-1}/\mu]$ .

Next, for  $v \in [p^* - \delta, v_1]$  consider the difference  $(T\alpha_k)(v) - (T\alpha_{k-1})(v)$  and note that by the mean value theorem we can always find  $\xi$  between  $\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_k(s) ds$  and  $\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_{k-1}(s) ds$  such that

$$\left| \exp\left(-\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_k(s) ds\right) - \exp\left(-\int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_{k-1}(s) ds\right) \right| = e^{-\xi} \left| \int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_{k-1}(s) ds - \int_{\max\{v-\mu, p^*-\delta\}}^v \alpha_k(s) ds \right|.$$

Note that

$$\begin{aligned} |\xi| &\leq \max\left\{ \int_{\max\{v-\mu, p^*-\delta\}}^v |\alpha_k(s)| ds, \int_{\max\{v-\mu, p^*-\delta\}}^v |\alpha_{k-1}(s)| ds \right\} \leq \frac{(v - \max\{v - \mu, p^* - \delta\})}{\mu} \\ &\leq \frac{v_1 - p^* + \delta}{\mu}, \end{aligned}$$

therefore, for all  $v \in [p^* - \delta, v_1]$  we have

$$|\alpha_{k+1}(v) - \alpha_k(v)| \leq \underbrace{\frac{e^{-1}}{\mu} \cdot e^{-(v_1 - p^* + \delta)/\mu}}_R \int_{\max\{v - \mu, p^* - \delta\}}^v |\alpha_k(s) - \alpha_{k-1}(s)| ds, \quad \forall k \geq 0.$$

By iterating the this inequality we find that

$$|\alpha_{k+1}(v) - \alpha_k(v)| \leq \max_{s \in [p^* - \delta, v_1]} |\alpha_1(s) - \alpha_0(s)| \frac{R^k \cdot (v - p^* + \delta)^k}{k!} \leq \frac{2}{\mu} \cdot \frac{R^k \cdot (v - p^* + \delta)^k}{k!},$$

and since the number on the right-most inequality are summable we can conclude, by Weierstrass M-test, that the series  $\sum_{k=0}^{\infty} (\alpha_{k+1}(v) - \alpha_k(v))$  converges absolutely and uniformly on  $[p^* - \delta, v_1]$ . This in turn implies that  $\alpha_k(v)$  converges uniformly on  $[p^* - \delta, v_1]$ , indeed, denote by  $S(v)$  the limit of the series above then

$$|\alpha_k(v) - \alpha_0(v) - S(v)| = \left| \sum_{i=0}^{k-1} (\alpha_{i+1}(v) - \alpha_i(v)) - S(v) \right|, \quad (63)$$

converges uniformly to zero on  $[p^* - \delta, v_1]$ . Let us use  $\alpha(v)$  to denote the limit of  $\alpha_k(v)$ . Note that by definition  $\alpha_k$  is continuous and, therefore, so is  $\alpha$ . In turn  $(T\alpha)(v)$  is well defined and we also have

$$\begin{aligned} \alpha(v) &= \lim_{v \rightarrow \infty} \alpha_k(v) \\ &= \lim_{v \rightarrow \infty} -\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v - \mu, p^* - \delta\}}^v \alpha_{k-1}(s) ds\right) \\ &= -\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v - \mu, p^* - \delta\}}^v \lim_{v \rightarrow \infty} \alpha_{k-1}(s) ds\right) \\ &= -\frac{e^{-1}}{\mu} \exp\left(-\int_{\max\{v - \mu, p^* - \delta\}}^v \alpha(s) ds\right), \end{aligned}$$

where the interchange of the limit and the integral is justified by the dominated converge theorem. This means that  $\alpha$  is a solution to Eq. (61) for any  $v \in [p^* - \delta, v_1]$ . But since  $v_1$  was chosen arbitrarily we conclude that  $\alpha(v) = \lim_{k \rightarrow \infty} \alpha_k(v)$  is a solution to Eq. (61) for all  $v \geq p^* - \delta$ . This completes the proof that  $y(v)$  is the unique a solution the delayed differential equation (60).

To conclude we verify that  $q$ —the unique solution to delayed differential equation (60)—is strictly decreasing and that it satisfies the exponential bounds. We note that  $\alpha(v) \in [-1/\mu, -e^{-1}/\mu]$  and, therefore,  $\alpha(v) < 0$  for all  $v \geq p^* - \delta$  which implies that  $q$  is strictly decreasing. Moreover, since  $y(v) = \exp\left(\int_{p^* - \delta}^v \alpha(s) ds\right)$  we have that

$$\exp\left(-\frac{(v - p^* + \delta)}{\mu}\right) \leq y(v) \leq \exp\left(-e^{-1} \frac{(v - p^* + \delta)}{\mu}\right), \quad \forall v \geq p^* - \delta. \quad (64)$$

This concludes the proof.



LEMMA 7. Let  $\Gamma(x)$  be given by

$$\Gamma(x) = \sum_{j=0}^{\lfloor x \rfloor + 1} \frac{(-1)^j e^{-j}}{j!} (x+1-j)^j, \quad x \geq 0.$$

Then  $\Gamma(x)$  is decreasing and is  $\Theta(xe^{-x})$  (here the  $\Theta$  notation is for large  $x$ ). Moreover,  $\limsup_{x \rightarrow \infty} \frac{\Gamma(x)}{xe^{-x}} \leq 2$  and  $\liminf_{x \rightarrow \infty} \frac{\Gamma(x)}{xe^{-x}} \geq 2e^{-1}$ .

**Proof of Lemma 7** First we show that  $\Gamma(\cdot)$  is decreasing, then we argue that is  $\Theta(xe^{-x})$ . At the end we prove the limits.

**Decreasing.** Note that  $\Gamma(x) = y(\mu x + p^* - \delta)$  where  $y$  is the solution to the delayed differential equation (60) (see Norkin et al. (1973) p.8). Since by Lemma 6  $y(v)$  is decreasing for  $v \geq p^* - \delta$ , we deduce that  $\Gamma(x)$  is decreasing for  $x \geq 0$ .

**Order.** We start by analyzing the terms

$$S_n = \sum_{j=0}^n \frac{(-1)^j e^{-j}}{j!} (n-j)^j.$$

We first show that  $S_n$  is  $\Theta(ne^{-n})$ . Then we will use this to argue the desired result. Let  $A_j(t)$  be the Eulerian polynomial defined by the generating function

$$\sum_{j=0}^{\infty} A_j(t) \frac{x^j}{j!} = \frac{t-1}{t - \exp((t-1)x)}. \quad (65)$$

Using the above, we have that  $A_j(t)$  satisfies the following relation

$$A_j(t) \frac{t}{(1-t)^{j+1}} = \sum_{k=0}^{\infty} k^j t^k, \quad \forall j \geq 0. \quad (66)$$

Now consider the generating function of  $S_n$ , with  $S_0 = 0$ , given by

$$S(t) \triangleq \sum_{n \geq 0} S_n t^n.$$

We will find an alternative expression for  $S(t)$  of the form  $\sum_{n \geq 0} q_n t^n$  where  $q_n$  is  $\Theta(ne^{-n})$ . This will imply that  $S_n$  is  $\Theta(ne^{-n})$ . Indeed,

$$\begin{aligned} S(t) &= \sum_{n \geq 0} S_n t^n = \sum_{n \geq 0} \sum_{j=0}^n \frac{(-e)^{-j}}{j!} (n-j)^j t^n = \sum_{j=0}^{\infty} \sum_{n=j}^{\infty} \frac{(-e)^{-j}}{j!} (n-j)^j t^n \\ &= \sum_{j=0}^{\infty} \frac{(-e)^{-j}}{j!} t^j \sum_{n=0}^{\infty} n^j t^n \\ &\stackrel{(66)}{=} \sum_{j=0}^{\infty} \frac{(-e)^{-j}}{j!} t^j \frac{t A_j(t)}{(1-t)^{j+1}} \\ &= \frac{t}{(1-t)} \sum_{j=0}^{\infty} \frac{A_j(t)}{j!} \left( \frac{e^{-1}t}{t-1} \right)^j \end{aligned}$$

$$\stackrel{(65)}{=} \frac{t}{(1-t)} \frac{t-1}{t - e^{e^{-1}t}}$$

$$= \frac{t}{e^{e^{-1}t} - t}.$$

Now, let  $\hat{S}(t) \triangleq S(e \cdot t)$  then  $\hat{S}(t) = \frac{t}{e^{t-1} - t}$ . Let  $x = t - 1$  hence

$$\frac{x+1}{e^x - x - 1} = \frac{x+1}{\sum_{k=2}^{\infty} \frac{x^k}{k!}} = \frac{2(x+1)}{x^2 \left(1 + \frac{x}{3} + \mathcal{O}(x^2)\right)}. \quad (67)$$

Note that

$$\frac{1}{1+x} = 1 - x + \mathcal{O}(x^2), \quad (68)$$

thus

$$\frac{x+1}{e^x - x - 1} = \frac{2(x+1)}{x^2} \left(1 - \frac{x}{3} + \mathcal{O}(x^2)\right) = \frac{2}{x^2} + \frac{4/3}{x} + \mathcal{O}(1). \quad (69)$$

In turn, this implies that

$$\hat{S}(t) = \frac{t}{e^{t-1} - t} = \frac{2}{(1-t)^2} - \frac{4/3}{1-t} + F(t) = \sum_{n=0}^{\infty} \left(2n + \frac{2}{3}\right) t^n + H(t), \quad (70)$$

where  $H(t)$  is function that does not have a pole at  $t = 1$ . Moreover, considering  $H$  defined in the complex plane, we can prove that  $H(t)$  does not have singularities in the unit disc with center at the origin. This will prove that  $H(t)$  is analytical in the closed unit disc and, therefore, it can be extended to be analytical in a disc of radius  $R > 1$ . In that disc, we have that because  $H(t)$  is analytical it can be expressed as  $H(t) = \sum_{n \geq 0} c_n t^n$ . In order to show that  $H$  does not have singularities, it is enough to verify that the function  $e^{t-1} - t$  only has a zero in the border of the disc. Consider  $t = r e^{i\theta}$  for  $r \in [0, 1]$  and  $\theta \in (-\pi, \pi]$ , then a zero can be found by solving  $e^{r e^{i\theta} - 1} = r e^{i\theta}$ . The latter equation becomes

$$e^{r \cos(\theta) - 1} \cos(r \sin(\theta)) = r \cos(\theta),$$

$$e^{r \cos(\theta) - 1} \sin(r \sin(\theta)) = r \sin(\theta).$$

The second equation above can only be true if  $r \sin(\theta) = 0$ . If it was true for  $r \sin(\theta) \neq 0$  then we would have that  $|y| = e^{r \cos(\theta) - 1} |\sin(y)|$  for some  $y \in [-1, 1]$ . However,  $|y| > |\sin(y)|$  for all  $y \neq 0$  and  $e^{r \cos(\theta) - 1} \leq 1$  for all  $\theta, r$ . Therefore,  $r \sin(\theta) = 0$  which in turn implies that  $\theta = 0$ . This yields  $e^{r-1} = r$  which can only be true for  $r = 1$ . This proves that  $H(t)$  is analytic in the closed disc and, therefore, it can be extended outside it. In turn we can write

$$H(t) = \sum_{n=0}^{\infty} c_n t^n, \quad \text{where } c_n = O(a^n) \text{ for some } a \in (0, 1),$$

Note that  $c_n = O(a^n)$  by Cauchy's inequality which establishes that for an analytical function  $H(z)$  we have

$$|c_n| \leq \frac{\sup_{|z|=R} H(z)}{R^n}, \quad \forall n \geq 0. \quad (71)$$

Then,

$$S(t) = \sum_{n=0}^{\infty} e^{-n} \left( 2n + \frac{2}{3} + c_n \right) t^n.$$

From this we conclude that

$$S_n = 2ne^{-n} + o(ne^{-n}).$$

To conclude, we need to show that  $\Gamma(x)$  is  $\Theta(xe^{-x})$ . Note that by definition  $\Gamma(x) = S_{\lfloor x \rfloor + 1}$ . Because  $S_n = \Theta(ne^{-n})$ , we must have that  $\Gamma(x) = \Theta((\lfloor x \rfloor + 1)e^{-(\lfloor x \rfloor + 1)})$  or, equivalently,  $\Gamma(x) = \Theta(xe^{-x})$ . As desired.

**Limits.** From the above we that

$$\frac{\Gamma(x)}{xe^{-x}} = \frac{S_{\lfloor x \rfloor + 1}}{xe^{-x}} = \frac{2 \cdot (\lfloor x \rfloor + 1) \cdot e^{-(\lfloor x \rfloor + 1)}}{xe^{-x}} + o(1).$$

Note that  $x - 1 \leq \lfloor x \rfloor \leq x$ . Hence,

$$2 \cdot e^{-1} \leq \frac{2 \cdot (\lfloor x \rfloor + 1) \cdot e^{-(\lfloor x \rfloor + 1)}}{xe^{-x}} \leq \frac{2(x+1)}{x}.$$

Taking the limit when  $x \rightarrow \infty$  delivers the bounds for the lim sup and lim inf in the statement of the lemma. This concludes the proof.

**LEMMA 8.** *Suppose that  $f$  is Lipschitz with constant  $C_f$  and that is bounded below by  $\underline{f}$  and above by  $\bar{f}$  both positive constants. Then the virtual value function,  $\psi(v) = v - \frac{\bar{F}(v)}{\underline{f}(v)}$ , is Lipschitz continuous.*

**Proof of Lemma 8** Consider  $v_1, v_2 \in [0, \bar{v}]$  then

$$\begin{aligned} |\psi(v_1) - \psi(v_2)| &\leq |v_1 - v_2| + \left| \frac{\bar{F}(v_1)}{\underline{f}(v_1)} - \frac{\bar{F}(v_2)}{\underline{f}(v_2)} \right| \\ &\leq |v_1 - v_2| + \frac{1}{\underline{f}^2} |\bar{F}(v_1)f(v_2) - \bar{F}(v_2)f(v_1)| \\ &= |v_1 - v_2| + \frac{1}{\underline{f}^2} |\bar{F}(v_1)(f(v_2) - f(v_1)) - f(v_1)(\bar{F}(v_2) - \bar{F}(v_1))| \\ &\leq |v_1 - v_2| + \frac{1}{\underline{f}^2} [|\bar{F}(v_1)(f(v_2) - f(v_1))| + |f(v_1)(\bar{F}(v_2) - \bar{F}(v_1))|] \\ &\leq |v_1 - v_2| + \frac{1}{\underline{f}^2} [|f(v_2) - f(v_1)| + \bar{f}|\bar{F}(v_2) - \bar{F}(v_1)|] \\ &\stackrel{(a)}{\leq} |v_1 - v_2| + \frac{1}{\underline{f}^2} [C_f|v_2 - v_1| + \bar{f}^2|v_2 - v_1|] \\ &= \left(1 + \frac{C_f + \bar{f}^2}{\underline{f}^2}\right) \cdot |v_1 - v_2|, \end{aligned}$$

where (a) comes from

$$|\overline{F}(v_2) - \overline{F}(v_1)| = \left| \int_{v_2}^{\overline{v}} f(v)dv - \int_{v_1}^{\overline{v}} f(v)dv \right| = \int_{\min\{v_1, v_2\}}^{\max\{v_1, v_2\}} f(v)dv \leq \overline{f}|v_1 - v_2|. \quad (72)$$

This concludes the proof.
