MAHLER MEASURE NUMEROLOGY

WADIM ZUDILIN

To David Boyd, an oustanding conductor of the Mahler measures, on the ocassion of his 80th birthday

ABSTRACT. We discuss some (conjectural) evaluations of L-values attached to elliptic curves of conductors 15, 21, 24 and 32 as 'hypergeometric periods'. These numerical observations are motivated by the Mahler measures of three-variable polynomials.

The (logarithmic) Mahler measure

$$m(P(x_1,...,x_k)) = \frac{1}{(2\pi i)^k} \int \cdots \int_{|x_1|=\cdots=|x_k|=1} \log |P(x_1,...,x_k)| \frac{dx_1}{x_1} \cdots \frac{dx_k}{x_k}$$

of an k-variable (Laurent) polynomial $P(x_1, \ldots, x_k) \in \mathbb{C}[x_1, \ldots, x_k]$ is a quite unique attractor of numerous problems in mathematics [3]. One of big problems (well open even in the case k = 1!) is the range of the Mahler measures attached to polynomials with *integer* coefficients [1]. A particular aspect of this problem is a remarkable connection of such Mahler measures to the L-values of algebraic varieties, usually related to the zero loci of the underlying polynomials $P(x_1, \ldots, x_k)$. Research in this direction originated in the 1990s: the works of Deninger [4], Boyd [2] and Rodriguez Villegas [8] set up in depth the story for the case of two-variable polynomials P(x, y) such that P(x, y) = 0 defines an elliptic curve. The papers all feature the family of two-variable Mahler measures

$$\mu(k) = m(k + (x + 1/x)(y + 1/y)),$$

which is indeed quite special. Illustrative examples for the range 0 < k < 4 include

$$\mu(1) = L'(E_{15a8}, 0), \quad \mu(\sqrt{2}) = 4L'(E_{56a1}, 0), \qquad \mu(2) = L'(E_{24a4}, 0),$$

$$\mu(2\sqrt{2}) = L'(E_{32a1}, 0), \qquad \mu(3) = \frac{1}{2}L'(E_{21a4}, 0), \quad \mu(2\sqrt{3}) \stackrel{?}{=} 2L'(E_{72a1}, 0),$$

where E_{NxM} refers to the elliptic curve labeled in accordance with [5] (the label corresponds to a Weierstrass form of the curve k + (x + 1/x)(y + 1/y) = 0 which is defined over \mathbb{Q} whenever $k^2 \in \mathbb{Q} \setminus \{0, 16\}$). Notice that for this range

$$\mu(k) = \frac{k}{4} \cdot {}_{3}F_{2} \left(\frac{\frac{1}{2}, \frac{1}{2}, \frac{1}{2}}{1, \frac{3}{2}} \mid \frac{k^{2}}{16} \right) = \int_{0}^{k/4} {}_{2}F_{1} \left(\frac{\frac{1}{2}, \frac{1}{2}}{1} \mid x^{2} \right) dx, \tag{1}$$

so that the Mahler measure evaluations can be translated into equalities of the L-values and the values of hypergeometric functions.

The L-values of conductor 15, 21 and 24 elliptic curves also show up, conjecturally(!), in the three-variable Mahler measures¹

$$m(1+x+y+xy+z) \stackrel{?}{=} -2L'(E_{15},-1) = \frac{15^2}{4\pi^4}L(E_{15},3) = 0.4839979734...,$$

$$m((1+x)^2+y+z) \stackrel{?}{=} -L'(E_{24},-1) = \frac{72}{\pi^4}L(E_{24},3) = 0.7025655062...,$$

$$m(1+x+y-xy+z) \stackrel{?}{=} -\frac{5}{4}L'(E_{21},-1) = \frac{5\cdot 21^2}{32\pi^4}L(E_{21},3) = 0.6242499823....$$

The Mahler measures in all these cases are reduced to hypergeometric integrals [3, Section 6.3] (see also [9]), and there are also hypergeometric expressions available for $L'(E_{32}, -1)$ [10]. Here we highlight the corresponding formulae for the L-values, dropping off the intermediate Mahler measures, and give some additional formulae that are not linked to known conjectures on the Mahler measures but reflect similarities with the two-variable expression (1).

Conductor 15 (k = 1): The expectation in this case is

$$-L'(E_{15}, -1) \stackrel{?}{=} \frac{1}{\pi} \int_{1/4}^{1} {}_{2}F_{1} \left(\frac{1}{2}, \frac{1}{2} \mid 1 - x^{2} \right) \log(4x) dx$$

$$= -\frac{1}{\pi} \int_{0}^{1/4} {}_{2}F_{1} \left(\frac{1}{2}, \frac{1}{2} \mid 1 - x^{2} \right) \log(4x) dx. \tag{2}$$

Notice the induced evaluation

$$\frac{1}{\pi} \int_0^1 {}_2F_1\left(\frac{\frac{1}{2}, \frac{1}{2}}{1} \mid 1 - x^2\right) \log(4x) \, \mathrm{d}x = 0 \tag{3}$$

established in [9]. There is a complimentary observation of H. Cohen (2018) in this case, not related to a Mahler measure:

$$L'(E_{15}, -2) \stackrel{?}{=} \frac{12}{\pi^2} \int_0^{1/4} {}_2F_1\left(\frac{1}{2}, \frac{1}{2} \mid x^2\right) \log^2(4x) \, \mathrm{d}x. \tag{4}$$

Conductor 21 (k = 3): Here we expect

$$-5L'(E_{21},-1) \stackrel{?}{=} \frac{2}{\pi} \int_{1/4}^{2} {}_{2}F_{1}\left(\frac{\frac{1}{2},\frac{1}{2}}{1} \middle| 1 - (1-x)^{2}\right) \log(4x) dx. \tag{5}$$

The argument $2x - x^2$ of the hypergeometric integrand in (5) ranges between $1 - k^2/16$ and 1 when $\frac{1}{4} < x < 1$ and then between 1 and 0 when 1 < x < 2. Thus, taking into account the evaluation²

$$\frac{7\zeta(3)}{\pi^2} = -28\zeta'(-2) = \frac{1}{\pi} \int_0^1 {}_2F_1\left(\frac{1}{2}, \frac{1}{2} \mid 1 - x^2\right) \log(4(1+x)) \, \mathrm{d}x \tag{6}$$

for the second part (see also (3)), our main expectation is

$$-\frac{5}{2}L'(E_{21},-1) + 28\zeta'(-2) \stackrel{?}{=} \frac{1}{\pi} \int_0^{3/4} {}_2F_1\left(\begin{array}{c} \frac{1}{2}, \frac{1}{2} \\ 1 \end{array} \middle| 1 - x^2\right) \log(4(1-x)) \, \mathrm{d}x. \tag{7}$$

Conductor 24 (k = 2): We know in this case [9] that

$$-L'(E_{24}, -1) \stackrel{?}{=} \frac{2\sqrt{2}}{\pi\sqrt{\pi}} \sum_{n=0}^{\infty} \frac{(\frac{1}{2})_n \Gamma(\frac{n}{2} + \frac{3}{4})}{n! \Gamma(\frac{n}{2} + \frac{5}{4}) (2n+1)^2} \left(\frac{1}{2}\right)^n$$

$$= \frac{8\Gamma(\frac{3}{4})^2}{\pi^{5/2}} {}_{5}F_4\left(\frac{\frac{1}{4}, \frac{1}{4}, \frac{1}{4}, \frac{3}{4}, \frac{3}{4}}{\frac{1}{2}, \frac{5}{4}, \frac{5}{4}} \left|\frac{1}{4}\right) + \frac{\Gamma(\frac{1}{4})^2}{54\pi^{5/2}} {}_{5}F_4\left(\frac{\frac{3}{4}, \frac{3}{4}, \frac{5}{4}, \frac{5}{4}}{\frac{7}{4}, \frac{7}{4}} \left|\frac{1}{4}\right).$$

$$(8)$$

However there is an identification of $L'(E_{24}, -1)$ similar to (2) and (7) but not related to a Mahler measure:

$$-2L'(E_{24}, -1) + 28\zeta'(-2) \stackrel{?}{=} \frac{1}{\pi} \int_0^{2/4} {}_2F_1\left(\frac{1}{2}, \frac{1}{2} \mid 1 - x^2\right) \log\left(\frac{1-x}{x}\right) dx. \tag{9}$$

In a different direction, here is a striking connection of (8) with other L-values of the same elliptic curve³:

$$L'(E_{24},0) \stackrel{?}{=} \frac{1}{\sqrt{2\pi}} \sum_{n=0}^{\infty} \frac{\left(\frac{1}{2}\right)_n \Gamma\left(\frac{n}{2} + \frac{3}{4}\right)}{n! \Gamma\left(\frac{n}{2} + \frac{5}{4}\right) (2n+1)} \left(-\frac{1}{2}\right)^n, \tag{10}$$

$$L(E_{24}, 1) = \frac{\sqrt{\pi}}{4\sqrt{2}} \sum_{n=0}^{\infty} \frac{\left(\frac{1}{2}\right)_n \Gamma\left(\frac{n}{2} + \frac{3}{4}\right)}{n! \Gamma\left(\frac{n}{2} + \frac{5}{4}\right)} \left(\frac{1}{2}\right)^n.$$
(11)

These two evaluations can be compared with

$$L'(E_{24},0) = \frac{1}{2} \sum_{n=0}^{\infty} \frac{\left(\frac{1}{2}\right)_n^2}{n!^2 (2n+1)} \left(\frac{1}{4}\right)^n, \tag{12}$$

$$L(E_{24}, 1) = \frac{\pi}{8} \sum_{n=0}^{\infty} \frac{\left(\frac{1}{2}\right)_n^2}{n!^2} \left(1 - \frac{1}{4}\right)^n, \tag{13}$$

where the first one comes out of the formula for $\mu(2)$ interpreted through (1).

$$\begin{split} &\frac{\sqrt{\pi}}{2} \sum_{n=0}^{\infty} \frac{(\frac{1}{2})_n \, \Gamma(\frac{n}{2} + \frac{3}{4})}{n! \, \Gamma(\frac{n}{2} + \frac{5}{4})} \, z^n = \sum_{n=0}^{\infty} \frac{(\frac{1}{2})_n}{n!} \, z^n \int_0^1 t^{n+1/2} (1-t^2)^{-1/2} \, \mathrm{d}t = \int_0^1 \frac{\sqrt{t}}{\sqrt{(1-t^2)(1-zt)}} \, \mathrm{d}t \\ &= \sqrt{2} \left(\int_0^1 \frac{\mathrm{d}u}{(1-\frac{1}{2}u^2)\sqrt{(1-u^2)(1-\frac{1}{2}(1+z)u^2)}} - \int_0^1 \frac{\mathrm{d}u}{\sqrt{(1-u^2)(1-\frac{1}{2}(1+z)u^2)}} \right) \end{split}$$

to arrive, when $z = \frac{1}{2}$, at

$$\int_0^1 \frac{\mathrm{d}u}{(1 - \frac{1}{2}u^2)\sqrt{(1 - u^2)(1 - \frac{3}{4}u^2)}} = \frac{3}{2} \int_0^1 \frac{\mathrm{d}u}{\sqrt{(1 - u^2)(1 - \frac{3}{4}u^2)}},$$

and this allows one to conclude with (11) from (13). There seems to be no simple relation like this for $z = -\frac{1}{2}$ (and for other values of z from the real interval |z| < 1). This fact makes it difficult to lift the finding to (10).

Conductor 32 $(k = 2\sqrt{2})$: Here we have the following [10]:

$$-L'(E_{32}, -1) = \frac{\Gamma(\frac{1}{4})^2}{6\sqrt{2}\pi^{5/2}} {}_{4}F_{3}\begin{pmatrix} 1, 1, 1, \frac{1}{2} \\ \frac{7}{4}, \frac{3}{2}, \frac{3}{2} \end{pmatrix} 1 + \frac{4\Gamma(\frac{3}{4})^2}{\sqrt{2}\pi^{5/2}} {}_{4}F_{3}\begin{pmatrix} 1, 1, 1, \frac{1}{2} \\ \frac{5}{4}, \frac{3}{2}, \frac{3}{2} \end{pmatrix} 1$$

$$+ \frac{\Gamma(\frac{1}{4})^2}{2\sqrt{2}\pi^{5/2}} {}_{4}F_{3}\begin{pmatrix} 1, 1, 1, \frac{1}{2} \\ \frac{3}{4}, \frac{3}{2}, \frac{3}{2} \end{pmatrix} 1 .$$

$$(14)$$

Conjecturally we find out the following representation resembling (2), (7) and (9):

$$-L'(E_{32}, -1) \stackrel{?}{=} \frac{1}{\pi} \int_0^{2\sqrt{2}/4} {}_2F_1\left(\frac{1}{2}, \frac{1}{2} \mid 1 - x^2\right) \log\left(\frac{1 - x^2}{x^2}\right) dx. \tag{15}$$
