Spectral analysis and long-time asymptotics of the generalized AKNS equation

Abstract In this paper, we obtain the long-time asymptotics of the generalized AKNS equation via Defit-Zhou method (Nonlinear steepest descent method). The Cauchy problem of the generalized AKNS equation is transformed into the corresponding Riemann-Hilbert problem on the basis of the Lax pair and the scattering matrix. After that Riemann-Hilbert problems are converted through a decomposition of the matrix-valued spectral function and factorizations of the jump matrix for Riemann-Hilbert problem. Finally, by solving the last model problem, the long-time asymptotics of the generalized AKNS equation are derived.

Keywords Riemann-Hilbert problem; Generalized AKNS equation; Nonlinear steepest descent method; Long-time asymptotics

1. Introduction

The research of nonlinear partial differential equations (NLPDEs) has played an important role in the development of science and technology. Nowadays, NLPDEs can be used to explain some complex physical phenomena, including mathematics, plasma physics, aerodynamics, fluid mechanics, atmospheric oceans, etc [1-8]. Hirota bilinear method[9,10], Darboux transformation[11,12], the inverse scattering transformation[13] and so on are effective method to solve NLPDEs. Especially, the inverse scattering transformation is the first method found to be used to obtain the exact solution of the soliton equation, and it is called an effective method for analyzing the initial value of the integrable evolution equation on a straight line[14-16]. In 1993, Defit and Zhou proposed the famous nonlinear steepest descent method to analyze the long-time asymptotic behavior of integrable evolution equations[17]. And Defit and Zhou analyzed the long-time asymptotic behavior of the solution to the initial value problem of the famous mKdV equation and Schrödinger equation[17,18]. Subsequently, the nonlinear steepest descent method was extended to the study of integrable evolution equations. In recent years, Fan and Geng researched some long-time asymptotic behavior of integrable evolution equations based on the method[19-24].

In this paper, we study the equation derived from the Lax pair given by Yishen Li[25]. The Lax pair is

$$\psi_x = -iz\sigma_3\psi + P\psi,$$

$$\psi_t = (\vartheta z^3 + \iota z^2 + \kappa z + \varsigma)\sigma_3\psi + Q\psi,$$

where $\psi(z; x, t)$ is a 2×2 matrix, $\sigma_3 = \text{diag}(1, -1)$, and

$$P = \begin{pmatrix} 0 & u \\ v & 0 \end{pmatrix},$$

$$Q = i\vartheta z^2 P - iz \begin{pmatrix} \frac{i\vartheta}{2}uv & -\frac{i\vartheta}{2}u_x - \iota u \\ \frac{i\vartheta}{2}v_x - \iota v & -\frac{i\vartheta}{2}uv \end{pmatrix} - \begin{pmatrix} \frac{i\vartheta}{4}(uv_x - vu_x) - \frac{\iota}{2}uv & -\frac{i\vartheta}{4}(-u_{xx} + 2u^2v) + \frac{\iota}{2}u_x - i\kappa u \\ \frac{-i\vartheta}{4}(-v_{xx} + 2uv^2) - \frac{\iota}{2}v_x - i\kappa v & -\frac{i\vartheta}{4}(uv_x - vu_x) + \frac{\iota}{2}uv \end{pmatrix}$$

$$(1.2)$$

The Lax pair (1.1) derive the following equation:

$$\begin{cases} u_t = -\frac{i\vartheta}{4}(u_{xxx} - 6uvu_x) - \frac{\iota}{2}(u_{xx} - 2u^2v) + i\kappa u_x + 2\varsigma u, \\ v_t = -\frac{i\vartheta}{4}(v_{xxx} - 6uvv_x) + \frac{\iota}{2}(v_{xx} - 2v^2u) + i\kappa v_x - 2\varsigma v. \end{cases}$$
(1.3)

(I) Take $\vartheta = -4i$, $\iota = \kappa = \varsigma = 0$, v = -1, Eq.(1.3) reduces to KdV equation

$$u_t + 6uu_x + u_{xxx} = 0. (1.4)$$

(II) Take $\vartheta = -4i$, $\iota = \kappa = \varsigma = 0$, v = -u, Eq.(1.3) reduces to generalized KdV equation

$$u_t + 6u^2u_x + u_{xxx} = 0. (1.5)$$

(III) Take $\iota = -2i$, $\vartheta = \kappa = \varsigma = 0$, $v = \mp \overline{u}$, Eq.(1.3) reduces to nonlinear Schrödinger equation

$$iu_t + u_{xx} \pm 2u^2 \overline{u} = 0, \tag{1.6}$$

where superscript bar denotes complex conjugate.

(IV)Take $\iota = -2$, $\vartheta = \kappa = \varsigma = 0$, $q_x = uv = (\frac{u_x}{u})_x$, Eq.(1.3) reduces to Burger equation

$$q_t = 2qq_x - q_{xx}. (1.7)$$

Especially, take $\vartheta = -i\alpha$ ($\alpha > 0$), $\iota = \kappa = \varsigma = 0$ and $v = \overline{u}$, Eq.(1.3) reduces to the generalized AKNS equation

$$u_t = \frac{\alpha}{4}(-u_{xxx} + 2(|u|^2 u)_x), \tag{1.8}$$

where u(x,t) is complex-valued function of variate (x,t).

In this paper, we use Defit-Zhou nonlinear steepest descent method to study long-time asymptotics of Eq.(1.8) with Schwartz decaying initial data

$$u(t=0,x)=u_0(x)\in\mathcal{S}(\mathbb{R}).$$

We know that long-time asymptotics of Eq.(1.8) has not been researched, the main result is presented in the following theorem.

Theorem 1.1 u(x,t) be the solution for the Cauchy problem of the generalized AKNS equation (1.8) with $u_0 \in \mathcal{S}(\mathbb{R})$, where $\mathcal{S}(\mathbb{R})$ represents Schwartz space: $\mathcal{S}(\mathbb{R}) = f \in C^{\infty}(R)$, $||f||_{\alpha,\beta} = \sup|x^{\alpha}\partial^{\beta}f(x)| < \infty$, $\alpha, \beta \in Z_+$. For x < 0 and $\frac{x}{t} \leq C$, the leading asymptotics of u(x,t) has the form:

$$u(x,t) = \frac{ve^{\frac{\pi v}{2}}}{\sqrt{6\alpha t z_0 \pi}} ((\delta_B^0)^2 e^{-\frac{3\pi i}{4}} \Gamma(iv) \overline{r(z_0)} - (\delta_B^0)^{-2} e^{\frac{3\pi i}{4}} \Gamma(-iv) r(z_0)) + o(c(z_0)t^{-1}logt)$$
(1.9)

where C is a constant, Γ is the Gamma function, c is a rapidly decreasing function, and

$$\begin{split} \delta_B^0 &= (12\alpha t(z_0)^3)^{-\frac{i\nu}{2}} e^{2i\alpha tz_0^3} e^{\chi(z_0)}, \\ z_0 &= \sqrt{-\frac{x}{3\alpha t}}, \ v = -\frac{1}{2\pi}log(1-|r(z_0)|^2), \\ \chi(z_0) &= \frac{1}{2\pi i} \int_{-z_0}^{z_0} log(\frac{1-|r(\xi_0)|^2}{1-|r(z_0)|^2}) \frac{d\xi}{\xi-z}. \end{split}$$

The outline of this paper is as follows. In section 2, we analyze eigenfunction and spectral function of Eq.(1.8) to construct a original Riemann-Hilbert problem. In section 3, by deforming the jump matrix of the original Riemann-Hilbert problem and extending region, the original Riemann-Hilbert problem is transformed into a model Riemann-Hilbert problem. Then the solution of the model Riemann-Hilbert problem can be expressed by the solution of Weber equation. Finally, we obtain the long-time asymptotics of the Cauchy problem for the generalized AKNS equation.

2. The Riemann-Hilbert Problems

In this section, we first make use of the Lax pair of the generalized AKNS equation to construct the matrix Jost solutions. Then the Cauchy problem of the generalized AKNS equation turns into Riemann-Hilbert problem.

We make a transformation

$$\mu(z;x,t) = \psi(z;x,t)e^{izx\sigma_3 + i\alpha z^3t\sigma_3},\tag{2.1}$$

Eq.(2.1) satisfy the following Lax pair

$$\mu_x = iz[\mu, \sigma_3] + P\mu,$$

$$\mu_t = i\alpha z^3[\mu, \sigma_3] + Q\mu,$$
(2.2)

where $e^{\sigma_3} = \operatorname{diag}(e, e^{-1})$, $[\mu, \sigma_3] = \mu \sigma_3 - \sigma_3 \mu$. Lax pair (2.2) can be written as following total differential form

$$d(e^{(izx+i\alpha z^3t)\hat{\sigma}_3}\mu) = e^{(izx+i\alpha z^3t)\hat{\sigma}_3}[(Pdx+Qdt)\mu], \tag{2.3}$$

where $e^{\hat{\sigma}_3}u = e^{\sigma_3}ue^{-\sigma_3}$. To analyze the eigenfunction $\mu(z;x,t)$, we choose two special integral paths

$$(-\infty, t) \to (x, t), \quad and \quad (\infty, t) \to (x, t),$$
 (2.4)

and acquire two eigenfunctions of Lax pair (2.2)

$$\mu_{1}(z;x,t) = I + \int_{-\infty}^{x} e^{-iz(x-\xi)\hat{\sigma}_{3}} P(z;\xi,t) \mu_{1}(z;\xi,t) d\xi,$$

$$\mu_{2}(z;x,t) = I - \int_{x}^{\infty} e^{-iz(x-\xi)\hat{\sigma}_{3}} P(z;\xi,t) \mu_{2}(z;\xi,t) d\xi.$$
(2.5)

 $\mu_1(z;x,t)$ and $\mu_2(z;x,t)$ have the following asymptotics

$$\mu_1(z; x, t), \mu_2(z; x, t) \to I, \quad x \to \pm \infty,$$

 $\mu_1(z; x, t), \mu_2(z; x, t) \to I, \quad z \to \infty.$ (2.6)

Lax pair (1.1) is first order linear homogeneous equations, $\psi_1(z;x,t) = \mu_1(z;x,t)e^{-i\theta(z)\hat{\sigma}_3}$ and $\psi_2(z;x,t) = \mu_2(z;x,t)e^{-i\theta(z)\hat{\sigma}_3}$ are solution of Lax pair (1.1), then $\psi_1(z;x,t)$ and $\psi_2(z;x,t)$ are linearly correlated, thus we have

$$\mu_1(z; x, t) = \mu_2(z; x, t)e^{-i\theta(z)\hat{\sigma}_3}S(z), \tag{2.7}$$

where

$$\theta(z) = zx + \alpha z^3 t, \quad S(z) = \begin{pmatrix} s_{11}(z) & s_{12}(z) \\ s_{21}(z) & s_{22}(z) \end{pmatrix},$$

S(z) is irrelevant to x, t and it is called as the spectral matrix function. Nextly, we study the analyticity of $\mu_1(z; x, t)$, $\mu_2(z; x, t)$ and S(z). For integral equation (2.5), when $\xi < x$, we have

$$e^{-iz(x-\xi)\hat{\sigma}_3}P(z;\xi,t) = \begin{pmatrix} 0 & ue^{-2iz(x-\xi)} \\ \overline{u}e^{2iz(x-\xi)} & 0 \end{pmatrix}, \tag{2.8}$$

$$e^{2iz(x-\xi)} = e^{2i(x-\xi)Rez}e^{-2(x-\xi)Imz}, \quad e^{-2iz(x-\xi)} = e^{-2i(x-\xi)Rez}e^{2(x-\xi)Imz}.$$

By direct calculation, first column of $\mu_1(z; x, t)$ is analytical in the upper half plane \mathbb{C}_+ , second column of $\mu_1(z; x, t)$ is analytical in the lower half plane \mathbb{C}_- , $\mu_1(z; x, t)$ can be written as

$$\mu_1 = \begin{pmatrix} \mu_1^{(11)} & \mu_1^{(12)} \\ \mu_1^{(21)} & \mu_1^{(22)} \end{pmatrix} = (\mu_1^+, \mu_1^-). \tag{2.9}$$

In the same way, first column of $\mu_2(z; x, t)$ is analytical in the lower half plane \mathbb{C}_- and second column of $\mu_2(z; x, t)$ is analytical in the upper half plane \mathbb{C}_+ , $\mu_2(z; x, t)$ can be written as

$$\mu_2 = \begin{pmatrix} \mu_2^{(11)} & \mu_2^{(12)} \\ \mu_2^{(21)} & \mu_2^{(22)} \end{pmatrix} = (\mu_2^-, \mu_2^+). \tag{2.10}$$

In virtue of $tr(P - iz\sigma_3) = 0$ and $tr(Q - i\alpha z^3\sigma_3) = 0$, by using Abel formula, we get

$$(\det \psi_j)_x = tr(P - iz\sigma_3)\det \psi_j = 0,$$

$$(\det \psi_j)_t = tr(Q - i\alpha z^3\sigma_3)\det \psi_j = 0,$$
(2.11)

then through transformation (2.1), we have

$$det\mu_j = det\psi_j det(e^{i\theta(z)\sigma_3}) = det\psi_j, \tag{2.12}$$

therefore, we obtain

$$(\det \mu_j)_x = (\det \mu_j)_t = 0. \tag{2.13}$$

Which imply that $det \mu_j$ is independent of x and t, and $\mu_j \to I$, $|x| \to \infty$, so we have

$$det\mu_j = \lim_{|x| \to \infty} det\mu_j = det(\lim_{|x| \to \infty} \mu_j) = 1,$$
(2.14)

taking determinants on both sides of Eq.(2.7), yield

$$detS(z) = 1. (2.15)$$

From Eq.(2.14), we know that $\mu_1(z;x,t)$, $\mu_2(z;x,t)$ are invertible matrix. Based on analyticity of the column vector of $\mu_1(z;x,t)$, $\mu_2(z;x,t)$, it can be inferred that first row and second row of $\mu_1^{-1}(z;x,t)$ is analytical in the lower half plane \mathbb{C}_+ and the upper half plane \mathbb{C}_+ respectively; first row and second row of $\mu_2^{-1}(z;x,t)$ is analytical in the upper half plane \mathbb{C}_+ and the lower half plane \mathbb{C}_- respectively. That is

$$\mu_1^{-1} = \begin{pmatrix} \mu_1^{(22)} & -\mu_1^{(12)} \\ -\mu_1^{(21)} & \mu_1^{(11)} \end{pmatrix} = \begin{pmatrix} \hat{\mu}_1^- \\ \hat{\mu}_1^+ \end{pmatrix}, \tag{2.16}$$

$$\mu_2^{-1} = \begin{pmatrix} \mu_2^{(22)} & -\mu_2^{(12)} \\ -\mu_2^{(21)} & \mu_2^{(11)} \end{pmatrix} = \begin{pmatrix} \hat{\mu}_2^+ \\ \hat{\mu}_2^- \end{pmatrix}, \tag{2.17}$$

Through Eq.(2.7), Eq.(2.16) and Eq.(2.17), we get

$$e^{-i\theta(z)\hat{\sigma}_3}S(z) = \mu_2^{-1}\mu_1 = \begin{pmatrix} \hat{\mu}_2^+ \\ \hat{\mu}_2^- \end{pmatrix}(\mu_1^+, \mu_1^-) = \begin{pmatrix} \hat{\mu}_2^+ \mu_1^+ & \hat{\mu}_2^+ \mu_1^- \\ \hat{\mu}_2^- \mu_1^+ & \hat{\mu}_2^- \mu_1^- \end{pmatrix}. \tag{2.18}$$

From Eq.(2.18), we know that $s_{11}(z)$ is analytical in the upper half plane \mathbb{C}_+ , $s_{22}(z)$ is analytical in the lower half plane \mathbb{C}_- , $s_{12}(z)$ and $s_{21}(z)$ are continuous to the real axis, but not analytical in the upper and lower half plane.

Theorem 2.1 The eigenfunctions $\mu_1(z;x,t)$, $\mu_2(z;x,t)$ and spectral matrix function S(z) have the following symmetry property

$$\mu_j(z; x, t) = \sigma_1 \overline{\mu_j(\overline{z}; x, t)} \sigma_1, \quad (j = 1, 2)$$

$$S(z) = \sigma_1 \overline{S(\overline{z})} \sigma_1, \quad (2.19)$$

where $\sigma_1 = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$.

Proof. From Lax pair (2.2), we have

$$\mu_{j,x}(z;x,t) + iz[\sigma_3, \mu_j(z;x,t)] = P\mu_j(z;x,t), \tag{2.20}$$

replace z with \overline{z} , then take the conjugate of Eq.(2.20), get

$$\overline{\mu_{j,x}(\overline{z};x,t)} - iz[\sigma_3, \overline{\mu_j(\overline{z};x,t)}] = \overline{P}\overline{\mu_j(\overline{z};x,t)}. \tag{2.21}$$

Multiply the left and right sides of Eq. (2.21) by σ_1 , notice that

$$\sigma_1 \sigma_3 \sigma_1 = -\sigma_3, \quad \sigma_1 \overline{P} \sigma_1 = P,$$
 (2.22)

and

$$\left[\sigma_{1}\overline{\mu_{j}(\overline{z};x,t)}\sigma_{1}\right]_{x} - iz\sigma_{1}\sigma_{3}\overline{\mu_{j}(\overline{z};x,t)}\sigma_{1} + iz\sigma_{1}\overline{\mu_{j}(\overline{z};x,t)}\sigma_{3}\sigma_{1} = \sigma_{1}\overline{P}\overline{\mu_{j}(\overline{z};x,t)}\sigma_{1}. \tag{2.23}$$

Therefore we obtain

$$[\sigma_1 \overline{\mu_i(\overline{z}; x, t)} \sigma_1]_x + iz[\sigma_3, \sigma_1 \overline{\mu_i(\overline{z}; x, t)} \sigma_1] = P\sigma_1 \overline{\mu_i(\overline{z}; x, t)} \sigma_1. \tag{2.24}$$

By comparing with Eq.(2.2) and Eq.(2.24), we know that $\mu_j(z;x,t)$ and $\sigma_1\overline{\mu_j(\overline{z};x,t)}\sigma_1$ satisfy the same differential equation and have the same asymptotic property: $\mu_j(z;x,t)$, $\sigma_1\overline{\mu_j(\overline{z};x,t)}\sigma_1 \to I$, $x \to \infty$. Consequently,

$$\mu_j(z;x,t) = \sigma_1 \overline{\mu_j(\overline{z};x,t)} \sigma_1, \qquad (2.25)$$

that is

$$\begin{pmatrix} \mu_{11}(z) & \mu_{12}(z) \\ \mu_{21}(z) & \mu_{22}(z) \end{pmatrix} = \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix} \begin{pmatrix} \overline{\mu_{11}(\overline{z})} & \overline{\mu_{12}(\overline{z})} \\ \overline{\mu_{21}(\overline{z})} & \overline{\mu_{22}(\overline{z})} \end{pmatrix} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix} = \begin{pmatrix} \overline{\mu_{22}(\overline{z})} & \overline{\mu_{21}(\overline{z})} \\ \overline{\mu_{11}(\overline{z})} & \overline{\mu_{11}(\overline{z})} \end{pmatrix}. \tag{2.26}$$

By comparing the two sides of the above equation, we have $\mu_{11}(z) = \overline{\mu_{22}(\overline{z})}$, $\mu_{12}(z) = \overline{\mu_{21}(\overline{z})}$. Nextly, we analyze the symmetry property of S(z). By deforming Eq.(2.7), we obtain

$$S(z) = e^{(izx + i\alpha z^3 t)\hat{\sigma}_3} (\mu_2^{-1}(z; x, t)\mu_1(z; x, t)), \tag{2.27}$$

we already know that $\mu_j(z;x,t) = \sigma_1 \overline{\mu_j(\overline{z};x,t)} \sigma_1$, then

$$\sigma_{1}\overline{S(\overline{z})}\sigma_{1} = \sigma_{1}e^{(-izx - i\alpha z^{3}t)\hat{\sigma}_{3}}\overline{\mu_{2}^{-1}(\overline{z})}\overline{\mu_{1}(\overline{z})}\sigma_{1}$$

$$= \sigma_{1}e^{(-izx - i\alpha z^{3}t)\sigma_{3}}\sigma_{1}\sigma_{1}\overline{\mu_{2}^{-1}(\overline{z})}\sigma_{1}\sigma_{1}\overline{\mu_{1}(\overline{z})}\sigma_{1}\sigma_{1}e^{(izx + i\alpha z^{3}t)\sigma_{3}}\sigma_{1}$$

$$= e^{(izx + i\alpha z^{3}t)\sigma_{3}}\mu_{2}^{-1}(z)\mu_{1}(z)e^{(-izx - i\alpha z^{3}t)\sigma_{3}}$$

$$= S(z).$$

$$(2.28)$$

So we get $\overline{s_{11}(\overline{z})} = s_{22}(z)$ and $\overline{s_{12}(\overline{z})} = s_{21}(z)$.

Theorem 2.2 The eigenfunction $\mu_1(z; x, t)$, $\mu_2(z; x, t)$ and spectral matrix function S(z) also have the following symmetry property

$$\sigma_3 \mu_j^H(\overline{z}; x, t) \sigma_3 = \mu_j^{-1}(z; x, t),$$

$$\sigma_3 S^H(\overline{z}) \sigma_3 = S^{-1}(z).$$
(2.29)

where superscript H denotes conjugate transpose and $\sigma_3 = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$.

Proof: By direct calculation

$$\sigma_{3}\mu_{j}^{H}(\overline{z};x,t)\sigma_{3} = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \begin{pmatrix} \mu_{j,11}(\overline{z},x,t) & \mu_{j,12}(\overline{z},x,t) \\ \mu_{j,21}(\overline{z},x,t) & \mu_{j,22}(\overline{z},x,t) \end{pmatrix}^{H} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \\
= \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \begin{pmatrix} \overline{\mu_{j,11}}(\overline{z},x,t) & \overline{\mu_{j,21}}(\overline{z},x,t) \\ \overline{\mu_{j,12}}(\overline{z},x,t) & \overline{\mu_{j,22}}(\overline{z},x,t) \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \\
= \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \begin{pmatrix} \mu_{j,22}(z) & \mu_{j,12}(z) \\ \mu_{j,21}(z) & \mu_{j,11}(z) \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \\
= \begin{pmatrix} \mu_{j,22}(z) & -\mu_{j,12}(z) \\ -\mu_{j,21}(z) & \mu_{j,11}(z) \end{pmatrix} \\
= \mu_{j}^{-1}(z;x,t). \tag{2.30}$$

Therefore, we have $\overline{\mu_{11}(\overline{z})} = \mu_{22}(z), \ \overline{\mu_{12}(\overline{z})} = \mu_{21}(z).$ In addition,

$$\begin{split} &\sigma_{3}S^{H}(\overline{z})\sigma_{3}\\ &=\sigma_{3}(e^{(i\overline{z}x+i\alpha\overline{z}^{3}t)\sigma_{3}}\mu_{2}^{-1}(\overline{z})\mu_{1}(\overline{z})e^{(-i\overline{z}x-i\alpha\overline{z}^{3}t)\sigma_{3}})^{H}\sigma_{3}\\ &=\sigma_{3}(e^{(-izx-i\alphaz^{3}t)\sigma_{3}}\overline{\mu_{2}^{-1}(\overline{z})}\overline{\mu_{1}(\overline{z})}e^{(izx+i\alphaz^{3}t)\sigma_{3}})^{T}\sigma_{3}\\ &=\sigma_{3}e^{(izx+i\alphaz^{3}t)\sigma_{3}}\overline{\mu_{1}(\overline{z})}^{T}\overline{\mu_{2}^{-1}(\overline{z})}^{T}e^{(-izx-i\alphaz^{3}t)\sigma_{3}}\sigma_{3}\\ &=\sigma_{3}e^{(izx+i\alphaz^{3}t)\sigma_{3}}\sigma_{3}\sigma_{3}\mu_{1}^{H}(\overline{z})\sigma_{3}\sigma_{3}(\mu_{2}^{-1}(\overline{z}))^{H}\sigma_{3}\sigma_{3}e^{(-izx-i\alphaz^{3}t)\sigma_{3}}\\ &=e^{(izx+i\alphaz^{3}t)\sigma_{3}}\mu_{1}^{-1}(z)\mu_{2}(z)e^{(-izx-i\alphaz^{3}t)\sigma_{3}}\\ &=e^{(izx+i\alphaz^{3}t)\sigma_{3}}\mu_{1}^{-1}(z)\mu_{2}(z)e^{(-izx-i\alphaz^{3}t)\sigma_{3}}\\ &=S^{-1}(z), \end{split}$$

3. Long-Time Asymptotic Behavior

3.1. Factorization of the jump matrix

Notice that there are two oscillatory terms $e^{it\theta(z)}$ and $e^{-it\theta(z)}$ in the jump matrix v(z;x,t), take

Now we seek a transformation to eliminate the middle diagonal matrix in $z \in (-z_0, z_0)$ factorization. Make a transformation

$$= \begin{pmatrix} 1 & -\delta_{-}^{2}\overline{r(\overline{z})}e^{-2it\theta(z)} \\ 0 & 1 \end{pmatrix} \begin{pmatrix} 1 & 0 \\ \delta_{-}^{-2}r(z)e^{2it\theta(z)} & 1 \end{pmatrix}.$$




Fig.2 Symbol distribution map of $Re(i\theta(z))$.




Figure 3. The oriented contour $\Sigma^{(2)}$.




Figure 4. The oriented contour $\Sigma^{(3)}$.




Figure 4. The oriented contour $\hat{\Sigma}^{(3)}$.




Figure 5. The oriented contour Σ .

(3.119)

 $M^{A0}(z) = I + \frac{M_1^{A0}}{z} + o(z^{-2}), z \to \infty$, we have $M_1^{A0} = -\int_{\Sigma_A} ((1 - C_{\omega_A^0})^{-1} I) \omega_A^0(\xi) \frac{d\xi}{2\pi i}$. For $z \in \Sigma_B$, set

$$M^{B0}(z,x,t) = I + \int_{\Sigma_B} \frac{((1 - C_{\omega_B^0})^{-1} I)(\xi) \omega_B^0}{\xi - z} \frac{d\xi}{2\pi i}.$$
 (3.120)

then ${\cal M}^{B0}(z,x,t)$ is the solution of the following Riemann-Hilbert problem

$$\begin{cases} M_{+}^{B0}(z,x,t) = M_{-}^{B0}(z,x,t)v^{B0}(z,x,t), & z \in \Sigma_{B}, \\ M^{B0}(z,x,t) \to I, & z \to \infty. \end{cases}$$

 $M^{B0}(z) = I + \frac{M_1^{B0}}{z} + o(z^{-2}), z \to \infty$, we have $M_1^{B0} = -\int_{\Sigma_B} ((1 - C_{\omega_B^0})^{-1} I) \omega_B^0(\xi) \frac{d\xi}{2\pi i}$. $v^{B0} = (I - \omega_{B^0-})^{-1} (I + \omega_{B^0+})$, where

$$\omega_{B}^{0} = \omega_{B^{0}+} = \begin{cases} \begin{pmatrix} 0 & (\delta_{B}^{0})^{2} z^{2iv} e^{-\frac{iz^{2}}{2}} \overline{r(z_{0})} \\ 0 & 0 \end{pmatrix}, z \in \Sigma_{B}^{1}, \\ \begin{pmatrix} 0 & (\delta_{B}^{0})^{2} z^{2iv} e^{-\frac{iz^{2}}{2}} \frac{-\overline{r(z_{0})}}{1 - |r(z_{0})|^{2}} \\ 0 & 0 \end{pmatrix}, z \in \Sigma_{B}^{3}, \end{cases}$$
(3.122)

$$\omega_{B}^{0} = \omega_{B^{0}} = \begin{cases} \begin{pmatrix} 0 & 0 \\ (\delta_{B}^{0})^{-2} z^{-2iv} e^{\frac{iz^{2}}{2}} r(z_{0}) & 0 \end{pmatrix}, z \in \Sigma_{B}^{2}, \\ \begin{pmatrix} 0 & 0 \\ (\delta_{B}^{0})^{-2} z^{-2iv} e^{\frac{iz^{2}}{2}} \frac{r(z_{0})}{1 - |r(z_{0})|^{2}} & 0 \end{pmatrix}, z \in \Sigma_{B}^{4}, \end{cases}$$

$$(3.123)$$

$$\delta_B^0 = e^{2i\alpha\tau} (12\alpha\tau)^{-\frac{i\nu}{2}} e^{\chi(z_0)}.$$
 (3.124)

By using (3.112)-(3.114) and (3.122)-(3.124), we have

$$v^{A0}(z) = \overline{(v^{B0})}(-\overline{z}). \tag{3.125}$$

According to the uniqueness of the solution,

$$M^{A0}(z) = \overline{(M^{B0})}(-\overline{z}), \tag{3.126}$$

therefore

$$M_1^{A0} = -\overline{(M_1^{B0})}, (3.127)$$

then we have

$$u(x,t) = \frac{i}{\sqrt{3\alpha t z_0}} (M_1^{B0} - \overline{M_1^{B0}})_{12}.$$

3.6. Solving the model problem.

In this subsection, our work is devoted to compute $(M_1^{B0})_{12}$ explicitly. Firstly, we introduce the transformation $\psi(z) = H(z)z^{iv\sigma_3}e^{-\frac{iz^2}{4}\sigma_3}$, $H(z) = (\delta_B^0)^{-\sigma_3}M_B^0(z)(\delta_B^0)^{\sigma_3}$, then

$$\psi_{+}(z) = (\delta_{B}^{0})^{-\sigma_{3}} M_{B+}^{0}(z) (\delta_{B}^{0})^{\sigma_{3}} z^{iv\sigma_{3}} e^{-\frac{iz^{2}}{4}\sigma_{3}}$$

$$= (\delta_{B}^{0})^{-\sigma_{3}} M_{B-}^{0}(z) v^{B0}(z) (\delta_{B}^{0})^{\sigma_{3}} z^{iv\sigma_{3}} e^{-\frac{iz^{2}}{4}\sigma_{3}}$$

$$= \psi_{-}(z) v(z_{0})$$
(3.129)

where $v(z_0) = z^{-iv\hat{\sigma}_3} e^{\frac{iz^2}{4}\hat{\sigma}_3} (\delta_B^0)^{-\hat{\sigma}_3} v^{B0}$. Notice that the jump matrix is irrelevant to z on each ray, so

$$\frac{d\psi_{+}(z)}{dz} = \frac{d\psi_{-}(z)}{dz}v(z_0) \tag{3.130}$$

and

$$\left(\frac{d\psi_{+}(z)}{dz}\right)\psi_{+}^{-1}(z) = \frac{d\psi_{-}(z)}{dz}v(z_{0})v^{-1}(z_{0})\psi_{-}^{-1}(z) = \frac{d\psi_{-}(z)}{dz}\psi_{-}^{-1}(z), \tag{3.131}$$

therefore, $\frac{d\psi}{dz}\psi^{-1}(z)$ has no jump discontinuity along any of the ray. Moreover, from the relation between $\psi(z)$ and H(z), we have

$$\frac{d\psi}{dz}\psi^{-1}(z) = \frac{dH(z)}{dz}H^{-1}(z) - \frac{i}{2}zH(z)\sigma_3H^{-1}(z)
= -\frac{i}{2}z\sigma_3 - \frac{i}{2}(\delta_B^0)^{-\hat{\sigma}_3}[M_1^{B0}, \sigma_3].$$
(3.132)

It follows by the Liouville's theorem that

$$\frac{d\psi(z)}{dz} + \frac{i}{2}z\sigma_3\psi(z) = \beta\psi(z), \tag{3.133}$$

where $\beta = -\frac{i}{2}(\delta_B^0)^{-\hat{\sigma}_3}[M_1^{B0}, \sigma_3] = \begin{pmatrix} 0 & \beta_{12} \\ \beta_{21} & 0 \end{pmatrix}$. So we have

$$M_1^{B0}_{12} = -i(\delta_B^0)^2 \beta_{12}. (3.134)$$

Set

$$\beta_{12}\psi_{21}(z) = \frac{d\psi_{11}(z)}{dz} + \frac{i}{2}z\psi_{11}(z), \tag{3.136}$$

$$\frac{d^2\psi_{22}(z)}{dz^2} = \left(\frac{i}{2} - \frac{z^2}{4} + \beta_{12}\beta_{21}\right)\psi_{22}(z),\tag{3.137}$$

$$\beta_{21}\psi_{12}(z) = \frac{d\psi_{11}(z)}{dz} - \frac{i}{2}z\psi_{11}(z). \tag{3.138}$$

We know that Weber's equation

$$d^{2}g(\xi) + \left(a + \frac{1}{2} - \frac{\xi^{2}}{4}\right)g(\xi) = 0 \tag{3.139}$$

has the solution

$$g(\xi) = c_1 D_a(\xi) + c_2 D_a(-\xi), \tag{3.140}$$

where $D_a(\cdot)$ denotes the standard parabolic-cylinder function and satisfies

$$\frac{dD_a(\xi)}{d\xi} + \frac{\xi}{2}D_a(\xi) - aD_{a-1}(\xi) = 0, \tag{3.141}$$

$$D_a(\pm \xi) = \frac{\Gamma(a+1)e^{\frac{i\pi a}{2}}}{\sqrt{2\pi}}D_{-a-1}(\pm i\xi) + \frac{\Gamma(a+1)e^{-\frac{i\pi a}{2}}}{\sqrt{2\pi}}D_{-a-1}(\mp i\xi).$$
(3.142)

According to [26], as $\xi \to \infty$, we have

$$D_{a}(\xi) = \begin{cases} \xi^{a} e^{-\frac{\xi^{2}}{4}} (1 + o(\xi^{-2})), & |arg\xi| < \frac{3\pi}{4}, \\ \xi^{a} e^{-\frac{\xi^{2}}{4}} (1 + o(\xi^{-2})) - \frac{\sqrt{2\pi}}{\Gamma(-a)} e^{a\pi i + \frac{\xi^{2}}{4}} \xi^{-a-1} (1 + o(\xi^{-2})), & \frac{\pi}{4} < arg\xi < \frac{5\pi}{4}, \\ \xi^{a} e^{-\frac{\xi^{2}}{4}} (1 + o(\xi^{-2})) - \frac{\sqrt{2\pi}}{\Gamma(-a)} e^{-a\pi i + \frac{\xi^{2}}{4}} \xi^{-a-1} (1 + o(\xi^{-2})), & -\frac{5\pi}{4} < arg\xi < -\frac{\pi}{4}, \end{cases}$$
(3.143)

where $\Gamma(\cdot)$ is the Gamma function. Setting $a = i\beta_{12}\beta_{21}$, we have

$$\psi_{11}(z) = c_3 D_a(e^{-\frac{3\pi i}{4}}z) + c_4 D_a(e^{\frac{\pi i}{4}}z)$$
(3.144)

and

$$\beta_{12}\psi_{22}(z) = c_5 D_{-a}(e^{\frac{3\pi i}{4}}z) + c_6 D_{-a}(e^{-\frac{\pi i}{4}}z). \tag{3.145}$$

When $arg(z) \in (-\frac{\pi}{4}, \frac{\pi}{4})$ and $z \to \infty$, we have $\psi_{11}(z) \to z^{i\upsilon}e^{-\frac{iz^2}{4}}$, $\psi_{22}(z) \to z^{-i\upsilon}e^{\frac{iz^2}{4}}$. By using Eq.(3.143) and (3.144), we obtain

$$c_3 = 0, c_4 = e^{\frac{\pi v}{4}}, a = iv, \psi_{11}(z) = e^{\frac{\pi v}{4}} D_a(e^{\frac{\pi i}{4}}z).$$
 (3.146)

Similarly, by using Eq.(3.143) and (3.145), we get

$$c_5 = 0, \ c_6 = \beta_{12}e^{\frac{\pi v}{4}}, \ a = iv, \ \beta_{12}(z)\psi_{22}(z) = \beta_{12}(z)e^{\frac{\pi v}{4}}D_{-a}(e^{-\frac{\pi i}{4}}z).$$
 (3.147)

Considering Eq.(3.133) and (3.136), we obtain

$$\beta_{21}\psi_{21}(z) = ae^{\frac{\pi(v+i)}{4}}D_{a-1}(e^{\frac{\pi i}{4}}z). \tag{3.148}$$

When $arg(z) \in (-\frac{3\pi}{4}, -\frac{\pi}{4})$ and $z \to \infty$, we have $\psi_{11}(z) \to z^{iv}e^{-\frac{iz^2}{4}}$, $\psi_{22}(z) \to z^{-iv}e^{\frac{iz^2}{4}}$, which implies

$$\psi_{11}(z) = e^{\frac{\pi v}{4}} D_a(e^{\frac{\pi i}{4}} z) \tag{3.149}$$

and

$$\beta_{12}\psi_{22}(z) = \beta_{12}e^{-\frac{3\pi\nu}{4}}D_{-a}(e^{\frac{3\pi i}{4}}z), \tag{3.150}$$

consequently,

$$\psi_{12}(z) = \beta_{12} e^{\frac{\pi v}{4}} e^{-\frac{3\pi i}{4}} D_{-a-1}(e^{-\frac{\pi i}{4}}z). \tag{3.151}$$

Along the ray arg $z = -\frac{\pi}{4}$, $\psi_{+}(z) = \psi_{-}(z) \begin{pmatrix} 0 & \overline{r(z_0)} \\ 0 & 0 \end{pmatrix}$ and $\beta_{12}e^{\frac{\pi(v-3i)}{4}}D_{-a-1}(e^{-\frac{\pi i}{4}}z) = e^{\frac{\pi v}{4}}D_a(e^{\frac{\pi i}{z}})\overline{r(z_0)} + e^{\frac{\pi v}{4}}D_a(e^{\frac{\pi i}{z}})\overline{r(z_0)}$

 $\beta_{12}e^{\frac{\pi(i-3v)}{4}}D_{-a-1}(e^{\frac{3\pi i}{4}}z).$ From Eq.(3.142), we have

$$D_a(e^{\frac{\pi i}{4}}z) = \frac{\Gamma(a+1)e^{\frac{i\pi a}{2}}}{\sqrt{2\pi}}D_{-a-1}(e^{\frac{3\pi i}{4}}z) + \frac{\Gamma(a+1)e^{-\frac{i\pi a}{2}}}{\sqrt{2\pi}}D_{-a-1}(e^{-\frac{\pi i}{4}}z). \tag{3.152}$$

Therefore, we obtain

$$\beta_{12} = \frac{e^{(\frac{3\pi i}{4} + \frac{\pi v}{2})}\Gamma(1+a)}{\sqrt{2\pi}} \overline{r(z_0)} = \frac{e^{(\frac{-3\pi i}{4} + \frac{\pi v}{2})}v\Gamma(iv)}{\sqrt{2\pi}} \overline{r(z_0)}.$$
(3.153)

Finally, theorem (1.1) gives the long-time asymptotics of Eq.(1.8).

4. Conclusion

In this paper, we study long-time asymptotics of the generalized AKNS equation by Defit-Zhou steepest descent method, in which the Schwartz initial data $u_0(x) \in \mathcal{S}(\mathbb{R})$ is inquired. The corresponding result is given in theorem 1.1.

In short order, we plan to consider weaker weighted Sobolev initial data $u_0(x) \in H^{1,1}(\mathbb{R})$ and $u_0(x) \in H^{2,2}(\mathbb{R})$ of long-time asymptotics to some NLPDEs.
