
Detecting Abrupt Changes in Sequential Pairwise Comparison Data

Abstract

The Bradley-Terry-Luce (BTL) model is a classic and very popular statistical approach for eliciting a global ranking among a collection of items using pairwise comparison data. In applications in which the comparison outcomes are observed as a time series, it is often the case that data are non-stationary, in the sense that the true underlying ranking changes over time. In this paper we are concerned with localizing the change points in a high-dimensional BTL model with piecewise constant parameters. We propose novel and practicable algorithms based on dynamic programming that can consistently estimate the unknown locations of the change points. We provide consistency rates for our methodology that depend explicitly on the model parameters, the temporal spacing between two consecutive change points and the magnitude of the change. We corroborate our findings with extensive numerical experiments and a real-life example.

1 Introduction

Pairwise comparison data are among the most common types of data collected for the purpose of eliciting a global ranking among a collection of items or teams. The Bradley-Terry-Luce model (Bradley and Terry, 1952; Luce, 1959) is a classical and popular parametric approach to model pairwise comparison data and to obtain an estimate of the underlying ranking. The Bradley-Terry-Luce model and its variants have been proven to be powerful approaches in many applications, including sports analytics (Fahrmeir and Tutz, 1994; Masarotto and Varin, 2012; Cattelan et al., 2013), bibliometrics (Stigler, 1994; Varin et al., 2016), search analytics (Radlinski and Joachims, 2007; Agresti, 2013), and much more.

To introduce the BTL model, suppose that we are interested in ranking n distinct items, each with a (fixed but unobserved) positive preference score w_i , $i \in [n]$, quantifying its propensity to beat other items in a pairwise comparison. The BTL model assumes that the outcomes of the comparisons between different pairs are independent Bernoulli random variables such that, for a given pair of items, say i and j in $[n] := \{1, \dots, n\}$, the probability that i is preferred to (or beats) j is

$$P_{ij} = \mathbb{P}(i \text{ beats } j) = \frac{w_i^*}{w_i^* + w_j^*}, \quad \forall i, j \in [n]. \quad (1.1)$$

A common reparametrization is to set $w_i^* = \exp(\theta_i^*)$ for each i , where $\boldsymbol{\theta}^* := (\theta_1^*, \dots, \theta_n^*)^\top \in \mathbb{R}^n$. To ensure identifiability it is further assumed that $\sum_{i \in [n]} \theta_i^* = 0$.

The properties and performance of the BTL model have been thoroughly studied under the assumption that the outcomes of all the pairwise comparisons are simultaneously available and follow the same BTL model. In many applications however, it is very common to observe pairwise comparison data sequentially (i.e. one at a time), with time stamps over multiple time periods. In these cases, it is unrealistic to assume that observations with different time stamps come from the same distribution. For instance, in sports analytics, the performance of teams often changes across match rounds, and Fahrmeir and Tutz (1994) utilized a state-space generalization of the BTL model to analyze sport tournaments data. Ranking analysis with temporal variants has also become increasingly important because of the growing needs for models and methods to handle time-dependent data. A series of results in this direction can be found in Glickman (1993), Glickman and Stern (1998), Cattelan et al. (2013), Lopez et al. (2018), Maystre et al. (2019), Bong et al. (2020), Karlé and Tyagi (2021) and references therein. Much of the aforementioned literature on time-varying BTL model postulates that temporal changes in the model parameters are smooth functions of time and thus occur gradually on a relatively large time scale. However, there are instances in which it may be desirable to instead model abrupt changes in the underlying parameters and estimate the times at which such change has occurred. These change point settings, which, to the best of our knowledge, have not been considered in the literature, and are the focus of this paper.

Contributions

We make the following methodological and theoretical contributions.

- **Novel change point methodology.** We develop a computationally efficient methodology to consistently estimate the change points for a time-varying BTL model with piece-wise constant parameters. Our baseline procedure Algorithm 1 consists of a penalized maximum likelihood estimator of the BTL model under an ℓ_0 penalty, and can be efficiently implemented via dynamic programming. We further propose a slightly more computationally expensive two-step procedure in Algorithm 2 that takes as input the estimator returned by our baseline procedure and delivers a more precise estimator with provably better error rates. We demonstrate through simulations and a real life example the performance and practicality of the procedure we develop.
- **Theoretical guarantees.** We obtain finite sample error rates for our procedures that depend explicitly on all the parameters at play: the dynamic range of the BTL model and the number of items to be compared, the number of change points, the smallest distance between two consecutive change points and the minimal magnitude of the difference between the model parameters at two consecutive change points. Our results hold provided that a critical signal-to-noise ratio condition involving all the relevant parameters is satisfied. We conjecture that this condition is optimal in an information theoretic sense. Both the signal-to-noise ratio condition and the localization rates we obtain exhibit a quadratic dependence on the number of items to be compared, which matches the sample complexity bound for two sample testing for the BTL model recently derived by Rastogi et al. (2020).

We emphasize that the change point setting we consider have not been previously studied and both our methodology and the corresponding theoretical guarantees appear to be the first contribution of its kind in this line of work.

Related work

Change point detection is a classical problem in statistics that dates back to 1940s (Wald, 1945; Page, 1954). Contributions in the 1980s established asymptotic theory for change point detection methods (Vostrikova, 1981; James et al., 1987; Yao and Au, 1989). Most of the classical literature studied the univariate mean model. Recently with more advanced theoretical tools developed in modern statistics, more delicate analysis of change point detection came out in high-dimensional mean models (Jirak, 2015; Aston and Kirch, 2018; Wang and Samworth, 2018), covariance models (Aue et al., 2009; Avanesov and Buzun, 2018; Wang et al., 2021b), high-dimensional regression models (Rinaldo et al., 2021; Wang et al., 2021c), network models (Wang et al., 2021a), and temporally-correlated times series (Davis et al., 2006; Cho and Fryzlewicz, 2015; Preuss et al., 2015; Chen et al., 2021; Wang and Zhao, 2022).

Although change point detection has already been extensively studied in many different settings, little is known about the case of pairwise comparison data. Höhle (2010) numerically study the CUSUM method for online change point detection in logit models and BTL models without giving theoretical

guarantees. We aim to fill the gap in the literature and propose a theoretically trackable approach that can optimally localize abrupt changes in the pairwise comparison data.

2 Model and assumptions

Below we introduce the time-varying BTL model with piece-wise constant coefficients that we are going to study and the sampling scheme for collecting pairwise comparison data over time.

We assume throughout that data are collected as a time series indexed by $t \in [T] := \{1, \dots, T\}$ that, at each time point t , a single pairwise comparison among a collection of n items is observed. The distinct pair $(i_t, j_t) \in [n]^2$ of items to be compared at time t is randomly chosen from the n items, independently over time. That is,

$$\mathbb{P}(i_t = i, j_t = j) = \frac{2}{n(n-1)}, \quad \forall 1 \leq i < j \leq n. \quad (2.1)$$

For each t , let $y_t \in \{0, 1\}$ denote the outcome of the comparison between i_t and j_t , where $y_t = 1$ indicates that item i_t beats item j_t in the comparison. We assume that y_t follows a Bradley-Terry model (1.1), i.e.

$$\mathbb{P}_{\theta^*(t)}[y_t = 1 | (i_t, j_t)] = \frac{e^{\theta_{i_t}^*(t)}}{e^{\theta_{i_t}^*(t)} + e^{\theta_{j_t}^*(t)}}, \quad (2.2)$$

where $\theta^*(t) = (\theta_1^*(t), \dots, \theta_n^*(t))$ is, a possibly time-varying, parameter that is assumed to belong to the set

$$\Theta_B := \{\theta \in \mathbb{R}^n : \mathbf{1}_n^\top \theta = 0, \|\theta\|_\infty \leq B\}, \quad (2.3)$$

for some $B > 0$. In the recent literature on the BTL model, the parameter B is referred to as the *dynamic range* (see, e.g., Chen et al., 2019) which readily implies a bound on the smallest possible probability that an item is beaten by any other item. Indeed, it follows from (2.2) and (2.3) that

$$\min_{t \in [T], i, j \in [n]} P_{ij}(t) \geq e^{-2B} / (1 + e^{-2B}) := p_{lb} > 0. \quad (2.4)$$

Remark 1. The quantity p_{lb} have appeared in several equivalent forms in the BTL literature, e.g., $\max_{i, j \in [n]} \frac{w_i^*}{w_j^*}$ (Simons and Yao, 1999; Negahban et al., 2017; Chen et al., 2019) and e^{2B} (Bong and Rinaldo, 2022; Li et al., 2022). The minimal winning probability p_{lb} can be used to quantify the difficulty in estimating the model parameters, with a small p_{lb} implying that some items are systematically better than others, a fact that is known to lead to non-existence of the MLE (see, e.g. Ford, 1957) and to hinder parameter estimability. In the BTL literature the dynamic range B and, as a result, the quantity p_{lb} are often treated as known constants and thus omitted (Shah et al., 2016; Chen et al., 2020), a strong assumption that results in an implicit regularization but potentially hides an important feature of the model. As argued in Bong and Rinaldo (2022), in high-dimensional settings this may not be realistic. We will allow for the possibility of a varying B and p_{lb} , and keep track of the effect of these parameters on our consistency rates.

It is convenient to rewrite (2.2) in a different but equivalent form that is reminiscent of logistic regression and will facilitate our analysis. One can express the fact that, at time t , the items i_t and j_t are randomly selected to be compared using a random n -dimensional vector $\mathbf{x}(t)$ that is uniformly drawn from the sets of all vectors in $\{-1, 0, 1\}^n$ with exactly two-non-zero entries of opposite sign, namely $x_{i_t}(t) = 1$ and $x_{j_t}(t) = -1$. Then equation (2.2) can be written as

$$\mathbb{P}_{\theta^*(t)}[y_t = 1 | \mathbf{x}(t)] = \psi(\mathbf{x}(t)^\top \theta^*(t)), \quad (2.5)$$

where $\psi(x) = \frac{1}{1+e^{-x}}$ is the sigmoid function. For any time interval $\mathcal{I} \subset [T]$ we then assume that the data take the form of an i.i.d. sequence $\{(\mathbf{x}(t), y_t)\}_{t \in \mathcal{I}}$, where each $\mathbf{x}(t)$ is an i.i.d. draw from $\{-1, 0, 1\}^n$ with aforementioned properties and, conditionally on $\mathbf{x}(t)$, y_t is a Bernoulli random variable with success probability (2.2). The negative log-likelihood of the data is then given by

$$L(\theta, \mathcal{I}) = \sum_{t \in \mathcal{I}} \ell_t(\theta), \quad \text{where } \ell_t(\theta) := \ell(\theta; y_t, \mathbf{x}(t)) = -y_t \mathbf{x}(t)^\top \theta + \log[1 + \exp(\mathbf{x}(t)^\top \theta)]. \quad (2.6)$$

For a time interval \mathcal{I} , we can define a random *comparison graph* $\mathcal{G}(V, E)$ with vertex set $V := [n]$ and edge set $E := \{(i, j) : i \text{ and } j \text{ are compared}\}$. It is well-known that the topology of $\mathcal{G}(V, E)$

plays an important role in the estimation of BTL parameters (Shah et al., 2016). Under assumption (2.1), the comparison graph over \mathcal{I} follows the random graph model $G(n, |\mathcal{I}|)$, which has $|\mathcal{I}|$ edges randomly picked from the full edge set $E_{\text{full}} := \{(i, j) : 1 \leq i < j \leq n\}$ with replacement. Therefore, the process $\{(\mathbf{x}(t), y_t)\}_{t \in \mathcal{I}}$ is stationary as long as $\boldsymbol{\theta}^*(t)$ is unchanged over \mathcal{I} .

In the change point BTL model we assume that, for some unknown integer $K \geq 1$, there exist $K + 2$ points $\{\eta_k\}_{k=0}^{K+1}$ such that $1 = \eta_0 < \eta_1 < \dots < \eta_K < \eta_{K+1} = T$ and $\boldsymbol{\theta}^*(t) \neq \boldsymbol{\theta}^*(t-1)$ whenever $t \in \{\eta_k\}_{k \in [K]}$. Define the *minimal spacing* Δ between consecutive change points and the *minimal jump size* κ as

$$\Delta = \min_{k \in [K+1]} (\eta_k - \eta_{k-1}), \quad \kappa = \min_{k \in [K+1]} \|\boldsymbol{\theta}^*(\eta_k) - \boldsymbol{\theta}^*(\eta_{k-1})\|_2. \quad (2.7)$$

As we mentioned in the introduction, the goal of change point localization is to produce an estimator of the change points $\{\hat{\eta}_k\}_{k \in [\hat{K}]}$ such that, with high-probability as $T \rightarrow \infty$, we recover the correct number of change points and the localization error is a vanishing fraction of the minimal distance between change points, i.e. that

$$\hat{K} = K, \text{ and } \max_{k \in [K]} |\hat{\eta}_k - \eta_k| / \Delta = o(1). \quad (2.8)$$

In change point literature, estimators satisfying the above conditions are called *consistent*. In the next section we will present two change point estimators and prove their consistency.

3 Main results

To estimate the change points, we solve the following regularized maximum likelihood problem over all possible partitions \mathcal{P} of the time course $[T]$:

$$\hat{\mathcal{P}} = \arg \min_{\mathcal{P}} \left\{ \sum_{\mathcal{I} \in \mathcal{P}} L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) + \gamma |\mathcal{P}| \right\}, \quad \hat{\boldsymbol{\theta}}(\mathcal{I}) = \arg \min_{\boldsymbol{\theta} \in \Theta_B} L(\boldsymbol{\theta}, \mathcal{I}), \quad (3.1)$$

where $L(\boldsymbol{\theta}, \mathcal{I})$ is the negative log-likelihood function for the BTL model defined in (2.6) and $\gamma > 0$ is an user-specified tuning parameter. Here a partition \mathcal{P} is defined as a set of integer intervals:

$$\mathcal{P} = \{[1, p_1], [p_1, p_2], \dots, [p_{K_{\mathcal{P}}}, T]\}, \quad 1 < p_1 < p_2 < \dots < p_{K_{\mathcal{P}}} < T. \quad (3.2)$$

With $\tilde{K} = K_{\hat{\mathcal{P}}} = |\hat{\mathcal{P}}| - 1$, the estimated change points $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$ are then induced by $\tilde{\eta}_k = \hat{p}_k$, $k \in [\tilde{K}]$. The optimization problem (3.1) has an ℓ_0 -penalty, and can be solved by a dynamic programming algorithm described in Algorithm 1 with $O(T^2 \mathcal{C}(T))$ complexity (Friedrich et al., 2008; Rinaldo et al., 2021), where $\mathcal{C}(T)$ is the complexity of solving $\min_{\boldsymbol{\theta}} L(\boldsymbol{\theta}, [1, T])$.

In this section, we will demonstrate that the estimator returned by Algorithm 1 is consistent. Towards that goal, we require the following signal-to-noise ratio condition involving the parameters Δ , κ and B , n and the sample size T .

Assumption 3.1 (Signal-to-noise ratio). Let $\{(\mathbf{x}(t), y_t)\}_{t \in [T]}$ be i.i.d. observations generated from model (2.1) and (2.5) with parameters $\{\boldsymbol{\theta}^*(t)\} \subset \Theta_B$ defined in (2.3). We assume that for a diverging sequence $\{\mathcal{B}_T\}_{T \in \mathbb{Z}^+}$,

$$\Delta \kappa^2 \geq \mathcal{B}_T p_{lb}^{-4} K n^2 \log(Tn), \quad (3.3)$$

where we recall that $p_{lb} := \frac{e^{-2B}}{1+e^{-2B}}$.

The formulation of signal-to-noise ratio conditions involving all the parameters of the model has become a staple of modern change point analysis literature. To provide some intuition, the term $\Delta \kappa^2$ is a proxy for the strength of the signal of change points in the sense that the localization and detection problems are expected to become easier, as the magnitude of the jumps and the spacing between change points increase. On the other hand, the right hand side of Equation (3.3) collects terms that impact negatively the difficulty of the problem: the smaller the minimal win probability p_{lb} , the larger the number of items n to compare and the number of change points K , the more difficult it is to estimate the change points.

Remark 2 (On the sharpness of the signal-to-noise ratio condition). We will now argue that the requirements imposed by the signal-to-noise ratio (3.1) are reasonably sharp by relating it to the sample complexity of a two-sample testing problem. To that effect, consider the simplified setting in which there is only one change point at time $\Delta = T/2$. In this case, it can be shown that the signal-to-noise ratio requirement (3.1) becomes (see Proposition B.5)

$$\Delta \kappa^2 \geq \mathcal{B}_T p_{lb}^{-2} n^2 \log(Tn), \quad (3.4)$$

i.e. the dependence on the dynamic range B is through p_{lb}^{-2} instead of p_{lb}^{-4} . It stands to reason that estimating the unknown change point Δ should be at least as hard as testing the null hypothesis that there exists a change point at time Δ . Indeed, this testing problem should be easier because Δ has been revealed and because, in general, testing is easier than estimation. This can in turn be cast as a two-sample testing problem of the form

$$H_0 : \mathbf{P}(\boldsymbol{\theta}^{(1)}) = \mathbf{P}(\boldsymbol{\theta}^{(2)}) \text{ v.s. } H_1 : \frac{1}{n} \|\mathbf{P}(\boldsymbol{\theta}^{(1)}) - \mathbf{P}(\boldsymbol{\theta}^{(2)})\|_F \geq \epsilon, \quad (3.5)$$

where $\epsilon > 0$ is to be specified, $\boldsymbol{\theta}^{(1)}$ and $\boldsymbol{\theta}^{(2)}$ are the BTL model parameters for the first and the last Δ observations respectively and, for $i \in \{1, 2\}$, $\mathbf{P}(\boldsymbol{\theta}^{(i)})$ is the $n \times n$ matrix of winning probabilities corresponding to the BTL model parameter $\boldsymbol{\theta}^{(i)}$ as specified by (2.2). To see how one arrives at (3.5), we have that, by Proposition B.4,

$$\|\mathbf{P}(\boldsymbol{\theta}^{(1)}) - \mathbf{P}(\boldsymbol{\theta}^{(2)})\|_F^2 \geq \frac{np_{lb}^2}{16} \|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2. \quad (3.6)$$

Thus, a change point setting with $\|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2 = \kappa^2$, translate into a two-sample testing problem of the form (3.5) with $\epsilon^2 = \kappa^2 p_{lb}^2 / (16n)$. By Theorem 7 of Rastogi et al. (2020), there exists an algorithm that will return a consistent test for (3.5) based on two independent samples of size N if $N \geq cn^2 \log(n) \frac{1}{n\epsilon^2}$. When we apply this result to the simplified change point settings described above (by replacing N and ϵ^2 with Δ and $\kappa^2 p_{lb}^2 / (16n)$ respectively) we conclude that the sample complexity bound of Theorem 7 of Rastogi et al. (2020) corresponds, up to constants, to the above signal-to-noise ratio condition (3.4) save for the terms $\log(T)$ and \mathcal{B}_T . Thus, we conclude that the assumed signal-to-noise ratio condition for change point localization is essentially equivalent to the sample complexity needed to tackle the simpler two-sample testing problem, an indication that our assumption is sharp.

Finally, we take notice that, when there are multiple change points, in our analysis it appears necessary to strengthen the signal-to-noise ratio condition (3.4) to (3.1) by requiring a dependence on p_{lb}^{-4} .

We are now ready to present our first consistency result.

Theorem 3.2. *Let $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$ be the estimates of change points from Algorithm 1 with the tuning parameter $\gamma = C_\gamma p_{lb}^{-2} (K+1)n \log(Tn)$ where C_γ is a universal constant. Under Assumption 3.1 we have*

$$\mathbb{P} \left\{ \tilde{K} = K, \quad \max_{k \in [\tilde{K}]} |\tilde{\eta}_k - \eta_k| \leq C_P p_{lb}^{-4} \frac{Kn^2}{\kappa^2} \log(Tn) \right\} \geq 1 - 2(Tn)^{-2}, \quad (3.7)$$

where $C_P > 0$ is a universal constant that depends on C_γ .

Theorem 3.2 gives a high-probability upper bound for the localization error of the output $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$ of Algorithm 1. By Assumption 3.1, it follows that as $T \rightarrow \infty$, with high probability,

$$\max_{k \in [K]} |\tilde{\eta}_k - \eta_k| \leq C_P p_{lb}^{-4} \frac{Kn^2}{\kappa^2} \log(Tn) = C_P \frac{\Delta}{\mathcal{B}_T} = o(\Delta), \quad (3.8)$$

which implies that the estimators $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$ are consistent. Moreover, when $K = 0$ or there is no change point, it is guaranteed that with high probability, Algorithm 1 will return an empty set. We summarize this property as Proposition B.6 and include it in Appendix B.2 due to the limit of space.

Inspired by previous works (Wang et al., 2021a; Rinaldo et al., 2021), we can further improve the localization error by applying a local refinement procedure as described in Algorithm 2 to $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$. This methodology takes as input any preliminary estimator of the change points that estimates the

number of change points correctly with a localization error that is a (not necessarily vanishing) fraction of the minimal spacing Δ , and returns a new estimator with a provably smaller localization error. A natural preliminary estimator is the one returned in Algorithm 1. The next result derives the improved localization rates delivered by the local refinement step. The two improvements are the elimination of the term K in the rate and a better dependence on p_{lb} .

Theorem 3.3. *Let $\{\hat{\eta}_k\}_{k \in [\hat{K}]}$ be the output of Algorithm 2 with input $\{\tilde{\eta}_k\}_{k \in [\tilde{K}]}$ returned by Algorithm 1. Under Assumption 3.1, for all sufficiently large T we have*

$$\mathbb{P} \left\{ \hat{K} = K, \quad \max_{k \in [K]} |\hat{\eta}_k - \eta_k| \leq C_P p_{lb}^{-2} \frac{n^2}{\kappa^2} \log(Tn) \right\} \geq 1 - 2(Tn)^{-2}, \quad (3.10)$$

where $C_P > 0$ is a universal constant that depends on C_γ .

Remark 3. By ‘‘sufficiently large T ’’ in the theorem statement, we mean that T should be large enough to make $\max_{k \in [K]} |\hat{\eta}_k - \eta_k| \leq \Delta/5$ (see Proposition B.3 in Appendix B for details). Such T exists because of Equation (3.8) and the fact that \mathcal{B}_T is diverging in T .

We conjecture that the rate (3.10) resulting from the local refinement procedure is, aside possibly from a logarithmic factor, minimax optimal.

4 Experiments

In this section, we study the numerical performance of our newly proposed method, i.e., dynamic programming with local refinement (DPLR). We note that the detection of multiple change points in pairwise comparison data has not been studied before, as Höhle (2010) only focus on single change

point detection for pairwise comparison data, so we are not aware of any existing competing methods in the literature. Thus, we develop a potential competitor based on the combination of *Wild Binary Segmentation* (WBS) (Fryzlewicz, 2014), a popular method for univariate change point detection, and the likelihood ratio approach studied in Höhle (2010). We will call this potential competitor WBS-GLR (GLR stands for generalized likelihood ratio). Due to the limit of space, we include the detail of WBS-GLR in Appendix A.1.

All of our simulation results show that our proposed method DPLR outperforms WBS-GLR in the sense that DPLR gives more accurate change point estimates with similar running time. Each experiment is run on a virtual machine of Google Colab with Intel(R) Xeon(R) CPU of 2 cores 2.30 GHz and 12GB RAM. All of our reproducible code is openly accessible ¹

Simulation Settings. Suppose we have K change points $\{\eta_k\}_{k \in [K]}$ in the sequential pairwise comparison data, with $\eta_0 = 1$. We can use $\theta^*(\eta_k)$ to represent the value of true parameters after the change point η_k . To begin, we define $\theta_i^*(\eta_0)$ as follows. For $1 < i \leq n$, we set $\theta_i^*(\eta_0) = \theta_1^*(\eta_0) + (i-1)\delta$ with some constant δ . In each experiment, we set δ first and then set $\theta_1^*(\eta_0)$ to make $\mathbf{1}_n^\top \theta^*(\eta_0) = 0$. For a given n , we set $\delta = \frac{1}{n-1} \psi^{-1}(p) = \frac{1}{n-1} \log\left(\frac{p}{1-p}\right)$ where ψ^{-1} is the inverse function of ψ and $p = 0.9$. Recall that $P_{ij} = \psi(\theta_i - \theta_j)$ is the winning probability, so the value of δ guarantees that the maximum winning probability is 0.9. We consider three types of changes:

Type I (reverse): $\theta_i^*(\eta_k) = \theta_{n+1-i}^*(\eta_0)$.

Type II (block-reverse): $\theta_i^*(\eta_k) = \theta_{\lfloor \frac{n}{2} \rfloor + 1 - i}^*(\eta_0)$ for $i \leq \lfloor \frac{n}{2} \rfloor$; $\theta_i^*(\eta_k) = \theta_{\lfloor \frac{n}{2} \rfloor + n + 1 - i}^*(\eta_0)$ for $i > \lfloor \frac{n}{2} \rfloor$.

Type III (block exchange): $\theta_i^*(\eta_k) = \theta_{i + \lfloor \frac{n}{2} \rfloor}^*(\eta_0)$ for $i \leq \lfloor \frac{n}{2} \rfloor$; $\theta_i^*(\eta_k) = \theta_{i - \lfloor \frac{n}{2} \rfloor}^*(\eta_0)$ for $i > \lfloor \frac{n}{2} \rfloor$.

We consider four simulation settings. For each setting, we have $T = (K+1)\Delta$ and the change points locate at $\eta_i = i\Delta$ for $i \in [K]$. To describe the true parameter at each change point, we use an ordered tuple. For instance, (I, II, III, I) means that $K = 4$ and the true parameters at $\eta_1, \eta_2, \eta_3, \eta_4$ are determined based on $\theta^*(\eta_0)$ and the change type I, II, III, and I, respectively.

For the localization error and running time (in seconds), the average over 100 trials is shown with standard error in the bracket. The three columns on the right record the number of trials in which $\hat{K} < K$, $\hat{K} = K$, and $\hat{K} > K$ respectively.

For the constrained MLE in Equation (3.1), we use the function in `sklearn` for fitting the ℓ_2 -penalized logistic regression, as it is well-known that the constrained and the penalized estimators for generalized linear models are equivalent. For both DPLR and WBS-GLR, we use $\lambda = 0.1$. For M , the number of random intervals in WBS-GLR, we set it to be 50 as a balance of time and accuracy.

For both methods, we use cross-validation to choose the tuning parameter γ . Given the sequential pairwise comparison data in each trial, we use samples with odd time indices as training data and even time indices as test data. For each tuning parameter, the method is applied to the training data to get estimates of change points. Then a BTL model is fitted to the test data for each interval determined

by the estimated change points. The tuning parameter and the corresponding change point estimators with the minimal test error (negative loglikelihood) are selected. We run 100 trials for each setting.

Results. To measure the localization errors, we use the Hausdorff distance $H(\{\hat{\eta}_i\}_{i \in [\hat{K}]}, \{\eta_i\}_{i \in [K]})$ between the estimated change points $\{\hat{\eta}_i\}_{i \in [\hat{K}]}$ and the true change points $\{\eta_i\}_{i \in [K]}$. The Hausdorff distance $H(S_1, S_2)$ between two sets of scalars is defined as

$$H(S_1, S_2) = \max\left\{\sup_{x \in S_1} \inf_{y \in S_2} |x - y|, \sup_{y \in S_2} \inf_{x \in S_1} |x - y|\right\}. \quad (4.1)$$

The results are summarized in Table 1, where we use $H(\hat{\eta}, \eta)$ to denote the localization error for brevity. As we can see, our proposed method DPLR gives more accurate localization with similar running time compared to the potential competitor WBS-GLR.

5 Application: the National Basketball Association games

We study the game records of the National Basketball Association (NBA) ². Usually a regular NBA season begins in October and ends in April of the next year, so in what follows, a season is named by the two years it spans over. The original data contains all game records of NBA from season 1946-1947 to season 2015-2016. We focus on a subset of 24 teams founded before 1990 and seasons from season 1980-1981 to season 2015-2016. All code of analysis is available online with the data ³

We start with an exploratory data analysis and the results show strong evidence for multiple change points ⁴. Therefore, we apply our method DPLR to the dataset to locate those change points. We use the samples with odd time indices as training data and even time indices as test data, and use cross-validation to choose the tuning parameter γ .

To interpret the estimated change points, we fit the BTL model on each subset splitted at change point estimates separately. The result is summarized in Table 2. Several teams show significant jumps in the preference scores and rankings around change points. Apart from this quantitative assessment, the result is also firmly supported by memorable facts in NBA history, and we will name a few here. In 1980s, Celtics was in the ‘‘Larry Bird’’ era with its main and only competitor ‘‘Showtime’’ Lakers. Then starting from 1991, Michael Jordan and Bulls created one of the most famous dynasties in NBA history. 1998 is the year Michael Jordan retired, after which Lakers and Spurs were dominating during 1998-2009 with their famous cores ‘‘Shaq and Kobe’’ and ‘‘Twin Towers’’. The two teams together won 8 champions during these seasons. S2010-S2012 is the well-known ‘‘Big 3’’ era of Heat. Meanwhile, Spurs kept its strong competitiveness under the lead of Timothy Duncan. From 2013, with the arise of super stars Stephen Curry and Klay Thompson, Warriors started to take the lead.

6 Conclusions

We have formulated and investigate a novel change point analysis problem for pairwise comparison data based on a high-dimensional BTL model. We have developed a novel methodology that yields consistent estimators of the change points, and establish theoretical guarantees with nonasymptotic localization error. To the best of our knowledge, this is the first work in the literature that addresses in both a methodological and theoretically sound way multiple change points in ranking data.

Although we filled a big gap in the literature, there remain many open and interesting problems for future work. First, we only consider pairwise comparison data modeled by the BTL model. Of course, there are other popular ranking models for general ranking data, e.g., the Plackett-Luce model (Luce, 1959; Plackett, 1975), Stochastically Transitive models (Shah et al., 2017), and the Mallows model (Tang, 2019). It would be interesting to see that for those models how different the method and theory would be from our settings. Second, we have focused on *retrospective* setting of change point detection and *passive* setting of ranking. On the other hand, *online* change point detection (Vovk, 2021) and *active ranking* (Heckel et al., 2019; Ren et al., 2021) are widely used in practice. Thus, it would be interesting to consider the online or active framework in change point detection for ranking

data. Third, in the recent change point detection literature, incorporating temporal dependence is of growing interest (Chen et al., 2021; Wang and Zhao, 2022), so investigating how temporal dependence in the pairwise comparison data can affect our results seems like a worthwhile direction. Lastly, we assume that the compared pairs are randomly sampled from the full edge set, or the complete graph, making the comparison graph similar to an Erdős-Rényi graph. Although this setting is common in the literature (Chen et al., 2019, 2020), it does not explicitly show the impact of the graph topology

of the comparison graph on ranking. Therefore, it would be very interesting to generalize our results to explicitly show the effect of the topology of the sampling graph.

At last, we discuss potential societal impacts of our work. The BTL model does have applications with potentially undesirable societal impacts, e.g., sports-betting (McHale and Morton, 2011), which could amplify the negative impacts of gambling. We recommend using our method for research purposes rather than gambling-driven purposes.

A Appendix: supplementary to numerical results

A.1 Wild binary segmentation based on likelihood

Binary segmentation is a classical and popular method for detecting change points that can at least date back to Scott and Knott (1974). It is based on the so-called CUSUM statistics. In the case where we are interested in detecting the change point in the mean of univariate random variables $\{Y_t\}_{t \in [T]}$, the CUSUM statistic at time t over an interval (s, e) is defined as

$$\text{CUSUM}(t; s, e) := \left| \sqrt{\frac{e-t}{(e-s)(t-s)}} \sum_{i=s+1}^t Y_i - \sqrt{\frac{t-s}{(e-s)(e-t)}} \sum_{i=t+1}^e Y_i \right|. \quad (\text{A.1})$$

It is known that Binary Segmentation is consistent but not optimal (Venkatraman (1992)). As an improvement, Fryzlewicz (2014) propose Wild Binary Segmentation and show that it has a better localization rate.

OUTPUT: The set of estimated change points.

Algorithm 3 shows the general framework of WBS algorithm. For univariate mean, we have $\mathcal{R}(t; s, e) = \text{CUSUM}(t; s, e)$. While for our problem, the Bradley-Terry model, we set $\mathcal{R}(t; s, e)$ to be the (logarithmic) generalized likelihood ratio given by

$$\mathcal{R}(t; s, e) = \text{GLR}(t; s, e) := \max_{\theta_l \in \Theta_B} \{-L(\theta_l, [s, t])\} + \max_{\theta_r \in \Theta_B} \{-L(\theta_r, [t, e])\} - L_{s,e}, \quad (\text{A.2})$$

where $L_{s,e} := \max_{\theta \in \Theta_B} \{-L(\theta, [s, e])\}$ and $L(\theta, \mathcal{I})$ is the negative log-likelihood function over interval \mathcal{I} , as is defined in Equation (2.6). The use of generalized likelihood ratio in change point detection has been demonstrated in many previous works (Höhle, 2010; Wang et al., 2020). In fact, when $\{Y_t\}_{t \in [T]}$ follows Gaussian distribution with known variance, the GLR statistic at t is the square of $\text{CUSUM}(t; s, e)$.

Similar to the DP approach, WBS also has a tuning parameter γ . By Equation (A.2) and the design of Algorithm 1 and 3, we know that the γ parameters for both DP and WBS-GLR act as the threshold for the GLR statistic. Therefore, one should use the same candidate list of γ for both methods when tuning parameters by cross-validation for fair comparison, as we do in all experiments.

In addition, the number of intervals M acts as another tuning parameter and makes WBS more tricky to apply compared to the DP approach. In practice, people usually set intervals $\{(\alpha_m, \beta_m)\}_{m \in [M]}$ to be uniformly randomly sampled from $[0, T]$. Although it doesn't affect the theoretical guarantee too much Wang et al. (2020), numerically the performance of WBS heavily depends on M . Typically, the larger M is, the more accurate the result is, and the more time it takes to execute WBS. When the model of the data is simple, e.g., univariate mean model, computation of $\mathcal{R}(t; s, e)$ is cheap and one can just set M to be large to improve the localization accuracy. However, for more complex models like the BTL model, a large M may not be computationally affordable, so it can be hard to set an appropriate value for M .

A.2 Additional results for applications

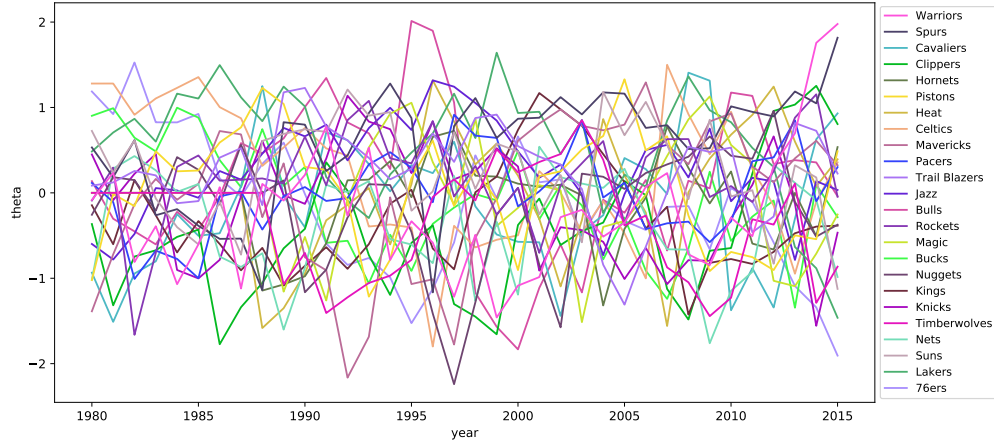


Figure 1: Path of $\hat{\theta}(\mathcal{I}_s)$ for \mathcal{I}_s being each season of the NBA data.

We start our analysis by fitting the BTL model on each season and drawing the path of fitted $\hat{\theta}(\mathcal{I}_s)$, where \mathcal{I}_s is the index interval for games in the s -th season in our range of interest, i.e., from season 1980-1981 to season 2015-2016. The resulted path shown in Figure 1 is fairly noisy for interpretation and inference, and it shows a strong evidence that the data is unstationary. In addition, such a messy path explains why we need some principled framework like change point structures to model such unstationary data and some reliable method to help us locate potential change points.

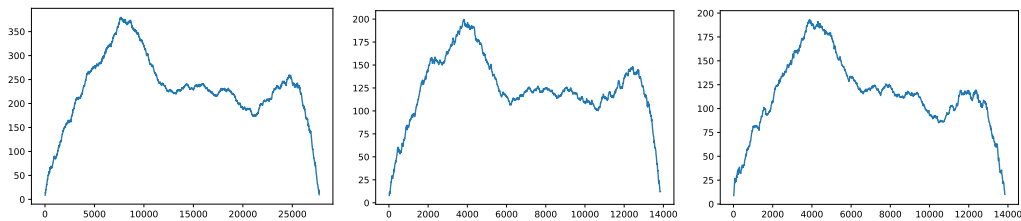


Figure 2: Path of (logarithmic) generalized loglikelihood ratio on NBA data. Left: GLR path on all samples; mid: GLR path on samples with odd indices; right: GLR path on samples with even indices.

To get some rough sense of the number and locations of change points, we check the path of the logarithm of generalized likelihood ratio statistics, as is shown in Figure 2. It should be noted that although it looks like the GLR path suggests the existence and locations of two change points, we cannot rely on it, because when multiple change points exist, there will be some cancel-out effect and the GLR path itself may not give consistent estimates of change points (Venkatraman, 1992). Here the useful information from the GLR path is that splitting the data by odd and even indices is reasonable.

With all the information in the exploratory analysis, we apply our method DPLR to the dataset and summarize results in Section 5.

B Appendix: Proof

This section has three parts:

1. Appendix B.1 contains the proof of two theorems in Section 3.
2. Appendix B.2 contains propositions used throughout the paper with proof.
3. Appendix B.3 contains all technical lemmas with proof.

B.1 Proof of main theorems

Proof of Theorem 3.2. The theorem is a straightforward conclusion of Proposition B.2 and Proposition B.1. More specifically, conclusion 3 and 4 of Proposition B.2 guarantee that $K \leq |\hat{\mathcal{P}}| \leq 3K$ with probability at least $1 - (Tn)^{-2}$ and Proposition B.1 further confirms the consistency of \hat{K} . Then conclusion 1 and 2 of Proposition B.2 control the localization error. \square

Proof of Theorem 3.3. The theorem is a straightforward conclusion of Theorem 3.2 that quantifies the localization error of outputs of dynamic programming and Proposition B.3 that shows the improvement of local refinement. \square

B.2 Main propositions

Proposition B.1 (Consistency of \hat{K}). *Let $\hat{\mathcal{P}}$ be the estimator of change points in Equation (3.1). Assume $K \leq |\hat{\mathcal{P}}| \leq 3K$. Under all assumptions above, it holds with probability at least $1 - (Tn)^{-2}$ that $|\hat{\mathcal{P}}| = K$.*

Proof. For a sequence of strictly increasing integer time points $\{\eta'_j\}_{j \in [J+1]}$ with $\eta'_0 = 1$ and $\eta'_{J+1} = T + 1$, let $\mathcal{I}_j = [\eta'_{j-1}, \eta'_j)$ and

$$L(\{\eta'_j\}_{j \in [J+1]}) = \sum_{j \in [J+1]} L(\hat{\boldsymbol{\theta}}(\mathcal{I}_j), \mathcal{I}_j),$$

where $\hat{\boldsymbol{\theta}}(\mathcal{I}_j) := \arg \min_{\boldsymbol{\theta} \in \Theta_B} L(\boldsymbol{\theta}, \mathcal{I}_j)$. Furthermore, when $\{\eta_k\}_{k \in [K]} \subset \{\eta'_j\}_{j \in [J+1]}$ so that $\theta^*(t)$ remains unchanged in each interval \mathcal{I}_j , we can define the risk of true parameters

$$L^*(\{\eta'_j\}_{j \in [J+1]}) = \sum_{j \in [J+1]} L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j).$$

Let $\{\hat{\eta}_k\}_{k \in [\hat{K}]}$ be the change points given by the estimator $\hat{\mathcal{P}}$ and $\mathbf{Sort}(\cdot)$ be an operator on finite ordered tuple of scalars such that $\mathbf{Sort}((a_1, \dots, a_m)) = (a_{(1)}, \dots, a_{(m)})$ where $a_{(i)} \leq a_{(j)}$ for $i < j$ and $\{a_{(i)}\}_{i \in [m]} = \{a_i\}_{i \in [m]}$. Then a sufficient condition for $|\hat{\mathcal{P}}| = K$ is

$$\begin{aligned} & L^*(\eta_1, \dots, \eta_K) + K\gamma \\ & \geq L(\eta_1, \dots, \eta_K) + K\gamma \end{aligned} \tag{B.1}$$

$$\geq L(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}) + \hat{K}\gamma \tag{B.2}$$

$$\geq L^*(\mathbf{Sort}(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}, \eta_1, \dots, \eta_K)) + \hat{K}\gamma - CKp_{lb}^{-2}n \log(Tn), \tag{B.3}$$

and

$$L^*(\eta_1, \dots, \eta_K) \leq L^*(\mathbf{Sort}(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}, \eta_1, \dots, \eta_K)) + C_1 K p_{lb}^{-2} n \log(Tn). \tag{B.4}$$

In fact, if $\hat{K} \geq K + 1$, under the conditions above and the assumption that $|\hat{\mathcal{P}}| \leq 3K$, we have

$$\gamma \leq (\hat{K} - K)\gamma \leq C_2 K p_{lb}^{-2} n \log(Tn),$$

which is contradictory to the definition $\gamma = C_\gamma p_{lb}^{-2} (K + 1) n \log(Tn)$ for sufficiently large C_γ .

Now we prove that the sufficient condition holds with probability at least $1 - (Tn)^{-2}$. Equation (B.1) is a straightforward conclusion of the definition $\hat{\boldsymbol{\theta}}(\mathcal{I}_j) := \arg \min_{\boldsymbol{\theta} \in \Theta_B} L(\boldsymbol{\theta}, \mathcal{I}_j)$ and Equation (B.2) is implied by the definition of $\hat{\mathcal{P}}$ in Equation (3.1).

Equation (B.4) is guaranteed by Lemma B.9 because for any interval \mathcal{I} determined by endpoints that are two consecutive points in $\mathbf{Sort}(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}, \eta_1, \dots, \eta_K)$, there will not be any true change point in the interior of \mathcal{I} .

For Equation (B.3), notice that by Proposition B.2, with probability $1 - (Tn)^{-4}$, there are at most two change points in \mathcal{I} . Therefore, Lemma B.7 ensures that

$$L(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}) \geq L^*(\mathbf{Sort}(\hat{\eta}_1, \dots, \hat{\eta}_{\hat{K}}, \eta_1, \dots, \eta_K)) - CKp_{lb}^{-2}n \log(Tn).$$

□

Proposition B.2 (Four cases). *Let $\hat{\mathcal{P}}$ be the estimator of change points in Equation (3.1). Under Assumption 3.1 and Assumption B.14, with probability at least $1 - (Tn)^{-2}$ the following four events hold uniformly for all $\mathcal{I} = (s, e) \in \hat{\mathcal{P}}$:*

1. *If \mathcal{I} contains only one change point η , then for some universal constant $C > 0$,*

$$\min\{\eta - s, e - \eta\} \leq Cp_{lb}^{-2} \frac{n}{\kappa^2} [\gamma + n \log(Tn)].$$

2. *If \mathcal{I} contains exactly two change points η_k and η_{k+1} , then for some universal constant $C > 0$,*

$$\min\{\eta_k - s, e - \eta_{k+1}\} \leq Cp_{lb}^{-2} \frac{n}{\kappa^2} [\gamma + n \log(Tn)].$$

3. *If $|\hat{\mathcal{P}}| > 1$, then for any two consecutive intervals \mathcal{I} and \mathcal{J} in $\hat{\mathcal{P}}$, the joint interval $\mathcal{I} \cup \mathcal{J}$ contains at least one change point.*

4. *Interval \mathcal{I} does not contain more than two change points.*

Proof. Conclusion 1 is implied by Lemma B.11 and conclusion 2 is guaranteed by Lemma B.12. Conclusion 4 is a direct consequence of Lemma B.13 and the definition of $\hat{\mathcal{P}}$.

To prove conclusion 3, assume instead that there is no true change point in $\mathcal{I} \cup \mathcal{J}$. Then by Lemma B.10 we have

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) + L(\hat{\boldsymbol{\theta}}(\mathcal{J}), \mathcal{J}) + \gamma \geq L(\boldsymbol{\theta}^*(\mathcal{I} \cup \mathcal{J}), \mathcal{I} \cup \mathcal{J}) \geq L(\hat{\boldsymbol{\theta}}(\mathcal{I} \cup \mathcal{J}), \mathcal{I} \cup \mathcal{J}),$$

which is contradictory to the definition of $\hat{\mathcal{P}}$. □

Proposition B.3 (Local refinement). *Consider the local refinement procedure given in Algorithm 2, that is,*

$$\left(\hat{\eta}_k, \hat{\boldsymbol{\theta}}^{(1)}, \hat{\boldsymbol{\theta}}^{(2)} \right) = \arg \min_{\substack{\eta \in \{s_k+1, \dots, e_k-1\} \\ \boldsymbol{\theta}^{(1)}, \boldsymbol{\theta}^{(2)} \in \Theta_B}} \left\{ \sum_{t=s_k+1}^{\eta} \ell_t(\boldsymbol{\theta}^{(1)}) + \sum_{t=\eta+1}^{e_k} \ell_t(\boldsymbol{\theta}^{(2)}) \right\}, \quad (\text{B.5})$$

where $s_k = 2\tilde{\eta}_{k-1}/3 + \tilde{\eta}_k/3$ and $e_k = \tilde{\eta}_k/3 + 2\tilde{\eta}_{k+1}/3$ and $\ell_t(\boldsymbol{\theta})$ is the negative log-likelihood given in Equation (2.6). Suppose the input $\{\tilde{\eta}_k\}_{k \in [\hat{K}]}$ satisfies $\tilde{K} = K$ and

$$\max_{k \in [\hat{K}]} |\tilde{\eta}_k - \eta_k| \leq \Delta/5.$$

Let $\{\hat{\eta}_k\}_{k \in [K]}$ be the output. Then it holds with probability at least $1 - (Tn)^{-2}$ that

$$\max_{k \in [K]} |\hat{\eta}_k - \eta_k| \leq \frac{Cp_{lb}^{-2}n^2 \log(Tn)}{\kappa^2}. \quad (\text{B.6})$$

Proof. For each $k \in [K]$, let $\hat{\boldsymbol{\theta}}(t) = \hat{\boldsymbol{\theta}}^{(1)}$ if $s_k < t \leq \hat{\eta}_k$ and $\hat{\boldsymbol{\theta}}(t) = \hat{\boldsymbol{\theta}}^{(2)}$ otherwise, and $\boldsymbol{\theta}^*(t)$ be the true parameter at time point t . First we show that under conditions $\tilde{K} = K$ and $\max_{k \in [K]} |\tilde{\eta}_k - \eta_k| \leq \Delta/5$, there is only one true change point η_k in (s_k, e_k) . It suffices to show that

$$|\tilde{\eta}_k - \eta_k| \leq \frac{2}{3}(\tilde{\eta}_{k+1} - \tilde{\eta}_k), \text{ and } |\tilde{\eta}_{k+1} - \eta_{k+1}| \leq \frac{1}{3}(\tilde{\eta}_{k+1} - \tilde{\eta}_k). \quad (\text{B.7})$$

Denote $R = \max_{k \in [K]} |\hat{\eta}_k - \eta_k|$, then

$$\begin{aligned} \tilde{\eta}_{k+1} - \tilde{\eta}_k &= \tilde{\eta}_{k+1} - \eta_{k+1} + \eta_{k+1} - \eta_k + \eta_k - \tilde{\eta}_k \\ &= (\eta_{k+1} - \eta_k) + (\tilde{\eta}_{k+1} - \eta_{k+1}) + (\eta_k - \tilde{\eta}_k) \in [\eta_{k+1} - \eta_k - 2R, \eta_{k+1} - \eta_k + 2R]. \end{aligned}$$

Therefore, Equation (B.7) is guaranteed as long as

$$R \leq \frac{1}{3}(\Delta - 2R),$$

which is equivalent to $R \leq \Delta/5$.

Now without loss of generality, assume that $s_k < \eta_k < \hat{\eta}_k < e_k$. Denote $\mathcal{I}_k = \{s_k + 1, \dots, e_k\}$. Consider two cases:

Case 1 If

$$\hat{\eta}_k - \eta_k < \max\{Cp_{lb}^{-2}n^2 \log(Tn), Cp_{lb}^{-2} \log(Tn)/\kappa^2\},$$

then the proof is done.

Case 2 If

$$\hat{\eta}_k - \eta_k \geq \max\{Cp_{lb}^{-2}n^2 \log(Tn), Cp_{lb}^{-2} \log(Tn)/\kappa^2\},$$

then we proceed to prove that $|\hat{\eta}_k - \eta_k| \leq Cp_{lb}^{-2}n^2 \log(Tn)/\kappa^2$ with probability at least $1 - (Tn)^{-3}$. Then we either prove the result or get a contradiction, and complete the proof in either case.

By the definition of $\hat{\eta}_k$, $\hat{\theta}^{(1)}$, and $\hat{\theta}^{(2)}$, we have

$$\sum_{t \in \mathcal{I}_k} \ell_t(\hat{\theta}(t)) \leq \sum_{t \in \mathcal{I}_k} \ell_t(\theta^*(t)).$$

By Lemma B.8, this implies that

$$ce^{-2B} \sum_{t \in \mathcal{I}_k} [\mathbf{x}(t)^\top \Delta(t)]^2 \leq \sum_{t \in \mathcal{I}_k} \epsilon_t \mathbf{x}(t)^\top \Delta(t), \quad (\text{B.8})$$

where $\Delta(t) := \hat{\theta}(t) - \theta^*(t)$ and $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \theta^*(t))}{1 + \exp(\mathbf{x}(t)^\top \theta^*(t))}$. For the cross term, by Lemma B.17 we have

$$\begin{aligned} \sum_{t \in \mathcal{I}_k} \epsilon_t \mathbf{x}(t)^\top \Delta(t) &= \sum_{i \in [n]} \left\{ \frac{\sum_{t \in \mathcal{I}_k} \epsilon_t x_i(t) \Delta_i(t)}{\sqrt{\sum_{t \in \mathcal{I}_k} \Delta_i(t)^2}} \right\} \sqrt{\sum_{t \in \mathcal{I}_k} \Delta_i(t)^2} \\ &\leq \sup_{i \in [n]} \left| \frac{\sum_{t \in \mathcal{I}_k} \epsilon_t x_i(t) \Delta_i(t)}{\sqrt{\sum_{t \in \mathcal{I}_k} \Delta_i(t)^2}} \right| \sum_{i \in [n]} \sqrt{\sum_{t \in \mathcal{I}_k} \Delta_i(t)^2} \end{aligned} \quad (\text{B.9})$$

$$\leq Cn^{-1/2} \log^{1/2}(Tn) \sum_{i \in [n]} \sqrt{\sum_{t \in \mathcal{I}_k} \Delta_i(t)^2} \leq C \log^{1/2}(Tn) \sqrt{\sum_{t \in \mathcal{I}_k} \|\Delta(t)\|_2^2}. \quad (\text{B.10})$$

Equation (B.8) and Equation (B.10) together imply that

$$ce^{-2B} \sum_{t \in \mathcal{I}_k} [\mathbf{x}(t)^\top \Delta(t)]^2 \leq C \log^{1/2}(Tn) \sqrt{\sum_{t \in \mathcal{I}_k} \|\Delta(t)\|_2^2}. \quad (\text{B.11})$$

Let

$$\mathcal{J}_1 = (s_k, \eta_k], \mathcal{J}_2 = (\eta_k, \hat{\eta}_k], \mathcal{J}_3 = (\hat{\eta}_k, e_k].$$

Under Assumption 3.1 and the condition of the proposition, it holds that $\min\{|\mathcal{J}_1|, |\mathcal{J}_3|\} \geq C_0 n \log(Tn)$. Thus, by Lemma B.15, with probability at least $1 - (Tn)^{-3}$, we have

$$\sum_{t \in \mathcal{I}_k} [\mathbf{x}(t)^\top \Delta(t)]^2 \geq \frac{c_1}{n} \sum_{t \in \mathcal{I}_k} \|\Delta(t)\|_2^2.$$

The inequality above leads to

$$\sum_{t \in \mathcal{I}_k} \|\hat{\boldsymbol{\theta}}(t) - \boldsymbol{\theta}^*(t)\|_2^2 \leq Cp_{lb}^{-2} n^2 \log(Tn).$$

Recall that we defined $\boldsymbol{\theta}^{(1)} = \boldsymbol{\theta}^*(\eta_k - 1)$ and $\boldsymbol{\theta}^{(2)} = \boldsymbol{\theta}^*(\eta_k)$. Then we have

$$\sum_{t \in \mathcal{I}_k} \|\hat{\boldsymbol{\theta}}(t) - \boldsymbol{\theta}^*(t)\|_2^2 = |\mathcal{J}_1| \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(1)}\|_2^2 + |\mathcal{J}_2| \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2 + |\mathcal{J}_3| \|\hat{\boldsymbol{\theta}}^{(2)} - \boldsymbol{\theta}^{(2)}\|_2^2.$$

Since $|\mathcal{J}_1| = \eta_k - s_k \geq c_0 \Delta$ with some constant c_0 under Assumption 3.1, we have

$$\Delta \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(1)}\|_2^2 \leq c_0 |\mathcal{J}_1| \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(1)}\|_2^2 \leq c_1 p_{lb}^{-2} n^2 \log(Tn) \leq c_2 \Delta \kappa^2, \quad (\text{B.12})$$

with some constant $c_2 \in (0, 1/4)$, where the last inequality is due to the fact that $\mathcal{B}_T \rightarrow \infty$. Thus we have

$$\|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(1)}\|_2^2 \leq c_2 \kappa^2.$$

Triangle inequality gives

$$\|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2 \geq \|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2 - \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(1)}\|_2 \geq \kappa/2.$$

Therefore, $\kappa^2 |\mathcal{J}_2|/4 \leq |\mathcal{J}_2| \|\hat{\boldsymbol{\theta}}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2 \leq Cp_{lb}^{-2} n^2 \log(Tn)$ and

$$|\hat{\eta}_k - \eta_k| = |\mathcal{J}_2| \leq \frac{Cp_{lb}^{-2} n^2 \log(Tn)}{\kappa^2}.$$

□

Proposition B.4. Let $\mathbf{P}(\boldsymbol{\theta})$ be the winning probability matrix induced by $\boldsymbol{\theta}$. For $\boldsymbol{\theta}^{(1)}, \boldsymbol{\theta}^{(2)} \in \Theta_B$, it holds that

$$\frac{np_{lb}^2}{16} \|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2 \leq \|\mathbf{P}(\boldsymbol{\theta}^{(1)}) - \mathbf{P}(\boldsymbol{\theta}^{(2)})\|_F^2 \leq \frac{n}{16} \|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2, \quad (\text{B.13})$$

where $p_{lb} = \frac{e^{-2B}}{1+e^{-2B}}$.

Proof. This result has been shown in Shah and Wainwright (2018) (In the proof of Theorem 4). We include it here for completeness.

Denote $\psi(t) = \frac{1}{1+e^{-t}}$. For any pair $(i, j) \in [n]^2$, by the mean value theorem we have

$$\begin{aligned} |P_{ij}(\boldsymbol{\theta}^{(1)}) - P_{ij}(\boldsymbol{\theta}^{(2)})| &= |\psi(\theta_i^{(1)} - \theta_j^{(1)}) - \psi(\theta_i^{(2)} - \theta_j^{(2)})| \\ &= |\psi'(\xi)| |(\theta_i^{(1)} - \theta_j^{(1)}) - (\theta_i^{(2)} - \theta_j^{(2)})|, \end{aligned}$$

where ξ is a scalar between $(\theta_i^{(1)} - \theta_j^{(1)})$ and $(\theta_i^{(2)} - \theta_j^{(2)})$. Since $\psi'(t) = \psi(t)(1-\psi(t)) \in (\frac{1}{4e^{2B}}, \frac{1}{4})$ for $t \in [-2B, 2B]$, we have

$$\frac{1}{4e^{2B}} |(\theta_i^{(1)} - \theta_j^{(1)}) - (\theta_i^{(2)} - \theta_j^{(2)})| \leq |P_{ij}(\boldsymbol{\theta}^{(1)}) - P_{ij}(\boldsymbol{\theta}^{(2)})| \leq \frac{1}{4} |(\theta_i^{(1)} - \theta_j^{(1)}) - (\theta_i^{(2)} - \theta_j^{(2)})|.$$

By the property of Graph Laplacian and the fact that $\mathbf{1}_n^\top \boldsymbol{\theta}^{(i)} = 0$, $i = 1, 2$, we have

$$\sum_{i, j \in [n]^2} [(\theta_i^{(1)} - \theta_j^{(1)}) - (\theta_i^{(2)} - \theta_j^{(2)})]^2 = (\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)})^\top [n\mathbf{I}_n - \mathbf{1}_n \mathbf{1}_n^\top] (\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}) \quad (\text{B.14})$$

$$= n \|\boldsymbol{\theta}^{(1)} - \boldsymbol{\theta}^{(2)}\|_2^2. \quad (\text{B.15})$$

Combining the results above gives the conclusion. □

Proposition B.5 (Single change point). Suppose we observe $\{(\mathbf{x}(t), y_t)\}_{t \in [T]}$ following model (2.1) and (2.5) and there is a single change point $\eta \in (1, T)$. In addition, assume that

$$\Delta := \min\{\eta - 1, T - \eta\} \geq \mathcal{B}_T \frac{n^2}{p_{lb}^2 \kappa^2} \log(Tn), \quad (\text{B.16})$$

for a diverging sequence $\{\mathcal{B}_T\}_{T \in \mathbb{Z}_+}$. Let the estimator $\hat{\eta}$ of the change point be

$$\hat{\eta} = \arg \min_{\eta \in [T]} \left\{ \min_{\boldsymbol{\theta}^{(1)} \in \Theta_B} \sum_{t=1}^{\eta} \ell_t(\boldsymbol{\theta}^{(1)}) + \min_{\boldsymbol{\theta}^{(2)} \in \Theta_B} \sum_{t=\eta+1}^T \ell_t(\boldsymbol{\theta}^{(2)}) \right\}, \quad (\text{B.17})$$

where $\ell_t(\boldsymbol{\theta})$ is the negative log-likelihood given in Equation (2.6). Then it holds with probability at least $1 - (Tn)^{-2}$ that

$$|\hat{\eta} - \eta| \leq \frac{Cn^2 \log(Tn)}{p_{lb}^2 \kappa^2}. \quad (\text{B.18})$$

Proof. The estimator $\hat{\eta}$ is the same as the output of the local refinement algorithm. Under the assumption (B.16), the same arguments in the proof of Proposition B.3 can be applied here to show the conclusion.

It should be noted that the estimator $\hat{\eta}$ gives consistent localization because as $T \rightarrow \infty$, we have $\mathcal{B}_T \rightarrow \infty$ and with high probability,

$$\frac{|\hat{\eta} - \eta|}{\Delta} \leq \frac{C}{\mathcal{B}_T} = o(1).$$

□

Proposition B.6 (No change point). *Suppose we observe $\{(\mathbf{x}(t), y_t)\}_{t \in [T]}$ following model (2.1) and (2.5) and there is no single change point in $[1, T]$. In addition, assume that*

$$T \geq \mathcal{B}_T \frac{n^2}{p_{lb}^2 \kappa^2} \log(Tn), \quad (\text{B.19})$$

for a diverging sequence $\{\mathcal{B}_T\}_{T \in \mathbb{Z}_+}$. Then it holds with probability at least $1 - (Tn)^{-2}$ that the DP procedure in Algorithm 1 with tuning parameter $\gamma = C_\gamma p_{lb}^{-2} n \log(Tn)$ will return an empty set.

Proof. Assume that the output $\hat{\mathcal{P}} = \{\hat{\eta}_k\}_{k \in [\hat{K}]}$ with $\hat{K} \geq 1$. Let $\mathcal{I}_0 = [1, \hat{\eta}_1)$ and $\mathcal{I}_{\hat{K}} = [\hat{\eta}_{\hat{K}}, T]$. When $\hat{K} > 1$, let $\mathcal{I}_k = [\hat{\eta}_{k-1}, \hat{\eta}_k)$ for $k \in [\hat{K} - 1]$. Then by Lemma B.9, with probability at least $1 - (Tn)^{-4}$, we have

$$\begin{aligned} \sum_{k=0}^{\hat{K}} L(\hat{\boldsymbol{\theta}}(\mathcal{I}_k), \mathcal{I}_k) + \hat{K} C p_{lb}^{-2} n \log(Tn) &\geq \sum_{k=0}^{\hat{K}} L(\boldsymbol{\theta}^*(\mathcal{I}_k), \mathcal{I}_k) \\ &= L(\boldsymbol{\theta}^*([1, T]), [1, T]) \geq L(\hat{\boldsymbol{\theta}}([1, T]), [1, T]), \end{aligned}$$

which is contradictory to the definition of $\hat{\mathcal{P}}$ as long as $C_\gamma > C$. □

B.3 Technical lemmas

This section has three parts:

1. Lemma B.7 is a summary of three different cases, and is used in the proof of Proposition B.1.
2. Appendix B.3.1 contains results on the excess risk of $L(\boldsymbol{\theta}(\mathcal{I}), \mathcal{I})$ in four cases.
3. Appendix B.3.2 contains lemmas on some basic concentration properties related to our problem.

Lemma B.7. *Given any interval $\mathcal{I} = (s, e] \subset [1, T]$ with integers s, e that contains at most two change points. Under all assumptions above, we have*

1. *If \mathcal{I} contains no change points, then with probability at least $1 - (Tn)^{-2}$ it holds that*

$$L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) + C p_{lb}^{-2} n \log(Tn).$$

2. *If \mathcal{I} contains exactly one change point η_r with partition $\mathcal{I}_1 = (s, \eta_r]$ and $\mathcal{I}_2 = (\eta_r, e]$, then with probability at least $1 - (Tn)^{-2}$ it holds that*

$$L(\boldsymbol{\theta}^*(\mathcal{I}_1), \mathcal{I}_1) + L(\boldsymbol{\theta}^*(\mathcal{I}_2), \mathcal{I}_2) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) + C p_{lb}^{-2} n \log(Tn).$$

3. If \mathcal{I} contains exactly two change points η_{r+1} and η_{r+2} with partition $\mathcal{I}_1 = (s, \eta_{r+1}]$, $\mathcal{I}_2 = (\eta_{r+1}, \eta_{r+2}]$, and $\mathcal{I}_3 = (\eta_{r+2}, e]$, then with probability at least $1 - (Tn)^{-2}$ it holds that

$$\sum_{j=1}^3 L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) + Cp_{lb}^{-2}n \log(Tn).$$

Proof. Case 1 is guaranteed by Lemma B.9.

For case 3, since $|\mathcal{I}_2| \geq \Delta$, by Assumption 3.1, Lemma B.9 and the definition of $\hat{\boldsymbol{\theta}}$, it holds with probability at least $1 - (Tp)^{-4}$ that

$$L(\boldsymbol{\theta}^*(\mathcal{I}_2), \mathcal{I}_2) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}_2), \mathcal{I}_2) + Cp_{lb}^{-2}n \log(Tn) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_2) + Cp_{lb}^{-2}n \log(Tn), \quad (\text{B.20})$$

where the second inequality is implied by the definition of $\hat{\boldsymbol{\theta}}(\mathcal{I}_2)$.

For \mathcal{I}_1 , we need to consider two cases. If $|\mathcal{I}_1| \geq C_0n \log(Tn)$ where C_0 is some fixed absolute constant in the sample size condition in Assumption B.14, then by Lemma B.9, with probability at least $1 - (Tn)^{-4}$ we have

$$L(\boldsymbol{\theta}^*(\mathcal{I}_1), \mathcal{I}_1) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}_1), \mathcal{I}_1) + Cp_{lb}^{-2}n \log(Tn) \leq L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_1) + Cp_{lb}^{-2}n \log(Tn).$$

Otherwise when $|\mathcal{I}_1| < C_0n \log(Tn)$, let $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$ and we can get

$$\begin{aligned} & L(\boldsymbol{\theta}^*(\mathcal{I}_1), \mathcal{I}_1) - \sum_{t \in \mathcal{I}_1} \ell_t(\hat{\boldsymbol{\theta}}(\mathcal{I})) \\ &= \sum_{t \in \mathcal{I}_1} \ell_t(\boldsymbol{\theta}^*(\mathcal{I}_1)) - \sum_{t \in \mathcal{I}_1} \ell_t(\hat{\boldsymbol{\theta}}(\mathcal{I})) \\ &\leq \sum_{t \in \mathcal{I}_1} \epsilon_t \mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I}_1)) - ce^{-2B} [\mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I}_1))]^2 \\ &\leq \frac{e^{2B}}{4c} \sum_{t \in \mathcal{I}_1} [\epsilon_t]^2 \leq \frac{e^{2B}}{4c} |\mathcal{I}_1| \leq C_1 p_{lb}^{-2} n \log(Tn), \end{aligned}$$

where the last inequality holds because $|\mathcal{I}_1| < C_0n \log(Tn)$. Similarly, we can show that

$$L(\boldsymbol{\theta}^*(\mathcal{I}_3), \mathcal{I}_3) - \sum_{t \in \mathcal{I}_3} \ell_t(\hat{\boldsymbol{\theta}}(\mathcal{I})) \leq C_1 p_{lb}^{-2} n \log(Tn).$$

Combining the three facts proves the conclusion for case 3. Similar arguments can be used to prove the conclusion for case 2. \square

B.3.1 Excess risk

Lemma B.8. Suppose $\boldsymbol{\theta}, \boldsymbol{\theta}^*(t) \in \Theta_B$, then

$$\ell_t(\boldsymbol{\theta}) - \ell_t(\boldsymbol{\theta}^*(t)) \geq \left[\frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))} - y_t \right] \mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t)) + ce^{-2B} [\mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t))]^2. \quad (\text{B.21})$$

Proof. By Taylor expansion,

$$\begin{aligned} & \log(1 + e^{\mathbf{x}(t)^\top \boldsymbol{\theta}}) - \log(1 + e^{\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t)}) \\ &= \left[\frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))} - y_t \right] \mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t)) + \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\xi})}{[1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\xi})]^2} [\mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t))]^2 \\ &\geq \left[\frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))} - y_t \right] \mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t)) + \frac{1}{4e^{2B}} [\mathbf{x}(t)^\top (\boldsymbol{\theta} - \boldsymbol{\theta}^*(t))]^2. \end{aligned}$$

where $\boldsymbol{\xi}$ is a convex combination of $\boldsymbol{\theta}$ and $\boldsymbol{\theta}^*(t)$. Thus, $\boldsymbol{\xi} \in \Theta_B$ and we also use the facts that $|\mathbf{x}(t)^\top \mathbf{v}| \leq 2B$ for any $\mathbf{v} \in \Theta_B$ and $\frac{e^x}{(1+e^x)^2} \geq \frac{1}{4e^{|x|}}$. \square

Lemma B.9. *Assume there is no change points in interval \mathcal{I} , then it holds with probability at least $1 - (Tn)^{-4}$ that*

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) - L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}) = \sum_{t \in \mathcal{I}} [\ell_t(\hat{\boldsymbol{\theta}}) - \ell_t(\boldsymbol{\theta}^*)] \geq -Cp_{lb}^{-2}n \log(Tn),$$

where C is a universal constant that is independent of the choice of \mathcal{I} .

Proof. Let $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$. By Lemma B.8, we have

$$\begin{aligned} & L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}) - L(\hat{\boldsymbol{\theta}}, \mathcal{I}) \\ & \leq \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I})) - ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I}))]^2 \\ & \leq \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I})) \\ & \leq \|\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I})\|_1 \max_{i \in [p]} \left| \sum_{t \in \mathcal{I}} \epsilon_t x_i(t) \right|. \end{aligned} \tag{B.22}$$

When $|\mathcal{I}| \gtrsim C_0 n \log(Tn)$, by Lemma B.16, we have $\|\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I})\|_1 \lesssim p_{lb}^{-2} n^{3/2} \sqrt{\log(Tn)/|\mathcal{I}|}$. Thus, Lemma B.18 ensures that the first term is upper bounded by $Cp_{lb}^{-2}n \log(Tn)$ where C does not depend on C_0 .

When $|\mathcal{I}| < C_0 n \log(Tn)$, we can bound the difference by

$$\begin{aligned} & L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}) - L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) \\ & \leq \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I})) - ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top (\hat{\boldsymbol{\theta}}(\mathcal{I}) - \boldsymbol{\theta}^*(\mathcal{I}))]^2 \\ & \leq \frac{e^{2B}}{4c} \sum_{t \in \mathcal{I}} \epsilon_t^2 \leq Cp_{lb}^{-2}n \log(Tn), \end{aligned} \tag{B.23}$$

where we use the fact that $|\epsilon_t| \leq 1$ and $\boldsymbol{\theta}^* \in \Theta_B$ by our assumption, and the basic inequality $ab \leq a^2 + b^2/4$. \square

Lemma B.10. *Under all assumptions in Theorem 3.2, let $\mathcal{I} = (s, e] \subset [1, T]$ be any interval containing no change point. Let $\mathcal{I}_1, \mathcal{I}_2$ be two intervals such that $\mathcal{I}_1 \cup \mathcal{I}_2 = \mathcal{I}$. It holds with probability at least $1 - (Tn)^{-4}$ that*

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}_1), \mathcal{I}_1) + L(\hat{\boldsymbol{\theta}}(\mathcal{I}_2), \mathcal{I}_2) + \gamma \geq L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}).$$

Proof. If $|\mathcal{I}| < 2C_0 n \log(Tn)$, following the same arguments in Lemma B.9 we have that for $i = 1, 2$, with probability at least $1 - (Tn)^{-4}$,

$$L(\boldsymbol{\theta}^*(\mathcal{I}_i), \mathcal{I}_i) - L(\hat{\boldsymbol{\theta}}(\mathcal{I}_i), \mathcal{I}_i) \leq Cp_{lb}^{-2}n \log(Tn).$$

Thus, by the fact that $L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}) = L(\boldsymbol{\theta}^*(\mathcal{I}_1), \mathcal{I}_1) + L(\boldsymbol{\theta}^*(\mathcal{I}_2), \mathcal{I}_2)$ and $\gamma = C_\gamma p_{lb}^{-2}n \log(Tn)$ with C_γ large enough, the conclusion holds.

Now assume $|\mathcal{I}| > 2C_0 n \log(Tn)$. We will prove the lemma by contradiction. Assume that

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}_1), \mathcal{I}_1) + L(\hat{\boldsymbol{\theta}}(\mathcal{I}_2), \mathcal{I}_2) + \gamma < L(\boldsymbol{\theta}^*(\mathcal{I}), \mathcal{I}).$$

By Lemma B.8, the equation above implies that

$$ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 < -\gamma + \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t), \tag{B.24}$$

where $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$ and $\Delta_i(t) = \hat{\theta}_i(\mathcal{I}) - \theta_i^*(t)$. For (B.24), following the same arguments in the proof of Lemma B.11, we can get that with probability at least $1 - (Tn)^{-4}$,

$$\sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t) \leq C \log^{\frac{1}{2}}(Tn) \left[\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \right]^{\frac{1}{2}}.$$

By Lemma B.15, with probability at least $1 - (Tn)^{-5}$, $\sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 \geq \frac{c_1}{n} \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2$. Thus let $z = \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2$ and we have

$$\frac{cc_1}{e^{2B}n} z + \gamma \leq C \sqrt{\log(Tn)} \sqrt{z} \leq \frac{C^2 e^{2B} n}{cc_1} \log(Tn) + \frac{cc_1}{4e^{2B}n} z,$$

which implies that

$$\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 + C_1 p_{lb}^{-1} n \gamma \leq C_2 p_{lb}^{-2} n^2 \log(Tn),$$

which is contradictory to the fact that $\gamma = C_\gamma p_{lb}^{-2} (K+1)n \log(Tn)$ for sufficiently large constant C_γ . \square

Lemma B.11. For $\mathcal{I} = (s, e) \subset (0, T+1)$, assume that \mathcal{I} contains only one change point η . Denote $\mathcal{I}_1 = (s, \eta]$ and $\mathcal{I}_2 = (\eta, e]$. Assume that $\|\boldsymbol{\theta}^*(\mathcal{I}_1) - \boldsymbol{\theta}^*(\mathcal{I}_2)\|_2 = \kappa > 0$. If

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) \leq L(\boldsymbol{\theta}^*(\mathcal{I}_1), \mathcal{I}_1) + L(\boldsymbol{\theta}^*(\mathcal{I}_2), \mathcal{I}_2) + \gamma,$$

then with probability at least $1 - (Tn)^{-4}$, there exists an absolute constant $C > 0$ such that

$$\min\{|\mathcal{I}_1|, |\mathcal{I}_2|\} \leq C \frac{p_{lb}^{-2} n}{\kappa^2} [\gamma + n \log(Tn)].$$

Proof. Without loss of generality, assume $|\mathcal{I}_1| \geq |\mathcal{I}_2|$. If $|\mathcal{I}_2| < C_0 n \log(Tn)$ then the conclusion holds automatically, where C_0 is the constant in Lemma B.16 and Lemma B.17, since we can set C_γ to be sufficiently large (notice that in the worst case, κ^2 can be as large as nB^2). Thus, in what follows we can assume $|\mathcal{I}_2| \geq C_0 n \log(Tn)$. Let $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$ and $\Delta_i(t) = \hat{\theta}_i(\mathcal{I}) - \theta_i^*(t)$. By the condition of the lemma and Lemma B.8, we have

$$ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 \leq \gamma + \sum_{t \in \mathcal{I}} \sum_{i \in [n]} \epsilon_t x_i(t) \Delta_i(t).$$

Lemma B.17 implies that with probability at least $1 - (Tn)^{-4}$, the term on the right hand side satisfies

$$\begin{aligned} & \sum_{t \in \mathcal{I}} \sum_{i \in [n]} \epsilon_t x_i(t) (\hat{\theta}_i - \theta_i^*(t)) \\ & \leq \sup_{i \in [n]} \left| \frac{\sum_{t \in \mathcal{I}} \epsilon_t x_i(t) (\hat{\theta}_i - \theta_i^*(t))}{\sqrt{\sum_{t \in \mathcal{I}} (\hat{\theta}_i - \theta_i^*(t))^2}} \right| \sum_{i \in [n]} \sqrt{\sum_{t \in \mathcal{I}} (\hat{\theta}_i - \theta_i^*(t))^2} \\ & \leq C n^{-\frac{1}{2}} \log^{\frac{1}{2}}(Tn) \sum_{i \in [n]} \sqrt{\sum_{t \in \mathcal{I}} (\hat{\theta}_i - \theta_i^*(t))^2} \leq C \log^{\frac{1}{2}}(Tn) \sqrt{\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2}. \end{aligned}$$

By Lemma B.15, $\sum_{t \in \mathcal{I}_i} [\mathbf{x}(t)^\top \Delta(t)]^2 \geq \frac{1}{n} \sum_{t \in \mathcal{I}_i} \|\Delta(t)\|_2^2$ with probability at least $1 - (Tn)^{-5}$ for $i = 1, 2$. Therefore, letting $z = \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2$, we have

$$c_1 e^{-2B} z/n \leq \gamma + c_2 \log^{\frac{1}{2}}(Tn) \sqrt{z}.$$

Solving the inequality above gives

$$\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \leq C p_{lb}^{-2} n [\gamma + n \log(Tn)],$$

where C is a universal constant that only depends on c_1, c_2 . Since $\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \geq \frac{|\mathcal{I}_1||\mathcal{I}_2|}{|\mathcal{I}|} \kappa^2 \geq \frac{\kappa^2}{2} |\mathcal{I}_2|$, we have $|\mathcal{I}_2| \leq \frac{2C}{\kappa^2} p_{lb}^{-2} n [\gamma + n \log(Tn)]$. \square

Lemma B.12. Under all assumptions in Theorem 3.2, let $\mathcal{I} = (s, e] \subset [1, T]$ be any interval containing exactly two change points η_{r+1} and η_{r+2} , $\mathcal{I}_1 = (e, \eta_{r+1}]$, $\mathcal{I}_2 = (\eta_{r+1}, \eta_{r+2}]$, and $\mathcal{I}_3 = (\eta_{r+2}, e]$. Let $\kappa_i = \|\boldsymbol{\theta}^*(\mathcal{I}_i) - \boldsymbol{\theta}^*(\mathcal{I}_{i+1})\|_2$ for $i = 1, 2$ and $\kappa = \min\{\kappa_1, \kappa_2\}$. If

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) \leq \sum_{i=1}^3 L(\boldsymbol{\theta}^*(\mathcal{I}_i), \mathcal{I}_i) + 2\gamma,$$

then it holds with probability at least $1 - (Tn)^{-4}$ that

$$\max\{|\mathcal{I}_1|, |\mathcal{I}_3|\} \leq C p_{lb}^{-2} \frac{n}{\kappa^2} [\gamma + n \log(Tn)].$$

Proof. Without loss of generality, we assume $|\mathcal{I}_1| \geq |\mathcal{I}_3|$. There are three possible cases: 1. $|\mathcal{I}_1| \leq C_0 n \log(Tn)$, 2. $|\mathcal{I}_3| \geq C_0 n \log(Tn)$, and 3. $|\mathcal{I}_1| \geq C_0 n \log(Tn) \geq |\mathcal{I}_3|$ where C_0 is the constant in Lemma B.16 and Lemma B.17. In case 1 the conclusion holds immediately since we can set C_γ to be large enough. In case 2, the condition in the lemma implies that

$$ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 \leq 2\gamma + \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t),$$

where $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$ and $\Delta_i(t) = \hat{\theta}_i(\mathcal{I}) - \theta_i^*(t)$.

For the term involving ϵ_t , following the same arguments in the proof of Lemma B.11, we can get that with probability at least $1 - (Tn)^{-4}$,

$$\sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t) \leq C \log^{\frac{1}{2}}(Tn) \left[\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \right]^{\frac{1}{2}}.$$

Let $z = \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2$. By Lemma B.15, $\sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 \geq \frac{c_1}{n} \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2$ with probability at least $1 - (Tn)^{-5}$, and thus we have

$$\frac{cc_1}{e^{2B}n} z \leq C \sqrt{\log(Tn)} \sqrt{z} + 2\gamma,$$

which implies that

$$\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \leq C_1 p_{lb}^{-2} n^2 \log(Tn) + C_2 e^{2B} n \gamma.$$

Denote $\tilde{\mathcal{I}}$ as the shorter one of $|\mathcal{I}_1|$ and $|\mathcal{I}_2|$. The left hand can be lower bounded by

$$\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \geq \sum_{t \in \mathcal{I}_1 \cup \mathcal{I}_2} \|\Delta(t)\|_2^2 \geq \frac{|\mathcal{I}_1| |\mathcal{I}_2|}{|\mathcal{I}_1| + |\mathcal{I}_2|} \kappa^2 \geq \frac{|\tilde{\mathcal{I}}|}{2} \kappa^2.$$

If $|\mathcal{I}_2| < |\mathcal{I}_1|$, then we have

$$\frac{|\mathcal{I}_2|}{2} \kappa^2 \leq C_1 p_{lb}^{-2} n^2 \log(Tn) + C_2 p_{lb}^{-1} n \gamma,$$

which leads to the bound

$$|\mathcal{I}_2| \lesssim \frac{p_{lb}^{-2} n}{\kappa^2} [\gamma + n \log(Tn)],$$

and is contradictory to the assumption that $\Delta \geq \mathcal{B}_T p_{lb}^{-4} \frac{Kn^2}{\kappa^2} \log(Tn)$ in Assumption 3.1 because of the definition $\gamma = C_\gamma p_{lb}^{-2} \frac{n}{\kappa^2} (K+1) \log(Tn)$. Therefore, we have $|\mathcal{I}_2| \geq |\mathcal{I}_1|$ and by the same arguments,

$$|\mathcal{I}_1| \lesssim \frac{p_{lb}^{-2} n}{\kappa^2} [\gamma + n \log(Tn)].$$

Since we assume $|\mathcal{I}_3| \leq |\mathcal{I}_1|$, the desired bound holds.

In case 3, we only need to prove that $|\mathcal{I}_1| \leq C p_{lb}^{-2} \frac{n}{\kappa^2} [\gamma + n \log(Tn)]$. Following the same arguments for Equation (B.23), we can get that with probability at least $1 - (Tn)^{-5}$,

$$L(\boldsymbol{\theta}^*(\mathcal{I}_3), \mathcal{I}_3) - L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_3) \leq C p_{lb}^{-2} n \log(Tn) \leq \gamma/3.$$

Therefore, by the condition of the lemma, we have

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_1 \cup \mathcal{I}_2) \leq \sum_{i=1}^2 L(\boldsymbol{\theta}^*(\mathcal{I}_i), \mathcal{I}_i) + \frac{7}{3} \gamma.$$

Since $\mathcal{I}_1 \cup \mathcal{I}_2$ only contains 1 true change point, the conclusion can be shown by the same arguments of Lemma B.11. \square

Lemma B.13. *Under all assumptions in Theorem 3.2, let $\mathcal{I} = (s, e] \subset [1, T]$ be any interval containing $J \geq 3$ change points $\eta_{r+1}, \dots, r+J$. Let $\mathcal{I}_1 = (e, \eta_{r+1}]$, $\mathcal{I}_j = (\eta_{r+j-1}, \eta_{r+j}]$ for $j = 2, \dots, J$, and $\mathcal{I}_{J+1} = (\eta_{r+J}, e]$. Also let $\kappa_j = \|\boldsymbol{\theta}^*(\mathcal{I}_j) - \boldsymbol{\theta}^*(\mathcal{I}_{j+1})\|_2$ for $j \in [J]$ and $\kappa = \min_{j \in [J]} \{\kappa_j\}$. Then it holds with probability at least $1 - (Tn)^{-4}$ that*

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) > \sum_{j=1}^{J+1} L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) + J\gamma,$$

Proof. Without loss of generality, assume that $|\mathcal{I}_1| \geq |\mathcal{I}_{J+1}|$. Similar to Lemma B.12, there are three cases: 1. $|\mathcal{I}_1| \leq C_0 n \log(Tn)$, 2. $|\mathcal{I}_{J+1}| \geq C_0 n \log(Tn)$, and 3. $|\mathcal{I}_1| \geq C_0 n \log(Tn) \geq |\mathcal{I}_{J+1}|$ where C_0 is the constant in Lemma B.16 and Lemma B.17. In case 2, we prove the conclusion by contradiction. Assume that

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) \leq \sum_{j=1}^{J+1} L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) + J\gamma$$

We have

$$ce^{-2B} \sum_{t \in \mathcal{I}} [\mathbf{x}(t)^\top \Delta(t)]^2 \leq J\gamma + \sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t),$$

where $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$ and $\Delta_i(t) = \hat{\theta}_i(\mathcal{I}) - \theta_i^*(t)$.

For the term that contains ϵ_t , we can bound it as

$$\sum_{t \in \mathcal{I}} \epsilon_t \mathbf{x}(t)^\top \Delta(t) \leq C \log^{\frac{1}{2}}(Tn) \left[\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \right]^{\frac{1}{2}},$$

with probability at least $1 - (Tn)^{-4}$. Combining the bounds on both terms and use Lemma B.15 lead to a similar inequality in Lemma B.12 whose solution gives us

$$\sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 \leq C_1 p_{lb}^{-2} n^2 \log(Tn) + C_2 J e^{2B} n \gamma.$$

By definition we know that for $1 \leq j \leq J$, $|\mathcal{I}_j| \geq \Delta$ and thus,

$$\begin{aligned} \sum_{t \in \mathcal{I}} \|\Delta(t)\|_2^2 &\geq \sum_{j=1}^J \sum_{t \in \mathcal{I}_j} \|\Delta(t)\|_2^2 \\ &\geq \sum_{j=1}^{J-1} \frac{1}{2} \left[\sum_{t \in \mathcal{I}_j} \|\Delta(t)\|_2^2 + \sum_{t \in \mathcal{I}_{j+1}} \|\Delta(t)\|_2^2 \right] \\ &\geq \sum_{j=1}^{J-1} \frac{1}{2} \cdot \frac{|\mathcal{I}_j| |\mathcal{I}_{j+1}|}{|\mathcal{I}_j| + |\mathcal{I}_{j+1}|} \kappa^2 \\ &\geq \frac{1}{4} (J-1) \Delta \kappa^2. \end{aligned}$$

Therefore, we have

$$\Delta \kappa^2 \leq C_3 p_{lb}^{-2} n [\gamma + n \log(Tn) / J].$$

Since we assume $|\mathcal{I}_2| \geq |\mathcal{I}_3|$, the inequality above contradicts to the assumption that $\Delta \kappa^2 \geq \mathcal{B}_T p_{lb}^{-4} K n^2 \log(Tn)$ in Assumption 3.1.

In case 1, following the same arguments of Equation (B.23), we can get that for $j = 1, J+1$, with probability at least $1 - (Tn)^{-5}$,

$$L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) - L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_j) \leq C p_{lb}^{-2} n \log(Tn) \leq \gamma/3.$$

Similar to case 2, we assume that

$$L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}) \leq \sum_{j=1}^{J+1} L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) + J\gamma.$$

Therefore,

$$\sum_{j=2}^J L(\hat{\boldsymbol{\theta}}(\mathcal{I}), \mathcal{I}_j) \leq \sum_{j=2}^J L(\boldsymbol{\theta}^*(\mathcal{I}_j), \mathcal{I}_j) + (J + \frac{2}{3})\gamma.$$

When $J = 3$, following same arguments in Lemma B.12, we lead to a contradiction that $\Delta \leq Cp_{lb}^{-2} \frac{n}{\kappa^2} [\gamma + n \log(Tn)]$. When $J > 3$, we can get the same contradiction by the same arguments for case 2 in this lemma. Case 3 can be handled in a similar manner. \square

B.3.2 Basic concentrations

First we introduce some results on the empirical risk minimizer of the Bradley-Terry model, which is defined by the constraint MLE

$$\hat{\boldsymbol{\theta}} = \arg \min_{\boldsymbol{\theta} \in \Theta_B} \sum_{i \in [m]} \ell_i(\boldsymbol{\theta}). \quad (\text{B.25})$$

Assumption B.14. Assume that $(\mathbf{x}(t), y_t)_{t \in [m]}$ are i.i.d. observations generated from model (2.5) with $\boldsymbol{\theta}^*(t) = \boldsymbol{\theta}^* \in \Theta_B$ being a constant vector and (2.1) and the sample size m satisfies $m \geq C_0 n \log(n)$.

Recall that the random graph model $G(n, m)$ generates random graphs with the vertex set $[n]$ and m edges randomly sampled from the full edge set $E_{full} = \{(i, j) : 1 \leq i < j \leq n\}$. Lemma B.15 gives high probability bounds for the spectra of random graphs following $G(n, m)$.

Lemma B.15. Let A be an adjacency matrix sampled from the random graph model $G(n, m)$ and $L_A = D - A$ be the Laplacian matrix. Denote the eigenvalues of L_A as $0 = \lambda_1 \leq \lambda_2 \leq \dots \leq \lambda_n$. Suppose $m \geq C_0 n \log n$ for some sufficiently large constant $C_0 > 0$, then with probability at least $1 - O(n^{-10})$ we have

$$\frac{m}{n} \leq \lambda_2(L_A) \leq \lambda_n(L_A) \leq \frac{4m}{n}. \quad (\text{B.26})$$

Proof. Consider a partial isometry matrix $R \in \mathbb{R}^{(n-1) \times n}$ that satisfies $RR^\top = I_{n-1}$ and $R\mathbf{1}_n = 0$. By basic algebra we know that $\text{rank}(R) = n - 1$ and $\{R^\top v : v \in \mathbb{R}^{n-1}\} = \{a\mathbf{1}_n : a \in \mathbb{R}\}^\perp$. Consider $Y = RL_A R^\top$, then the eigenvalues $\{\lambda_i\}_{i=2}^n$ are the same as eigenvalues of Y . Since $\mathbb{E}[Y] = \frac{2m}{n-1} I_{n-1}$, by matrix Chernoff inequality (e.g., Theorem 5.1.1 in Tropp (2015)), we have

$$\mathbb{P}(\lambda_2(L_A) \leq \frac{m}{n-1}) = \mathbb{P}(\lambda_{\min}(Y) \leq \frac{m}{n-1}) \leq (n-1) \left(\frac{e}{2}\right)^{-\frac{m}{2(n-1)}} \leq n^{-10} \quad (\text{B.27})$$

for $m \geq C_0 n \log n$ where C_0 is a sufficiently large constant. Similarly, we can show that $\lambda_n(L_A) \leq 4m/n$ with probability at least $1 - n^{-10}$. \square

Lemma B.16. Under Assumption B.14, for the MLE $\hat{\boldsymbol{\theta}}$ defined in Equation (B.25), with probability at least $1 - O(n^{-10})$ we have

$$\|\hat{\boldsymbol{\theta}} - \boldsymbol{\theta}^*\|_2 \leq Cp_{lb}^{-2} n \sqrt{\frac{\log n}{m}}, \quad \|\hat{\boldsymbol{\theta}} - \boldsymbol{\theta}^*\|_1 \leq Cp_{lb}^{-2} n^{3/2} \sqrt{\frac{\log n}{m}}. \quad (\text{B.28})$$

Proof. The first inequality is a corollary of Theorem 2 in Shah et al. (2016) and Lemma B.15. Specifically, Shah et al. (2016) ensures that with probability at least $1 - O(n^{-12})$,

$$\|\hat{\boldsymbol{\theta}} - \boldsymbol{\theta}^*\|_2^2 \leq Cp_{lb}^{-4} \frac{n \log(n)}{\lambda_2(L_A)}.$$

By Equation (B.27), $\lambda_2(L_A) \geq m/n$ with probability at least $1 - O(n^{-12})$, so a union bound leads to the conclusion. The second inequality is implied by $\|x\|_1 \leq \sqrt{n} \|x\|_2$ for any $x \in \mathbb{R}^n$. \square

In what follows, we prove some concentration properties related to $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$.

Lemma B.17. *Under all assumptions in Theorem 3.2, let $\mathcal{I} = [1, T]$ be an integer interval such that $|\mathcal{I}| \geq c_0(R+1)n \log(Tn)$ and R be a fixed integer. Denote $\mathcal{S}_{\mathcal{I}, R} = \{\mathbf{v} \in \mathbb{R}^{|\mathcal{I}|} : \|\mathbf{v}\|_2 = 1, \|D\mathbf{v}\|_0 = R, \min\{k : v_j \neq v_{j+k}\} \geq c_0 n \log(Tn)\}$ and $\epsilon_t := y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$. Then for some sufficiently large constant C , it holds with probability at least $1 - (Tn)^{-2R-10}$ that*

$$\max_{i \in [p]} \sup_{\mathbf{v} \in \mathcal{S}_{\mathcal{I}, R}} \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \leq C \sqrt{\log(Tn)R/n}.$$

Proof. Since $\|D\mathbf{v}\|_0 = R$, $\{v_t\}$ is piece-wise constant over $\mathcal{I} = [1, T]$ and has R change points that have at most $\binom{T}{R}$ possible choices of locations. Let $\{\eta_k\}_{k \in [R]}$ be the change points of $\{v_t\}$ and $\mathcal{S}(\{\eta_k\}_{k \in [R]})$ the linear subspace of $\mathcal{R}^{|\mathcal{I}|}$ that contains all piecewise-linear sequences over \mathcal{I} whose change points are $\{\eta_k\}_{k \in [R]}$. Let $\mathcal{N}_\delta(\{\eta_k\}_{k \in [R]})$ be a δ -net of $\mathcal{S}(\{\eta_k\}_{k \in [R]}) \cap \mathcal{S}^{|\mathcal{I}|}$ where $\mathcal{S}^{|\mathcal{I}|}$ is the unit sphere in $\mathcal{R}^{|\mathcal{I}|}$. By Lemma 4.1 in Pollard (1990), since $\mathcal{S}(\{\eta_k\}_{k \in [R]})$ is an affine space with dimension $R+1$, we can pick a δ -net $\mathcal{N}_\delta(\{\eta_k\}_{k \in [R]})$ such that $|\mathcal{N}_\delta(\{\eta_k\}_{k \in [R]})| \leq \left(\frac{3}{\delta}\right)^{R+1}$.

Taking $\delta = \frac{1}{|\mathcal{I}|}$, then for any fixed $i \in [n]$ and fixed set of change points $\{\eta_k\}_{k \in [R]}$, we have

$$\begin{aligned} & \mathbb{P} \left[\sup_{\mathbf{v} \in \mathcal{S}_{\mathcal{I}, R}} \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq \mathbb{P} \left[\sup_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}(\{\eta_k\}_{k \in [R]})} \left| \sum_{t \in \mathcal{I}} u_t \epsilon_t x_i(t) \right| + \sup_{\mathbf{v} \in \mathcal{S}_{\mathcal{I}, R}} \inf_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}} \left| \sum_{t \in \mathcal{I}} (v_t - u_t) \epsilon_t x_i(t) \right| \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq \mathbb{P} \left[\sup_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}(\{\eta_k\}_{k \in [R]})} \left| \sum_{t \in \mathcal{I}} u_t \epsilon_t x_i(t) \right| + \sup_{\mathbf{v}} \inf_{\mathbf{u}} \|\mathbf{v} - \mathbf{u}\|_1 \max_{t \in \mathcal{I}} |\epsilon_t x_i(t)| \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq \mathbb{P} \left[\sup_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}(\{\eta_k\}_{k \in [R]})} \left| \sum_{t \in \mathcal{I}} u_t \epsilon_t x_i(t) \right| + \frac{\sqrt{|\mathcal{I}|}}{|\mathcal{I}|} \cdot \max_{t \in \mathcal{I}} |\epsilon_t x_i(t)| \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq \mathbb{P} \left[\sup_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}(\{\eta_k\}_{k \in [R]})} \left| \sum_{t \in \mathcal{I}} u_t \epsilon_t x_i(t) \right| \geq C \sqrt{R \log(Tn)/n} \right] \\ & \quad \times \mathbb{P} \left[\max_{t \in \mathcal{I}} |\epsilon_t x_i(t)| < C \sqrt{R |\mathcal{I}| \log(Tn)/n} \right] + \mathbb{P} \left[\max_{t \in \mathcal{I}} |\epsilon_t x_i(t)| \geq C \sqrt{R |\mathcal{I}| \log(Tn)/n} \right] \end{aligned}$$

Since $\|\mathbf{x}(t)\|_\infty \leq 1$ and $|\epsilon_t| \leq 2$ under Model (2.5), we can make C sufficiently large so that $\mathbb{P} \left[\max_{t \in \mathcal{I}} |\epsilon_t x_i(t)| \geq C \sqrt{R |\mathcal{I}| \log(Tn)/n} \right] = 0$. Therefore,

$$\begin{aligned} & \mathbb{P} \left[\sup_{\mathbf{v} \in \mathcal{S}_{\mathcal{I}, R}} \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq (3|\mathcal{I}|)^{R+1} \sup_{\mathbf{u} \in \mathcal{N}_{1/|\mathcal{I}|}(\{\eta_k\}_{k \in [R]})} \mathbb{P} \left[\left| \sum_{t \in \mathcal{I}} u_t \epsilon_t x_i(t) \right| \geq C \sqrt{R \log(Tn)/n} \right] \\ & \leq (3|\mathcal{I}|)^{R+1} \times \max \left\{ 2 \exp \left[-\frac{CR \log(Tn)}{\sum_{t \in \mathcal{I}} u_t^2} \right], (Tn)^{-3R-12} \right\} \\ & \leq C_2 \exp(-C_2 R \log(Tn) + R \log(3|\mathcal{I}|)), \end{aligned}$$

where in the second inequality we use Lemma B.18. Therefore, for the given interval $\mathcal{I} \subset [1, T]$, it holds that

$$\mathbb{P}(\mathcal{B}_R(\mathcal{I})) \leq \binom{T}{R} C_2 \exp(-C_3 R \log(Tn)) \leq (Tn)^{-2R-10},$$

where the event $\mathcal{B}_R(\mathcal{I}) := \{\max_{i \in [n]} \sup_{\mathbf{v} \in \mathcal{S}_{\mathcal{I}, R}} \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \geq C \sqrt{R \log(Tn)/n}\}$ for some sufficiently large universal constant C . \square

Lemma B.18. Let $\epsilon_t = y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$. Under all assumptions in Theorem 3.2, for any fixed integer interval $\mathcal{I} \subset [1, T]$ such that $|\mathcal{I}| \geq c_0(R+1)n \log(Tn)$ for some sufficiently large constant $c_0 > 0$ and any fixed $\mathbf{v} \in D_{\mathcal{I}, R}$ where $D_{\mathcal{I}, R} = \{\mathbf{v} \in \mathbb{R}^{|\mathcal{I}|} : \|\mathbf{D}\mathbf{v}\|_0 = R, \min\{k : v_j \neq v_{j+k}\} \geq c_0 n \log(Tn)\}$ with a fixed integer R , it holds for any $\kappa > 0$ that

$$\max_{i \in [n]} \mathbb{P} \left[\left| \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \right| \geq \kappa \right] \leq \max \left\{ 2 \exp \left(-\frac{Cn\kappa^2}{\sum_{t \in \mathcal{I}} v_t^2} \right), (Tn)^{-3R-12} \right\}.$$

Proof. Following the same arguments in the proof of Lemma B.19, we have index set of nonzero terms \mathcal{I}_i for each $i \in [n]$. Furthermore, let $\{\mathcal{J}_k\}_{k \in [R+1]}$ be the $R+1$ subintervals such that for each k , v_j takes identical values for all $j \in \mathcal{J}_k$. Since R is fixed, by similar arguments we can prove that uniformly for $k \in [R+1]$ and $i \in [n]$, we have $|\mathcal{I}_i \cap \mathcal{J}_k| \leq \frac{3}{n} |\mathcal{J}_k|$ with probability at least $1 - (Tn)^{-4R-13}$. Now we condition on this event.

By definition, $\mathbb{E}[\epsilon_t | \mathbf{x}(t)] = 0$, so for each $i \in [n]$, if we let $S_i(t) = \sum_{j \in [t]} v_{l_{i,t}} \epsilon(l_{i,t}) x_i(l_{i,t})$ for $t \in [|\mathcal{I}_i|]$ and $S_i(0) = 0$, then $\{S_i(t)\}$ is a martingale with respect to the filtration $\{\mathcal{F}_t : \mathcal{F}_t = \sigma(\mathbf{x}(l_{i,1}), \dots, \mathbf{x}(l_{i,t}))\}$. Furthermore, for any $t \in [1, T]$,

$$|S_i(t) - S_i(t-1)| \leq |v_{l_{i,t}} x_i(l_{i,t})| \leq |v_{l_{i,t}}|.$$

Thus by Lemma B.21 we have

$$\mathbb{P} \left[\left| \sum_{t \in \mathcal{I}} v_t \epsilon_t x_i(t) \right| \geq \kappa \right] \leq 2 \exp \left(-\frac{C\kappa^2}{\sum_{t \in \mathcal{I}_i} v_t^2} \right).$$

Now by the fact that $|\mathcal{I}_i \cap \mathcal{J}_k| \leq \frac{3}{n} |\mathcal{J}_k|$ for each i, k , we have $\sum_{t \in \mathcal{I}_i} v_t^2 \leq \frac{3}{n} \sum_{t \in \mathcal{I}} v_t^2$. Then the conclusion follows from a union bound. \square

Lemma B.19. Let $\epsilon_t = y_t - \frac{\exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}{1 + \exp(\mathbf{x}(t)^\top \boldsymbol{\theta}^*(t))}$. Under all assumptions in Theorem 3.2, for any integer interval $\mathcal{I} \subset [1, T]$ such that $|\mathcal{I}| \geq c_0 n \log(Tn)$ for some sufficiently large constant $c_0 > 0$, it holds with probability at least $1 - (Tn)^{-10}$

$$\max_{i \in [n]} \left| \sum_{t \in \mathcal{I}} \epsilon_t x_i(t) \right| \leq \sqrt{|\mathcal{I}| \log(Tn)} / \sqrt{n}.$$

Proof. By the assumptions of Theorem 3.2, i.e., in the comparison graph at each time point a single edge is uniformly randomly picked among all $n(n-1)/2$ edges, we know that $\mathbb{P}[|x_i(t)| = 1] = \frac{2}{n}$. Therefore, it follows from Lemma B.20 that for each $i \in [n]$ with probability at least $1 - (Tn)^{-12}$,

$$\sum_{t \in \mathcal{I}} |x_i(t)| - \frac{2}{n} |\mathcal{I}| \leq c \sqrt{\log(Tn)} \cdot \sqrt{\frac{2}{n} |\mathcal{I}|} \leq C \frac{1}{n} |\mathcal{I}|,$$

which implies that with probability at least $1 - (Tn)^{-11}$, it holds uniformly for all $i \in [n]$ that in summation $\sum_{t \in \mathcal{I}} \epsilon_t x_i(t)$ there are at most $C|\mathcal{I}|/n$ nonzero terms.

Now we condition on this event and denote for each $i \in [n]$ the index set of nonzero terms as \mathcal{I}_i . Thus we have $\sum_{t \in \mathcal{I}} \epsilon_t x_i(t) = \sum_{t \in \mathcal{I}_i} \epsilon_t x_i(t)$. For each \mathcal{I}_i , we write its elements as $l_{i,t}$ for $t \in [|\mathcal{I}_i|]$ such that $l_{i,1} < l_{i,2} < \dots < l_{i,|\mathcal{I}_i|}$.

By definition, $\mathbb{E}[\epsilon_t | \mathbf{x}(t)] = 0$, so for each $i \in [n]$, if we let $S_i(t) = \sum_{j \in [t]} \epsilon(l_{i,t}) x_i(l_{i,t})$ for $t \in [|\mathcal{I}_i|]$ and $S_i(0) = 0$, then $\{S_i(t)\}$ is a martingale with respect to the filtration $\{\mathcal{F}_t : \mathcal{F}_t = \sigma(\mathbf{x}(l_{i,1}), \dots, \mathbf{x}(l_{i,t}))\}$. Furthermore, for any $t \in [1, T]$,

$$|S_i(t) - S_i(t-1)| \leq |x_i(l_{i,t})| \leq 1.$$

Thus by Lemma B.21 and a union bound we can get the conclusion. \square

Lemma B.20. Suppose Z_1, \dots, Z_s are independent random variables with zero expectation and variance $\mathbb{E}Z_i^2 = \sigma_i^2$ satisfying $|Z_i| \leq 1$ almost surely, then

$$\mathbb{P} \left\{ \left| \sum_{i \in [s]} Z_i \right| \geq u\sigma \right\} \leq C \max \{ e^{-cu^2}, e^{-cu\sigma} \},$$

where $\sigma^2 = \sum_{i \in [s]} \sigma_i^2$, and $C, c > 0$ are universal constants. In particular, for $u \leq \sigma$, we have

$$\mathbb{P}\left\{\left|\sum_{i \in [s]} Z_i\right| \geq u\sigma\right\} \leq Ce^{-cu^2}.$$

Proof. See Theorem 2.1.3 in Tao (2012). \square

A sequence of random variables $\{D_k\}_{k \in \mathbb{Z}_+}$ is called a martingale difference if there exists a martingale $(Z_k, \mathcal{F}_k)_{k \in \mathbb{Z}_+}$ such that $D_k = Z_k - Z_{k-1}$. The following result is well-known in high-dimensional statistics (Wainwright, 2019). We include the proof for completeness and the convenience of readers.

Lemma B.21 (Azuma's Inequality or Azuma-Hoeffding Inequality). *Suppose $\{D_k\}_{k \in \mathbb{Z}_+}$ is a martingale difference. If $D_k \in (a_k, b_k)$ almost surely for some $a_k < b_k$, then*

$$\mathbb{P}\left(\left|\sum_{k=1}^n D_k\right| \geq t\right) \leq 2 \exp\left\{-\frac{2t^2}{\sum_k (b_k - a_k)^2}\right\}. \quad (\text{B.29})$$

Proof. $D_k \in (a_k, b_k)$ almost surely implies that for almost all $\omega \in \Omega$, the conditional variable $(D_k | \mathcal{F}_{k-1})(\omega) \in (a_k, b_k)$ almost surely, where $(D_k | \mathcal{F}_{k-1})(\omega)$ is defined using regular conditional distributions. By the Hoeffding's bound, $(D_k | \mathcal{F}_{k-1})(\omega)$ is sub-Gaussian with parameter $\sigma^2 = (b_k - a_k)^2/4$, for almost all ω . Therefore by the definition of sub-Gaussian random variables, we have that for almost all ω ,

$$\mathbb{E}[\exp\{\lambda(D_k | \mathcal{F}_{k-1})(\omega)\}] \leq \exp\left\{\lambda^2 \frac{(b_k - a_k)^2}{8}\right\}. \quad (\text{B.30})$$

By the property of regular conditional distributions,

$$\mathbb{E}[e^{\lambda D_k} | \mathcal{F}_{k-1}](\omega) = \mathbb{E}[\exp\{\lambda(D_k | \mathcal{F}_{k-1})(\omega)\}], \text{ almost surely.} \quad (\text{B.31})$$

Therefore

$$\mathbb{E}[e^{\lambda D_k} | \mathcal{F}_{k-1}] \leq \exp\left\{\lambda^2 \frac{(b_k - a_k)^2}{8}\right\}, \text{ almost surely.} \quad (\text{B.32})$$

Now let $\nu_k^2 = (b_k - a_k)^2/4$ and $\alpha_k = 0$ in Theorem B.22 and we can prove the inequality. \square

A random variable X with $\mathbb{E} = \mu$ is called sub-exponential with parameters ν^2 and α , or $\text{SE}(\nu^2, \alpha)$ for brevity, if

$$\mathbb{E}[e^{\lambda(X-\mu)}] \leq e^{\lambda^2 \nu^2/2}, \quad \forall |\lambda| \leq \frac{1}{\alpha}.$$

Lemma B.22. *Let $\{(D_k, \mathcal{F}_k), k \in \mathbb{Z}_+\}$ be a martingale difference s.t.*

$$\mathbb{E}[e^{\lambda D_k} | \mathcal{F}_{k-1}] \leq e^{\lambda^2 \nu_k^2/2}, \quad \forall |\lambda| \leq \frac{1}{\alpha_k}, \quad (\text{B.33})$$

almost surely. Then

- 1) $\sum_{k=1}^n D_k \in \text{SE}(\sum_k \nu_k^2, \max_k \alpha_k)$;
- 2)

$$\mathbb{P}\left(\left|\sum_k D_k\right| \geq t\right) \leq \begin{cases} 2 \exp\left\{-\frac{t^2}{2 \sum_k \nu_k^2}\right\}, & t \leq \frac{\sum_k \nu_k^2}{\max_k \alpha_k}, \\ 2 \exp\left\{-\frac{t}{2 \max_k \alpha_k}\right\}, & t > \frac{\sum_k \nu_k^2}{\max_k \alpha_k}. \end{cases} \quad (\text{B.34})$$

Proof. 1). By the iterated law of expectation

$$\mathbb{E}\left[e^{\lambda \sum_{k=1}^n D_k}\right] = \mathbb{E}\left[\mathbb{E}\left[e^{\lambda \sum_{k=1}^n D_k} | \mathcal{F}_{n-1}\right]\right]$$

$$\begin{aligned}
&= \mathbb{E} \left[\exp \left\{ \lambda \sum_{k=1}^{n-1} D_k \right\} \mathbb{E} \left[e^{\lambda D_n} \mid \mathcal{F}_{n-1} \right] \right] \\
&\leq \mathbb{E} \left[\exp \left\{ \lambda \sum_{k=1}^{n-1} D_k \right\} e^{\lambda^2 \nu_n^2 / 2} \right] \\
&= e^{\lambda^2 \nu_n^2 / 2} \mathbb{E} \left[e^{\lambda \sum_{k=1}^{n-1} D_k} \right], \text{ for } |\lambda| < \frac{1}{\alpha_n},
\end{aligned}$$

where we use the fact that $\exp\{\lambda \sum_{k=1}^{n-1} D_k\} \in \mathcal{F}_{n-1}$ and (B.33). Repeating the same procedure for $k = n-1, \dots, 2$, we can get

$$\mathbb{E} \left[e^{\lambda \sum_{k=1}^n D_k} \right] \leq e^{\lambda^2 \frac{\sum_{k=1}^n \nu_k^2}{2}}, \text{ for } |\lambda| < \frac{1}{\max_k \alpha_k}. \quad (\text{B.35})$$

2) Use the property of sub-exponential random variables and 1). □
