Generalize dissipaton theory versus Fokker–Planck quantum master equation with quadratic coupling environment.

Quadratic system—bath coupling term plays a critical role in many real—world physical models. To treat the quadratic coupling term exactly, we have developed the generalized dissipaton—equations—of—motion (DEOM) method and stochastic—fields—dressed DEOM (SFD—DEOM) method. Among them, the generalized DEOM needs to be scrutinized and SFD—DEOM has many restrictions in the application. In this article, we combine the traditional DEOM theory with the Fokker—Planck algebra. The resulting Fokker—Planck quantum master equation (FP-QME) is an exact dynamical master equation for open quantum systems, and can be directly applied to non-linear system—bath coupling cases. We scrutiny those three methods and the results witness the establishment of the exact theory and numerical method of the open quantum system under quadratic system—bath coupling.

I. INTRODUCTION

Quantum dissipation plays a crucial role in many fields of modern science. Various methods, such as hierarchical–equations–of–motion (HEOM) formalism, ^{1–8} have been constructed but are strict in the linear bath coupling cases. While the non–linear system–bath coupling cases are widespread in real–world open quantum systems and play an important role in it. Such as the vibronic optical lineshape and rate problems, ^{9–11} beyond the linear response theory. ^{12–14} The interest here is also closely related to the recent efforts toward quantum computing devices, where the fluctuations of linear noise could be effectively suppressed in optimal operational situations.

In our previous paper, we have developed dissipaton–equations–of–motion-2 (DEOM-2)¹⁵ and stochastic-fields-dressed DEOM (SFD–DEOM)¹⁶ methods to handle these scenarios. These approaches start from different physical foundations and obtain distinct equations of motion (EOM). Among them, the generalized DEOM method has a good numerical performance and more clarify algebra structure, but needs to be scrutinized. And the SFD–DEOM method is regarded as the strict numerical method, which can be utilized as the validation, but has many restrictions in the application due to the bad numerical performance.

In this paper, we treat the first-shell bath (the solvation modes) explicitly by combining the traditional HEOM theory with the Fokker-Planck (FP) algebra. We regard the core system, which was formed by the first-shell bath and the system, as the new system. This result in the coupling of the core system and the bath is always linear coupling. Then this model can be exactly solved using the traditional HEOM theory. The resulting Fokker-Planck quantum master equation (FP-QME), which can be directly applied to non-linear system-bath coupling cases, is an exact dynamical equation of motion for open quantum systems. It also explicitly treats the

solvation phase–space (both coordinate and momentum). Just like what we do in the development of phase–space DEOM theory¹⁷. As such, it extends both the application and interpretation of DEOM algebra. As shown later, we scrutiny generalized DEOM and FP-QME using SFD–DEOM approaches. These results witness the establishment of the exact theory and numerical method of the open quantum system under quadratic system–bath coupling. Especially, the validation of the Generalized Wick's Theorem–2 (GWT–2) shows the superiority of DEOM theory.⁸

The remainder of this paper is organized as follows. In Sec. II, we briefly review the FP algebra and then derive the FP-QME. In Sec. III, we cross check FP-QME not only with generalized DEOM¹⁵ but also with SFD-DEOM.¹⁶ This work is summarized in Sec. IV, together with perspectives on further applications. Throughout the paper we set $\hbar=1$ and $\beta=1/(k_BT)$, with k_B the Boltzmann constant and T the temperature.

II. HYBRIDIZED DEOM THEORY

Without loss of generality, we focus explicitly on a single–dissipative–mode case. The total system–plus–bath composite Hamiltonian reads

$$H_{\rm T} = \hat{H}_{\rm S} + \hat{Q}_{\rm S} F(\hat{x}_{\rm B}) + h_{\rm B}.$$

The system Hamiltonian \hat{H}_{S} and hybridizing mode \hat{Q}_{S} are rather arbitrary. For the bath, h_{B} and \hat{x}_{B} are modeled to be harmonic and linear; i.e.,

$$h_{\rm B} = \sum_{j} \frac{\omega_{j}}{2} (\hat{p}_{j}^{2} + \hat{x}_{j}^{2}) \text{ and } \hat{x}_{\rm B} = \sum_{j} c_{j} \hat{x}_{j}.$$

In Eq. (1), $F(\hat{x}_B)$ is assumed to be a polynomial of the solvation coordinate \hat{x}_B , i.e.,

$$F(\hat{x}_{\scriptscriptstyle B}) = \sum_{u=0}^{N_c} \alpha_u \hat{x}_{\scriptscriptstyle B}^u. \tag{3}$$

A. Hybrid description

In the hybrid description, bath Hamiltonian in Eq. (2) can be divided into the solvation modes and secondary bath parts with the Calderia–Leggett model, which reads

$$h_{\rm B} = \frac{1}{2} \omega_{\rm B} (\hat{p}_{\rm B}^2 + \hat{x}_{\rm B}^2) + \frac{1}{2} \sum_j \tilde{\omega}_j \left[\tilde{p}_j^2 + (\tilde{x}_j - \frac{\tilde{c}_j}{\tilde{\omega}_j} \hat{x}_{\rm B})^2 \right]. \tag{4}$$

The solvation mode of frequency $\omega_{\rm B}$, with coordinate operator $\hat{x}_{\rm B}$ and momentum operator $\hat{p}_{\rm B}$, is a Brownian oscillator subject to the stochastic force $\tilde{F}(t)=e^{i\tilde{h}_{\rm B}t}(\sum_{j}\tilde{c}_{j}\tilde{x}_{j})e^{-i\tilde{h}_{\rm B}t}$ from secondary $\tilde{h}_{\rm B}$ -bath oscillators $\{\tilde{\omega}_{j},\tilde{x}_{j},\tilde{p}_{j}\}$. By denoting $\hat{x}_{\rm B}(t)\equiv e^{ih_{\rm B}t}\hat{x}_{\rm B}e^{-ih_{\rm B}t}$, and $\langle\hat{O}\rangle_{\rm B}\equiv {\rm tr}_{\rm B}(\hat{O}e^{-\beta h_{\rm B}})/{\rm tr}_{\rm B}e^{-\beta h_{\rm B}}$, we can obtain

$$\langle \hat{x}_{\rm B}(t)\hat{x}_{\rm B}\rangle_{\rm B} = \frac{1}{\pi} \int_{-\infty}^{\infty} \mathrm{d}\omega \, \frac{\chi_{\rm B}''(\omega)e^{-i\omega t}}{1 - e^{-\beta\omega}},$$

with $\chi_{\scriptscriptstyle B}''(\omega) = \operatorname{Im} \chi_{\scriptscriptstyle B}(\omega)$ and

$$\chi_{\rm B}(\omega) = \frac{\omega_{\rm B}}{\omega_{\rm B}^2 - \omega^2 - i\omega\zeta_{\rm B}(\omega)}.$$

Here, $\zeta_{\rm B}(\omega) \equiv \int_0^\infty \! {\rm d}t \, e^{i\omega t} \, \tilde{\zeta}_{\rm B}(t)$, with the classical friction function reading

$$\tilde{\zeta}_{\rm B}(t) = \omega_{\rm B} \sum_{i} (\tilde{c}_{j}^{2} / \tilde{\omega}_{j}) \cos(\omega_{j} t). \tag{7}$$

The spectral density of secondary bath is then

$$\tilde{J}(\omega) = \frac{\omega}{\omega} \text{Re} \zeta_{\text{B}}(\omega),$$

with the secondary bath fluctuation-dissipation theorem reading

$$\langle \tilde{F}(t)\tilde{F}\rangle_{\tilde{B}} = \frac{1}{\pi} \int_{-\infty}^{\infty} d\omega \frac{\tilde{J}(\omega)e^{-i\omega t}}{1 - e^{-\beta\omega}}.$$

Using Eq. (9) with (8), we can write down the HEOM where system and solvation are considered to be a composite system, and the second bath correlation function contributes to the DDOs. According to the fluctuation–dissipation theorem Eq. (9), together with Matsubara, Padé, and Prony expansion, we can obtain

$$\langle \tilde{F}(t)\tilde{F}\rangle_{\tilde{\mathbf{B}}} = \sum_{k=1}^{N_K} \tilde{\eta}_k e^{-\tilde{\gamma}_k t} \quad (t > 0). \tag{10}$$

B. Hybridized DEOM

The traditional DEOM then reads

$$\dot{\rho}_{\tilde{\mathbf{n}}} = -i \left[\hat{H}_{\text{core}}, \rho_{\tilde{\mathbf{n}}} \right] - \gamma_{\tilde{\mathbf{n}}} \rho_{\tilde{\mathbf{n}}} - i \sum_{k=1}^{N_K} \left[\hat{x}_{\text{B}}, \rho_{\tilde{\mathbf{n}}_k^+} \right]$$

$$-i \sum_{k=1}^{N_K} \tilde{n}_k \left(\tilde{\eta}_k \hat{x}_{\text{B}} \rho_{\tilde{\mathbf{n}}_k^-} - \tilde{\eta}_{\tilde{k}}^* \rho_{\tilde{\mathbf{n}}_k^-} \hat{x}_{\text{B}} \right).$$

$$(11)$$

with the core-system Hamiltonian \hat{H}_{core} defined as

$$\hat{H}_{\text{core}} = \hat{H}_{\text{S}} + \hat{Q}_{\text{S}}F(\hat{x}_{\text{B}}) + \frac{\omega_{\text{B}}}{2}(\hat{p}_{\text{B}}^2 + \hat{x}_{\text{B}}^2) + \frac{1}{2}\sum_{j}\frac{\tilde{c}_{j}^2}{\tilde{\omega}_{j}}\hat{x}_{\text{B}}^2.$$

Note that with Eq. (7), we obtain the reorganization coefficient,

$$\tilde{\zeta}_{\text{B}}(0) = \frac{1}{2} \sum_{j} \frac{\tilde{c}_{j}^{2}}{\tilde{\omega}_{j}}.$$

Here, the involved $\{\rho_{\tilde{\mathbf{n}}}\}$ include both system and solvation degrees of freedom, where $\tilde{\mathbf{n}}$ is a K-dimensional vector labeling the secondary bath dissipatons. In Eq. (11), we denote $\gamma_{\tilde{\mathbf{n}}} = \sum_k \tilde{n}_k \tilde{\gamma}_k$. Written in the solvation modes in the Wigner's representation, See Eq. (A18). We can expand $\{\rho_{\tilde{\mathbf{n}}}(x_B, p_B)\}$ as

$$\rho_{\tilde{\mathbf{n}}}(x_{\mathrm{B}}, p_{\mathrm{B}}) = \left(\frac{\beta \omega_{\mathrm{B}}}{2\pi}\right)^{\frac{1}{2}} \sum_{n_{1}, n_{2}} \frac{s_{n_{1}n_{2}}}{\sqrt{n_{1}! n_{2}!}} \rho_{n_{1}n_{2}; \tilde{\mathbf{n}}} \times e^{-\frac{\beta \omega_{\mathrm{B}}}{4} (x_{\mathrm{B}}^{2} + p_{\mathrm{B}}^{2})} \Psi_{n_{1}, n_{2}}(x_{\mathrm{B}}, p_{\mathrm{B}}), \tag{14}$$

where the coefficients $\{\rho_{n_1n_2;\tilde{\mathbf{n}}}\}$ is a core system operator. It is easy to show that $\rho_{00;\tilde{\mathbf{0}}}$ is the reduced system operator. The Derivation details of Eq. (14) are in Appandix. A 1. We can obtain the EOM for $\{\rho_{n_1n_2;\tilde{\mathbf{n}}}\}$ as

$$\dot{\rho}_{n_{1}n_{2};\tilde{\mathbf{n}}} = -i \left[\mathcal{L}_{\text{core}} - \gamma_{\tilde{\mathbf{n}}} \right] \rho_{n_{1}n_{2};\tilde{\mathbf{n}}} - i \sum_{k=1}^{N_{K}} (\hat{x}_{\text{B}}^{>} - \hat{x}_{\text{B}}^{<}) \rho_{n_{1}n_{2};\tilde{\mathbf{n}}_{k}^{+}}$$

$$-i \sum_{k=1}^{N_{K}} \tilde{n}_{k} \left(\tilde{\eta}_{k} \hat{x}_{\text{B}}^{>} \rho_{n_{1}n_{2};\tilde{\mathbf{n}}_{k}^{-}} - \tilde{\eta}_{\tilde{k}}^{*} \hat{x}_{\text{B}}^{<} \rho_{n_{1}n_{2};\tilde{\mathbf{n}}_{k}^{-}} \right). \tag{15}$$

Here,

$$\mathcal{L}_{\text{core}} \rho_{n_{1}n_{2};\tilde{\mathbf{n}}} = -i \left[\frac{\omega_{\text{B}}}{2} \left(\hat{p}_{\text{B}}^{>2} + \hat{x}_{\text{B}}^{>2} - \hat{p}_{\text{B}}^{<2} - \hat{x}_{\text{B}}^{<2} \right) \right] + \tilde{\zeta}_{\text{B}}(0) \left(\hat{x}_{\text{B}}^{>2} - \hat{x}_{\text{B}}^{<2} \right) \rho_{n_{1}n_{2};\tilde{\mathbf{n}}} - i [H_{\text{S}}, \rho_{n_{1}n_{2};\tilde{\mathbf{n}}}] - i [\hat{Q}_{\text{S}} F(\hat{x}_{\text{B}}^{>}) \rho_{n_{1}n_{2};\tilde{\mathbf{n}}} - F(\hat{x}_{\text{B}}^{<}) \rho_{n_{1}n_{2};\tilde{\mathbf{n}}} \hat{Q}_{\text{S}}].$$

The Eq. (15) has the same structure as the traditional DEOM, and Eq. (16) is the Liouville operator of the core systems under the description of FP algebra. We note that it is a hybridized description of coordinate and momentum phasespace.

III. NUMERICAL DEMONSTRATION

For demonstration, we apply the Drude model,

$$\hat{\zeta}_{\text{B}}(\omega) = \frac{i\tilde{\eta}\,\omega_{\text{B}}}{\omega + i\tilde{\gamma}},\tag{17}$$

for the second bath, which lead to $\tilde{J}(\omega)$ the expression [c.f. Eq. (8)]

$$\tilde{J}(\omega) = \frac{\tilde{\eta}\,\tilde{\gamma}\omega}{\omega^2 + \tilde{\gamma}^2}.\tag{18}$$

For numerical demonstrations, we select a two-state model system as in Ref. 15. In this model, the Eq. (1) can be described by

$$H_{\rm T} = h_e |g\rangle\langle g| + (h_e + \Delta)|e\rangle\langle e|, \tag{19}$$

where.

$$h_e = \frac{1}{2}\omega_{\rm B}(\hat{p}_{\rm B}^2 + \hat{x}_{\rm B}^2) + \frac{1}{2}\sum_k \widetilde{\omega}_k [\widetilde{p}_k^2 + (\widetilde{x}_k - \frac{\widetilde{c}_k}{\widetilde{\omega}_k}\hat{x}_{\rm B})^2], \quad (20)$$

and,

$$h_g = \frac{1}{2}\omega_{\rm B}'(\hat{p}_{\rm B}'^2 + \hat{x}_{\rm B}'^2) + \frac{1}{2}\sum_{k}\widetilde{\omega}_{k}'[\tilde{p}_{k}'^2 + (\tilde{x}_{k}' - \frac{\tilde{c}_{k}'}{\widetilde{\omega}_{k}'}\hat{x}_{\rm B}')^2], \quad (21)$$

follow the Caldeira–Leggett's interaction form. ¹⁸ Then in the H_g –based description, H_T can be reformulated as:

$$H_{T} = \Delta |e\rangle\langle e| + h_{g} + (h_{e} - h_{g})|e\rangle\langle e|$$

$$= \Delta |e\rangle\langle e| + h_{g} + (\alpha_{0} + \alpha_{1}\hat{x}_{B} + \alpha_{2}\hat{x}_{B}^{2})|e\rangle\langle e|, \qquad (22)$$

where,

$$\alpha_0 = \lambda \theta_B^2$$
, $\alpha_1 = -(2\lambda \omega_B)^{\frac{1}{2}} \theta_B^2$, $\alpha_2 = \frac{\omega_B}{2} (\theta_B^2 - 1)$. (23)

Here, λ represents the linear–displacement induced reorganization and $\theta_B = \omega_B'/\omega_B$.

In this article, we only consider the scenario that $F(\hat{x}_B) = \alpha_0 + \alpha_1 \hat{x}_B + \alpha_1 \hat{x}_B^2$ due to the designated model described before. We can use Eq. (A22) to obtain the explicit result; See appendix B. Note in Eq. (15), the $F(\hat{x}_B^<)$ only appears in one term, so the FP–QME is still a general method for nonlinear coupling and a little modification is needed in the other cases. As the validation step, we show the evolution of the FP–QME, SFD–DEOM, and generalize DEOM. Although these SFD–DEOM and generalized DEOM methods are applicable in this scenario. To have consistency in the dynamic evolution, we must set these two methods with the same initial state. So we use step Hamiltonian $H_T = \omega_{eg} |e\rangle \langle e| + V\Theta(t) (|e\rangle \langle g| + |g\rangle \langle e|)$ to make sure they have the same initial state at t = 0, where the $\Theta(t)$ is the step function. This step Hamiltonian guarantee the initial state at t = 0 is the equilibrium state of $H_T = \omega_{eg} |e\rangle \langle e|$.

In this paper, we set $\omega_{\rm B}=\Delta$, $\tilde{\eta}=10\Delta$, $\tilde{\gamma}=15\Delta$, $\beta\Delta=1$. We truncate the FP-QME by set all ADO satisfied $n_1+n_2>8$ and $\sum_k \tilde{\mathbf{n}}_k>30$ to 0 with filter as 1×10^{-8} , these results are converged compare to $L_{\rm FP}=9$ and $L_{\rm Tra}=40$. The SFD-DEOM method uses 100000 samples and the generalized DEOM method truncates at L=40 with the same filter as FP-QME. We set $\omega_{eg}=\Delta$ in the validation step and $\omega_{eg}=50\Delta$ in the calculation of spectrum density.

We show the evolution of the von Neumann entropy (upper panel) and the density matrix (lower panel) under step Hamiltonian in Fig. 2 with $\omega_{eg} = \Delta$ and $[\theta_B, \lambda]$ parameters: $[8/9, 0.1\Delta]$, and corresponding coupling strength $[\alpha_0, \alpha_1, \alpha_2]$ are: [0.13, -0.57, 0.13]. It can be seen that the result of generalized DEOM is the same as FP–QME. The result of generalized DEOM and FP–QME have a little bit different from SFD–DEOM, especially in the long time region. This may be




FIG. 1. Validation of FP–QME and generalized DEOM with nolinear effect. We set $\omega_{eg} = 50\Delta$. and the parameters of the spectrum density are: $\omega_B = \Delta$, $\tilde{\eta} = 10\Delta$, $\tilde{\gamma} = 15\Delta$, $\beta\Delta = 1$. The $[\theta_B, \eta]$ parameters are [9/8, 0.1]. Here, $S_{\nu N} = -\text{Tr}(\rho ln\rho)$ and $\langle \sigma_z \rangle = \text{Tr}(\rho \sigma_z) = \rho_S^{ee} - \rho_S^{gg}$.

caused by the difficulty in the convergence of SFD–DEOM for a long time. Those numerical results, especially, the results of the SFD–DEOM, mean the obtained FP–QME and the generalized DEOM are validated. The different structures in generalized DEOM and FP–QME can be viewed as different truncate schemes. ¹⁹




FIG. 2. Comparison of absorption spectra using FP–QME and generalized DEOM. Parameters of spectrum density are the same as Fig. 1. The $[\theta_{\rm B},~\eta]$ parameters are $[4/3,~0.25\Delta],~[4/3,~0],~[1,~\Delta],~\omega_{eg}=50\Delta$ and others the same as Fig. 1.

The results of the absorption spectrum using FP-QME and generalized DEOM are also shown in the Fig. 2. The SFD-DEOM is absent due to difficulty in converging. The absorption spectrum is defined as:

$$S(\omega) = \operatorname{Re} \int_0^\infty t e^{i\omega t} \langle \hat{\mu}_{\mathbf{S}}(t) \hat{\mu}_{\mathbf{S}}(0) \rangle, \tag{24}$$

where, $\mu_{\rm S} = |e\rangle\langle g| + |g\rangle\langle e|$. The detailed protocol of evolution on the dipole–dipole correlation function via traditional DEOM can be found in Ref. 20. The only difference in the protocol of the FP-QME is in the first step. The initial state $(\rho_{0...0} = |e\rangle\langle e|)$ is the equilibrium state in the generalized DEOM and SFD–DEOM methods but not in the FP-QME methods. Under the FP-QME, we have to solve the equilibrium state to obtain the same equilibrium state as other DEOM (DEOM, generalized DEOM, and SFD–DEOM) methods.

As shown in Fig. 2, the FP-QME can obtain the same result as GWT-2 DEOM with $\omega_{eg} = 50\Delta$ and different $[\theta_{\rm B}, \lambda]$ parameters: $[4/3, 0.25\Delta]$, [4/3, 0], $[1, \Delta]$, and corresponding coupling strength $[\alpha_0, \alpha_1, \alpha_2]$ are: [0.44, -1.26, 0.39], [1.00, -1.41, 0.00], [0.00, -0.00, 0.39]. We use the same truncate as before. The numerical unstable in FP-QME are observed under parameters of $[4/3, 0.5\Delta]$ and $[3/4, \Delta]$. Moreover, the reported numerical unstable in generalized DEOM¹⁵ is confirmed under FP-QME, and both the numerical stability and

numerical performance of FP-QME are much worse than generalized DEOM.

IV. SUMMARY

In this paper, we scrutiny dissipaton-equations-of-motion-2 (DEOM-2) theorem via the FP-OME methods. The FP-QME methods, combining the traditional with FP algebra, have the consistent result with the DEOM-2¹⁵ and SFD-DEOM¹⁶ we developed before. The consistent numerical methods under the quadratic system-bath coupling scenarios, which plays a critical role in many real-world physical models, can provide a broader and more detailed range of applications for the theoretical study of the open quantum system. Specifically, these methods can be directly applied to nonlinear system-bath coupling cases and possess application prospects in various subjects such as spectra and dynamics in the excitation energy transfer processing and molecular dynamics. Moreover, in the theoretical aspects, the FP-QME can be regarded as an extension of DEOM theory, which treats the solvation phase–space (both coordinate and momentum) explicitly and extends the meaning of dissipaton a lot.

Appendix A: FP operator and FP algebra

In this appendix, we combine the traditional HEOM theory with the Fokker–Planck (FP) algebra. The result in hybridized DEOM theory is an exact dynamical theory for open quantum systems, and it also treats the solvation phase–space (both coordinate and momentum) explicitly. This formalism can be directly applied to nonlinear system–bath coupling cases, which is beyond the scope of existing DEOM formalism.

1. Review of FP algebra

We start with Eq. (5). In the Markovian limit, $\zeta_B(\omega) = \zeta_B$. By further adopting the high-temperature approximation, ²¹ we have

$$\langle \hat{x}_{\mathrm{B}}(t)\hat{x}_{\mathrm{B}}(0)\rangle_{\mathrm{B}} \approx \eta_{+}e^{-\gamma_{+}t} + \eta_{-}e^{-\gamma_{-}t},$$
 (A1)

with

$$\gamma_{\pm} = \frac{1}{2} [\zeta_{\rm B} \pm (\zeta_{\rm B}^2 - 4\omega_{\rm B}^2)^{\frac{1}{2}}], \tag{A2}$$

and

$$\eta_{\pm} = \mp \frac{\omega_{\rm B}}{\gamma_{+} - \gamma_{-}} \left(\frac{1}{\beta \gamma_{\pm}} - \frac{i}{2} \right). \tag{A3}$$

It should be noticed that the Markovian and high-temperature limit are needed only for the construction of FP operator and FP algebra, and are not necessary for the derivation of FP-QME.

Now we construct the FP operator that would generate FP algebra. It reads
