

# Equilibrium Pricing of Securities in the Co-presence of Cooperative and Non-cooperative Populations

## Abstract

In this work, we develop an equilibrium model for price formation of securities in a market composed of two populations of different types: the first one consists of cooperative agents, while the other one consists of non-cooperative agents. The trading of every cooperative member is assumed to be coordinated by a central planner. In the large population limit, the problem for the central planner is shown to be a conditional extended mean-field control. In addition to the convexity assumptions, if the relative size of the cooperative population is small enough, then we are able to show the existence of a unique equilibrium for both the finite-agent and the mean-field models. The strong convergence to the mean-field model is also proved under the same conditions.

**Keywords :** market clearing, mean-field games, extended mean-field control, controlled-FBSDEs

## 1 Introduction

In this paper, we study the problem of equilibrium price formation by considering, as an example, a simple model of a securities market. The prices of securities have always been the center of interest of many people for centuries. They inspire people to consider their properties not only for speculative reasons but also for true academic interests, such as how they are determined, how they behave in a given environment, how they are influenced by preferences and the level of risk-averseness of investors, and so on. In fact, since the appearance of modern securities markets, the huge amount of price data they provide have induced the significant developments of related academic areas, such as financial mathematics, financial economics, statistical inference etc. However, despite its importance, we are still quite far from the complete understanding of a price process even when we restrict our attention to a standard liquid stock. The main reason behind this difficulty is that any price process is inevitably affected by complicated interactions among a large number of market participants, which includes various financial firms, individual investors, governments and even supernational institutions.

The recent progress in the mean field game (MFG) theory has started to shed new light on the long-standing problem of multi-agent games. The MFG theory was pioneered by the seminal works of Lasry & Lions [42, 43, 44] and Huang et al. [37, 38, 39], which characterizes a Nash equilibrium by a coupled system of Hamilton-Jacobi-Bellman and Kolmogorov equations. A probabilistic approach to the MFG theory based on forward backward stochastic differential equations (FBSDEs) of McKean-Vlasov type was established by Carmona & Delarue [11, 12]. The two volumes of [13, 14] by the same authors provide the readers a detailed account of the topic. The method using the concept of relaxed controls (see, for example, [40, 41]), which can significantly weaken the regularity assumptions, has also been intensively studied. For interested readers, there are an excellent lecture note [10] and many monographs such as [9, 32, 33] on various topics regarding the MFG theory.

Along side of its theoretical developments, MFGs have successfully found vast applications in various areas. In particular, energy and financial markets have been popular targets for applications. As is well known, any price in these free competitive markets is determined so that it balances the supply and demand of the asset. Unfortunately, this *market clearing condition* does not fit well to the concept of Nash equilibrium. In fact, if we shift a control of one agent away from her equilibrium strategy while keeping the others unchanged, then the market clearing condition would be broken down. Since the MFG theory has been developed primarily for the analysis of Nash equilibrium, a standard approach in the literature assumes a specific structure of the price process without imposing the market clearing condition. A popular way is to hypothesize that the price process is decomposed into two parts; one is a so-called fundamental price whose dynamics is exogenously given and the other is a price-impact term whose size is affected by actions of agents in a specific manner. Another way is to suppose that a price is given by a certain function of total demand or supply of the asset. One can find many interesting examples on optimal executions [25, 26, 20], games in a smart grid [5, 16], price formation in an electricity market [22, 23], entry and exit games [3], trading with different beliefs [15], and trading of exhaustible commodities [36], just name a few. There are also macroeconomic applications of MFGs, for examples, on growth, inequality and unemployment, and so on [2, 4, 8, 30].

In the above examples, the structure of a price process is assumed exogenously and the emphasis of research is not on the price process itself. In this paper, on the other hand, our primary interest is in the construction of a price process endogenously from the market clearing condition. There has also been recent progress in the field of MFGs regarding this direction of research. Gomes & Saúde [34] present a deterministic model of electricity price formation. Different mathematical approaches and numerical calculation techniques on the same model are developed by Ashrafyan et al. [6, 7]. Its generalization with a random supply function is provided by Gomes et al. [31]. Evangelista et al. [21] use the actual high-frequency data to give a promising numerical results for the listed stocks in several exchanges. Shrivats et al. [52] solve the price formation problem of solar renewable energy certificate (SREC), and Firoozi et al. [24] deal with a principal-agent problem in the associated emission market. Fujii & Takahashi [27] solve a stochastic mean-field price model of securities and prove that the market is cleared in the large population limit. In [28], the same authors provide the FBSDE characterization of the market clearing price in the finite-agent market, and then prove its strong convergence to the mean-field model of [27]. Its extension to the presence of a major agent is studied in [29].

In this paper, we build upon the previous works [27, 28, 29] and develop a new model of a securities market composed of **two populations of different types**: the first one consists of cooperative agents, while the other one consists of non-cooperative agents. Every agent is supposed to be a registered financial firm and tries to minimize her cost functional by the continuous trading at the common exchange. What is new in this paper is the existence of the cooperative population, which can be a large number of subsidiaries of a giant financial group or a temporary alliance of many financial firms for a certain purpose. The trading of every cooperative member is assumed to be coordinated by a central planner. We show that, in the mean field limit, this cooperation makes the problem of the central planner an *extended mean-field control* [1] with common noise, where the law of the controls of the cooperative agents enters her cost functional. Here, let us refer to some works on extended mean-field control problems: Graber [35] studies a linear-quadratic model for production of a exhaustible resource. Acciaio et al. [1] present the necessary and sufficient conditions of Pontryagin's maximum principle. Motte & Pham [45] investigate a mean-field Markov decision problem. Djete et al. [17, 18] and Djete [19] provide a dynamic programming principle as well as the limit theory by making use of the relaxed control technique and its generalization.

To the author's knowledge, this is the first work studying the equilibrium price formation in the co-presence of cooperative and non-cooperative agents. Using a general convex cost function for the cooperative agents, we show that there exists a unique market clearing equilibrium for a given duration if the relative size of the cooperative population is small enough. After solving the problem in the finite-agent market, we construct the corresponding MFG model and finally prove the strong

convergence when the large population limit is taken. We want to emphasize that, although we have chosen a model of a securities market, the developed methods (with appropriate modifications) will also be useful to describe other markets with cooperative producers and/or buyers, such as, a crude oil market with a cooperative association of exporters i.e. OPEC. In addition to the financial economics perspective, the current work also contributes to the MFG theory in general. Firstly, in addition to the sufficiency, we show the existence of a unique optimal solution to an extended mean-field control problem. The existence result using the adjoint equations for this type of problem is new except those obtained in the linear-quadratic settings [1, 35]. Next, although the general convergence results for extended mean-field control problems are already studied by [18, 19], our proof is directly built upon the result for the standard (not extended) mean-field control problem by Carmona & Delarue [12] and the monotonicity technique used in [28]. In return for strong convexity assumptions, the proof is more straightforward.

The organization of the paper is as follows. After explaining some notations in Section 2, we solve the finite-agent market model in Section 3. The corresponding mean-field model is built and solved in Section 4. Finally, in Section 5, we prove the strong convergence to the mean-field limit. Section 6 concludes the paper.

## 2 Notations

We first introduce  $(1 + N_1 + N_2)$  complete probability spaces.

- $(\Omega^0, \mathcal{F}^0, \mathbb{P}^0)$  is a complete probability space with a complete and right-continuous filtration  $\mathbb{F}^0 := (\mathcal{F}_t^0)_{t \geq 0}$  generated by  $d_0$ -dimensional standard Brownian motion  $W^0 := (W_t^0)_{t \geq 0}$ .
- For each  $1 \leq i \leq N_1$ ,  $(\bar{\Omega}^{1,i}, \bar{\mathcal{F}}^{1,i}, \bar{\mathbb{P}}^{1,i})$  is a complete probability space with a complete and right-continuous filtration  $\bar{\mathbb{F}}^{1,i} := (\bar{\mathcal{F}}_t^{1,i})_{t \geq 0}$  generated by  $d_1$ -dimensional standard Brownian motion  $W^i := (W_t^i)_{t \geq 0}$  and a  $\sigma$ -algebra  $\sigma(\xi^i)$  belonging to  $\bar{\mathcal{F}}_0^{1,i}$ , generated by a square integrable  $\mathbb{R}^n$ -valued random variable  $\xi^i$ . The distribution of  $\xi^i$  is the same for every  $i$ .
- For each  $1 \leq j \leq N_2$ ,  $(\bar{\Omega}^{2,j}, \bar{\mathcal{F}}^{2,j}, \bar{\mathbb{P}}^{2,j})$  is a complete probability space with a complete and right-continuous filtration  $\bar{\mathbb{F}}^{2,j} := (\bar{\mathcal{F}}_t^{2,j})_{t \geq 0}$  generated by  $d_2$ -dimensional standard Brownian motion  $B^j := (B_t^j)_{t \geq 0}$  and a  $\sigma$ -algebra  $\sigma(\eta^j)$  belonging to  $\bar{\mathcal{F}}_0^{2,j}$ , generated by a square integrable  $\mathbb{R}^n$ -valued random variable  $\eta^j$ . The distribution of  $\eta^j$  is the same for every  $j$ .

We then introduce probability spaces defined by the Cartesian products of those defined above.

- $(\bar{\Omega}, \bar{\mathcal{F}}, \bar{\mathbb{P}})$  is a probability space defined by the product  $\bar{\Omega} := \bar{\Omega}^{1,1} \times \dots \times \bar{\Omega}^{1,N_1} \times \bar{\Omega}^{2,1} \times \dots \times \bar{\Omega}^{2,N_2}$  with  $(\bar{\mathcal{F}}, \bar{\mathbb{P}})$  the completion of  $(\otimes_{i=1}^{N_1} \bar{\mathcal{F}}^{1,i} \otimes_{j=1}^{N_2} \bar{\mathcal{F}}^{2,j}, \otimes_{i=1}^{N_1} \bar{\mathbb{P}}^{1,i} \otimes_{j=1}^{N_2} \bar{\mathbb{P}}^{2,j})$ .  $\bar{\mathbb{F}} := (\bar{\mathcal{F}}_t)_{t \geq 0}$  denotes the complete and right-continuous augmentation of  $(\otimes_{i=1}^{N_1} \bar{\mathcal{F}}_t^{1,i} \otimes_{j=1}^{N_2} \bar{\mathcal{F}}_t^{2,j})_{t \geq 0}$ .
- $(\Omega, \mathcal{F}, \mathbb{P})$  is a probability space defined by the product  $\Omega := \Omega^0 \times \bar{\Omega}$  with  $(\mathcal{F}, \mathbb{P})$  the completion of  $(\mathcal{F}^0 \otimes \bar{\mathcal{F}}, \mathbb{P}^0 \otimes \bar{\mathbb{P}})$ .  $\mathbb{F} := (\mathcal{F}_t)_{t \geq 0}$  denotes the complete and right-continuous augmentation of  $(\mathcal{F}_t^0 \otimes \bar{\mathcal{F}}_t)_{t \geq 0}$ . The expectation with respect to  $\mathbb{P}$  is denoted by  $\mathbb{E}[\cdot]$ , and a generic element of  $\Omega$  is denoted by  $\omega = (\omega^0, \bar{\omega})$  with  $\omega^0 \in \Omega^0$  and  $\bar{\omega} \in \bar{\Omega}$ .

For notational simplicity, we do not distinguish a random variable  $X$  defined on a marginal probability space, such as  $(\bar{\Omega}, \bar{\mathcal{F}}, \bar{\mathbb{P}})$ , with its natural extension to  $(\Omega, \mathcal{F}, \mathbb{P})$ . Without loss of generality, we may always suppose that the probability spaces are the completions of those countably generated by working on the Borel sets of appropriate Polish spaces.

Throughout the work,  $T (> 0)$  is a given time horizon, the symbol  $L$  denotes a given positive constant, and the symbol  $C$  a general positive constant which may change line by line. For any measurable space  $(\Omega, \mathcal{G})$  with filtration  $\mathbb{G} := (\mathcal{G}_t)_{t \geq 0}$ , we use the following notations for frequently encountered spaces:

- $\mathcal{S}_+^n$  denotes the space of  $n \times n$  strictly positive definite symmetric matrices.
- $\mathbb{L}^2(\mathbb{G}; \mathbb{R}^d)$  denotes the set of  $\mathbb{R}^d$ -valued  $\mathbb{G}$ -measurable random variables  $X$  satisfying

$$\|X\|_{\mathbb{L}^2} := \mathbb{E}[|X|^2]^{\frac{1}{2}} < \infty.$$

- $\mathbb{S}^2(\mathbb{G}; \mathbb{R}^d)$  is the set of  $\mathbb{R}^d$ -valued  $\mathbb{G}$ -adapted continuous processes  $X$  satisfying

$$\|X\|_{\mathbb{S}^2} := \mathbb{E}\left[\sup_{t \in [0, T]} |X_t|^2\right]^{\frac{1}{2}} < \infty.$$

- $\mathbb{H}^2(\mathbb{G}; \mathbb{R}^d)$  is the set of  $\mathbb{R}^d$ -valued  $\mathbb{G}$ -progressively measurable processes  $Z$  satisfying

$$\|Z\|_{\mathbb{H}^2} := \mathbb{E}\left[\left(\int_0^T |Z_t|^2 dt\right)\right]^{\frac{1}{2}} < \infty.$$

- $\mathcal{L}(X)$  denotes the law of a random variable  $X$ .
- $\mathcal{P}(\mathbb{R}^d)$  is the set of probability measures on  $(\mathbb{R}^d, \mathcal{B}(\mathbb{R}^d))$ .
- $\mathcal{P}_p(\mathbb{R}^d)$  with  $p \geq 1$  is the subset of  $\mathcal{P}(\mathbb{R}^d)$  with finite  $p$ th moment, i.e. the set of  $\mu \in \mathcal{P}(\mathbb{R}^d)$  satisfying

$$M_p(\mu) := \left(\int_{\mathbb{R}^d} |x|^p \mu(dx)\right)^{\frac{1}{p}} < \infty.$$

We always assign  $\mathcal{P}_p(\mathbb{R}^d)$  the  $p$ -Wasserstein distance  $W_p$ , which makes  $\mathcal{P}_p(\mathbb{R}^d)$  a Polish space. It is defined by, for any  $\mu, \nu \in \mathcal{P}_p(\mathbb{R}^d)$ ,

$$W_p(\mu, \nu) := \inf_{\pi \in \Pi_p(\mu, \nu)} \left[ \left( \int_{\mathbb{R}^d \times \mathbb{R}^d} |x - y|^p \pi(dx, dy) \right)^{\frac{1}{p}} \right],$$

whre  $\Pi_p(\mu, \nu) \subset \mathcal{P}_p(\mathbb{R}^d \times \mathbb{R}^d)$  denotes the set of probability measures with marginals  $\mu$  and  $\nu$ .

- For  $k = 1, 2$ , the empirical mean of  $N_k$  variables  $(x^i)_{i=1}^{N_k}$  is denoted by  $\mathbf{m}_k(x) := \frac{1}{N_k} \sum_{i=1}^{N_k} x^i$ .

We often omit the arguments such as  $(\mathbb{G}, \mathbb{R}^d)$  when they are clear from the context.

### 3 Price formation in a finite-agent market

In this section, we consider the price formation problem in a finite-agent market composed of two populations: the first one consists of  $N_1$  cooperative agents, and the second one consists of  $N_2$  non-cooperative agents. We often use  $i$  (respectively,  $j$ ) to index an agent in the first (respectively, second) population. Each agent represents a registered financial firm trading at a common securities exchange. She is supposed to have many individual clients who cannot directly access to the exchange, and she provides financial services by using her own inventory to answer the sale and purchase requests from those clients. This is the so-called over-the-counter (OTC) market. Therefore, every agent faces the stochastic order flows from her OTC clients in addition to idiosyncratic as well as common market shocks. Under such an environment, every agent carries out the optimal continuous trading at the exchange to minimize her cost functional. For the members of the first population, we assume that every trading is coordinated by a central planner.

We suppose that there are  $n$  tradable securities in the market, whose prices are denoted by  $(\varpi_t^k)_{k=1}^n$ . The goal of the paper is to determine the price process  $\varpi := (\varpi_t)_{t \in [0, T]}$  endogenously so that it clears the market, i.e. matches the supply and demand of securities at the exchange. Unless otherwise stated, we will work on the filtered probability space  $(\Omega, \mathcal{F}, \mathbb{F}, \mathbb{P})$  defined in the last section. By construction,  $(\xi^i)_{i=1}^{N_1}$  and also  $(\eta^j)_{j=1}^{N_2}$  are independently and identically distributed (i.i.d.). Let us introduce the following processes to describe the various types of information:

- $c^0 := (c_t^0)_{t \in [0, T]}$  belongs to  $\mathbb{H}^2(\mathbb{F}^0; \mathbb{R}^m)$  with  $\sup_{t \in [0, T]} \mathbb{E}[|c_t^0|^2] < \infty$ , which is used to represent common market information including the cash flows from the securities.
- For  $1 \leq i \leq N_1$ ,  $c^i := (c_t^i)_{t \in [0, T]}$  belongs to  $\mathbb{H}^2(\overline{\mathbb{F}}^{1, i}; \mathbb{R}^m)$  with  $\sup_{t \in [0, T]} \mathbb{E}[|c_t^i|^2] < \infty$ . They are used to represent idiosyncratic noises for the first population, and  $(c^i)_{i=1}^{N_1}$  are i.i.d.
- For  $1 \leq j \leq N_2$ ,  $\mathbf{c}^j := (\mathbf{c}_t^j)_{t \in [0, T]}$  belongs to  $\mathbb{H}^2(\overline{\mathbb{F}}^{2, j}; \mathbb{R}^m)$  with  $\sup_{t \in [0, T]} \mathbb{E}[|\mathbf{c}_t^j|^2] < \infty$ . They are used to represent idiosyncratic noises for the second population, and  $(\mathbf{c}^j)_{j=1}^{N_2}$  are i.i.d.

Here, the dimension  $m \in \mathbb{N}$  is commonly chosen just for notational simplicity.

### 3.1 Problem for the non-cooperative agents

#### 3.1.1 Problem description

We first study the problem for the non-cooperative agents in the second population. Here, we basically follow the technique developed in [27, 28]. Let us introduce three  $\mathbb{F}^0$ -progressively measurable bounded processes,  $b := (b_t)_{t \in [0, T]}$ ,  $\rho_2 := (\rho_2(t))_{t \in [0, T]}$  and  $\Lambda = (\Lambda_t)_{t \in [0, T]}$ , where  $b_t$  and  $\rho_2(t)$  are non-negative, and  $\Lambda_t$  is  $\mathcal{S}_+^n$ -valued. We introduce the following measurable functions;  $l_2 : [0, T] \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}^n$ ,  $(\sigma_2^0, \sigma_2) : [0, T] \times (\mathbb{R}^m)^2 \rightarrow (\mathbb{R}^{n \times d_0}, \mathbb{R}^{n \times d_2})$ ,  $\overline{f}_2 : [0, T] \times \mathbb{R}^n \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}$  and  $g_2 : \mathbb{R}^n \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}$ . For each  $t \in [0, T]$ ,  $x, \varpi, \alpha \in \mathbb{R}^n$ ,  $c^0, \mathbf{c} \in \mathbb{R}^m$ , we also set

$$f_2(t, x, \varpi, \alpha, c^0, \mathbf{c}) := \langle \alpha, \varpi \rangle + \frac{1}{2} \langle \alpha, \Lambda_t \alpha \rangle - b_t \langle x, \varpi \rangle + \overline{f}_2(t, x, c^0, \mathbf{c}).$$

Here,  $\langle \cdot, \cdot \rangle$  denotes an inner product of  $n$ -dimensional vectors. For given stochastic processes  $(c_t^0, (\mathbf{c}_t^j)_{j=1}^{N_2}, b_t, \Lambda_t)_{t \in [0, T]}$ , we use the following abbreviations to simplify the notations: for  $1 \leq j \leq N_2$  and  $(t, x, \varpi, \alpha) \in [0, T] \times (\mathbb{R}^n)^3$ ,

$$\begin{aligned} l_2^j(t) &:= l_2(t, c_t^0, \mathbf{c}_t^j), & (\sigma_2^{j,0}(t), \sigma_2^j(t)) &:= (\sigma_2^0, \sigma_2)(t, c_t^0, \mathbf{c}_t^j), \\ \overline{f}_2^j(t, x) &:= \overline{f}_2(t, x, c_t^0, \mathbf{c}_t^j), & g_2^j(x) &:= g_2(x, c_T^0, \mathbf{c}_T^j), \\ f_2^j(t, x, \varpi, \alpha) &:= \langle \alpha, \varpi \rangle + \frac{1}{2} \langle \alpha, \Lambda_t \alpha \rangle - b_t \langle x, \varpi \rangle + \overline{f}_2^j(t, x). \end{aligned} \tag{3.1}$$

Before providing various conditions on these functions, let us describe the financial problem for each non-cooperative agent indexed by  $j = 1, \dots, N_2$ . The following concept is important.

**Definition 3.1** (price taker). *An agent is called a price taker if she behaves under the assumption that there is no price impact from her trading. In other words, she always accepts the market price as it is without trying to control it.*

The following assumption is used throughout this work.

**Assumption 3.1.** *Every non-cooperative agent is a price taker.*

This is a natural assumption if the size of population  $N_2$  is large enough so that the market share of every individual agent is negligibly small. Under Assumption 3.1, every non-cooperative agent considers the price process  $\varpi \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  of the  $n$  securities as an exogenously given input. We suppose that the problem for each non-cooperative agent  $1 \leq j \leq N_2$  is to minimize the cost functional

$$\inf_{\alpha^j \in \mathbb{A}_2} J^j(\alpha^j) \tag{3.2}$$

under the dynamic constraint

$$dx_t^j = (\alpha_t^j + \rho_2(t)\varpi_t + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \quad x_0^j = \eta^j.$$

Here, the cost functional is defined by

$$J^j(\alpha^j) := \mathbb{E} \left[ \int_0^T f_2^j(t, x_t^j, \varpi_t, \alpha_t^j) dt + g_2^j(x_T^j) \right],$$

and  $\mathbb{A}_2 := \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  is the space of admissible controls.

Let us provide an economic interpretation of each term;  $x^j = (x_t^j)_{t \in [0, T]}$  is an  $\mathbb{R}^n$ -valued process giving the time evolution of the position size of the  $n$  securities for the  $j$ th agent, and  $\eta^j$  denotes its initial value. Any negative component of  $(x_t^j) \in \mathbb{R}^n$  represents a short position at time  $t$ .  $\alpha^j = (\alpha_t^j)_{t \in [0, T]} \in \mathbb{A}_2$  is a control of the  $j$ th agent denoting her trading rate of the securities. Here, each component of  $\alpha_t^j dt$  ( $\in \mathbb{R}^n$ ) gives the amount of the corresponding security bought (or sold if negative) at the exchange within a time interval  $[t, t + dt]$ . In addition to the direct trading via the exchange, the level of her inventory is affected by the stochastic order flows from her OTC clients, which are described by  $(\rho_2(t)\varpi_t + l_2^j(t))dt$  and  $(\sigma_2^{j,0}(t)dW_t^0, \sigma_2^j(t)dB_t^j)$ . In particular, the term  $\rho_2(t)\varpi_t$  represents a reaction of her clients to the price level.  $f_2^j$  and  $g_2^j$  denote the running and terminal cost functions, respectively;  $\langle \alpha, \varpi \rangle$  in  $f_2^j$  represents the direct trading cost of the securities of price  $\varpi$  with trading rate  $\alpha$ ;  $\frac{1}{2}\langle \alpha, \Lambda_t \alpha \rangle$  an internal trading cost or a trading fee to be paid to the exchange;  $-b_t \langle x, \varpi \rangle$  the reduction of the cost based on the mark-to-market value of the inventory with a stochastic discount factor  $b_t$ ;  $\bar{f}_2^j$  the other contributions to the running cost depending on the inventory level, informations and cash flows  $(c^0, \mathbf{c}^j)$ . The terminal cost function  $g_2^j$  represents the penalty on the open position at the closing time  $T$ .

**Remark 3.1.** From the problem setup and (3.1), we see that all the heterogeneities among the non-cooperative agents come from i.i.d. inputs only; idiosyncratic informations  $(\mathbf{c}^j)_{j=1}^{N_2}$ , initial conditions  $(\eta^j)_{j=1}^{N_2}$ , and the Brownian motions  $(B^j)_{j=1}^{N_2}$ .

### 3.1.2 Solving the individual problem for $j = 1, \dots, N_2$

In order to solve the above problem, let us introduce the following conditions.

**Assumption 3.2.** (i)  $\Lambda = (\Lambda_t)_{t \in [0, T]}$  is an  $\mathbb{F}^0$ -progressively measurable  $\mathcal{S}_+^n$ -valued process such that both  $\Lambda_t$  and  $\bar{\Lambda}_t$  ( $:= \Lambda_t^{-1}$ ) are bounded by  $L$  for every  $t \in [0, T]$ .

(ii) For every  $(t, c^0, \mathbf{c}) \in [0, T] \times (\mathbb{R}^m)^2$ ,  $|l_2(t, c^0, \mathbf{c})| + |\sigma_2^0(t, c^0, \mathbf{c})| + |\sigma_2(t, c^0, \mathbf{c})| \leq L(1 + |c^0| + |\mathbf{c}|)$ .

(iii) For every  $(t, x, c^0, \mathbf{c}) \in [0, T] \times \mathbb{R}^n \times (\mathbb{R}^m)^2$ ,  $|\bar{f}_2(t, x, c^0, \mathbf{c})| + |g_2(x, c^0, \mathbf{c})| \leq L(1 + |x|^2 + |c^0|^2 + |\mathbf{c}|^2)$ .

(iv) For every  $(t, c^0, \mathbf{c}) \in [0, T] \times (\mathbb{R}^m)^2$ ,  $\bar{f}_2$  and  $g_2$  are once continuously differentiable in  $x$ , and their derivatives have the affine form in  $x$ :

$$\partial_x \bar{f}_2(t, x, c^0, \mathbf{c}) = c_f(t, c^0, \mathbf{c})x + h_f(t, c^0, \mathbf{c}), \quad \partial_x g_2(x, c^0, \mathbf{c}) = c_g(c^0, \mathbf{c})x + h_g(c^0, \mathbf{c}).$$

Here,  $(c_f, h_f) : [0, T] \times (\mathbb{R}^m)^2 \rightarrow (\mathcal{S}_+^n, \mathbb{R}^n)$  and  $(c_g, h_g) : (\mathbb{R}^m)^2 \rightarrow (\mathcal{S}_+^n, \mathbb{R}^n)$  are measurable functions that satisfy, with some positive constants  $\gamma_2^f, \gamma_2^g > 0$ ,

$$\begin{aligned} |h_f(t, c^0, \mathbf{c})| + |h_g(c^0, \mathbf{c})| &\leq L(1 + |c^0| + |\mathbf{c}|), \quad |c_f(t, c^0, \mathbf{c})| + |c_g(c^0, \mathbf{c})| \leq L, \\ \langle \theta, c_f(t, c^0, \mathbf{c})\theta \rangle &\geq \gamma_2^f |\theta|^2, \quad \langle \theta, c_g(c^0, \mathbf{c})\theta \rangle \geq \gamma_2^g |\theta|^2, \quad \forall \theta \in \mathbb{R}^n. \end{aligned}$$

(v)  $b := (b_t)_{t \in [0, T]}$  and  $\rho_2 := (\rho_2(t))_{t \in [0, T]}$  are  $\mathbb{F}^0$ -progressively measurable bounded processes satisfying

$$0 \leq b_t \leq L, \quad \frac{b_t^2}{2\gamma_2^f} \leq \rho_2(t) \leq L, \quad \forall t \in [0, T].$$

**Remark 3.2.** The benefit (i.e. negative cost) due to the continuous payoff (respectively, lump-sum payoff at  $T$ ) from the securities can be included in  $h_f$  (respectively,  $h_g$ ). The affine structures in (iv) will be used in later sections to guarantee the convexity of Hamiltonian for the ‘‘cooperative’’ agents.



With the adjoint variable  $y \in \mathbb{R}^n$ , the Hamiltonian for (3.2) of the  $j$ th agent is given by

$$H_2^j(t, x, y, \varpi, \alpha) := \langle y, \alpha + \rho_2(t)\varpi + l_2^j(t) \rangle + \langle \alpha, \varpi \rangle + \frac{1}{2} \langle \alpha, \Lambda_t \alpha \rangle - b_t \langle x, \varpi \rangle + \bar{F}_2^j(t, x).$$

For each  $\omega \in \Omega$ , this gives a map from  $[0, T] \times (\mathbb{R}^n)^4$  to  $\mathbb{R}$ . Under Assumption 3.2, for a given adjoint variable  $y$ ,  $H_2^j$  is jointly and strictly convex in  $(x, \alpha)$ . Its unique minimizer  $\hat{\alpha}$  is given by  $\hat{\alpha} = -\bar{\Lambda}_t(y + \varpi)$ . Hence, for a given  $\varpi \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$ , the system of the state and adjoint equations from the maximum principle is given by

$$\begin{aligned} dx_t^j &= (-\bar{\Lambda}_t(y_t^j + \varpi_t) + \rho_2(t)\varpi_t + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\ dy_t^j &= -(\partial_x \bar{F}_2^j(t, x_t^j) - b_t \varpi_t)dt + z_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} z_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} z_t^{j,k}dB_t^k \end{aligned} \quad (3.3)$$

with  $x_0^j = \eta^j$  and  $y_T^j = \partial_x g_2^j(x_T^j)$ , for each agent  $1 \leq j \leq N_2$ .

**Theorem 3.1.** *Let  $\varpi \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  be given. Under Assumption 3.2, for each  $j = 1, \dots, N_2$ , there exists a unique square integrable solution with  $(x^j, y^j) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)$  to the FBSDE (3.3). Moreover, the problem (3.2) has a unique optimal solution  $\hat{\alpha}^j := (\hat{\alpha}_t^j)_{t \in [0, T]}$  given by  $\hat{\alpha}_t^j = -\bar{\Lambda}_t(y_t^j + \varpi_t)$ .*

*Proof.* This is a simple adaptation of [28, Theorem 3.1]. By the convexity and the differentiability of the Hamiltonian, it is standard to check the sufficiency of the Pontryagin's maximum principle. The uniqueness of the optimal solution follows from the strict convexity of  $H_2^j$  in  $\alpha$ . Thus it only remains to prove the existence of the unique solution to the FBSDE (3.3). For each  $(t, \omega) \in [0, T] \times \Omega$ , let us define the maps from state variables  $u := (x^j, y^j) \in \mathbb{R}^n \times \mathbb{R}^n$  to  $\mathbb{R}^n$  by

$$\begin{aligned} B_{x^j}(t, u) &:= -\bar{\Lambda}_t(y^j + \varpi_t) + \rho_2(t)\varpi_t + l_2^j(t), \\ F_{y^j}(t, u) &:= -\partial_x \bar{F}_2^j(t, x^j) + b_t \varpi_t, \quad G_{y^j}(u) := \partial_x g_2^j(x^j). \end{aligned}$$

Under Assumption 3.2, they are uniformly Lipschitz continuous in  $u$ , and  $(B_{x^j}(t, u), F_{y^j}(t, u), G_{y^j}(u))$  satisfy the square integrability for a given  $u$ . Hence it suffices to check the Peng-Wu's monotonicity [47, (H2.3)]. For two inputs  $(u, \hat{u})$ , let us set  $\Delta x^j := x^j - \hat{x}^j$ ,  $\Delta y^j := y^j - \hat{y}^j$ ,  $\Delta B_{x^j}(t) := B_{x^j}(t, u) - B_{x^j}(t, \hat{u})$ ,  $\Delta F_{y^j}(t) := F_{y^j}(t, u) - F_{y^j}(t, \hat{u})$  and  $\Delta G_{y^j} := G_{y^j}(u) - G_{y^j}(\hat{u})$ . Then, from condition (iv), it is straightforward to see  $\langle \Delta B_{x^j}(t), \Delta y^j \rangle + \langle \Delta F_{y^j}(t), \Delta x^j \rangle \leq -\gamma_2^f |\Delta x^j|^2$  and  $\langle \Delta G_{y^j}, \Delta x^j \rangle \geq \gamma_2^g |\Delta x^j|^2$ . Thus the existence of a unique solution to (3.3) follows from [47, Theorem 2.6] with  $\mu_1 = \gamma_2^g$ ,  $\beta_1 = \gamma_2^f$  with the identity matrix  $G = I_{n \times n}$ .  $\square$

### 3.1.3 Market clearing equilibrium with given order flows from the first population

Let us denote by  $\beta^i := (\beta_t^i)_{t \in [0, T]}$  the trading rate of each agent  $i = 1, \dots, N_1$  in the first population at the securities exchange.

**Definition 3.2.** *We say that the market clearing condition is satisfied if the next equality holds:*

$$\sum_{j=1}^{N_2} \alpha_t^j + \sum_{i=1}^{N_1} \beta_t^i = 0, \quad dt \otimes d\mathbb{P}\text{-a.e.}$$

**Definition 3.3.** *With given order flows  $(\beta^i \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n), i = 1, \dots, N_1)$  from the first population, if there exists a price process  $\varpi \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  and the set of optimal solutions  $(\hat{\alpha}^j)_{j=1}^{N_2}$  to the problem (3.2) that satisfies the market clearing condition, then we say that the market clearing equilibrium exists with the equilibrium price process  $\varpi$  and the given order flows  $(\beta^i)_{i=1}^{N_1}$ .*

Since we know  $\hat{\alpha}_t^j = -\bar{\Lambda}_t(y_t^j + \varpi_t)$  from Theorem 3.1, the market clearing condition implies that the price process  $\varpi_t$  must be equal to  $\varpi_t(y_t, \beta_t)$  defined by

$$\varpi_t(y, \beta) := -\mathbf{m}_2(y) + \delta_n \Lambda_t \mathbf{m}_1(\beta), \quad (3.4)$$

where

$$\delta_n := N_1/N_2$$

denotes the ratio of the two populations. Recall that  $\mathbf{m}_2(y)$  and  $\mathbf{m}_1(\beta)$  give the empirical means of  $(y^j)_{j=1}^{N_2}$  and  $(\beta^i)_{i=1}^{N_1}$ , respectively. As in [27, 28], the relation (3.4) leads us to consider the FBSDEs;

$$\begin{aligned} dx_t^j &= (-\bar{\Lambda}_t(y_t^j + \varpi_t(y_t, \beta_t)) + \rho_2(t)\varpi_t(y_t, \beta_t) + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\ dy_t^j &= -(\partial_x \bar{F}_2^j(t, x_t^j) - b_t \varpi_t(y_t, \beta_t))dt + z_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} \beta_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} z_t^{j,k}dB_t^k \end{aligned} \quad (3.5)$$

with  $x_0^j = \eta^j$  and  $y_T^j = \partial_x g_2^j(x_T^j)$ ,  $1 \leq j \leq N_2$ . It is a coupled system by the interaction in  $\varpi_t(y, \beta)$ . The relevance of (3.5) may be understood from the next theorem.

**Theorem 3.2.** *Let  $(\beta^i)_{i=1}^{N_1}$  with  $\beta^i \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  be given. Under Assumption 3.2, there exists a unique square integrable solution with  $(x, y) = ((x^j)_{j=1}^{N_2}, (y^j)_{j=1}^{N_2}) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2}$  to the system of FBSDEs (3.5). Moreover, there exists a unique market clearing equilibrium with the equilibrium price process  $(\varpi_t = \varpi_t(y_t, \beta_t))_{t \in [0, T]}$  for the given order flows  $(\beta^i)_{i=1}^{N_1}$ .*

*Proof.* This is an adaptation of [28, Theorems 3.2 and 3.3]. Firstly, the existence of the solution to (3.5) is a necessary condition so that  $(\hat{\alpha}^j)_{j=1}^{N_2}$  clears the market with the given order flows  $(\beta^i)_{i=1}^{N_1}$ . Conversely, if there exists a square integrable solution to the system (3.5), then one can check that the price process  $(\varpi_t(y_t, \beta_t))_{t \geq 0}$  defined by its solution  $y$  actually clears the market when it is used as an input price process  $\varpi$  for the problem (3.2). In fact, due to the uniqueness of the solution to (3.3) by Theorem 3.1, the backward solutions  $y^j$  of the two equations coincides.

Hence it suffices to show that there exists a unique square integrable solution to (3.5). As before, this is done by Peng-Wu's continuation method. For each  $(t, \omega)$ , we define the maps from  $u := ((x^j)_{j=1}^{N_2}, (y^j)_{j=1}^{N_2}) \in (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2}$  to  $\mathbb{R}^n$  by

$$\begin{aligned} B_{x^j}(t, u) &:= -\bar{\Lambda}_t(y^j + \varpi_t(y, \beta_t)) + \rho_2(t)\varpi_t(y, \beta_t) + l_2^j(t), \\ F_{y^j}(t, u) &:= -\partial_x \bar{F}_2^j(t, x^j) + b_t \varpi_t(y, \beta_t), \quad G_{y^j}(u) := \partial_x g_2^j(x^j) \end{aligned}$$

with  $1 \leq j \leq N_2$ . By Assumption 3.2, they are uniformly Lipschitz continuous with respect to  $u$ . We can also check, for a given  $u$ , the square integrability  $B_{x^j}(\cdot, u), F_{x^j}(\cdot, u) \in \mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$ , and  $G_{y^j}(u) \in \mathbb{L}^2(\mathcal{F}_T; \mathbb{R}^n)$ . Now, it only remains to confirm the Peng-Wu's monotonicity conditions. For two inputs  $(u, \acute{u})$ , let us set  $\Delta x^j := x^j - \acute{x}^j$ ,  $\Delta y^j = y^j - \acute{y}^j$ ,  $\Delta B_{x^j}(t) := B_{x^j}(t, u) - B_{x^j}(t, \acute{u})$ ,  $\Delta F_{y^j}(t) := F_{y^j}(t, u) - F_{y^j}(t, \acute{u})$  and  $\Delta G_{y^j} := G_{y^j}(u) - G_{y^j}(\acute{u})$ . We have

$$\begin{aligned} &\sum_{j=1}^{N_2} \langle \Delta B_{x^j}(t), \Delta y^j \rangle + \sum_{j=1}^{N_2} \langle \Delta F_{y^j}(t), \Delta x^j \rangle \\ &= -\sum_{j=1}^{N_2} \langle \bar{\Lambda}_t(\Delta y^j - \mathbf{m}_2(\Delta y)) + \rho_2(t)\mathbf{m}_2(\Delta y), \Delta y^j \rangle - \sum_{j=1}^{N_2} \langle c^f(t, c_t^0, \mathbf{c}_t^j) \Delta x^j + b_t \mathbf{m}_2(\Delta y), \Delta x^j \rangle \\ &\leq -N_2 \rho_2(t) |\mathbf{m}_2(\Delta y)|^2 - \gamma_2^f \sum_{j=1}^{N_2} |\Delta x^j|^2 + b_t \sum_{j=1}^{N_2} |\langle \Delta x^j, \mathbf{m}_2(\Delta y) \rangle| \leq -\frac{\gamma_2^f}{2} \sum_{j=1}^{N_2} |\Delta x^j|^2. \end{aligned}$$

In the first inequality, we have used the condition (iv) and the fact that  $\sum_{j=1}^{N_2} \langle \bar{\Lambda}_t \Delta y^j, \Delta y^j \rangle \geq N_2 \langle \bar{\Lambda}_t \mathbf{m}_2(\Delta y), \mathbf{m}_2(\Delta y) \rangle$ . The Young's inequality and the assumption (v) give the last one. From the condition (iv), we also have  $\sum_{j=1}^{N_2} \langle \Delta G_{y^j}, \Delta x^j \rangle \geq \gamma_2^g \sum_{j=1}^{N_2} |\Delta x^j|^2$ . Hence, we can apply [47, Theorem 2.6] with  $(\beta_1, \mu_1) = (\gamma_2^f/2, \gamma_2^g)$  and the identity matrix  $G$ .  $\square$



**Remark 3.3.** *It is interesting to observe an economic role played by the term  $\rho_2(t)\varpi_t$ . Since  $\rho_2$  is positive, it increases the inflow of securities to the agents' inventory when the price  $\varpi$  rises. This is equivalent to the increase of the sales from the OTC clients. Since agents (i.e. financial firms) are trying to maintain the optimal inventory level, this reduces the demand of the securities among the financial firms. Assumption 3.2 (v) guarantees that this is stronger than the opposite effect caused by the mark-to-market term  $-b_t\langle x, \varpi \rangle$ . By making the demand for securities react in an opposite way to the price level, the term  $\rho_2(t)\varpi_t$  seems to prevent market bubbles/crashes from happening and allow the equilibrium to exist for general duration  $T$ .*

## 3.2 Problem for the cooperative agents

### 3.2.1 Problem description

We now study the problem for the first population that consists of cooperative agents. In contrast to the previous case, the agents are no longer price takers. Although the market share of each agent may be negligibly small, their coordinated actions in total can influence the behavior of the price process. In order to describe their problem in a concrete manner, let us first introduce the following measurable functions;  $l_1 : [0, T] \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}^n$ ,  $(\sigma_1^0, \sigma_1) : [0, T] \times (\mathbb{R}^m)^2 \rightarrow (\mathbb{R}^{n \times d_0}, \mathbb{R}^{n \times d_1})$ ,  $f_1 : [0, T] \times \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times \mathbb{R}^n \times A_1 \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}$ , and  $g_1 : \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times (\mathbb{R}^m)^2 \rightarrow \mathbb{R}$ . Here,  $A_1$  is a closed convex subset of  $\mathbb{R}^n$ . We also introduce  $\mathbb{R}$ -valued  $\mathbb{F}^0$ -progressively measurable process  $\rho_1 := (\rho_1(t))_{t \in [0, T]}$ . As in (3.1), for given stochastic processes  $(c_t^0, c_t^i)_{t \in [0, T]}$ , we often use the following abbreviations

$$\begin{aligned} l_1^i(t) &:= l_1(t, c_t^0, c_t^i), & (\sigma_1^{i,0}(t), \sigma_1^i(t)) &:= (\sigma_1^0, \sigma_1)(t, c_t^0, c_t^i), \\ f_1^i(t, x, \mu, \varpi, \beta) &:= f_1(t, x, \mu, \varpi, \beta, c_t^0, c_t^i), & g_1^i(x, \mu) &:= g_1(x, \mu, c_T^0, c_T^i) \end{aligned} \quad (3.6)$$

for  $(t, x, \mu, \varpi, \beta) \in [0, T] \times \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times \mathbb{R}^n \times A_1$  and  $1 \leq i \leq N_1$ . We also use, for  $1 \leq j \leq N_2$ ,

$$c_f^j(t) := c_f^j(t, c_t^0, c_t^j), \quad c_g^j := c_g(c_T^0, c_T^j).$$

Let us denote by  $\beta := (\beta^i)_{i=1}^{N_1}$  with  $\beta^i := (\beta_t^i)_{t \in [0, T]}$  the trading rate of the cooperative agents at the exchange.  $X^i = (X_t^i)_{t \in [0, T]}$  is an  $\mathbb{R}^n$ -valued process describing the evolution of the position size of the  $n$  securities of the  $i$ th agent. We suppose that it obeys the dynamics given by

$$dX_t^i = (\beta_t^i + \rho_1(t)\varpi_t(y_t, \beta_t) + l_1^i(t))dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \quad X_0^i = \xi^i,$$

$1 \leq i \leq N_1$ . Here, the term  $\varpi_t(y_t, \beta_t)$  is defined by (3.4) with  $y = (y^j)_{j=1}^{N_2}$  being the solution to the system of FBSDEs (3.5). The economic interpretation is similar to the previous case; each component of  $\beta_t^i dt$  ( $\in \mathbb{R}^n$ ) gives the amount of the corresponding security bought (or sold if negative) by the  $i$ th agent at the exchange within a time interval  $[t, t + dt]$ ;  $(\rho_1(t)\varpi_t(y_t, \beta_t) + l_1^i(t))dt$  and  $(\sigma_1^{i,0}(t)dW_t^0, \sigma_1^i(t)dW_t^i)$  give the stochastic order flows from her OTC clients. We suppose that the cost functional for each agent  $i$  is given by

$$J_1^i(\beta) := \mathbb{E} \left[ \int_0^T f_1^i(t, X_t^i, \nu_t^{N_1}, \varpi_t(y_t, \beta_t), \beta_t^i) dt + g_1^i(X_T^i, \nu_T^{N_1}) \right],$$

where  $\nu_t^{N_1}$  is the time- $t$  empirical distribution of the securities position among the cooperative agents, i.e.  $\nu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X_t^i}$ .  $f_1^i$  and  $g_1^i$  denote the running and terminal costs, respectively. Since the agents are cooperative, it is natural to suppose that each of them takes care of not only her own inventory but also its distribution across the members. This is represented by the dependence on the empirical distribution  $\nu^{N_1}$  in the cost functions. The running cost  $f_1^i$  is allowed to have general convex dependence on  $\varpi$  to describe the agent's preference on the price level.

We suppose that all the trading actions in the first population are coordinated by the central planner, whose problem is defined by

$$\inf_{\beta^i \in \mathbb{A}_1, i=1, \dots, N_1} \sum_{i=1}^{N_1} J_1^i(\beta). \quad (3.7)$$

Here,  $\mathbb{A}_1 := \mathbb{H}^2(\mathbb{F}; A_1)$  is the admissible space for each  $\beta^i$ . Thus, at every time  $t \in [0, T]$ , each control  $\beta_t^i$  has to take values in a given closed convex set  $A_1$ . The central planner is responsible to control every  $\beta^i, i = 1, \dots, N_1$  within  $\mathbb{A}_1$  to minimize the total cost of the whole population. Due to the reactions from the non-cooperative agents, she needs to deal with complicated price impacts from her own trading. Notice that, in addition to the direct impact from  $\mathfrak{m}_1(\beta)$ -term in  $\varpi_t(\cdot)$ , she also receives implicit feedbacks from  $\mathfrak{m}_2(y)$ -term via (3.5). In fact, the coupling with (3.5) makes the problem for the central planner an optimization with respect to the system of controlled-FBSDEs instead of controlled-SDEs. See the works by J. Yong [53, 54] for general discussions on the problems of controlled-FBSDEs.

**Remark 3.4.** *Similarly to the second population, we see that all the heterogeneities among the cooperative agents come from i.i.d. inputs only; idiosyncratic informations  $(c^i)_{i=1}^{N_1}$ , initial conditions  $(\xi^i)_{i=1}^{N_1}$ , and the Brownian motions  $(W^i)_{i=1}^{N_1}$ .*

Before giving the set of main assumptions, let us mention about the concept of differentiability of functions defined on the space of probability measures. In this work, we adopt the notion of  $L$ -differentiability used in [13, 14], which was first introduced by P.L.Lions in his lecture at College de France. Here, the differentiation is based on the lifting of function  $\mathcal{P}_2(\mathbb{R}^n) \ni \mu \mapsto u(\mu) \in \mathbb{R}$  to a function  $\tilde{u}$  defined on the Hilbert space  $\mathbb{L}^2(\Omega, \mathcal{F}, \mathbb{P}; \mathbb{R}^n)$  by  $\tilde{u}(X) := u(\mathcal{L}(X))$  with  $X \in \mathbb{L}^2(\Omega, \mathcal{F}, \mathbb{P}; \mathbb{R}^n)$ . Here, the probability space  $(\Omega, \mathcal{F}, \mathbb{P})$  is chosen arbitrarily with a Polish set  $\Omega$  and an atomless probability measure  $\mathbb{P}$  to support the random variable  $X$  with  $\mathcal{L}(X) = \mu$ . The  $L$ -derivative of  $u(\mu)$  is defined as the Frechet derivative of the lifted function  $\tilde{u}(X)$ .

**Definition 3.4** (Definition 5.22 in [13]). *A function  $u$  on  $\mathcal{P}_2(\mathbb{R}^n)$  is said to be  $L$ -differentiable at  $\mu_0 \in \mathcal{P}_2(\mathbb{R}^n)$  if there exists a random variable  $X$  with law  $\mu_0$  such that the lifted function  $\tilde{u}$  is Frechet differentiable at  $X$ .*

We distinguish the Frechet derivative by using the symbol  $D$ . By [13, Proposition 5.24], if  $u$  is  $L$ -differentiable at  $\mu_0$ , the  $\tilde{u}$  is Frechet differentiable at any  $\hat{X}$  with  $\mathcal{L}(\hat{X}) = \mu_0$  and the law of the pair  $(\hat{X}, D\tilde{u}(\hat{X}))$  is independent of the choice of the random variable  $\hat{X}$ . Thus, the  $L$ -derivative may be denoted by  $\partial_\mu u(\mu_0)(\cdot) : \mathbb{R}^n \ni x \mapsto \partial_\mu u(\mu_0)(x) \in \mathbb{R}^n$ , which is uniquely defined  $\mu_0$ -a.e. on  $\mathbb{R}^n$ . By its definition, the  $L$ -derivative satisfies

$$u(\mu) = u(\mu_0) + \mathbb{E}[\langle X - X_0, \partial_\mu u(\mu_0)(X_0) \rangle] + o(\|X - X_0\|_{\mathbb{L}^2}),$$

for any random variables  $X$  and  $X_0$  with  $\mathcal{L}(X) = \mu$  and  $\mathcal{L}(X_0) = \mu_0$ . For example, if the function  $u$  is of the form  $u(\mu) := \int_{\mathbb{R}^n} h(x)\mu(dx)$  for some function  $h : \mathbb{R}^n \rightarrow \mathbb{R}$ , we have  $\tilde{u}(X) = \mathbb{E}[h(X)]$  with  $\mathcal{L}(X) = \mu$ . If the function  $h$  is differentiable, then the definition of  $L$ -derivative implies that  $\partial_\mu u(\mu)(\cdot) = \partial_x h(\cdot)$ . See [13, 14] for details and many more examples.

In our analysis, in particular, functions on empirical distributions play a special role. Suppose that a function  $u : \mathcal{P}_2(\mathbb{R}^n) \rightarrow \mathbb{R}$  is given. By considering the map  $(\mathbb{R}^n)^N \ni (x^i)_{i=1}^N \mapsto u\left(\frac{1}{N} \sum_{i=1}^N \delta_{x^i}\right) \in \mathbb{R}$ ,  $u$  can also be seen as a function on  $(\mathbb{R}^n)^N$ . If  $u : \mathcal{P}_2(\mathbb{R}^n) \rightarrow \mathbb{R}$  is  $L$ -differentiable, [13, Proposition 5.35] tells that the function  $u$ , when seen as a function on  $(\mathbb{R}^n)^N$ , is differentiable for each  $x^i$  and satisfies

$$\partial_{x^i} u(x^1, \dots, x^N) = \frac{1}{N} \partial_\mu u\left(\frac{1}{N} \sum_{i=1}^N \delta_{x^i}\right)(x^i). \quad (3.8)$$

Here, with slight abuse of notations, we used the same symbol  $u$  to denote the two maps.

Now, our assumptions on the cooperative agents are given as follows.

**Assumption 3.3.** (0) The population sizes  $(N_1, N_2)$  satisfy  $\delta_n \leq L$ , where  $\delta_n := N_1/N_2$ .

(i) For every  $(t, c^0, c) \in [0, T] \times (\mathbb{R}^m)^2$ ,  $|l_1(t, c^0, c)| + |\sigma_1^0(t, c^0, c)| + |\sigma_1(t, c^0, c)| \leq L(1 + |c^0| + |c|)$ .

(ii) For every  $(t, x, \mu, \varpi, \beta, c^0, c) \in [0, T] \times \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times \mathbb{R}^n \times A_1 \times (\mathbb{R}^m)^2$ , the cost functions satisfy

$$\begin{aligned} |f_1(t, x, \mu, \varpi, \beta, c^0, c)| &\leq L(1 + |x|^2 + M_2(\mu)^2 + |\varpi|^2 + |\beta|^2 + |c^0|^2 + |c|^2), \\ |g_1(x, \mu, c^0, c)| &\leq L(1 + |x|^2 + M_2(\mu)^2 + |c^0|^2 + |c|^2). \end{aligned}$$

and, with another inputs  $(\acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta})$ , they also satisfy the local Lipschitz continuity;

$$\begin{aligned} &|f_1(t, x, \mu, \varpi, \beta, c^0, c) - f_1(t, \acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}, c^0, c)| \\ &\leq L(1 + |x| + |\acute{x}| + M_2(\mu) + M_2(\acute{\mu}) + |\varpi| + |\acute{\varpi}| + |c^0| + |c|)(|x - \acute{x}| + W_2(\mu, \acute{\mu}) + |\varpi - \acute{\varpi}| + |\beta - \acute{\beta}|), \\ &|g_1(x, \mu, c^0, c) - g_1(\acute{x}, \acute{\mu}, c^0, c)| \leq L(1 + |x| + |\acute{x}| + M_2(\mu) + M_2(\acute{\mu}) + |c^0| + |c|)(|x - \acute{x}| + W_2(\mu, \acute{\mu})). \end{aligned}$$

(iii) The cost functions  $f_1$  and  $g_1$  are once continuously differentiable in  $(x, \mu, \varpi, \beta)$  and  $(x, \mu)$  respectively with uniformly Lipschitz continuous derivatives in the sense that

$$\begin{aligned} &|[(\partial_x, \partial_\varpi, \partial_\beta)f_1](t, x, \mu, \varpi, \beta, c^0, c) - [(\partial_x, \partial_\varpi, \partial_\beta)f_1](t, \acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}, c^0, c)| \leq L(|x - \acute{x}| + W_2(\mu, \acute{\mu}) + |\varpi - \acute{\varpi}| + |\beta - \acute{\beta}|), \\ &|\partial_\mu f_1(t, x, \mu, \varpi, \beta, c^0, c)(v) - \partial_\mu f_1(t, \acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}, c^0, c)(\acute{v})| \leq L(|x - \acute{x}| + W_2(\mu, \acute{\mu}) + |\varpi - \acute{\varpi}| + |\beta - \acute{\beta}| + |v - \acute{v}|), \\ &|\partial_x g_1(x, \mu, c^0, c) - \partial_x g_1(\acute{x}, \acute{\mu}, c^0, c)| \leq L(|x - \acute{x}| + W_2(\mu, \acute{\mu})), \\ &|\partial_\mu g_1(x, \mu, c^0, c)(v) - \partial_\mu g_1(\acute{x}, \acute{\mu}, c^0, c)(\acute{v})| \leq L(|x - \acute{x}| + W_2(\mu, \acute{\mu}) + |v - \acute{v}|), \end{aligned}$$

hold for every  $(t, c^0, c) \in [0, T] \times (\mathbb{R}^m)^2$  and  $(x, \mu, \varpi, \beta, v), (\acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}, \acute{v}) \in \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times \mathbb{R}^n \times A_1 \times \mathbb{R}^n$ . Moreover, the derivatives satisfy the linear growth property:

$$\begin{aligned} &|[(\partial_x, \partial_\varpi, \partial_\beta)f_1](t, x, \mu, \varpi, \beta, c^0, c)| + |\partial_\mu f_1(t, x, \mu, \varpi, \beta, c^0, c)(v)| \leq L(1 + |x| + M_2(\mu) + |\varpi| + |\beta| + |v| + |c^0| + |c|), \\ &|\partial_x g_1(x, \mu, c^0, c)| + |\partial_\mu g_1(x, \mu, c^0, c)(v)| \leq L(1 + |x| + M_2(\mu) + |v| + |c^0| + |c|). \end{aligned}$$

(iv) For any  $(t, c^0, c) \in [0, T] \times (\mathbb{R}^m)^2$ ,  $f_1$  is jointly convex in  $(x, \mu, \varpi, \beta)$  in the sense that

$$\begin{aligned} &f_1(t, \acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}, c^0, c) - f_1(t, x, \mu, \varpi, \beta, c^0, c) - \langle \partial_{(x, \varpi, \beta)} f_1(t, x, \mu, \varpi, \beta, c^0, c), (\acute{x} - x, \acute{\varpi} - \varpi, \acute{\beta} - \beta) \rangle \\ &- \mathbb{E}[\langle \partial_\mu f_1(t, x, \mu, \varpi, \beta, c^0, c)(X), \acute{X} - X \rangle] \geq \frac{\gamma_1^f}{2} |\acute{x} - x|^2 + \frac{\lambda_\beta}{2} |\acute{\beta} - \beta|^2 + \frac{\lambda_\varpi}{2} |\acute{\varpi} - \varpi|^2 \end{aligned}$$

holds for any pair of inputs  $(x, \mu, \varpi, \beta), (\acute{x}, \acute{\mu}, \acute{\varpi}, \acute{\beta}) \in \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n) \times \mathbb{R}^n \times A_1$  and random variables  $X, \acute{X}$  with  $\mathcal{L}(X) = \mu, \mathcal{L}(\acute{X}) = \acute{\mu}$ . Here,  $\gamma_1^f, \lambda_\beta, \lambda_\varpi > 0$  are some positive constants, and  $\partial_{(x, \varpi, \beta)} f_1$  stands for the gradient of  $f_1$  in the joint variables  $(x, \varpi, \beta)$ .

(v) For any  $(c^0, c) \in (\mathbb{R}^m)^2$ ,  $g_1$  is jointly convex in  $(x, \mu)$  with some positive constant  $\gamma_1^g > 0$ ,

$$g_1(\acute{x}, \acute{\mu}, c^0, c) - g_1(x, \mu, c^0, c) - \langle \partial_x g_1(x, \mu, c^0, c), \acute{x} - x \rangle - \mathbb{E}[\langle \partial_\mu g_1(x, \mu, c^0, c)(X), \acute{X} - X \rangle] \geq \frac{\gamma_1^g}{2} |\acute{x} - x|^2$$

holds for any pair of inputs  $(x, \mu), (\acute{x}, \acute{\mu}) \in \mathbb{R}^n \times \mathcal{P}_2(\mathbb{R}^n)$  and random variables  $X, \acute{X}$  with  $\mathcal{L}(X) = \mu, \mathcal{L}(\acute{X}) = \acute{\mu}$ .

(vi)  $\rho_1 := (\rho_1(t))_{t \in [0, T]}$  is an  $\mathbb{R}$ -valued  $\mathbb{F}^0$ -progressively measurable bounded process with  $|\rho_1(t)| \leq L, \forall t \in [0, T]$ . Moreover,  $\rho_2$  satisfies

$$\max\left(\frac{1}{L}, \frac{2b_t^2}{\gamma_2^f}\right) \leq \rho_2(t) \leq L, \quad \forall t \in [0, T].$$

**Remark 3.5.** Note that,  $f_1$  can have much more general form than  $f_2$ . In particular,  $f_1$  having a linear quadratic form in  $(x, \varpi, \beta)$  with appropriate convexity is a special example satisfying the above assumptions.

### 3.2.2 Adjoint equations

Let us first introduce the notations  $X, P \in (\mathbb{R}^n)^{N_1}, \beta \in A_1^{N_1}$  and  $x, y, p, r \in (\mathbb{R}^n)^{N_2}$  in the following way;  $X := (X^i)_{i=1}^{N_1}, P := (P^i)_{i=1}^{N_1}, \beta := (\beta^i)_{i=1}^{N_1}, x := (x^j)_{j=1}^{N_2}, y := (y^j)_{j=1}^{N_2}, p := (p^j)_{j=1}^{N_2}$  and  $r := (r^j)_{j=1}^{N_2}$ .

With adjoint variables  $(P, p, r)$ , the Hamiltonian  $H$  for the problem (3.7) is defined by

$$\begin{aligned} H(t, X, x, y, P, p, r, \beta) &:= \sum_{i=1}^{N_1} \{ \langle P^i, \beta^i + \rho_1(t) \varpi_t(y, \beta) + l_1^i(t) \rangle + f_1^i(t, X^i, \nu^{N_1}, \varpi_t(y, \beta), \beta^i) \} \\ &+ \sum_{j=1}^{N_2} \{ \langle p^j, -\bar{\Lambda}_t(y^j + \varpi_t(y, \beta)) + \rho_2(t) \varpi_t(y, \beta) + l_2^j(t) \rangle + \langle r^j, -\partial_x \bar{F}_2^j(t, x^j) + b_t \varpi_t(y, \beta) \rangle \}, \end{aligned} \quad (3.9)$$

which gives, for each  $(t, \omega)$ , a map from  $(\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2} \times A_1^{N_1}$  to  $\mathbb{R}$ . Here,  $\varpi_t(y, \beta)$  is defined by (3.4) and  $\nu^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X^i}$ . With slight abuse of notation, let us also write the above Hamiltonian as  $H(t, X, x, y, P, p, r, \varpi, \beta)$  when we treat  $\varpi \in \mathbb{R}^n$  as a separate argument. From the number of arguments involved in the expression, one may understand which definition is used without confusion. Note that, in the both definitions, the dependence on  $\nu^{N_1}$  is treated as a function of  $X = (X^i)_{i=1}^{N_1}$ . For each  $u := (X, x, y, P, p, r)$ , we want to find a minimizer:

$$\widehat{\beta}(t, u) := \operatorname{argmin}(H(t, X, x, y, P, p, r, \beta) : \beta = (\beta^i)_{i=1}^{N_1} \in A_1^{N_1}).$$

We often use the following derivatives: with  $\varpi := \varpi_t(y, \beta)$  and  $f_1^i(t, u, \beta^i) := f_1^i(t, X^i, \nu^{N_1}, \varpi, \beta^i)$ ,

$$\begin{aligned} \partial_{\beta^i} H(t, u, \beta) &= \partial_{\beta^i} H(t, u, \varpi, \beta) + \frac{\Lambda_t}{N_2} \partial_{\varpi} H(t, u, \varpi, \beta), \\ &= P^i + \partial_{\beta^i} f_1^i(t, u, \beta^i) + \frac{\Lambda_t}{N_2} \sum_{k=1}^{N_1} \partial_{\varpi} f_1^k(t, u, \beta^k) + \delta_n \rho_1(t) \Lambda_t \mathbf{m}_1(P) + (-I + \rho_2(t) \Lambda_t) \mathbf{m}_2(p) + b_t \Lambda_t \mathbf{m}_2(r), \\ \partial_{X^i} H(t, u, \beta) &= \partial_x f_1^i(t, u, \beta^i) + \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_{\mu} f_1^k(t, u, \beta^k)(X^i), \\ \partial_{x^j} H(t, u, \beta) &= -c_f^j(t) r^j, \\ \partial_{y^j} H(t, u, \beta) &= -\frac{1}{N_2} \sum_{k=1}^{N_1} \partial_{\varpi} f_1^k(t, u, \beta^k) - \delta_n \rho_1(t) \mathbf{m}_1(P) - b_t \mathbf{m}_2(r) + \bar{\Lambda}_t (\mathbf{m}_2(p) - p^j) - \rho_2(t) \mathbf{m}_2(p). \end{aligned} \quad (3.10)$$

Here, we have used (3.8) to get  $\partial_{X^i} H(t, u, \beta)$ .

**Lemma 3.1.** *Under Assumptions 3.2-3.3, for each  $(t, \omega)$  and a given set of adjoint variables  $(P, p, r) \in (\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2}$ , the Hamiltonian  $H$  defined by (3.9) is jointly convex in  $(X, x, y, \beta) \in (\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2} \times A_1^{N_1}$  and strictly so in  $(X, \beta)$ . In particular, for any  $t \in [0, T]$  and input  $u := (X, x, y, P, p, r)$ , there exists a unique minimizer  $(\widehat{\beta}^i = \widehat{\beta}^i(t, u))_{i=1}^{N_1}$  with  $\widehat{\beta}_t^i \in A_1$  that satisfies the following linear growth and the Lipschitz continuity properties:*

$$\begin{aligned} \sum_{i=1}^{N_1} |\widehat{\beta}^i(t, u)|^2 &\leq C \sum_{i=1}^{N_1} [1 + |X^i|^2 + |P^i|^2 + |\mathbf{m}_2(y)|^2 + |\mathbf{m}_2(p)|^2 + |\mathbf{m}_2(r)|^2 + |c_t^0|^2 + |c_t^i|^2], \\ \sum_{i=1}^{N_1} |\widehat{\beta}^i(t, u) - \widehat{\beta}^i(t, \acute{u})|^2 &\leq C \sum_{i=1}^{N_1} [|X^i - \acute{X}^i|^2 + |P^i - \acute{P}^i|^2 + |\mathbf{m}_2(y - \acute{y})|^2 + |\mathbf{m}_2(p - \acute{p})|^2 + |\mathbf{m}_2(r - \acute{r})|^2], \end{aligned}$$

where  $\acute{u} := (\acute{X}, \acute{x}, \acute{y}, \acute{P}, \acute{p}, \acute{r})$  is another input and  $C$  is some positive constant independent of the population sizes.

*Proof.* First, we check the relevant convexity of  $H$ . For a given  $(P, p, r)$ , we consider two arbitrary sets of state variables  $(X, x, y), (\hat{X}, \hat{x}, \hat{y})$  and controls  $\beta, \hat{\beta}$ . With  $u := (X, x, y, P, p, r)$  and  $\hat{u} := (\hat{X}, \hat{x}, \hat{y}, P, p, r)$ , we compare  $H(t, u, \beta)$  and  $H(t, \hat{u}, \hat{\beta})$ . For notational simplicity, let us set  $\nu^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X^i}, \hat{\nu}^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{\hat{X}^i}, \varpi := \varpi_t(y, \beta), \hat{\varpi} := \varpi_t(\hat{y}, \hat{\beta}), \Delta X^i := \hat{X}^i - X^i, \Delta \beta^i := \hat{\beta}^i - \beta^i, \Delta \varpi := \hat{\varpi} - \varpi = -\mathbf{m}_2(\Delta y) + \delta_n \Lambda_t \mathbf{m}_1(\Delta \beta)$ , etc. We also put  $f_1^i(t, u, \beta^i) := f_1^i(t, X^i, \nu^{N_1}, \varpi, \beta^i), f_1^i(t, \hat{u}, \hat{\beta}^i) := f_1^i(t, \hat{X}^i, \hat{\nu}^{N_1}, \hat{\varpi}, \hat{\beta}^i)$ . Since the linear terms in  $H$  cancel, we obtain by direct calculation using (3.10),

$$\begin{aligned}
& H(t, \hat{u}, \hat{\beta}) - H(t, u, \beta) \\
& - \sum_{i=1}^{N_1} [\langle \partial_{\beta^i} H(t, u, \beta), \Delta \beta^i \rangle + \langle \partial_{X^i} H(t, u, \beta), \Delta X^i \rangle] - \sum_{j=1}^{N_2} [\langle \partial_{x^j} H(t, u, \beta), \Delta x^j \rangle + \langle \partial_{y^j} H(t, u, \beta), \Delta y^j \rangle] \\
& = \sum_{i=1}^{N_1} [f_1^i(t, \hat{u}, \hat{\beta}^i) - f_1^i(t, u, \beta^i) - \langle \partial_{\beta} f_1^i(t, u, \beta^i), \Delta \beta^i \rangle - \langle \partial_{\varpi} f_1^i(t, u, \beta^i), \Delta \varpi \rangle] \\
& - \langle \partial_x f_1^i(t, u, \beta^i), \Delta X^i \rangle - \mathbb{E}^\theta [\langle \partial_\mu f_1^i(t, u, \beta^i)(X^\theta), \Delta X^\theta \rangle] \geq \frac{1}{2} \sum_{i=1}^{N_1} (\gamma_1^f |\Delta X^i|^2 + \lambda_\beta |\Delta \beta^i|^2 + \lambda_\varpi |\Delta \varpi|^2),
\end{aligned} \tag{3.11}$$

which gives the desired convexity. Since  $A_1$  is convex and closed, it guarantees the existence of the unique minimizer. Here, we have introduced a random variable  $\theta$  on a probability space  $(\Omega^\theta, \mathcal{F}^\theta, \mathbb{P}^\theta)$ , which is distributed uniformly on the set  $\{1, 2, \dots, N_1\}$ . We use  $\mathbb{E}^\theta[\cdot]$  to denote the expectation with respect to  $\mathbb{P}^\theta$ . In particular,

$$\frac{1}{N_1} \sum_{i=1}^{N_1} \sum_{k=1}^{N_1} \langle \partial_\mu f_1^k(t, u, \beta^k)(X^i), \Delta X^i \rangle = \sum_{k=1}^{N_1} \mathbb{E}^\theta [\langle \partial_\mu f_1^k(t, u, \beta^k)(X^\theta), \Delta X^\theta \rangle]. \tag{3.12}$$

Since the distribution of the random variables  $X^\theta, \hat{X}^\theta$  are equal to  $\nu^{N_1}$  and  $\hat{\nu}^{N_1}$  respectively, Assumption 3.3 (iv) gives the inequality (3.11).

We now prove the latter claims. The convexity (3.11) implies that, for any fixed  $(\beta_0^i \in A_1)_{i=1}^{N_1}$ ,

$$H(t, u, \beta_0) \geq H(t, u, \hat{\beta}(t, u)) \geq H(t, u, \beta_0) + \sum_{i=1}^{N_1} \langle \hat{\beta}_t^i - \beta_0^i, \partial_{\beta^i} H(t, u, \beta_0) \rangle + \frac{\lambda_\beta}{2} \sum_{i=1}^{N_1} |\hat{\beta}_t^i - \beta_0^i|^2,$$

which gives, by Young's inequality,  $\sum_{i=1}^{N_1} |\hat{\beta}_t^i - \beta_0^i|^2 \leq C \sum_{i=1}^{N_1} |\partial_{\beta^i} H(t, u, \beta_0)|^2$ , where  $C$  depends on  $\lambda_\beta$ . Hence (3.10), the conditions (0) and (iii) give the desired growth property for  $\hat{\beta}$ . Finally, let us put  $\hat{\beta}_t^i = \hat{\beta}^i(t, u)$  and  $\hat{\beta}'_t{}^i = \hat{\beta}^i(t, \hat{u})$  the minimizers of  $H$  with two inputs  $u = (X, x, y, P, p, r)$  and  $\hat{u} = (\hat{X}, \hat{x}, \hat{y}, \hat{P}, \hat{p}, \hat{r})$ , respectively. Using the optimality condition, we have  $\sum_{i=1}^{N_1} \langle \hat{\beta}'_t{}^i - \hat{\beta}_t^i, \partial_{\beta^i} H(t, \hat{u}, \hat{\beta}'_t) \rangle - \partial_{\beta^i} H(t, u, \hat{\beta}_t) \leq 0$ . By rearrangement,

$$\sum_{i=1}^{N_1} \langle \hat{\beta}'_t{}^i - \hat{\beta}_t^i, \partial_{\beta^i} H(t, u, \hat{\beta}'_t) - \partial_{\beta^i} H(t, u, \hat{\beta}_t) \rangle \leq \sum_{i=1}^{N_1} \langle \hat{\beta}'_t{}^i - \hat{\beta}_t^i, \partial_{\beta^i} H(t, u, \hat{\beta}'_t) - \partial_{\beta^i} H(t, \hat{u}, \hat{\beta}'_t) \rangle.$$

Using the convexity in  $\beta$  in the left hand side yields  $\lambda_\beta \sum_{i=1}^{N_1} |\hat{\beta}'_t{}^i - \hat{\beta}_t^i|^2 \leq \sum_{i=1}^{N_1} \langle \hat{\beta}'_t{}^i - \hat{\beta}_t^i, \partial_{\beta^i} H(t, u, \hat{\beta}'_t) - \partial_{\beta^i} H(t, \hat{u}, \hat{\beta}'_t) \rangle$  and hence, an application of Young's inequality gives

$$\sum_{i=1}^{N_1} |\hat{\beta}'_t{}^i - \hat{\beta}_t^i|^2 \leq C \sum_{i=1}^{N_1} |\partial_{\beta^i} H(t, u, \hat{\beta}'_t) - \partial_{\beta^i} H(t, \hat{u}, \hat{\beta}'_t)|^2.$$

From (3.10), the conditions (0) and (iii) give the desired Lipschitz continuity.  $\square$

**Remark 3.6.** From the above result, we see that  $\hat{\beta}$  is coupled to the second population in a symmetric way; it is independent from  $x$  and depends on  $y, p, r$  only through their empirical means.

The system of coupled equations  $1 \leq i \leq N_1, 1 \leq j \leq N_2$  that characterizes the optimal solution to the problem (3.7) is given as follows:

$$\begin{aligned}
dX_t^i &= (\widehat{\beta}_t^i + \rho_1(t)\varpi_t(y_t, \widehat{\beta}_t) + l_1^i(t))dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \\
dx_t^j &= (-\overline{\Lambda}_t(y_t^j + \varpi_t(y_t, \widehat{\beta}_t)) + \rho_2(t)\varpi_t(y_t, \widehat{\beta}_t) + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\
dy_t^j &= -(\partial_x \overline{F}_2^j(t, x_t^j) - b_t \varpi_t(y_t, \widehat{\beta}_t))dt + z_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} \mathfrak{z}_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} z_t^{j,k}dB_t^k, \\
dP_t^i &= -\left\{ \partial_x f_1^i(t, X_t^i, \nu_t^{N_1}, \varpi_t(y_t, \widehat{\beta}_t), \widehat{\beta}_t^i) + \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu f_1^i(t, X_t^k, \nu_t^{N_1}, \varpi_t(y_t, \widehat{\beta}_t), \widehat{\beta}_t^k) \right\} dt \\
&\quad + Q_t^{i,0}dW_t^0 + \sum_{k=1}^{N_1} Q_t^{i,k}dW_t^k + \sum_{k=1}^{N_2} \mathfrak{Q}_t^{i,k}dB_t^k, \\
dp_t^j &= c_f^j(t)r_t^j dt + q_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} q_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} q_t^{j,k}dB_t^k, \\
dr_t^j &= -\left\{ \overline{\Lambda}_t(\mathbf{m}_2(p_t) - p_t^j) - \rho_2(t)\mathbf{m}_2(p_t) - \delta_n \rho_1(t)\mathbf{m}_1(p_t) - b_t \mathbf{m}_2(r_t) \right. \\
&\quad \left. - \frac{1}{N_2} \sum_{k=1}^{N_1} \partial_\varpi f_1^k(t, X_t^k, \nu_t^{N_1}, \varpi_t(y_t, \widehat{\beta}_t), \widehat{\beta}_t^k) \right\} dt
\end{aligned} \tag{3.13}$$

with the boundary conditions;  $X_0^i = \xi^i$ ,  $x_0^j = \eta^j$ ,  $r_0^j = 0$  and

$$y_T^j = \partial_x g_2^j(x_T^j), \quad P_T^i = \partial_x g_1^i(X_T^i, \nu_T^{N_1}) + \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu g_1^k(X_T^k, \nu_T^{N_1})(X_T^i), \quad p_T^j = -c_g^j r_T^j.$$

Note that the two populations are coupled only through the empirical means contained in  $\varpi_t(y, \beta)$ . The relevance of (3.13) is based on the next theorem.

**Remark 3.7.** From (3.10), one can check that the drift terms of adjoint variables  $(P^i, p^j, r^j)$  are given by  $-\partial_{X^i} H(t, u, \widehat{\beta})$ ,  $-\partial_{x^j} H(t, u, \widehat{\beta})$  and  $-\partial_{y^j} H(t, u, \widehat{\beta})$ , respectively.

**Theorem 3.3.** Let Assumption 3.2-3.3 be in force. Suppose that there exists a unique square integrable solution to the system of equations (3.13) with  $u := (X, x, y, P, p, r) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_1} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_1} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2}$  with  $\widehat{\beta}_t := (\widehat{\beta}^i(t, u_t))_{i=1}^{N_1}$  the minimizer of  $H(t, u_t, \cdot)$  for  $dt \otimes d\mathbb{P}$ -a.e. Then,  $\widehat{\beta}_t, t \in [0, T]$  is the unique optimal solution to (3.7).

*Proof.* Let  $u_t := (X_t, x_t, y_t, P_t, p_t, r_t), t \in [0, T]$  denote the solution to (3.13) with  $\widehat{\beta}_t$  the minimizer of  $H(t, u_t, \cdot)$ ,  $dt \otimes d\mathbb{P}$ -a.e. By Lemma 3.1 and the properties of  $(c^0, c^i)$  given at the beginning of Section 3,  $\widehat{\beta}$  is square integrable and hence admissible. We denote by  $(\widehat{X}_t, \widehat{x}_t, \widehat{y}_t), t \in [0, T]$  the state processes corresponding to another control  $\widehat{\beta} = (\widehat{\beta}^i)_{i=1}^{N_1} \in \mathbb{A}_1^{N_1}$  and set  $\widehat{u}_t := (\widehat{X}_t, \widehat{x}_t, \widehat{y}_t, P_t, p_t, r_t), t \in [0, T]$ . Let us put  $\nu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X_t^i}, \nu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{\widehat{X}_t^i}, \widehat{\varpi}_t := \varpi_t(\widehat{y}_t, \widehat{\beta}_t), \varpi_t := \varpi_t(y_t, \widehat{\beta}_t), \Delta X := \widehat{X} - X, \Delta x := \widehat{x} - x, \Delta \beta = \widehat{\beta} - \beta$  and similarly for the others. For notational ease, we also use  $f_1^i(t, u_t, \widehat{\beta}_t^i) := f_1^i(t, X_t^i, \nu_t^{N_1}, \varpi_t(y_t, \widehat{\beta}_t), \widehat{\beta}_t^i)$  and  $f_1^i(t, \widehat{u}_t, \widehat{\beta}_t^i) := f_1^i(t, \widehat{X}_t^i, \nu_t^{N_1}, \widehat{\varpi}_t(\widehat{y}_t, \widehat{\beta}_t), \widehat{\beta}_t^i)$ .

From Assumption 3.3 (v) and the technique used in (3.12), we have

$$\sum_{i=1}^{N_1} (g_1^i(\widehat{X}_T^i, \nu_T^{N_1}) - g_1^i(X_T^i, \nu_T^{N_1})) \geq \sum_{i=1}^{N_1} \langle P_T^i, \Delta X_T^i \rangle = \sum_{i=1}^{N_1} \langle P_T^i, \Delta X_T^i \rangle + \sum_{j=1}^{N_2} (\langle p_T^j, \Delta x_T^j \rangle + \langle r_T^j, \Delta y_T^j \rangle).$$

In the latter equality, we used the fact  $\langle p_T^j, \Delta x_T^j \rangle + \langle r_T^j, \Delta y_T^j \rangle = 0$ . By the initial condition  $\Delta X_0^i = \Delta x_0^j = r_0^j = 0$  and the optimality  $\sum_i \langle \partial_{\beta^i} H(t, u_t, \widehat{\beta}_t), \Delta \beta_t^i \rangle \geq 0$   $dt \otimes d\mathbb{P}$ -a.e., an application of Itô



formula yields

$$\begin{aligned}
\sum_{i=1}^{N_1} J_1^i(\hat{\beta}) - \sum_{i=1}^{N_1} J_1^i(\hat{\beta}) &\geq \mathbb{E} \left[ \sum_{i=1}^{N_1} \langle P_T^i, \Delta X_T^i \rangle + \sum_{j=1}^{N_2} (\langle p_T^j, \Delta x_T^j \rangle + \langle r_T^j, \Delta y_T^j \rangle) + \int_0^T \sum_{i=1}^{N_1} [f_1^i(t, \hat{u}_t, \hat{\beta}_t^i) - f_1^i(t, u_t, \hat{\beta}_t^i)] dt \right] \\
&\geq \mathbb{E} \int_0^T [H(t, \hat{u}_t, \hat{\beta}_t) - H(t, u_t, \hat{\beta}_t) - \sum_{i=1}^{N_1} (\langle \partial_{X^i} H(t, u_t, \hat{\beta}_t), \Delta X_t^i \rangle + \langle \partial_{\beta^i} H(t, u_t, \hat{\beta}_t), \Delta \beta_t^i \rangle) \\
&\quad - \sum_{j=1}^{N_2} (\langle \partial_{x^j} H(t, u_t, \hat{\beta}_t), \Delta x_t^j \rangle + \langle \partial_{y^j} H(t, u_t, \hat{\beta}_t), \Delta y_t^j \rangle)] dt.
\end{aligned}$$

The conclusion follows from the joint convexity (3.11) in Lemma 3.1.  $\square$

### 3.2.3 Existence of the optimal solution

We use the following maps to study the monotonicity [47, (H2.3)]. For each  $(t, \omega)$ , we define the maps on  $(\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_1} \times (\mathbb{R}^n)^{N_2} \times (\mathbb{R}^n)^{N_2} \ni u := (X, x, y, P, p, r) \mapsto \mathbb{R}^n$  by

$$B_{X^i}(t, u) := \hat{\beta}^i + \rho_1(t) \varpi_t(y, \hat{\beta}) + l_1^i(t),$$

$$B_{x^j}(t, u) := -\bar{\Lambda}_t(y^j + \varpi_t(y, \hat{\beta})) + \rho_2(t) \varpi_t(y, \hat{\beta}) + l_2^j(t),$$

$$B_{r^j}(t, u) := -\{\bar{\Lambda}_t(\mathbf{m}_2(p) - p^j) - \rho_2(t) \mathbf{m}_2(p) - \delta_n \rho_1(t) \mathbf{m}_1(P) - b_t \mathbf{m}_2(r) - \frac{1}{N_2} \sum_{k=1}^{N_1} \partial_{\varpi} f_1^k(t, X^k, \nu^{N_1}, \varpi_t(y, \hat{\beta}), \hat{\beta}^k)\},$$

$$F_{P^i}(t, u) := -\{\partial_x f_1^i(t, X^i, \nu^{N_1}, \varpi_t(y, \hat{\beta}), \hat{\beta}^i) + \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_{\mu} f_1^k(t, X^k, \nu^{N_1}, \varpi_t(y, \hat{\beta}), \hat{\beta}^k)(X^i)\},$$

$$F_{y^j}(t, u) := -(\partial_x \bar{f}_2^j(t, x^j) - b_t \varpi_t(y, \hat{\beta})), \quad F_{p^j}(t, u) := c_f^j(t) r^j,$$

and

$$G_{P^i}(u) := \partial_x g_1^i(X^i, \nu^{N_1}) + \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_{\mu} g_1^k(X^k, \nu^{N_1})(X^i), \quad G_{y^j}(u) := \partial_x g_2^j(x^j), \quad G_{p^j}(u) := -c_g^j r^j,$$

with  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ . Here,  $\nu^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X^i}$  and  $(\hat{\beta}^i := \hat{\beta}^i(t, u))_{i=1}^{N_1}$  is the minimizer of the Hamiltonian  $H(t, u, \cdot)$ . Let  $u := (X, x, y, P, p, r), \hat{u} := (\hat{X}, \hat{x}, \hat{y}, \hat{P}, \hat{p}, \hat{r}) \in (\mathbb{R}^n)^{2N_1+4N_2}$  be two arbitrary inputs. We use abbreviations, such as,  $\hat{\beta}^i = \hat{\beta}^i(t, u), \hat{\beta}^{\prime, i} := \hat{\beta}^i(t, \hat{u}), \varpi := \varpi_t(y, \hat{\beta}), \hat{\varpi} := \varpi_t(\hat{y}, \hat{\beta}^{\prime}), f_1^i(t, u, \hat{\beta}^i) := f_1^i(t, X^i, \nu^{N_1}, \varpi, \hat{\beta}^i), f_1^i(t, \hat{u}, \hat{\beta}^{\prime, i}) := f_1^i(t, \hat{X}^i, \hat{\nu}^{N_1}, \hat{\varpi}, \hat{\beta}^{\prime, i})$  and also put  $\Delta X^i := X^i - \hat{X}^i, \Delta y^j := y^j - \hat{y}^j, \Delta \hat{\beta}^i := \hat{\beta}^i - \hat{\beta}^{\prime, i}, \Delta \varpi := \varpi - \hat{\varpi}$ , and  $\Delta B_{X^i}(t) := B_{X^i}(t, u) - B_{X^i}(t, \hat{u}), \Delta F_{y^j}(t, u) := F_{y^j}(t, u) - F_{y^j}(t, \hat{u}), \Delta G_{P^i} := G_{P^i}(u) - G_{P^i}(\hat{u})$ , etc.

**Lemma 3.2.** *Under Assumptions 3.2-3.3, for any inputs  $(u, \hat{u})$ , the terminal functions satisfy*

$$\sum_{i=1}^{N_1} \langle \Delta G_{P^i}, \Delta X^i \rangle + \sum_{j=1}^{N_2} (\langle \Delta G_{y^j}, \Delta x^j \rangle + \langle (-1) \Delta G_{p^j}, \Delta r^j \rangle) \geq \gamma_1^g \sum_{i=1}^{N_1} |\Delta X^i|^2 + \gamma_2^g \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2).$$

*Proof.* This is a direct result of Assumption 3.2 (iv) and Assumption 3.3 (v).  $\square$

Although the proof requires rather lengthy calculation, the following result is crucial. It tells that the drift terms *do not* satisfy the Peng-Wu's monotonicity conditions. However, we shall show that the violation of the monotonicity can be controlled by  $\delta_n := N_1/N_2$ , the ratio of the two population sizes.

**Lemma 3.3.** *Let Assumptions 3.2-3.3 hold. Then, for any  $t \in [0, T]$  and inputs  $(u, \hat{u})$ , there exists a positive constant  $\delta_0^F$  such that, for any  $(N_1, N_2)$  satisfying  $\delta_n := N_1/N_2 \leq \delta_0^F$ , the inequality*

$$\mathcal{D}(t) \leq -\gamma^f \left[ \sum_{i=1}^{N_1} |\Delta X^i|^2 + \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2) \right] + \delta_n C \left[ \sum_{i=1}^{N_1} |\Delta P^i|^2 + \sum_{j=1}^{N_2} (|\Delta y^j|^2 + |\Delta p^j|^2) \right]$$

holds with  $\gamma^f := \min(\frac{\gamma_1^f}{2}, \frac{\gamma_2^f}{3})$  and some positive constant  $C$  independent of the population sizes. Here,

$$\begin{aligned} \mathcal{D}(t) &:= \sum_{i=1}^{N_1} \langle \Delta B_{X^i}(t), \Delta P^i \rangle + \sum_{j=1}^{N_2} [\langle \Delta B_{x^j}(t), \Delta y^j \rangle + \langle (-1)\Delta B_{r^j}(t), \Delta p^j \rangle] \\ &\quad + \sum_{i=1}^{N_1} \langle \Delta F_{P^i}(t), \Delta X^i \rangle + \sum_{j=1}^{N_2} [\langle \Delta F_{y^j}(t), \Delta x^j \rangle + \langle (-1)\Delta F_{p^j}(t), \Delta r^j \rangle]. \end{aligned}$$

*Proof.* Let us evaluate each term. From (3.10), we can express  $\Delta P^i$  as

$$\begin{aligned} \Delta P^i &= \partial_{\beta^i} H(t, u, \widehat{\beta}) - \partial_{\beta^i} H(t, \acute{u}, \widehat{\beta}') - (\partial_{\beta^i} f_1^i(t, u, \widehat{\beta}^i) - \partial_{\beta^i} f_1^i(t, \acute{u}, \widehat{\beta}'^i)) + (I - \rho_2(t)\Lambda_t)\mathbf{m}_2(\Delta p) \\ &\quad - b_t \Lambda_t \mathbf{m}_2(\Delta r) - \delta_n \rho_1(t) \Lambda_t \mathbf{m}_1(\Delta P) - \frac{\Lambda_t}{N_2} \sum_{k=1}^{N_1} (\partial_{\varpi} f_1^k(t, u, \widehat{\beta}^k) - \partial_{\varpi} f_1^k(t, \acute{u}, \widehat{\beta}'^k)). \end{aligned}$$

It gives, together with the optimality condition  $\sum_i \langle \partial_{\beta^i} H(t, u, \widehat{\beta}) - \partial_{\beta^i} H(t, \acute{u}, \widehat{\beta}'), \Delta \widehat{\beta}^i \rangle \leq 0$ ,

$$\begin{aligned} \sum_{i=1}^{N_1} \langle \Delta B_{X^i}(t), \Delta P^i \rangle &= \sum_{i=1}^{N_1} \langle \Delta \widehat{\beta}^i + \rho_1(t) \Delta \varpi, \Delta P^i \rangle \\ &\leq - \sum_{i=1}^{N_1} \langle \partial_{\beta^i} f_1^i(t, u, \widehat{\beta}^i) - \partial_{\beta^i} f_1^i(t, \acute{u}, \widehat{\beta}'^i), \Delta \widehat{\beta}^i \rangle - \sum_{i=1}^{N_1} \langle \partial_{\varpi} f_1^i(t, u, \widehat{\beta}^i) - \partial_{\varpi} f_1^i(t, \acute{u}, \widehat{\beta}'^i), \Delta \varpi + \mathbf{m}_2(\Delta y) \rangle \\ &\quad + N_1 \langle (I - \rho_2(t)\Lambda_t)\mathbf{m}_2(\Delta p) - b_t \Lambda_t \mathbf{m}_2(\Delta r), \mathbf{m}_1(\Delta \widehat{\beta}) \rangle - N_1 \rho_1(t) \langle \mathbf{m}_2(\Delta y), \mathbf{m}_1(\Delta P) \rangle. \end{aligned}$$

Since  $\sum_j \langle \overline{\Lambda}_t(\Delta y^j - \mathbf{m}_2(\Delta y)), \Delta y^j \rangle \geq 0$  and  $\sum_j \langle \overline{\Lambda}_t(\Delta p^j - \mathbf{m}_2(\Delta p)), \Delta p^j \rangle \geq 0$ , we have

$$\begin{aligned} \sum_{j=1}^{N_2} \langle B_{x^j}(t), \Delta y^j \rangle &\leq -N_2 \rho_2(t) |\mathbf{m}_2(\Delta y)|^2 + N_1 \langle (\rho_2(t)\Lambda_t - I)\mathbf{m}_1(\Delta \widehat{\beta}), \mathbf{m}_2(\Delta y) \rangle, \\ \sum_{j=1}^{N_2} \langle (-1)\Delta B_{r^j}(t), \Delta p^j \rangle &\leq -N_2 \rho_2(t) |\mathbf{m}_2(\Delta p)|^2 - N_2 b_t \langle \mathbf{m}_2(\Delta r), \mathbf{m}_2(\Delta p) \rangle - N_1 \rho_1(t) \langle \mathbf{m}_1(\Delta P), \mathbf{m}_2(\Delta p) \rangle \\ &\quad - \sum_{i=1}^{N_1} \langle \partial_{\varpi} f_1^i(t, u, \widehat{\beta}^i) - \partial_{\varpi} f_1^i(t, \acute{u}, \widehat{\beta}'^i), \mathbf{m}_2(\Delta p) \rangle. \end{aligned}$$

By the technique used for (3.12) in Lemma 3.1, we get

$$\begin{aligned} \sum_{i=1}^{N_1} \langle \Delta F_{P^i}(t), \Delta X^i \rangle &= - \sum_{i=1}^{N_1} \langle \partial_x f_1^i(t, u, \widehat{\beta}^i) - \partial_x f_1^i(t, \acute{u}, \widehat{\beta}'^i), \Delta X^i \rangle \\ &\quad - \sum_{i=1}^{N_1} \mathbb{E}^\theta [\langle \partial_\mu f_1^i(t, u, \widehat{\beta}^i)(X^\theta) - \partial_\mu f_1^i(t, \acute{u}, \widehat{\beta}'^i)(X^\theta), \Delta X^\theta \rangle]. \end{aligned}$$

Finally, as a direct result from Assumption 3.2 (iv), we have

$$\sum_{j=1}^{N_2} \langle \Delta F_{y^j}(t), \Delta x^j \rangle + \sum_{j=1}^{N_2} \langle (-1)\Delta F_{p^j}(t), \Delta r^j \rangle \leq -\gamma_2^f \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2) + N_2 b_t \langle \Delta \varpi, \mathbf{m}_2(\Delta x) \rangle.$$

Summing all the terms and using Assumption 3.3 (iv), we get

$$\mathcal{D}(t) \leq -\gamma_1^f \sum_{i=1}^{N_1} |\Delta X^i|^2 - \gamma_2^f \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2) - \sum_{i=1}^{N_1} (\lambda_\beta |\Delta \widehat{\beta}^i|^2 + \lambda_\varpi |\Delta \varpi|^2) + \mathcal{R}(t), \quad (3.14)$$

where the residual term  $\mathcal{R}(t)$  is defined by

$$\begin{aligned} \mathcal{R}(t) := & -N_2\rho_2(t)(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2) - \sum_{i=1}^{N_1} \langle \partial_{\varpi} f_1^i(t, u, \widehat{\beta}^i) - \partial_{\varpi} f_1^i(t, \acute{u}, \widehat{\beta}^{t,i}), \mathbf{m}_2(\Delta y + \Delta p) \rangle \\ & + N_1 \langle (1 - \rho_2(t)\Lambda_t)\mathbf{m}_2(\Delta p - \Delta y) - b_t\Lambda_t\mathbf{m}_2(\Delta r), \mathbf{m}_1(\Delta \widehat{\beta}) \rangle - N_1\rho_1(t) \langle \mathbf{m}_1(\Delta P), \mathbf{m}_2(\Delta y + \Delta p) \rangle \\ & - N_2b_t \langle \mathbf{m}_2(\Delta r), \mathbf{m}_2(\Delta p) \rangle + N_2b_t \langle \Delta \varpi, \mathbf{m}_2(\Delta x) \rangle. \end{aligned}$$

We get an estimate on  $\mathcal{R}(t)$  from the Lipschitz continuity of  $\partial_{\varpi} f_1^i$  and Young's inequality. In particular,

$$\begin{aligned} N_1|\rho_1(t) \langle \mathbf{m}_1(\Delta P), \mathbf{m}_2(\Delta y + \Delta p) \rangle| & \leq N_2\frac{\rho_2(t)}{2}(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2) + \frac{N_1^2\rho_1(t)^2}{N_2\rho_2(t)} \left( \frac{1}{N_1} \sum_{i=1}^{N_1} |\Delta P^i|^2 \right) \\ & \leq N_2\frac{\rho_2(t)}{2}(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2) + C\frac{N_1}{N_2} \sum_{i=1}^{N_1} |\Delta P^i|^2, \\ N_2b_t|\langle \Delta \varpi, \mathbf{m}_2(\Delta x) \rangle| & \leq \frac{\gamma_2^f}{2} \sum_{j=1}^{N_2} |\Delta x^j|^2 + \frac{N_2b_t^2}{\gamma_2^f} |\mathbf{m}_2(\Delta y)|^2 + C\frac{N_1}{N_2} \sum_{i=1}^{N_1} |\Delta \widehat{\beta}^i|^2 \end{aligned}$$

with some constant  $C$ . Similar calculations yield

$$\begin{aligned} \mathcal{R}(t) & \leq \sum_{i=1}^{N_1} \left[ \frac{\gamma_1^f}{2} |\Delta X^i|^2 + \frac{\lambda_{\varpi}}{2} |\Delta \varpi|^2 + \frac{\lambda_{\beta}}{2} |\Delta \widehat{\beta}^i|^2 \right] + \frac{\gamma_2^f}{2} \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2) \\ & \quad + CN_1(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2 + |\mathbf{m}_2(\Delta r)|^2) + C\frac{N_1}{N_2} \sum_{i=1}^{N_1} (|\Delta \widehat{\beta}^i|^2 + |\Delta P^i|^2) \\ & \quad - N_2\frac{\rho_2(t)}{2}(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2) + \frac{N_2b_t^2}{2\gamma_2^f} |\mathbf{m}_2(\Delta p)|^2 + \frac{N_2b_t^2}{\gamma_2^f} |\mathbf{m}_2(\Delta y)|^2 \tag{3.15} \\ & \leq \sum_{i=1}^{N_1} \left[ \frac{\gamma_1^f}{2} |\Delta X^i|^2 + \frac{\lambda_{\varpi}}{2} |\Delta \varpi|^2 + \frac{\lambda_{\beta}}{2} |\Delta \widehat{\beta}^i|^2 \right] + \frac{\gamma_2^f}{2} \sum_{j=1}^{N_2} (|\Delta x^j|^2 + |\Delta r^j|^2) \\ & \quad + CN_1(|\mathbf{m}_2(\Delta y)|^2 + |\mathbf{m}_2(\Delta p)|^2 + |\mathbf{m}_2(\Delta r)|^2) + C\frac{N_1}{N_2} \sum_{i=1}^{N_1} (|\Delta \widehat{\beta}^i|^2 + |\Delta P^i|^2), \end{aligned}$$

where we have used Assumption 3.3 (vi) in the second inequality. Note that, the constant  $C$  depends on  $L$  and convexity parameters but not on  $(N_1, N_2)$ . Now we choose  $\delta_0^F := \min(\frac{\lambda_{\beta}}{2C}, \frac{\gamma_2^f}{6C})$ . Then, for any  $\delta_n = N_1/N_2$  satisfying  $\delta_n \leq \delta_0^F$ , we have

$$\begin{aligned} \mathcal{R}(t) & \leq \sum_{i=1}^{N_1} \left[ \frac{\gamma_1^f}{2} |\Delta X^i|^2 + \frac{\lambda_{\varpi}}{2} |\Delta \varpi|^2 + \lambda_{\beta} |\Delta \widehat{\beta}^i|^2 \right] + \gamma_2^f \sum_{j=1}^{N_2} \left[ \frac{1}{2} |\Delta x^j|^2 + \frac{2}{3} |\Delta r^j|^2 \right] \\ & \quad + C\delta_n \left[ \sum_{i=1}^{N_1} |\Delta P^i|^2 + \sum_{j=1}^{N_2} (|\Delta y^j|^2 + |\Delta p^j|^2) \right]. \end{aligned}$$

By inserting into (3.14), we obtain the desired estimate on  $\mathcal{D}(t)$ .  $\square$

We now provide the first main result. Since Peng-Wu's monotonicity does not hold, we need in general to make all the Lipschitz constants small enough to guarantee the well-posedness of FBSDEs for a given duration. However, the result of Lemma 3.3, which shows the violation of the monotonicity is proportional to  $\delta_n$ , suggests that the well-posedness of the system (3.13) may be available as long as the ratio  $\delta_n = N_1/N_2$  is small enough. We shall show that this is actually the case by the next theorem.

**Theorem 3.4.** *Let Assumptions 3.2-3.3 hold. Then, there exists some positive constant  $\delta_*^F \leq \delta_0^F$  such that, for any  $(N_1, N_2)$  satisfying  $\delta_n \leq \delta_*^F$ , there exists a unique square integrable solution to the system of FBSDEs (3.13) with  $u := (X, x, y, P, p, r) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_1} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_1} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2} \times \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_2}$ .*

*Proof.* First, we put  $\gamma := \min(\frac{\gamma_1^f}{2}, \frac{\gamma_2^f}{3}, \gamma_1^g, \gamma_2^g)$ . Let  $I_{X^i}, I_{x^j}, I_{r^j}, I_{P^i}, I_{y^j}, I_{p^j}$  be in  $\mathbb{H}^2(\mathbb{F}; \mathbb{R}^n)$  and  $\theta_{P^i}, \theta_{y^j}, \theta_{p^j}$  be in  $\mathbb{L}^2(\mathcal{F}_T, \mathbb{R}^n)$  for every  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ . We hypothesize that, for any choice of  $(I_{X^i}, I_{x^j}, I_{y^j}, I_{P^i}, I_{p^j}, I_{r^j})$  and  $(\theta_{P^i}, \theta_{y^j}, \theta_{p^j})$ , there exists some  $\varrho \in [0, 1)$  such that there exists a unique square integrable solution with  $\bar{u} = (\bar{X}, \bar{x}, \bar{y}, \bar{P}, \bar{p}, \bar{r}) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$  to the following system of FBSDEs,  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ :

$$\begin{aligned} d\bar{X}_t^i &= (\varrho B_{X^i}(t, \bar{u}_t) + I_{X^i}(t))dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \\ d\bar{x}_t^j &= (\varrho B_{x^j}(t, \bar{u}_t) + I_{x^j}(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\ d\bar{r}_t^j &= (\varrho B_{r^j}(t, \bar{u}_t) + I_{r^j}(t))dt, \\ d\bar{P}_t^i &= -[(1-\varrho)\gamma\bar{X}_t^i - \varrho F_{P^i}(t, \bar{u}_t) + I_{P^i}(t)]dt + \bar{Q}_t^{i,0}dW_t^0 + \sum_{k=1}^{N_1} \bar{Q}_t^{i,k}dW_t^k + \sum_{k=1}^{N_2} \bar{\mathfrak{Q}}_t^{i,k}dB_t^k, \\ d\bar{y}_t^j &= -[(1-\varrho)\gamma\bar{x}_t^j - \varrho F_{y^j}(t, \bar{u}_t) + I_{y^j}(t)]dt + \bar{z}_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} \bar{\mathfrak{z}}_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} \bar{z}_t^{j,k}dB_t^k, \\ d\bar{p}_t^j &= -[-(1-\varrho)\gamma\bar{r}_t^j - \varrho F_{p^j}(t, \bar{u}_t) + I_{p^j}(t)]dt + \bar{q}_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} \bar{q}_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} \bar{q}_t^{j,k}dB_t^k, \end{aligned}$$

with  $\bar{X}_0^i = \xi^i$ ,  $\bar{x}_0^j = \eta^j$ ,  $\bar{r}_0^j = 0$  and  $\bar{P}_T^i = \varrho G_{P^i}(\bar{u}_T) + (1-\varrho)\bar{X}_T^i + \theta_{P^i}$ ,  $\bar{y}_T^j = \varrho G_{y^j}(\bar{u}_T) + (1-\varrho)\bar{x}_T^j + \theta_{y^j}$ ,  $\bar{p}_T^j = \varrho G_{p^j}(\bar{u}_T) - (1-\varrho)\bar{r}_T^j + \theta_{p^j}$ . The hypothesis clearly holds when  $\varrho = 0$  since then the system becomes the *decoupled* Lipschitz FBSDEs.

Now, with a given input process  $\bar{u} \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$ , we consider the perturbed FBSDEs on  $u = (X, x, y, P, p, r)$  with  $\zeta \in (0, 1)$ ,  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ :

$$\begin{aligned} dX_t^i &= [\varrho B_{X^i}(t, u_t) + \zeta B_{X^i}(t, \bar{u}_t) + I_{X^i}(t)]dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \\ dx_t^j &= [\varrho B_{x^j}(t, u_t) + \zeta B_{x^j}(t, \bar{u}_t) + I_{x^j}(t)]dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\ dr_t^j &= [\varrho B_{r^j}(t, u_t) + \zeta B_{r^j}(t, \bar{u}_t) + I_{r^j}(t)]dt, \\ dP_t^i &= -[(1-\varrho)\gamma X_t^i - \varrho F_{P^i}(t, u_t) + \zeta(-\gamma\bar{X}_t^i - F_{P^i}(t, \bar{u}_t)) + I_{P^i}(t)]dt \\ &\quad + Q_t^{i,0}dW_t^0 + \sum_{k=1}^{N_1} Q_t^{i,k}dW_t^k + \sum_{k=1}^{N_2} \mathfrak{Q}_t^{i,k}dB_t^k, \\ dy_t^j &= -[(1-\varrho)\gamma x_t^j - \varrho F_{y^j}(t, u_t) + \zeta(-\gamma\bar{x}_t^j - F_{y^j}(t, \bar{u}_t)) + I_{y^j}(t)]dt \\ &\quad + z_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} \mathfrak{z}_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} z_t^{j,k}dB_t^k, \\ dp_t^j &= -[-(1-\varrho)\gamma r_t^j - \varrho F_{p^j}(t, u_t) + \zeta(\gamma\bar{r}_t^j - F_{p^j}(t, \bar{u}_t)) + I_{p^j}(t)]dt \\ &\quad + q_t^{j,0}dW_t^0 + \sum_{k=1}^{N_1} q_t^{j,k}dW_t^k + \sum_{k=1}^{N_2} q_t^{j,k}dB_t^k, \end{aligned} \tag{3.16}$$

with the boundary conditions  $X_0^i = \xi^i$ ,  $x_0^j = \eta^j$ ,  $r_0^j = 0$  and  $P_T^i = \varrho G_{P^i}(u_T) + (1-\varrho)X_T^i + \zeta(G_{P^i}(\bar{u}_T) - \bar{X}_T^i) + \theta_{P^i}$ ,  $y_T^j = \varrho G_{y^j}(u_T) + (1-\varrho)x_T^j + \zeta(G_{y^j}(\bar{u}_T) - \bar{x}_T^j) + \theta_{y^j}$  and  $p_T^j = \varrho G_{p^j}(u_T) - (1-\varrho)r_T^j + \zeta(G_{p^j}(\bar{u}_T) + \bar{r}_T^j) + \theta_{p^j}$ . Note that, by the initial hypothesis, there exists a unique solution  $u = (X, x, y, P, p, r) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$  to the FBSDEs (3.16). This defines a map  $\mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2} \ni \bar{u} \mapsto u \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$ . If we show that this map is a contraction for some  $\zeta > 0$  independent of

$\varrho$ , then we can extend the hypothesis from  $\varrho$  to  $(\varrho + \zeta)$ . Then we are done, because  $\varrho = 1$  and  $I, \theta = 0$  give the interested FBSDEs (3.13). In the following, we shall show that if  $\delta_n \leq \delta_*^F$  with some  $\delta_*^F > 0$  determined independently from  $\varrho$ , there exists a sufficiently small  $\zeta > 0$  independent of  $\varrho$  such that the above map  $\bar{u} \mapsto u$  becomes a contraction as desired.

**First step:** Let us denote by  $u, \hat{u} \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$  the solutions to (3.16) with two input processes  $\bar{u}, \hat{\bar{u}} \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$ , respectively. As in Lemmas 3.2-3.3, we use the notations:  $\Delta u := u - \hat{u}$ ,  $\Delta \bar{u} := \bar{u} - \hat{\bar{u}}$ ,  $\Delta B_{X^i}(t) := B_{X^i}(t, u_t) - B_{X^i}(t, \hat{u}_t)$ ,  $\Delta \bar{B}_{X^i}(t) := B_{X^i}(t, \bar{u}_t) - B_{X^i}(t, \hat{\bar{u}}_t)$ ,  $\Delta F_{P^i}(t) := F_{P^i}(t, u_t) - F_{P^i}(t, \hat{u}_t)$ ,  $\Delta \bar{F}_{P^i}(t) := F_{P^i}(t, \bar{u}_t) - F_{P^i}(t, \hat{\bar{u}}_t)$ ,  $\Delta G_{P^i} := G_{P^i}(u_T) - G_{P^i}(\hat{u}_T)$ ,  $\Delta \bar{G}_{P^i} := G_{P^i}(\bar{u}_T) - G_{P^i}(\hat{\bar{u}}_T)$ , etc. An application of Itô formula with the result of Lemma 3.3 gives

$$\begin{aligned} & \sum_{i=1}^{N_1} \mathbb{E}[\langle \Delta X_T^i, \Delta P_T^i \rangle] + \sum_{j=1}^{N_2} \mathbb{E}[\langle \Delta x_T^j, \Delta y_T^j \rangle + \langle (-1)\Delta r_T^j, \Delta p_T^j \rangle] \\ & \leq -\gamma \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta X_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_t^j|^2 + |\Delta r_t^j|^2) \right] dt \\ & + \delta_n C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta P_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt + \zeta \mathbb{E} \int_0^T \sum_{i=1}^{N_1} [\langle \Delta \bar{B}_{X^i}(t), \Delta P_t^i \rangle + \langle \gamma \Delta \bar{X}_t^i + \Delta \bar{F}_{P^i}(t), \Delta X_t^i \rangle] dt \\ & + \zeta \mathbb{E} \int_0^T \sum_{j=1}^{N_2} [\langle \Delta \bar{B}_{x^j}(t), \Delta y_t^j \rangle + \langle \gamma \Delta \bar{x}_t^j + \Delta \bar{F}_{y^j}(t), \Delta x_t^j \rangle + \langle (-1)\Delta \bar{B}_{r^j}(t), \Delta p_t^j \rangle + \langle \gamma \Delta \bar{r}_t^j - \Delta \bar{F}_{p^j}(t), \Delta r_t^j \rangle] dt. \end{aligned}$$

We also have, from Lemma 3.2,

$$\begin{aligned} & \sum_{i=1}^{N_1} \mathbb{E}[\langle \Delta X_T^i, \Delta P_T^i \rangle] + \sum_{j=1}^{N_2} \mathbb{E}[\langle \Delta x_T^j, \Delta y_T^j \rangle + \langle (-1)\Delta r_T^j, \Delta p_T^j \rangle] \\ & \geq (\varrho\gamma + (1 - \varrho)) \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta X_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_T^j|^2 + |\Delta r_T^j|^2) \right] \\ & + \zeta \mathbb{E} \left[ \sum_{i=1}^{N_1} \langle \Delta \bar{G}_{P^i} - \Delta \bar{X}_T^i, \Delta X_T^i \rangle + \sum_{j=1}^{N_2} (\langle \Delta \bar{G}_{y^j} - \Delta \bar{x}_T^j, \Delta x_T^j \rangle + \langle \Delta \bar{G}_{p^j} + \Delta \bar{r}_T^j, (-1)\Delta r_T^j \rangle) \right]. \end{aligned}$$

Put  $\gamma_c := \min(1, \gamma)$ , which satisfies  $0 < \gamma_c \leq \varrho\gamma + (1 - \varrho)$ , then the above two inequalities yield

$$\begin{aligned} & \gamma_c \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta X_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_T^j|^2 + |\Delta r_T^j|^2) \right] + \gamma_c \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta X_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_t^j|^2 + |\Delta r_t^j|^2) \right] dt \\ & \leq \delta_n C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta P_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt + \zeta \mathbb{E} \int_0^T \sum_{i=1}^{N_1} [\langle \Delta \bar{B}_{X^i}(t), \Delta P_t^i \rangle + \langle \gamma \Delta \bar{X}_t^i + \Delta \bar{F}_{P^i}(t), \Delta X_t^i \rangle] dt \\ & + \zeta \mathbb{E} \int_0^T \sum_{j=1}^{N_2} [\langle \Delta \bar{B}_{x^j}(t), \Delta y_t^j \rangle + \langle \gamma \Delta \bar{x}_t^j + \Delta \bar{F}_{y^j}(t), \Delta x_t^j \rangle + \langle (-1)\Delta \bar{B}_{r^j}(t), \Delta p_t^j \rangle + \langle \gamma \Delta \bar{r}_t^j - \Delta \bar{F}_{p^j}(t), \Delta r_t^j \rangle] dt. \\ & - \zeta \mathbb{E} \left[ \sum_{i=1}^{N_1} \langle \Delta \bar{G}_{P^i} - \Delta \bar{X}_T^i, \Delta X_T^i \rangle + \sum_{j=1}^{N_2} (\langle \Delta \bar{G}_{y^j} - \Delta \bar{x}_T^j, \Delta x_T^j \rangle + \langle \Delta \bar{G}_{p^j} + \Delta \bar{r}_T^j, (-1)\Delta r_T^j \rangle) \right]. \end{aligned}$$

We now expand the right hand side by using Lipschitz continuity of functions, Lemma 3.1 and Cauchy-Schwarz inequality. By choosing  $\zeta$  small enough to absorb the terms  $(|\Delta X|^2, |\Delta x|^2, |\Delta r|^2)$  into the

left hand side, we obtain

$$\begin{aligned}
& \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta X_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_T^j|^2 + |\Delta r_T^j|^2) \right] + \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta X_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_t^j|^2 + |\Delta r_t^j|^2) \right] dt \\
& \leq (\zeta + \delta_n) C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta P_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt \\
& \quad + \zeta C \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta \bar{X}_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta \bar{x}_T^j|^2 + |\Delta \bar{r}_T^j|^2) \right] \\
& \quad + \zeta C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} (|\Delta \bar{X}_t^i|^2 + |\Delta \bar{P}_t^i|^2) + \sum_{j=1}^{N_2} (|\Delta \bar{x}_t^j|^2 + |\Delta \bar{r}_t^j|^2 + |\Delta \bar{y}_t^j|^2 + |\Delta \bar{p}_t^j|^2) \right] dt.
\end{aligned} \tag{3.17}$$

Here, the constant  $C$  depends only on  $L$  and the convexity parameters such as  $\gamma, \lambda$ . In particular,  $C$  and the  $\zeta$  used in the above transformation are independent of  $\varrho$  and the population sizes.

**Second step:** We need to get estimates on the backward components ( $|\Delta P|^2, |\Delta y|^2, |\Delta p|^2$ ) in the right hand side of (3.17). In addition to  $(\bar{u}, \hat{u})$ , let us now treat  $(X, x, r)$  as well as  $(\hat{X}, \hat{x}, \hat{r})$  as exogenous input processes. We consider  $(P, y, p)$  as the solution to the BSDEs in (3.16) with the input processes  $(\bar{u}, X, x, r)$ , and  $(\hat{P}, \hat{y}, \hat{p})$  with  $(\bar{u}, \hat{X}, \hat{x}, \hat{r})$ , respectively. We can then apply the standard stability result for Lipschitz BSDEs (see, for example, [55, Theorem 4.4.4] or [48, Theorem 5.21]) to obtain

$$\begin{aligned}
& \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta P_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt \\
& \leq C \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta X_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_T^j|^2 + |\Delta r_T^j|^2) \right] + C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta X_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_t^j|^2 + |\Delta r_t^j|^2) \right] dt \\
& \quad + \zeta C \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta \bar{X}_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta \bar{x}_T^j|^2 + |\Delta \bar{r}_T^j|^2) \right] \\
& \quad + \zeta C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} (|\Delta \bar{X}_t^i|^2 + |\Delta \bar{P}_t^i|^2) + \sum_{j=1}^{N_2} (|\Delta \bar{x}_t^j|^2 + |\Delta \bar{r}_t^j|^2 + |\Delta \bar{y}_t^j|^2 + |\Delta \bar{p}_t^j|^2) \right] dt,
\end{aligned}$$

where  $C$  depends also on  $T$  in addition to the Lipschitz constants. This result combined with (3.17) then implies

$$\begin{aligned}
& \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta X_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta x_T^j|^2 + |\Delta r_T^j|^2) + \int_0^T \left[ \sum_{i=1}^{N_1} (|\Delta X_t^i|^2 + |\Delta P_t^i|^2) + \sum_{j=1}^{N_2} (|\Delta x_t^j|^2 + |\Delta r_t^j|^2 + |\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt \right] \\
& \leq (\zeta + \delta_n) C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} |\Delta P_t^i|^2 + \sum_{j=1}^{N_2} (|\Delta y_t^j|^2 + |\Delta p_t^j|^2) \right] dt \\
& \quad + \zeta C \mathbb{E} \left[ \sum_{i=1}^{N_1} |\Delta \bar{X}_T^i|^2 + \sum_{j=1}^{N_2} (|\Delta \bar{x}_T^j|^2 + |\Delta \bar{r}_T^j|^2) \right] \\
& \quad + \zeta C \mathbb{E} \int_0^T \left[ \sum_{i=1}^{N_1} (|\Delta \bar{X}_t^i|^2 + |\Delta \bar{P}_t^i|^2) + \sum_{j=1}^{N_2} (|\Delta \bar{x}_t^j|^2 + |\Delta \bar{r}_t^j|^2 + |\Delta \bar{y}_t^j|^2 + |\Delta \bar{p}_t^j|^2) \right] dt.
\end{aligned} \tag{3.18}$$

Choose  $\delta_*^F \leq \delta_0^F$  so that  $C\delta_*^F < 1$ . Then, for any  $\delta_n = N_1/N_2 \leq \delta_*^F$ , there exists  $\zeta > 0$  sufficiently small so that

$$(\zeta + \delta_n)C < 1, \text{ and } \frac{\zeta C}{1 - (\zeta + \delta_n)C} < 1.$$



For such a  $\zeta$ , the inequality (3.18) implies that the map  $\bar{u} \mapsto u$  is a contraction with respect to the norm  $\mathbb{E}[|u_T|^2 + \int_0^T |u_t|^2 dt]^{\frac{1}{2}}$ . By a simple application of Burkholder-Davis-Gundy (BDG) inequality, one can also show that it is a contraction map in the space  $\mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$ .  $\square$

By Theorems 3.3 and 3.4,  $(\widehat{\beta}_t^i := \widehat{\beta}^i(t, u_t), i = 1, \dots, N_1)_{t \in [0, T]}$  and  $(\varpi_t(y_t, \widehat{\beta}_t))_{t \in [0, T]}$  defined by the solution  $u$  of (3.13) give the unique optimal solution to (3.7) and the associated equilibrium price process, respectively. As one can see from the form of  $\varpi_t(\cdot, \cdot)$ , the cooperative agents gain more market power, i.e. larger price impacts, as their relative population size  $\delta_n$  grows. It may allow the cooperative agents to make arbitrary amount of profit by some sort of price manipulation. In fact, in the literature on the optimal trade executions, it has been known that large price impacts may cause a so-called ‘‘hot-potato’’ problem of strongly oscillating sale and purchase. (See, for example, Schied & Zhang (2017) [51].) It is possible that this is one of the economic reasons why we need a small  $\delta_n$  for the well-posedness.

Since (3.13) has a strong unique  $\mathbb{F}$ -adapted solution, Yamada-Watanebe Theorem for FBSDEs [14, Theorem 1.33] implies that there exists a some measurable function  $\Phi$  satisfying

$$((X^i, P^i)_{\{i=1, \dots, N_1\}}, (x^j, y^j, p^j, r^j)_{\{j=1, \dots, N_2\}}) = \Phi(W^0, (\xi^i, W^i)_{\{i=1, \dots, N_1\}}, (\eta^j, B^j)_{\{j=1, \dots, N_2\}}).$$

By the symmetry in the interactions of the agents (Remark 3.6) with the form of empirical means, as well as the symmetry in their heterogeneities as mentioned in Remarks 3.1 and 3.4, the function  $\Phi$  does not depend on the order of indexes  $i$  and  $j$ . Hence, due to the i.i.d. property of  $(\xi^i, W^i)_{\{i=1, \dots, N_1\}}$  and  $(\eta^j, B^j)_{\{j=1, \dots, N_2\}}$ , we can see that the joint distributions of  $(X^i, P^i, \xi^i, c^i, \widehat{\beta}^i, W^i)_{\{i=1, \dots, N_1\}}$  as well as  $(x^j, y^j, p^j, r^j, \eta^j, c^j, B^j)_{\{j=1, \dots, N_2\}}$  are invariant under the permutation of their indexes respectively. In other words, they are the exchangeable random variables. Since  $W^0$  is independent from the other inputs, the exchangeability also holds  $\mathcal{F}^0$ -conditionally. Moreover, the permutation of  $(x^j, y^j, p^j, r^j, \eta^j, c^j, B^j)_{\{j=1, \dots, N_2\}}$  does not affect the distribution of  $(X^i, P^i, \xi^i, c^i, \widehat{\beta}^i, W^i)_{\{i=1, \dots, N_1\}}$  and vice versa.

## 4 Mean-field equilibrium

### 4.1 Notations and preliminary remarks

Before setting up the mean-field model, let us introduce some notations to be used in this section. Since we will single out an arbitrarily chosen pair of representative agents  $(i, j)$  from the two populations, and the other agents are to be decoupled, it is useful to work on smaller probability spaces.

- $(\overline{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}})$  is a probability space defined by the product  $\overline{\Omega} := \overline{\Omega}^{1,i} \times \overline{\Omega}^{2,j}$  with  $(\overline{\mathcal{F}}, \overline{\mathbb{P}})$  the completion of  $(\overline{\mathcal{F}}^{1,i} \otimes \overline{\mathcal{F}}^{2,j}, \overline{\mathbb{P}}^{1,i} \otimes \overline{\mathbb{P}}^{2,j})$ .  $\overline{\mathbb{F}} := (\overline{\mathcal{F}}_t)_{t \geq 0}$  denotes the complete and right-continuous augmentation of  $(\overline{\mathcal{F}}_t^{1,i} \otimes \overline{\mathcal{F}}_t^{2,j})_{t \geq 0}$ .
- $(\Omega, \mathcal{F}, \mathbb{P})$  is a probability space defined by the product  $\Omega := \Omega^0 \times \overline{\Omega}$  with  $(\mathcal{F}, \mathbb{P})$  the completion of  $(\mathcal{F}^0 \otimes \overline{\mathcal{F}}, \mathbb{P}^0 \otimes \overline{\mathbb{P}})$ .  $\mathbb{F} := (\mathcal{F}_t)_{t \geq 0}$  denotes the complete and right-continuous augmentation of  $(\mathcal{F}_t^0 \otimes \overline{\mathcal{F}}_t)_{t \geq 0}$ . Here,  $(\Omega^0, \mathcal{F}^0, \mathbb{P}^0)$  with  $\mathbb{F}^0$  is defined in the same way as in Section 2.

$\mathbb{E}[\cdot]$  denotes the expectation with respect to  $\mathbb{P}$ , and  $\omega = (\omega^0, \overline{\omega})$  with  $\omega^0 \in \Omega^0$  and  $\overline{\omega} \in \overline{\Omega}$  a generic element of  $\Omega$ . Recall that  $\mathbb{F}^0$  denotes the filtration generated by the common noise  $W^0$ . We also need the following:

- $(\Omega^{1,i}, \mathcal{F}^{1,i}, \mathbb{P}^{1,i})$  is a probability space defined by the product  $\Omega^{1,i} := \Omega^0 \times \overline{\Omega}^{1,i}$  with  $(\mathcal{F}^{1,i}, \mathbb{P}^{1,i})$  the completion of  $(\mathcal{F}^0 \otimes \overline{\mathcal{F}}^{1,i}, \mathbb{P}^0 \otimes \overline{\mathbb{P}}^{1,i})$ .  $\mathbb{F}^{1,i} := (\mathcal{F}_t^{1,i})_{t \geq 0}$  denotes the complete and right-continuous augmentation of  $(\mathcal{F}_t^0 \otimes \overline{\mathcal{F}}_t^{1,i})_{t \geq 0}$ .  $(\Omega^{2,j}, \mathcal{F}^{2,j}, \mathbb{P}^{2,j})$  with  $\mathbb{F}^{2,j} := (\mathcal{F}_t^{2,j})_{t \geq 0}$  is defined similarly as above with  $(\overline{\Omega}^{1,i}, \overline{\mathcal{F}}^{1,i}, \overline{\mathbb{P}}^{1,i})$  and  $\overline{\mathbb{F}}^{1,i}$  replaced by  $(\overline{\Omega}^{2,j}, \overline{\mathcal{F}}^{2,j}, \overline{\mathbb{P}}^{2,j})$  and  $\overline{\mathbb{F}}^{2,j}$ .

Let us give some remarks on the properties of  $\mathcal{F}^0$ -conditional distributions and expectations. By [14, Lemma 2.4], it is shown that for any  $\mathbb{R}^n$ -valued random variable  $X$  on  $(\Omega, \mathcal{F}, \mathbb{P})$ ,  $X(\omega^0, \cdot)$  is a random variable on  $(\bar{\Omega}, \bar{\mathcal{F}}, \bar{\mathbb{P}})$  for  $\mathbb{P}^0$ -a.e.  $\omega^0 \in \Omega^0$ . In particular, by assigning an arbitrary  $\mathcal{P}(\mathbb{R}^n)$  value for the exceptional set, the map defined by  $\omega^0 \mapsto \mathcal{L}^0(X)(\omega^0) := \mathcal{L}(X(\omega^0, \cdot))$  is a random variable on  $(\Omega^0, \mathcal{F}^0, \mathbb{P}^0)$  into  $\mathcal{P}(\mathbb{R}^n)$ , and  $\mathcal{L}^0(X)$  provides the conditional law of  $X$  given  $\mathcal{F}^0$ . Moreover, if  $X = (X_t)_{t \geq 0}$  is a stochastic process in  $\mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)$  then [14, Lemma 2.5] shows that we can find a version of  $(\mathcal{L}^0(X_t))_{t \geq 0}$  such that the process  $(\mathcal{L}^0(X_t))_{t \geq 0}$  is  $\mathbb{F}^0$ -adapted and has continuous paths in  $\mathcal{P}_2(\mathbb{R}^n)$ . We denote by  $\mathbb{E}^0[\cdot]$  the  $\mathcal{F}^0$ -conditional expectation, or equivalently the integration over  $\bar{\Omega}$  by  $\bar{\mathbb{P}}$ . For any integrable  $\mathbb{F}$ -adapted process  $X = (X_t)_{t \geq 0}$ , we have  $\mathbb{E}^0[X_t](\omega^0) = \mathbb{E}[X_t(\omega^0, \cdot)] = \mathbb{E}[X_t | \mathcal{F}_t^0](\omega^0) = \mathbb{E}[X_t | \mathcal{F}^0](\omega^0)$ , since  $\sigma(W_s^0 - W_t^0)$ ,  $s > t$  is independent of  $\sigma(X_t)$ . In [14, Section 4.1.3], it is shown that we can find a version of  $(\mathbb{E}^0[X_t])_{t \geq 0}$  which is  $\mathbb{F}^0$ -progressively measurable by modifying  $dt \otimes d\mathbb{P}^0$ -null set when the process  $X = (X_t)_{t \geq 0}$  is  $\mathbb{F}$ -progressively measurable. In the remainder, we always use such a version.

As we have discussed in Subsection 3.2.1, we need to lift a function on probability measures to that on  $\mathbb{L}^2$ -random variables to define the  $L$ -derivative. To do this, we need another probability space.

- $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}})$  is a copy of the probability space  $(\bar{\Omega}, \bar{\mathcal{F}}, \bar{\mathbb{P}})$ . For any random variable  $X$  on  $\Omega = \Omega^0 \times \bar{\Omega}$ , the symbol  $\tilde{X}$  is used to denote a random variable defined as a copy of  $X$  on the space  $\tilde{\Omega} := \Omega^0 \times \tilde{\Omega}$ . We also use the abbreviations such as,  $\tilde{f}_1^i(t, \cdot) := f_1(t, \cdot, c_t^0, \tilde{c}_t^i)$  and  $\tilde{g}_1^i(\cdot) := g_1(\cdot, c_T^0, \tilde{c}_T^i)$  to ease the notations.

In particular, conditionally on  $\mathcal{F}^0$  (i.e. for each  $\omega^0 \in \Omega^0$ ,  $\mathbb{P}^0$ -a.e.),  $X$  and  $\tilde{X}$  are independent and have the same distribution  $\mathcal{L}^0(X) = \mathcal{L}^0(\tilde{X})$ . The corresponding expectations  $\tilde{\mathbb{E}}[\cdot]$  and  $\tilde{\mathbb{E}}^0[\cdot]$  are defined in the same way as  $\mathbb{E}[\cdot]$  and  $\mathbb{E}^0[\cdot]$ , respectively. When we need to put both  $X$  and  $\tilde{X}$  on the common space, we always assume that they are extended naturally to the space  $\Omega^0 \times \bar{\Omega} \times \tilde{\Omega}$  and still use the same symbols. We have  $\mathbb{E}\tilde{\mathbb{E}}[\cdot] = \mathbb{E}\tilde{\mathbb{E}}^0[\cdot] = \tilde{\mathbb{E}}\mathbb{E}^0[\cdot]$ . In particular, if  $F : \mathbb{R}^n \times \mathbb{R}^n \rightarrow \mathbb{R}$  is a measurable function such that  $F(X, \tilde{X})$  is integrable, then Fubini's theorem implies  $\mathbb{E}\tilde{\mathbb{E}}^0[F(X, \tilde{X})] = \mathbb{E}\tilde{\mathbb{E}}^0[F(\tilde{X}, X)]$ . Throughout this section, we work under Assumptions 3.2-3.3.

## 4.2 Mean-field problem

Our problem in this section is to solve

$$\inf_{\beta^i \in \mathbb{A}_1^i} \mathcal{J}_1^i(\beta^i), \quad (4.1)$$

with the cost functional defined by

$$\mathcal{J}_1^i(\beta^i) := \mathbb{E} \left[ \int_0^T f_1^i(t, X_t^i, \mathcal{L}^0(X_t^i), \pi_t(y_t^j, \beta_t^i), \beta_t^i) dt + g_1^i(X_T^i, \mathcal{L}^0(X_T^i)) \right],$$

under the dynamic constraints:

$$\begin{aligned} dX_t^i &= (\beta_t^i + \rho_1(t)\pi_t(y_t^j, \beta_t^i) + l_1^i(t))dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \\ dx_t^j &= (-\bar{\Lambda}_t(y_t^j + \pi_t(y_t^j, \beta_t^i)) + \rho_2(t)\pi_t(y_t^j, \beta_t^i) + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dW_t^j, \\ dy_t^j &= -(\partial_x \bar{F}_2^j(t, x_t^j) - b_t \pi_t(y_t^j, \beta_t^i))dt + z_t^{j,0}dW_t^0 + z_t^{j,j}dB_t^j, \end{aligned} \quad (4.2)$$

with the boundary conditions;  $X_0^i = \xi^i$ ,  $x_0^j = \eta^j$  and  $y_T^j = \partial_x g_2^j(x_T^j)$ . Here,  $\mathbb{A}_1^i := \mathbb{H}^2(\mathbb{F}^{1,i}; A_1)$  is the space of admissible controls, and we have used the definition

$$\pi_t(y, \beta) := -\mathbb{E}^0[y] + \delta_n \Lambda_t \mathbb{E}^0[\beta]. \quad (4.3)$$

In this problem, we have chosen a pair  $(\mathbf{i}, \mathbf{j})$  as **the representative agents** from the two populations and they are kept fixed throughout this section. The rigorous discussions on the relation between this problem with the finite-agent equilibrium discussed in the previous sections will be the topic in the next section.

**Remark 4.1.** *Let Assumptions 3.2-3.3 hold. Then, for a given  $\beta^i \in \mathbb{A}_1^i$ , there exists a unique solution  $x^j, y^j \in \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)$  of (4.2). This can be shown by the Peng-Wu's continuation method in a completely parallel manner to Theorem 3.2. In fact, this is a special situation handled in [27, Theorem 4.2]. Therefore, for each  $\beta^i \in \mathbb{A}_1^i$ , the state processes  $(X^i, x^j, y^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times (\mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n))^2$  are defined uniquely.*

Note that, the symmetric interaction contained in  $\varpi_t(\cdot, \cdot)$  as the empirical means does not exist in  $\pi_t(\cdot, \cdot)$  anymore. This induces a decoupling among the agents, which can also be observed in the information structure. Since  $X^i$  is adapted to  $\mathbb{F}^{1,i}$ , the representative agent  $i$  only cares about the common information  $\mathbb{F}^0$  and her own idiosyncratic information  $\overline{\mathbb{F}}^{1,i}$ . The same observation holds for the agent  $j$  of the second population.

The involvement of  $\mathbb{E}^0[\beta_t^i]$ -term in the cost function makes our problem the conditional extended mean-field control [1]. For this type of problem, it is convenient to work on the lifted Hamiltonian  $\mathcal{H}$  defined on the  $\mathbb{L}^2$ -space. We define the map  $\mathcal{H} : [0, T] \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2 \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2 \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1) \ni (t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \beta_t^i) \mapsto \mathcal{H}(t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \beta_t^i) \in \mathbb{R}$  by

$$\begin{aligned} & \mathcal{H}(t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \beta_t^i) \\ & := \mathbb{E} \left[ \langle P_t^i, \beta_t^i + \rho_1(t) \pi_t(y_t^j, \beta_t^i) + l_1^i(t) \rangle + f_1^i(t, X_t^i, \mathcal{L}^0(X_t^i), \pi_t(y_t^j, \beta_t^i), \beta_t^i) \right. \\ & \quad \left. + \bar{\delta}_n \{ \langle p_t^j, -\bar{\Lambda}_t(y_t^j + \pi_t(y_t^j, \beta_t^i)) + \rho_2(t) \pi_t(y_t^j, \beta_t^i) + l_2^j(t) \rangle + \langle r_t^j, -\partial_x \bar{F}_2^j(t, x_t^j) + b_t \pi_t(y_t^j, \beta_t^i) \rangle \} \right], \end{aligned} \quad (4.4)$$

where  $\bar{\delta}_n := 1/\delta_n = N_2/N_1$ . The dependence on the conditional distribution  $\mathcal{L}^0(X_t^i)$  as well as the conditional expectations  $(\mathbb{E}^0[y_t^j], \mathbb{E}^0[\beta_t^i])$  in  $\pi_t(\cdot, \cdot)$  is treated as a function on the random variables  $X_t^i$  and  $(y_t^j, \beta_t^i)$ . Since there is no information about the size of populations in the dynamics (4.2), it must be given by hand to the Hamiltonian  $\mathcal{H}$  using the coefficient  $\bar{\delta}_n$ . The way in which  $\mathcal{H}$  depends on  $\bar{\delta}_n$  may be guessed from  $H$  in (3.9). As before, with slight abuse of notation, we write the lifted Hamiltonian as  $\mathcal{H}(t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \pi_t, \beta_t^i)$  when we treat  $\pi_t \in \mathbb{L}^2(\mathcal{F}_t^0; \mathbb{R}^n)$  as a separate argument.

For each  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$ , we want to find the minimizer:

$$\widehat{\beta}^i(t, u_t) := \operatorname{argmin}(\mathcal{H}(t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \beta_t^i); \beta_t^i \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)).$$

The optimization problem in a Hilbert space has been well studied and we can follow the standard technique using the weak sequential lower-semicontinuity. See, for example, [46] and a brief monograph [49]. We often use the following results on Frechet derivatives of  $\mathcal{H}$ : with  $\pi_t := \pi_t(y_t^j, \beta_t^i)$  and  $\mu_t := \mathcal{L}^0(X_t^i)$ ,

$$\begin{aligned} D_{\beta^i} \mathcal{H}(t, u_t, \beta_t^i) &= \partial_{\beta^i} \mathcal{H}(t, u_t, \pi_t, \beta_t^i) + \delta_n \Lambda_t \mathbb{E}^0[\partial_\pi \mathcal{H}(t, u_t, \pi_t, \beta_t^i)] \\ &= P_t^i + \partial_\beta f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i) + \delta_n \Lambda_t \mathbb{E}^0[\partial_\varpi f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i)] \\ &\quad + \delta_n \rho_1(t) \Lambda_t \mathbb{E}^0[P_t^i] + (-I + \rho_2(t) \Lambda_t) \mathbb{E}^0[p_t^j] + b_t \Lambda_t \mathbb{E}^0[r_t^j], \\ D_{X^i} \mathcal{H}(t, u_t, \beta_t^i) &= \partial_x f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i) + \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mu_t, \pi_t, \widetilde{\beta}_t^i)(X_t^i)], \\ D_{x^j} \mathcal{H}(t, u_t, \beta_t^i) &= \partial_{x^j} \mathcal{H}(t, u_t, \beta_t^i) = -c_f^j(t) r_t^j, \\ D_{y^j} \mathcal{H}(t, u_t, \beta_t^i) &= -\bar{\delta}_n \bar{\Lambda}_t p_t^j - \mathbb{E}^0[\partial_\pi \mathcal{H}(t, u_t, \pi_t, \beta_t^i)] \\ &= -\mathbb{E}^0[\partial_\varpi f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i)] - \rho_1(t) \mathbb{E}^0[P_t^i] + \bar{\delta}_n (\bar{\Lambda}_t (\mathbb{E}^0[p_t^j] - p_t^j) - \rho_2(t) \mathbb{E}^0[p_t^j] - b_t \mathbb{E}^0[r_t^j]). \end{aligned} \quad (4.5)$$

**Lemma 4.1.** *Under Assumptions 3.2-3.3, for each  $t \in [0, T]$  and a given set of adjoint variables  $(P_t^i, p_t^j, r_t^j) \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2$ , the lifted Hamiltonian  $\mathcal{H}$  defined by (4.4) is jointly convex in  $(X_t^i, x_t^j, y_t^j, \beta_t^i) \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2 \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)$  and strictly so in  $(X_t^i, \beta_t^i)$ . In particular, for any  $t \in [0, T]$  and input  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$ , there exists a unique minimizer  $\widehat{\beta}^i := \widehat{\beta}^i(t, u_t) \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)$  that satisfies the following linear growth and the Lipschitz continuity*

properties:

$$\begin{aligned}\mathbb{E}[|\widehat{\beta}^i(t, u_t)|^2] &\leq C\mathbb{E}\left[1 + |X_t^i|^2 + |P_t^i|^2 + |\mathbb{E}^0[y_t^j]|^2 + |\mathbb{E}^0[p_t^j]|^2 + |\mathbb{E}^0[r_t^j]|^2 + |c_t^0|^2 + |c_t^i|^2\right], \\ \mathbb{E}[|\widehat{\beta}^i(t, u_t) - \widehat{\beta}^i(t, \acute{u}_t)|^2] &\leq C\mathbb{E}\left[|X_t^i - \acute{X}_t^i|^2 + |P_t^i - \acute{P}_t^i|^2 + |\mathbb{E}^0[y_t^j - \acute{y}_t^j]|^2 + |\mathbb{E}^0[p_t^j - \acute{p}_t^j]|^2 + |\mathbb{E}^0[r_t^j - \acute{r}_t^j]|^2\right].\end{aligned}$$

where  $\acute{u}_t := (\acute{X}_t^i, \acute{x}_t^j, \acute{y}_t^j, \acute{P}_t^i, \acute{p}_t^j, \acute{r}_t^j)$  is another input and  $C$  is some positive constant independent of  $\delta_n$ .

*Proof.* Firstly, we check the relevant convexity of  $\mathcal{H}$ . For a given set of adjoint variables  $(P_t^i, p_t^j, r_t^j)$ , let us consider two arbitrary inputs  $(X_t^i, x_t^j, y_t^j), (\acute{X}_t^i, \acute{x}_t^j, \acute{y}_t^j) \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2$  and  $\beta_t^i, \acute{\beta}_t^i \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)$ . For notational simplicity, we put  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$  and  $\acute{u}_t := (\acute{X}_t^i, \acute{x}_t^j, \acute{y}_t^j, \acute{P}_t^i, \acute{p}_t^j, \acute{r}_t^j)$ ,  $\mu_t := \mathcal{L}^0(X_t^i), \acute{\mu}_t := \mathcal{L}^0(\acute{X}_t^i), \pi_t := \pi_t(y_t^j, \beta_t^i), \acute{\pi}_t := \pi_t(\acute{y}_t^j, \acute{\beta}_t^i), \Delta X_t^i := \acute{X}_t^i - X_t^i, \Delta \beta_t^i := \acute{\beta}_t^i - \beta_t^i$  and  $\Delta \pi_t := \acute{\pi}_t - \pi_t = -\mathbb{E}^0[\Delta y_t^j] + \delta_n \Lambda_t \mathbb{E}^0[\Delta \beta_t^i]$ , etc. Then, the Frechet derivatives (4.5), Assumption 3.3 (iv) and Fubini's theorem yield

$$\begin{aligned}\mathcal{H}(t, \acute{u}_t, \acute{\beta}_t^i) - \mathcal{H}(t, u_t, \beta_t^i) - \mathbb{E}[\langle D_{X^i} \mathcal{H}(t, u_t, \beta_t^i), \Delta X_t^i \rangle + \langle D_{x^j} \mathcal{H}(t, u_t, \beta_t^i), \Delta x_t^j \rangle \\ + \langle D_{y^j} \mathcal{H}(t, u_t, \beta_t^i), \Delta y_t^j \rangle + \langle D_{\beta^i} \mathcal{H}(t, u_t, \beta_t^i), \Delta \beta_t^i \rangle] \\ = \mathbb{E}[f_1^i(t, \acute{X}_t^i, \acute{\mu}_t, \acute{\pi}_t, \acute{\beta}_t^i) - f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i) - \widetilde{\mathbb{E}}^0[\langle \partial_{\mu} f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i)(\widetilde{X}_t^i), \Delta \widetilde{X}_t^i \rangle] \\ - \langle \partial_x f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i), \Delta X_t^i \rangle - \langle \mathbb{E}^0[\partial_{\varpi} f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i)], \Delta \pi_t \rangle - \langle \partial_{\beta} f_1^i(t, X_t^i, \mu_t, \pi_t, \beta_t^i), \Delta \beta_t^i \rangle] \\ \geq \frac{1}{2} \mathbb{E}[\gamma_1^f |\Delta X_t^i|^2 + \lambda_{\beta} |\Delta \beta_t^i|^2 + \lambda_{\varpi} |\Delta \pi_t|^2].\end{aligned}\tag{4.6}$$

This gives the desired convexity. Since the map  $\beta_t^i \mapsto \mathcal{H}(t, u_t, \beta_t^i)$  is coercive due to its strict  $\lambda_{\beta}$ -convexity, we can restrict its minimization on the set  $K := \{\beta_t^i \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1), \|\beta_t^i\|_{\mathbb{L}^2} \leq M\}$  for some constant  $M > 0$ . Since our probability spaces are assumed to be the completion of those countably generated, it is known that  $H := \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n)$  is a separable Hilbert space. Since  $K$  is a bounded and closed convex subset of  $H$ ,  $K$  is weakly sequentially compact by [46, Proposition 2.6]. Since the map  $\beta_t^i \mapsto \mathcal{H}(t, u_t, \beta_t^i)$  is strongly continuous and convex, it is also weakly sequentially lower semicontinuous by [46, Lemma 2.7]. Therefore, by [46, Theorem 3.1], there exists a minimizer  $\widehat{\beta}^i(t, u_t)$  of the map, which is unique by the strict convexity.

The latter claims can be proved similarly to those in Lemma 3.1. Let us fix  $\beta^0 \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)$  arbitrarily, and denote by  $\widehat{\beta}_t^i := \widehat{\beta}^i(t, u_t), \widehat{\beta}_t^{i,i} := \widehat{\beta}^i(t, \acute{u}_t) \in \mathbb{L}^2(\mathcal{F}_t^{1,i}; A_1)$  the unique minimizers of  $\mathcal{H}(t, u_t, \cdot)$  and  $\mathcal{H}(t, \acute{u}_t, \cdot)$ , respectively. Here,  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$  and  $\acute{u}_t := (\acute{X}_t^i, \acute{x}_t^j, \acute{y}_t^j, \acute{P}_t^i, \acute{p}_t^j, \acute{r}_t^j)$  are two arbitrary inputs. Using the convexity (4.6) and the optimality condition, we can show that the following inequalities hold:

$$\begin{aligned}\frac{\lambda_{\beta}}{2} \mathbb{E}[|\widehat{\beta}_t^i - \beta^0|^2] &\leq \mathbb{E}[\langle \beta^0 - \widehat{\beta}_t^i, D_{\beta^i} \mathcal{H}(t, u_t, \beta^0) \rangle], \\ \lambda_{\beta} \mathbb{E}[|\widehat{\beta}_t^{i,i} - \widehat{\beta}_t^i|^2] &\leq \mathbb{E}[\langle \widehat{\beta}_t^{i,i} - \widehat{\beta}_t^i, D_{\beta^i} \mathcal{H}(t, u_t, \widehat{\beta}_t^{i,i}) - D_{\beta^i} \mathcal{H}(t, \acute{u}_t, \widehat{\beta}_t^{i,i}) \rangle].\end{aligned}$$

Yong's equality and Lipschitz continuity from Assumption 3.3 (iii) then give the desired result.  $\square$

The system of state and adjoint equations for the problem (4.1) is given as follows:

$$\begin{aligned}dX_t^i &= (\widehat{\beta}_t^i + \rho_1(t)\pi_t(y_t^j, \widehat{\beta}_t^i) + l_1^i(t))dt + \sigma_1^{i,0}(t)dW_t^0 + \sigma_1^i(t)dW_t^i, \\ dx_t^j &= (-\overline{\Lambda}_t(y_t^j + \pi_t(y_t^j, \widehat{\beta}_t^i)) + \rho_2(t)\pi_t(y_t^j, \widehat{\beta}_t^i) + l_2^j(t))dt + \sigma_2^{j,0}(t)dW_t^0 + \sigma_2^j(t)dB_t^j, \\ dy_t^j &= -(\partial_x \overline{F}_2^j(t, x_t^j) - b_t \pi_t(y_t^j, \widehat{\beta}_t^i))dt + z_t^{j,0}dW_t^0 + z_t^{j,j}dB_t^j, \\ dP_t^i &= -\{\partial_x f_1^i(t, X_t^i, \mathcal{L}^0(X_t^i), \pi_t(y_t^j, \widehat{\beta}_t^i), \widehat{\beta}_t^i) + \widetilde{\mathbb{E}}^0[\partial_{\mu} \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mathcal{L}^0(X_t^i), \pi_t(y_t^j, \widehat{\beta}_t^i), \widetilde{\beta}_t^i)(X_t^i)]\}dt \\ &\quad + Q_t^{i,0}dW_t^0 + Q_t^{i,i}dW_t^i, \\ dp_t^j &= c_f^j(t)r_t^j dt + q_t^{j,0}dW_t^0 + q_t^{j,j}dB_t^j, \\ dr_t^j &= -\{\overline{\Lambda}_t(\mathbb{E}^0[p_t^j] - p_t^j) - \rho_2(t)\mathbb{E}^0[p_t^j] - b_t \mathbb{E}^0[r_t^j] \\ &\quad - \delta_n \rho_1(t)\mathbb{E}^0[P_t^i] - \delta_n \mathbb{E}^0[\partial_{\varpi} f_1^i(t, X_t^i, \mathcal{L}^0(X_t^i), \pi_t(y_t^j, \widehat{\beta}_t^i), \widehat{\beta}_t^i)]\}dt,\end{aligned}\tag{4.7}$$

with boundary conditions:  $X_0^i = \xi^i, x_0^j = \eta^j, r_0^j = 0$  and

$$y_T^j = \partial_x g_2^j(x_T^j), \quad P_T^i = \partial_x g_1^i(X_T^i, \mathcal{L}^0(X_T^i)) + \tilde{\mathbb{E}}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mathcal{L}^0(X_T^i))(X_T^i)], \quad p_T^j = -c_g^j r_T^j.$$

Here,  $\forall t \in [0, T]$ ,  $\hat{\beta}_t^i := \hat{\beta}^i(t, u_t)$  is the minimizer of  $\mathcal{H}(t, u_t, \cdot)$  with  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$ . The next theorem gives a mean-field counterpart of Theorem 3.3.

**Remark 4.2.** Using (4.5), one can check that the drift terms of the adjoint processes  $(P^i, p^j, r^j)$  are given by  $-D_{X^i} \mathcal{H}(t, u_t, \hat{\beta}_t^i)$ ,  $-\delta_n D_{x^j} \mathcal{H}(t, u_t, \hat{\beta}_t^i)$  and  $-\delta_n D_{y^j} \mathcal{H}(t, u_t, \hat{\beta}_t^i)$ , respectively.

**Theorem 4.1.** Let Assumptions 3.2-3.3 be in force. Suppose that there exists a unique square integrable solution to the system of equations (4.7) with  $(X^i, x^j, y^j, P^i, p^j, r^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)^2 \times \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)^2$  with  $\hat{\beta}_t^i := \hat{\beta}^i(t, u_t)$  the minimizer of  $\mathcal{H}(t, X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j, \cdot)$  for  $dt$ -a.e.  $t \in [0, T]$ . Then,  $\hat{\beta}_t^i, t \in [0, T]$  is the unique optimal solution to (4.1).

*Proof.* Let  $u := (X^i, x^j, y^j, P^i, p^j, r^j)$  be the solution to (4.7) with  $\hat{\beta}_t^i = \hat{\beta}^i(t, u_t)$  the minimizer of  $\mathcal{H}(t, u_t, \cdot)$ ,  $dt$ -a.e. We denote by  $(\hat{X}^i, \hat{x}^j, \hat{y}^j)$  the state processes corresponding to another control  $\hat{\beta}^i \in \mathbb{A}_1^i$  and set  $\hat{u} := (\hat{X}^i, \hat{x}^j, \hat{y}^j, P^i, p^j, r^j)$ . We put  $\mu_t := \mathcal{L}^0(X_t^i), \hat{\mu}_t := \mathcal{L}^0(\hat{X}_t^i), \pi_t := \pi_t(y_t^j, \hat{\beta}_t^i), \hat{\pi}_t := \pi_t(\hat{y}_t^j, \hat{\beta}_t^i), \Delta X_t^i = \hat{X}_t^i - X_t^i, \Delta x_t^j := \hat{x}_t^j - x_t^j, \Delta \beta_t^i := \hat{\beta}_t^i - \beta_t^i$  and  $\Delta \pi_t := \hat{\pi}_t - \pi_t$ , etc. From Assumption 3.3 (v), Fubini's theorem and the equality  $\langle p_T^j, \Delta x_T^j \rangle + \langle r_T^j, \Delta y_T^j \rangle = 0$ , we obtain

$$\mathbb{E}[g_1^i(\hat{X}_T^i, \hat{\mu}_T) - g_1^i(X_T^i, \mu_T)] \geq \mathbb{E}[\langle P_T^i, \Delta X_T^i \rangle + \bar{\delta}_n (\langle p_T^j, \Delta x_T^j \rangle + \langle r_T^j, \Delta y_T^j \rangle)].$$

Thus, an application of Itô-formula and the optimality condition  $\mathbb{E}[\langle D_{\beta^i} \mathcal{H}(t, u_t, \hat{\beta}_t^i), \Delta \beta_t^i \rangle] \geq 0$   $dt$ -a.e. yield

$$\begin{aligned} \mathcal{J}_1^i(\hat{\beta}^i) - \mathcal{J}_1^i(\hat{\beta}^i) &\geq \int_0^T \left[ \mathcal{H}(t, \hat{u}_t, \hat{\beta}_t^i) - \mathcal{H}(t, u_t, \hat{\beta}_t^i) - \mathbb{E}[\langle D_{X^i} \mathcal{H}(t, u_t, \hat{\beta}_t^i), \Delta X_t^i \rangle + \langle D_{x^j} \mathcal{H}(t, u_t, \hat{\beta}_t^i), \Delta x_t^j \rangle \right. \\ &\quad \left. + \langle D_{y^j} \mathcal{H}(t, u_t, \hat{\beta}_t^i), \Delta y_t^j \rangle + \langle D_{\beta^i} \mathcal{H}(t, u_t, \hat{\beta}_t^i), \Delta \beta_t^i \rangle \right] dt \\ &\geq \frac{1}{2} \int_0^T \mathbb{E}[\gamma_1^i |\Delta X_t^i|^2 + \lambda_\beta |\Delta \beta_t^i|^2 + \lambda_\pi |\Delta \pi_t|^2] dt, \end{aligned}$$

which proves the claim.  $\square$

### 4.3 Existence of mean-field equilibrium

By Theorem 4.1, it only remains to show the existence of a solution to the FBSDE (4.7) of conditional McKean-Vlasov type. Thanks to the similarity in the form of equations, we can proceed in a parallel fashion to Section 3.2.3. For each  $t$ , let us denote by  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$  a generic element in  $\mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2 \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2$ . As we have done before, we introduce the following maps:

$$\begin{aligned} B_{X^i}(t, u_t) &:= \hat{\beta}_t^i + \rho_1(t) \pi_t(y_t^j, \hat{\beta}_t^i) + l_1^i(t), \\ B_{x^j}(t, u_t) &:= -\bar{\Lambda}_t(y_t^j + \pi_t(y_t^j, \hat{\beta}_t^i)) + \rho_2(t) \pi_t(y_t^j, \hat{\beta}_t^i) + l_2^j(t), \\ B_{r^j}(t, u_t) &:= -\{\bar{\Lambda}_t(\mathbb{E}^0[p_t^j] - p_t^j) - \rho_2(t) \mathbb{E}^0[p_t^j] - b_t \mathbb{E}^0[r_t^j] - \delta_n \rho_1(t) \mathbb{E}^0[P_t^i] \\ &\quad - \delta_n \mathbb{E}^0[\partial_\omega f_1^i(t, X_t^i, \mu_t, \pi_t(y_t^j, \hat{\beta}_t^i), \hat{\beta}_t^i)]\}, \\ F_{P^i}(t, u_t) &:= -\{\partial_x f_1^i(t, X_t^i, \mu_t, \pi_t(y_t^j, \hat{\beta}_t^i), \hat{\beta}_t^i) + \tilde{\mathbb{E}}^0[\partial_\mu \tilde{f}_1^i(t, \tilde{X}_t^i, \mu_t, \pi_t(y_t^j, \hat{\beta}_t^i), \tilde{\beta}_t^i)(X_t^i)]\}, \\ F_{y^j}(t, u_t) &:= -\partial_x \bar{f}_2^j(t, x_t^j) + b_t \pi_t(y_t^j, \hat{\beta}_t^i), \quad F_{p^j}(t, u_t) := c_f^j(t) r_t^j, \end{aligned} \tag{4.8}$$

and similarly

$$G_{P^i}(u_T) := \partial_x g_1^i(X_T^i, \mu_T) + \tilde{\mathbb{E}}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mu_T)(X_T^i)], \quad G_{y^j}(u_T) := \partial_x g_2^j(x_T^j), \quad G_{p^j}(u_T) := -c_g^j r_T^j.$$



Here,  $\mu_t := \mathcal{L}^0(X_t^i)$  and  $\widehat{\beta}_t^i := \widehat{\beta}^i(t, u_t)$  is the minimizer of  $\mathcal{H}(t, u_t, \cdot)$ .

Let  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$  and  $\acute{u}_t := (\acute{X}_t^i, \acute{x}_t^j, \acute{y}_t^j, \acute{P}_t^i, \acute{p}_t^j, \acute{r}_t^j)$  be two arbitrary inputs in the space  $\mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2 \times \mathbb{L}^2(\mathcal{F}_t^{1,i}; \mathbb{R}^n) \times (\mathbb{L}^2(\mathcal{F}_t^{2,j}; \mathbb{R}^n))^2$ . We introduce the following abbreviations:  $\acute{\mu}_t := \mathcal{L}^0(\acute{X}_t^i)$ ,  $\widehat{\beta}_t^{i,i} := \widehat{\beta}^i(t, \acute{u}_t)$ ,  $\pi_t := \pi_t(y_t^j, \widehat{\beta}_t^i)$ ,  $\acute{\pi}_t := \pi_t(\acute{y}_t^j, \widehat{\beta}_t^{i,i})$ ,  $f_1^i(t, u_t, \widehat{\beta}_t^i) := f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i)$  and  $f_1^i(t, \acute{u}_t, \widehat{\beta}_t^{i,i}) := f_1^i(t, \acute{X}_t^i, \acute{\mu}_t, \acute{\pi}_t, \widehat{\beta}_t^{i,i})$ . We also put  $\Delta u_t := u_t - \acute{u}_t$ ,  $\Delta X_t^i := X_t^i - \acute{X}_t^i$ ,  $\Delta y_t^j := y_t^j - \acute{y}_t^j$ ,  $\Delta \pi_t := \pi_t - \acute{\pi}_t$ ,  $\Delta \widehat{\beta}_t^i := \widehat{\beta}_t^i - \widehat{\beta}_t^{i,i}$ ,  $\Delta B_{X^i}(t) := B_{X^i}(t, u_t) - B_{X^i}(t, \acute{u}_t)$ ,  $\Delta F_{P^i}(t) := F_{P^i}(t, u_t) - F_{P^i}(t, \acute{u}_t)$ ,  $\Delta G_{P^i} := G_{P^i}(u_T) - G_{P^i}(\acute{u}_T)$ , etc.

**Lemma 4.2.** *Under Assumptions 3.2-3.3, the terminal functions satisfy for any inputs  $(u_T, \acute{u}_T)$ ,*

$$\mathbb{E}[\langle \Delta G_{P^i}, \Delta X_T^i \rangle + \bar{\delta}_n(\langle \Delta G_{y^j}, \Delta x_T^j \rangle + \langle (-1)\Delta G_{p^j}, \Delta r_T^j \rangle)] \geq \mathbb{E}[\gamma_1^g |\Delta X_T^i|^2 + \bar{\delta}_n \gamma_2^g (|\Delta x_T^j|^2 + |\Delta r_T^j|^2)].$$

*Proof.* Using Fubini's theorem, it directly follows from Assumption 3.2 (iv) and Assumption 3.3 (v).  $\square$

**Lemma 4.3.** *Let Assumptions 3.2-3.3 hold. Then, for any  $t \in [0, T]$  and inputs  $(u_t, \acute{u}_t)$ , there exists a positive constant  $\delta_0^M$  such that, for any  $\delta_n \leq \delta_0^M$ , the inequality*

$$\mathcal{D}(t) \leq -\gamma^f \mathbb{E}[|\Delta X_t^i|^2 + \bar{\delta}_n (|\Delta x_t^j|^2 + |\Delta r_t^j|^2)] + \delta_n C \mathbb{E}[|\Delta P_t^i|^2 + \bar{\delta}_n (|\Delta y_t^j|^2 + |\Delta p_t^j|^2)]$$

holds with  $\gamma^f := \min(\frac{\gamma_1^f}{2}, \frac{\gamma_2^f}{3})$  and some positive constant  $C$  independent of  $\delta_n$ . Here,

$$\begin{aligned} \mathcal{D}(t) := & \mathbb{E}[\langle \Delta B_{X^i}(t), \Delta P_t^i \rangle + \bar{\delta}_n(\langle \Delta B_{x^j}(t), \Delta y_t^j \rangle + \langle (-1)\Delta B_{r^j}(t), \Delta p_t^j \rangle)] \\ & + \mathbb{E}[\langle \Delta F_{P^i}(t), \Delta X_t^i \rangle + \bar{\delta}_n(\langle \Delta F_{y^j}(t), \Delta x_t^j \rangle + \langle (-1)\Delta F_{p^j}(t), \Delta r_t^j \rangle)]. \end{aligned}$$

*Proof.* From (4.5), we now have

$$\begin{aligned} \Delta P_t^i = & D_{\beta^i} \mathcal{H}(t, u_t, \widehat{\beta}_t^i) - D_{\beta^i} \mathcal{H}(t, \acute{u}_t, \widehat{\beta}_t^{i,i}) - (\partial_{\beta} f_1^i(t, u_t, \widehat{\beta}_t^i) - \partial_{\beta} f_1^i(t, \acute{u}_t, \widehat{\beta}_t^{i,i})) + (I - \rho_2(t)\Lambda_t) \mathbb{E}^0[\Delta P_t^j] \\ & - b_t \Lambda_t \mathbb{E}^0[\Delta r_t^j] - \delta_n \rho_1(t) \Lambda_t \mathbb{E}^0[\Delta P_t^i] - \delta_n \Lambda_t \mathbb{E}^0[\partial_{\varpi} f_1^i(t, u_t, \widehat{\beta}_t^i) - \partial_{\varpi} f_1^i(t, \acute{u}_t, \widehat{\beta}_t^{i,i})]. \end{aligned}$$

With simple replacement of summations to expectations, we can proceed in almost the same way as in Lemma 3.3, hence we omit the details.  $\square$

**Theorem 4.2.** *Let Assumptions 3.2-3.3 be in force. Then, there exists some positive constant  $\delta_*^M \leq \delta_0^M$  such that, for any  $\delta_n \leq \delta_*^M$ , there exists a unique square integrable solution to the FBSDE (4.7) of McKean-Vlasov type with  $u := (X^i, x^j, y^j, P^i, p^j, r^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n) \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)$ . With the solution  $u$ , the process  $(\widehat{\beta}_t^i := \widehat{\beta}^i(t, u_t))_{t \in [0, T]}$  gives the unique optimal solution to (4.1).*

*Proof.* We put  $\gamma := \min(\frac{\gamma_1^f}{2}, \frac{\gamma_2^f}{3}, \gamma_1^g, \gamma_2^g)$  and choose  $I_{X^i}, I_{P^i} \in \mathbb{H}^2(\mathbb{F}^{1,i}; \mathbb{R}^n)$ ,  $I_{x^j}, I_{r^j}, I_{y^j}, I_{p^j} \in \mathbb{H}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)$ , and  $\theta_{P^i} \in \mathbb{L}^2(\mathcal{F}_T^{1,i}; \mathbb{R}^n)$ ,  $\theta_{y^j}, \theta_{p^j} \in \mathbb{L}^2(\mathcal{F}_T^{2,j}; \mathbb{R}^n)$  arbitrarily. For  $\varrho \in [0, 1)$  and  $\zeta \in (0, 1)$ , we consider the map from  $\bar{u} := (\bar{X}^i, \bar{x}^j, \bar{y}^j, \bar{P}^i, \bar{p}^j, \bar{r}^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times (\mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n))^2 \times \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times (\mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n))^2$  to  $u := (X^i, x^j, y^j, P^i, p^j, r^j)$  in the same space defined by

$$\begin{aligned} dX_t^i = & [\varrho B_{X^i}(t, u_t) + \zeta B_{X^i}(t, \bar{u}_t) + I_{X^i}(t)] dt + \sigma_1^{i,0}(t) dW_t^0 + \sigma_1^i(t) dW_t^i, \\ dx_t^j = & [\varrho B_{x^j}(t, u_t) + \zeta B_{x^j}(t, \bar{u}_t) + I_{x^j}(t)] dt + \sigma_2^{j,0}(t) dW_t^0 + \sigma_2^j(t) dB_t^j, \\ dr_t^j = & [\varrho B_{r^j}(t, u_t) + \zeta B_{r^j}(t, \bar{u}_t) + I_{r^j}(t)] dt, \\ dP_t^i = & -[(1 - \varrho)\gamma X_t^i - \varrho F_{P^i}(t, u_t) + \zeta(-\gamma \bar{X}_t^i - F_{P^i}(t, \bar{u}_t)) + I_{P^i}(t)] dt + Q_t^{i,0} dW_t^0 + Q_t^{i,i} dW_t^i, \\ dy_t^j = & -[(1 - \varrho)\gamma x_t^j - \varrho F_{y^j}(t, u_t) + \zeta(-\gamma \bar{x}_t^j - F_{y^j}(t, \bar{u}_t)) + I_{y^j}(t)] dt + z_t^{j,0} dW_t^0 + z_t^{j,j} dB_t^j, \\ dp_t^j = & -[-(1 - \varrho)\gamma r_t^j - \varrho F_{p^j}(t, u_t) + \zeta(\gamma \bar{r}_t^j - F_{p^j}(t, \bar{u}_t)) + I_{p^j}(t)] dt + q_t^{j,0} dW_t^0 + q_t^{j,j} dB_t^j, \end{aligned} \tag{4.9}$$



with the boundary conditions  $X_0 = \xi^i, x_0 = \eta^j, r_0 = 0$  and  $P_T^i = \varrho G_{P^i}(u_T) + (1 - \varrho)X_T^i + \zeta(G_{P^i}(\bar{u}_T) - \bar{X}_T^i) + \theta_{P^i}, y_T^j = \varrho G_{y^j}(u_T) + (1 - \varrho)x_T^j + \zeta(G_{y^j}(\bar{u}_T) - \bar{x}_T^j) + \theta_{y^j}$  and  $p_T^j = \varrho G_{p^j}(u_T) - (1 - \varrho)r_T^j + \zeta(G_{p^j}(\bar{u}_T) + \bar{r}_T^j) + \theta_{p^j}$ . Using (4.9) (instead of (3.16)), Lemmas 4.2-4.3, Fubini's theorem, and the estimate on  $|\widehat{\beta}^i(t, u_t) - \widehat{\beta}^i(t, \hat{u}_t)|^2$  from Lemma 4.1, we can prove the claim in an almost (i.e. replacing the summations by appropriate expectations) the same way as in the case for Theorem 3.4.  $\square$

## 5 Convergence to the mean-field limit

Finally, in this section, we are going to prove that the finite-agent equilibrium given in Section 3 converges to the one in Section 4 when we take a large population limit  $N_1, N_2 \rightarrow \infty$  while keeping the ratio  $\delta_n = N_1/N_2$  unchanged. To handle the large population limit, we make the probability space  $(\bar{\Omega}, \bar{\mathcal{F}}, \bar{\mathbb{P}})$  big enough  $\bar{\Omega} := \prod_{i=1}^{\infty} \bar{\Omega}^{1,i} \times \prod_{j=1}^{\infty} \bar{\Omega}^{2,j}$  to support the relevant random variables. The other conventions are the same as in Section 2 and Subsection 4.1. Throughout this section, we work under Assumptions 3.2-3.3 with

$$\delta_n \leq \delta_* := \min(\delta_*^F, \delta_*^M).$$

so that Theorems 3.4 and 4.2 hold.

Obviously, the analysis for the mean-field model done in Section 4 is independent from the choice of the representative agents  $(i, j)$ . Thanks to the existence of unique strong solution  $(X^i, P^i, x^j, y^j, p^j, r^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n)^2 \times \mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n)^4$  to (4.7), Yamada-Watanebe Theorem for FBSDEs (see, [14, Theorem 1.33]) indicates that there exists some measurable functions  $\Phi_1, \Phi_2$  such that

$$(X^i, P^i) = \Phi_1(W^0, \xi^i, W^i), \quad (x^j, y^j, p^j, r^j) = \Phi_2(W^0, \eta^j, B^j)$$

hold, where  $\Phi_1, \Phi_2$  are independent from the choice of  $(i, j)$  by the symmetry of the model (see, Remarks 3.1 and 3.4). This result implies that  $(X^i, P^i, \xi^i, c^i, W^i)_{i=1}^{N_1}$  as well as  $(x^j, y^j, p^j, r^j, \eta^j, c^j, B^j)_{j=1}^{N_2}$  are  $\mathcal{F}^0$ -conditionally i.i.d. within each group, and also that the two groups are mutually  $\mathcal{F}^0$ -conditionally independent. Moreover, Lemma 4.1 tells that  $\widehat{\beta}^i$  is independent from  $x^j$  and depends on  $(y^j, p^j, r^j)$  only through their  $\mathcal{F}^0$ -conditional expectations  $\mathbb{E}^0[\cdot]$ . Hence,  $(X^i, P^i, \widehat{\beta}^i, \xi^i, c^i, W^i)_{i=1}^{N_1}$  are also  $\mathcal{F}^0$ -conditionally i.i.d. As a result, an  $\mathbb{F}^0$ -adapted process  $\pi_t(y_t^j, \widehat{\beta}_t^i) = -\mathbb{E}^0[y_t^j] + \delta_n \Lambda_t \mathbb{E}^0[\widehat{\beta}_t^i], t \in [0, T]$  is independent from the choice of  $(i, j)$ , which is as expected if  $\pi$  is the market price process in the large population limit. This also implies that  $(X^i, P^i)$  are independent from the choice of  $j$  in  $(x^j, y^j, p^j, r^j)$  and vice versa since the two groups interact only through the price process  $\pi$ . Recall that, under the finite-agent setup in Section 3, we only have the ( $\mathcal{F}^0$ -conditional) exchangeability.

In the remainder of this section, for each  $(i, j)$  with  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ , let us denote by  $u := (X^i, x^j, y^j, P^i, p^j, r^j) \in \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times (\mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n))^2 \times \mathbb{S}^2(\mathbb{F}^{1,i}; \mathbb{R}^n) \times (\mathbb{S}^2(\mathbb{F}^{2,j}; \mathbb{R}^n))^2$  the solution to (4.7), and  $\widehat{\beta}^i := (\widehat{\beta}^i(t, u_t))_{t \in [0, T]} \in \mathbb{A}_1^i$  the minimizer of the lifted Hamiltonian  $\mathcal{H}(t, u_t, \cdot)$  in (4.4). On the other hand, we use the symbols with the superscript  $\mathbf{n} := (N_1, N_2)$  when we describe the variables in the finite-agent market, such as  $u^n := (X^n, x^n, y^n, P^n, p^n, r^n) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{2N_1+4N_2}$  and  $\widehat{\beta}^n \in \mathbb{A}_1^{N_1}$  with  $X^n := (X^{n,i})_{i=1}^{N_1}, x^n := (x^{n,j})_{j=1}^{N_2}, y^n := (y^{n,j})_{j=1}^{N_2}, P^n := (P^{n,i})_{i=1}^{N_1}, p^n := (p^{n,j})_{j=1}^{N_2}, r^n := (r^{n,j})_{j=1}^{N_2}$ , and  $\widehat{\beta}^n := (\widehat{\beta}^{n,i})_{i=1}^{N_1}$ . In particular, we denote by  $u^n$  the solution to the system of FBSDEs (3.13) and  $\widehat{\beta}_t^n$  the minimizer of Hamiltonian  $H(t, u_t^n, \cdot)$  in (3.9). Note that, as long as  $\delta_n = N_1/N_2 \leq \delta_*$  is kept constant, there exists some positive constant  $C$  independent of the population sizes  $(N_1, N_2)$  such that the inequality

$$\begin{aligned} \sup_{t \in [0, T]} \mathbb{E}[|X_t^{n,i}|^2 + |x_t^{n,j}|^2 + |y_t^{n,j}|^2 + |P_t^{n,i}|^2 + |p_t^{n,j}|^2 + |r_t^{n,j}|^2 + |\widehat{\beta}_t^{n,i}|^2 \\ + |X_t^i|^2 + |x_t^j|^2 + |y_t^j|^2 + |P_t^i|^2 + |p_t^j|^2 + |r_t^j|^2 + |\widehat{\beta}_t^i|^2] \leq C \end{aligned} \quad (5.1)$$

holds for every  $i$  and  $j$ . Here, the estimate for the first line is obtained from the standard result on the  $\mathbb{L}^2$ -moment of the FBSDE solutions normalized by each population size using the exchangeability,

and Lemma 3.1. The one for the second line is obvious from the  $\mathcal{F}^0$ -conditional i.i.d. property and Lemma 4.1.

What we are going to do is the comparison of the two cost functionals:

$$J_1^i(\widehat{\beta}^n) = \mathbb{E} \left[ \int_0^T f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t(y_t^n, \widehat{\beta}^n), \widehat{\beta}_t^{n,i}) dt + g_1^i(X_T^{n,i}, \nu_T^{N_1}) \right]$$

and

$$\mathcal{J}_1^i(\widehat{\beta}^i) = \mathbb{E} \left[ \int_0^T f_1^i(t, X_t^i, \mu_t, \pi_t(y_t^j, \widehat{\beta}_t^j), \widehat{\beta}_t^i) dt + g_1^i(X_T^i, \mu_T) \right],$$

where  $\nu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X_t^{n,i}}$  and  $\mu_t := \mathcal{L}^0(X_t^i) = \mathcal{L}^0(X_t^1)$ . Note that both  $J_1^i(\widehat{\beta}^n)$  and  $\mathcal{J}_1^i(\widehat{\beta}^i)$  are independent from the choice of  $i$  due to the exchangeability. Let us first provide two lemmas concerning the  $\mathcal{F}^0$ -conditional i.i.d. property of the mean-field solutions.

**Lemma 5.1.** *Let Assumptions 3.2-3.3 be in force and the ratio  $\delta_n \leq \delta_*$  be kept fixed. Set  $\mu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{\psi_t^i}$ ,  $\mu_t := \mathcal{L}^0(\psi_t^1)$ ,  $\nu_t^{N_2} := \frac{1}{N_2} \sum_{j=1}^{N_2} \delta_{\varphi_t^j}$  and  $\nu_t := \mathcal{L}^0(\varphi_t^1)$ , where  $\psi_t^i$  stands for either  $X_t^i$  or  $P_t^i$ , and  $\varphi_t^j$  for either  $x_t^j, y_t^j, p_t^j$ , or  $r_t^j$ . Then there exist some sequence  $(\epsilon_N)_{N \geq 1}$  converging to zero as  $N \rightarrow \infty$  such that*

$$\sup_{t \in [0, T]} \mathbb{E} [W_2(\mu_t^{N_1}, \mu_t)^2] \leq \epsilon_{N_1}, \quad \sup_{t \in [0, T]} \mathbb{E} [W_2(\nu_t^{N_2}, \nu_t)^2] \leq \epsilon_{N_2}.$$

Moreover, there exists some positive constant  $C$  independent of the population sizes that satisfies

$$\sup_{t \in [0, T]} \mathbb{E} [|\mathbf{m}_1(\psi_t) - \mathbb{E}^0[\psi_t^1]|^2] \leq CN_1^{-1}, \quad \sup_{t \in [0, T]} \mathbb{E} [|\mathbf{m}_2(\varphi_t) - \mathbb{E}^0[\varphi_t^1]|^2] \leq CN_2^{-1}.$$

In the latter claim,  $\psi_t^i$  can also stand for  $\widehat{\beta}_t^i$  and  $\partial_\varpi f_1^i(t, X_t^i, \mathcal{L}^0(X_t^1), \pi_t(y_t^1, \widehat{\beta}_t^1), \widehat{\beta}_t^i)$  in addition to  $(X^i, P^i)$ .

*Proof.* The first claim follows from Lemma [28, Lemma 4.1]. Let us prove the second claim. Since  $(\psi^i)_{i \geq 1}$  are  $\mathcal{F}^0$ -conditionally i.i.d., the ladder property of the conditional expectation yields

$$\mathbb{E} [|\mathbf{m}_1(\psi_t) - \mathbb{E}^0[\psi_t^1]|^2] = \mathbb{E} \left[ \left| \frac{1}{N_1} \sum_{i=1}^{N_1} (\psi_t^i - \mathbb{E}^0[\psi_t^1]) \right|^2 \right] = \frac{1}{N_1^2} \sum_{i=1}^{N_1} \mathbb{E} [|\psi_t^i - \mathbb{E}^0[\psi_t^1]|^2].$$

Since  $\sup_{t \in [0, T]} \mathbb{E} [|\psi_t^1 - \mathbb{E}^0[\psi_t^1]|^2] \leq 2 \sup_{t \in [0, T]} \mathbb{E} [|\psi_t^1|^2] \leq C$ , the conclusion follows. Note also that  $\widehat{\beta}_t^i, \partial_\varpi f_1^i(t, X_t^i, \mathcal{L}^0(X_t^1), \pi_t(y_t^1, \widehat{\beta}_t^1), \widehat{\beta}_t^i), i \geq 1$  are also  $\mathcal{F}^0$ -conditionally i.i.d. Hence, from the growth property in Lemma 4.1, the same estimate holds. The proof for  $\varphi$  is the same.  $\square$

**Remark 5.1.** *When certain stronger integrability conditions are satisfied, the dependence of  $\epsilon_N$  on the population size  $N$  is known to be available in a more explicit form. For details, see [13, Theorem 5.8].*

**Lemma 5.2.** *Let Assumptions 3.2-3.3 be in force and the ratio  $\delta_n \leq \delta_*$  be kept fixed. Let us set  $\mu_t := \mathcal{L}^0(X_t^1)$ ,  $\widehat{\beta}_t^i := \widehat{\beta}^i(t, u_t)$  and  $\pi_t := \pi_t(y_t^1, \widehat{\beta}_t^1), t \in [0, T]$ . Then, there exists some positive constant  $C$  independent of the population sizes that satisfies*

$$\begin{aligned} \sup_{t \in [0, T]} \mathbb{E} \left[ \left| \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu f_1^k(t, X_t^k, \mu_t, \pi_t, \widehat{\beta}_t^k)(X_t^i) - \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mu_t, \pi_t, \widetilde{\beta}_t^i)(X_t^i)] \right|^2 \right] &\leq CN_1^{-1}, \\ \mathbb{E} \left[ \left| \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu g_1^k(X_T^k, \mu_T)(X_T^i) - \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{g}_1^i(\widetilde{X}_T^i, \mu_T)(X_T^i)] \right|^2 \right] &\leq CN_1^{-1}. \end{aligned}$$

*Proof.* Let us first prove the second one. Recall that the notations  $\tilde{g}_1^i(\cdot) := g_1(\cdot, c_T^0, \tilde{c}_T^i)$  and also that  $\tilde{X}^i$  and  $\tilde{c}^i$  are the copies of  $X^i$  and  $c^i$  defined on the space  $\Omega^0 \times \tilde{\Omega}$  (see, Section 4.1.). Since  $(\tilde{X}^i, \tilde{c}^i)_{i \geq 1}, (X^i, c^i)_{i \geq 1}$  are  $\mathcal{F}^0$ -conditionally i.i.d., we have

$$\mathbb{E}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mu_T)(X_T^i)] = \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(v)]|_{v=X_T^i} = \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(X_T^i)|\sigma(X_T^i)]$$

for any  $j \neq i$ . Therefore,

$$\begin{aligned} & \mathbb{E}\left[\left|N_1^{-1} \sum_{k=1}^{N_1} \partial_\mu g_1^k(X_T^k, \mu_T)(X_T^i) - \tilde{\mathbb{E}}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mu_T)(X_T^i)]\right|^2\right] \\ &= \mathbb{E}\left[\left|N_1^{-1} \sum_{k=1}^{N_1} \left(\partial_\mu g_1^k(X_T^k, \mu_T)(X_T^i) - \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(X_T^i)|\sigma(X_T^i)]\right)\right|^2\right] \\ &\leq 2\mathbb{E}\left[\left|N_1^{-1} \sum_{k \neq i}^{N_1} \left(\partial_\mu g_1^k(X_T^k, \mu_T)(X_T^i) - \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(X_T^i)|\sigma(X_T^i)]\right)\right|^2\right] \\ &\quad + 2N_1^{-2} \mathbb{E}\left[\left|\partial_\mu g_1^i(X_T^i, \mu_T)(X_T^i) - \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(X_T^i)|\sigma(X_T^i)]\right|^2\right]. \end{aligned}$$

Obviously,  $(X^k, c^k)_{k \neq i}$  are  $\mathcal{F}^0 \vee \sigma(X^i)$ -conditionally i.i.d., which makes the cross terms in the first line vanish. Hence the right hand side of the above inequality is bounded by

$$2N_1^{-2} \sum_{k=1}^{N_1} \mathbb{E}\left[\left|\partial_\mu g_1^k(X_T^k, \mu_T)(X_T^i) - \mathbb{E}^0[\partial_\mu g_1^j(X_T^j, \mu_T)(X_T^i)|\sigma(X_T^i)]\right|^2\right] \leq CN_1^{-1},$$

where we have used the linear growth property  $\partial_\mu g_1^i$ . The first inequality can be proved in the same way from the  $\mathcal{F}^0$ -conditional i.i.d. property of  $(X^i, \hat{\beta}^i, c^i)_{i=1}^{N_1}$  and the growth property of  $\hat{\beta}^i(t, \cdot)$  in Lemma 4.1.  $\square$

Let us define the variable  $\varepsilon_{N_1}$  by

$$\varepsilon_{N_1} := \max\left(N_1^{-\frac{1}{2}}, \sup_{t \in [0, T]} \mathbb{E}[W_2(\mu_t^{N_1}, \mu_t)^2]^{\frac{1}{2}}\right) \quad (5.2)$$

with  $\mu_t := \mathcal{L}^0(X_t^1)$  and  $\mu_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X_t^i}$ . The following result is an extension of [12, Theorem 6.1] to our  $\mathcal{F}^0$ -conditional extended mean-field type control problem.

**Proposition 5.1.** *Let Assumptions 3.2-3.3 be in force and the ratio  $\delta_n \leq \delta_*$  be kept fixed. Then there exists some positive constant  $C$  independent of the population sizes that satisfies, for any  $1 \leq i \leq N_1$ ,*

$$\begin{aligned} J_1^i(\hat{\beta}^n) - J_1^i(\hat{\beta}^i) &\geq \mathbb{E} \int_0^T \left[ \frac{\gamma_1^f}{2} |X_t^{n,i} - X_t^i|^2 + \frac{\lambda_\beta}{2} |\hat{\beta}_t^{n,i} - \hat{\beta}_t^i|^2 + \frac{\lambda_\varpi}{2} |\varpi_t(y_t^n, \hat{\beta}_t^n) - \pi_t(y_t^i, \hat{\beta}_t^i)|^2 \right] dt \\ &\quad + \frac{\gamma_1^g}{2} \mathbb{E}[|X_T^{n,i} - X_T^i|^2] - C\varepsilon_{N_1}. \end{aligned}$$

*Proof.* We have  $J_1^i(\hat{\beta}^n) - J_1^i(\hat{\beta}^i) = V_1^i + V_2^i$  with

$$\begin{aligned} V_1^i &:= \mathbb{E}\left[\langle X_T^{n,i} - X_T^i, P_T^i \rangle + \int_0^T [f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t(y_t^n, \hat{\beta}_t^n), \hat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t, \pi_t(y_t^i, \hat{\beta}_t^i), \hat{\beta}_t^i)] dt\right], \\ V_2^i &:= \mathbb{E}\left[g_1^i(X_T^{n,i}, \nu_T^{N_1}) - g_1^i(X_T^i, \mu_T) - \langle X_T^{n,i} - X_T^i, \partial_x g_1^i(X_T^i, \mu_T) \rangle + \tilde{\mathbb{E}}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mu_T)(X_T^i)]\right]. \end{aligned}$$

By exchangeability, the values of  $V_1^i$  and  $V_2^i$  are independent from the choice of  $i$ . For notional ease, let us put  $\Delta X_t^i := X_t^{n,i} - X_t^i$ ,  $\Delta \hat{\beta}_t^i := \hat{\beta}_t^{n,i} - \hat{\beta}_t^i$ ,  $\varpi_t := \varpi_t(y_t^n, \hat{\beta}_t^n)$ ,  $\pi_t := \pi_t(y_t^i, \hat{\beta}_t^i) = \pi_t(y_t^i, \hat{\beta}_t^i)$  and  $\Delta \varpi_t := \varpi_t - \pi_t$ , etc.

**First step: Estimate on  $V_2^i$**

Let us separate the terms in  $V_2^i$  as follows:  $V_2^i = V_{2,1}^i - V_{2,2}^i - V_{2,3}^i$  where

$$\begin{aligned} V_{2,1}^i &:= \mathbb{E}[g_1^i(X_T^{n,i}, \nu_T^{N_1}) - g_1^i(X_T^i, \mu_T)], \\ V_{2,2}^i &:= \mathbb{E}[\langle \Delta X_T^i, \partial_x g_1^i(X_T^i, \mu_T) \rangle], \quad V_{2,3}^i := \mathbb{E}[\langle \Delta X_T^i, \tilde{\mathbb{E}}^0[\partial_\mu \tilde{g}_1^i(\tilde{X}_T^i, \mu_T)(X_T^i)] \rangle]. \end{aligned}$$

By local Lipschitz continuity in Assumption 3.3 (ii), (5.1) and Cauchy-Schwarz inequality, we have

$$\begin{aligned} V_{2,1}^i &\geq \mathbb{E}[g_1^i(X_T^{n,i}, \nu_T^{N_1}) - g_1^i(X_T^i, \mu_T^{N_1})] - C\mathbb{E}[(1 + |X_T^i| + M_2(\mu_T) + M_2(\mu_T^{N_1}) + |c_T^0| + |c_T^i|)W_2(\mu_T, \mu_T^{N_1})] \\ &\geq \mathbb{E}[g_1^i(X_T^{n,i}, \nu_T^{N_1}) - g_1^i(X_T^i, \mu_T^{N_1})] - C\varepsilon_{N_1}. \end{aligned}$$

From Assumption 3.3 (iii), similar calculations give

$$V_{2,2}^i \leq \mathbb{E}[\langle \Delta X_T^i, \partial_x g_1^i(X_T^i, \mu_T^{N_1}) \rangle] + C\varepsilon_{N_1}.$$

Using Lemma 5.2 and Assumption 3.3 (iii), we get

$$V_{2,3}^i \leq \mathbb{E}[\langle \Delta X_T^i, \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu g_1^k(X_T^k, \mu_T^{N_1})(X_T^i) \rangle] + C\varepsilon_{N_1}.$$

Note that the value of  $V_{2,3}^i$  is independent from  $i$ . From the same technique used in (3.12), we have

$$\begin{aligned} V_{2,3}^i &= \frac{1}{N_1} \sum_{i=1}^{N_1} V_{2,3}^i \leq \frac{1}{N_1^2} \sum_{i,k=1}^{N_1} \mathbb{E}[\langle \Delta X_T^i, \partial_\mu g_1^k(X_T^k, \mu_T^{N_1})(X_T^i) \rangle] + C\varepsilon_{N_1} \\ &= \frac{1}{N_1} \sum_{k=1}^{N_1} \mathbb{E}\mathbb{E}^\theta[\langle \Delta X_T^\theta, \partial_\mu g_1^k(X_T^k, \mu_T^{N_1})(X_T^\theta) \rangle] + C\varepsilon_{N_1} = \mathbb{E}\mathbb{E}^\theta[\langle \Delta X_T^\theta, \partial_\mu g_1^i(X_T^i, \mu_T^{N_1})(X_T^\theta) \rangle] + C\varepsilon_{N_1}. \end{aligned}$$

Combined the above estimates, we obtain, from Assumption 3.3 (v),

$$\begin{aligned} V_2^i &\geq \mathbb{E}[g_1^i(X_T^{n,i}, \nu_T^{N_1}) - g_1^i(X_T^i, \mu_T^{N_1}) \\ &\quad - \langle \Delta X_T^i, \partial_x g_1^i(X_T^i, \mu_T^{N_1}) \rangle - \mathbb{E}^\theta[\langle \Delta X_T^\theta, \partial_\mu g_1^i(X_T^i, \mu_T^{N_1})(X_T^\theta) \rangle]] - C\varepsilon_{N_1} \\ &\geq \frac{\gamma_1^g}{2} \mathbb{E}[|\Delta X_T^i|^2] - C\varepsilon_{N_1}. \end{aligned} \tag{5.3}$$

**Second step: Estimate on  $V_1^i$**

Since  $\langle \Delta x_T^j, p_T^j \rangle + \langle \Delta y_T^j, r_T^j \rangle = 0$  for any  $j$ , we have

$$\begin{aligned} V_1^i &= \mathbb{E}[\langle \Delta X_T^i, P_T^i \rangle + \bar{\delta}_n(\langle \Delta x_T^j, p_T^j \rangle + \langle \Delta y_T^j, r_T^j \rangle) + \int_0^T [f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \hat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t, \pi_t, \hat{\beta}_t^i)] dt] \\ &\geq \mathbb{E}[\langle \Delta X_T^i, P_T^i \rangle + \bar{\delta}_n(\langle \Delta x_T^j, p_T^j \rangle + \langle \Delta y_T^j, r_T^j \rangle) \\ &\quad + \int_0^T [f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \hat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t, \pi_t, \hat{\beta}_t^i) - \langle \Delta \hat{\beta}_t^i, D_{\beta^i} \mathcal{H}(t, u_t, \hat{\beta}_t^i) \rangle] dt]. \end{aligned}$$

Here, in the second line, we have set  $u_t := (X_t^i, x_t^j, y_t^j, P_t^i, p_t^j, r_t^j)$  and used the optimality condition on  $\hat{\beta}_t^i = \hat{\beta}^i(t, u_t)$  for  $\mathcal{H}(t, u_t, \cdot)$ . Direct calculation of the right hand side using the expression of  $D_{\beta^i} \mathcal{H}(\cdot)$

in (4.5) shows that  $V_1^i \geq V_{1,1}^i + V_{1,2}^i$  with

$$\begin{aligned}
V_{1,1}^i &:= \mathbb{E} \int_0^T \left[ f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \widehat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) - \langle \Delta \widehat{\beta}_t^i, \partial_\beta f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) \rangle \right. \\
&\quad - \langle \Delta X_t^i, \partial_x f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) \rangle + \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mu_t, \pi_t, \widetilde{\beta}_t^i)(X_t^i)] \\
&\quad \left. - \langle \mathbb{E}^0[\partial_\varpi f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i)], -\Delta y_t^j + \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle \right] dt, \\
V_{1,2}^i &:= \mathbb{E} \int_0^T \left[ \langle \rho_1(t) P_t^i, \Delta \varpi_t \rangle + \langle \rho_1(t) \mathbb{E}^0[P_t^i], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle \right. \\
&\quad + \overline{\delta}_n (\langle (-\overline{\Lambda}_t + \rho_2(t)) p_t^j, \Delta \varpi_t \rangle + \langle (-\overline{\Lambda}_t + \rho_2(t)) \mathbb{E}^0[p_t^j], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle) \\
&\quad \left. + \overline{\delta}_n (\langle b_t r_t^j, \Delta \varpi_t \rangle + \langle b_t \mathbb{E}^0[r_t^j], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle) \right] dt.
\end{aligned}$$

- Analysis for  $V_{1,2}^i$

For the first line, from the exchangeability of  $(P^i)$ ,  $(\Delta y^j)$  and  $(\Delta \widehat{\beta}^i)$ , we have

$$\begin{aligned}
&\mathbb{E}[\langle \rho_1(t) P_t^i, \Delta \varpi_t \rangle + \langle \rho_1(t) \mathbb{E}^0[P_t^i], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] \\
&= \mathbb{E}[\langle \rho_1(t) (P_t^i - \mathbb{E}^0[P_t^i]), \Delta \varpi_t \rangle + \langle \rho_1(t) \mathbb{E}^0[P_t^i], \varpi_t + \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] \\
&= \mathbb{E}[\langle \rho_1(t) (\mathbf{m}_1(P_t) - \mathbb{E}^0[P_t^1]), \Delta \varpi_t \rangle + \langle \rho_1(t) \mathbb{E}^0[P_t^1], \Delta \varpi_t + \mathbf{m}_2(\Delta y_t) - \delta_n \Lambda_t \mathbf{m}_1(\Delta \widehat{\beta}_t) \rangle].
\end{aligned}$$

Here, the second term is zero since

$$\begin{aligned}
&\mathbb{E}^0[\Delta \varpi_t + \mathbf{m}_2(\Delta y_t) - \delta_n \Lambda_t \mathbf{m}_1(\Delta \widehat{\beta}_t)] \\
&= \mathbb{E}^0[-\mathbf{m}_2(y_t^n) + \mathbb{E}^0[y_t^1] + \delta_n \Lambda_t (\mathbf{m}_1(\widehat{\beta}_t^n) - \mathbb{E}^0[\widehat{\beta}_t^1]) + \mathbf{m}_2(\Delta y_t) - \delta_n \Lambda_t \mathbf{m}_1(\Delta \widehat{\beta}_t)] = 0.
\end{aligned} \tag{5.4}$$

Applying Lemma 5.1 and Cauchy-Schwarz inequality to the first term, we obtain,

$$\mathbb{E}[\langle \rho_1(t) P_t^i, \Delta \varpi_t \rangle + \langle \rho_1(t) \mathbb{E}^0[P_t^i], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] \geq -C/\sqrt{N_1} \geq -C\varepsilon_{N_1}.$$

By the same technique and (5.4), the second and third lines can be estimated as

$$\begin{aligned}
&\mathbb{E}[\langle (-\overline{\Lambda}_t + \rho_2(t)) p_t^j, \Delta \varpi_t \rangle + \langle (-\overline{\Lambda}_t + \rho_2(t)) \mathbb{E}^0[p_t^j], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] \\
&\quad + \mathbb{E}[\langle b_t r_t^j, \Delta \varpi_t \rangle + \langle b_t \mathbb{E}^0[r_t^j], \Delta y_t^j - \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] \\
&= \mathbb{E}[\langle (-\overline{\Lambda}_t + \rho_2(t)) (\mathbf{m}_2(p_t) - \mathbb{E}^0[p_t^j]), \Delta \varpi_t \rangle + \langle (-\overline{\Lambda}_t + \rho_2(t)) \mathbb{E}^0[p_t^j], \Delta \varpi_t + \mathbf{m}_2(\Delta y_t) - \delta_n \Lambda_t \mathbf{m}_1(\Delta \widehat{\beta}_t) \rangle] \\
&\quad + \mathbb{E}[\langle b_t (\mathbf{m}_2(r_t) - \mathbb{E}^0[r_t^j]), \Delta \varpi_t \rangle + \langle b_t \mathbb{E}^0[r_t^j], \Delta \varpi_t + \mathbf{m}_2(\Delta y_t) - \delta_n \Lambda_t \mathbf{m}_1(\Delta \widehat{\beta}_t) \rangle] \\
&\geq -C/\sqrt{N_2} \geq -C\varepsilon_{N_1}.
\end{aligned}$$

Since every estimate is uniform in  $t \in [0, T]$  by (5.1), we get

$$V_{1,2}^i \geq -C\varepsilon_{N_1}. \tag{5.5}$$

- Analysis for  $V_{1,1}^i$

From (5.1) and the (local) Lipschitz continuity, it is easy to see, for the first line,

$$\begin{aligned}
&\mathbb{E}[f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \widehat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) - \langle \Delta \widehat{\beta}_t^i, \partial_\beta f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) \rangle] \\
&\geq \mathbb{E}[f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \widehat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) - \langle \Delta \widehat{\beta}_t^i, \partial_\beta f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) \rangle] - C\varepsilon_{N_1}.
\end{aligned}$$

Using Lemma 5.2, exchangeability and the technique in (3.12), we have

$$\begin{aligned}
&\mathbb{E}[\langle \Delta X_t^i, \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mu_t, \pi_t, \widetilde{\beta}_t^i)(X_t^i)] \rangle] \leq \frac{1}{N_1} \sum_{i=1}^{N_1} \mathbb{E} \left[ \langle \Delta X_t^i, \frac{1}{N_1} \sum_{k=1}^{N_1} \partial_\mu f_1^k(t, X_t^k, \mu_t, \pi_t, \widehat{\beta}_t^k)(X_t^i) \rangle \right] + C/\sqrt{N_1} \\
&= \mathbb{E}^\theta [\langle \Delta X_t^\theta, \partial_\mu f_1^i(X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i)(X_t^\theta) \rangle] + C/\sqrt{N_1}.
\end{aligned}$$

Thus, from the Lipschitz continuity of  $(\partial_x f_1, \partial_\mu f_1)$ , we see that the second line of  $V_{1,1}^i$  satisfies

$$\begin{aligned} & \mathbb{E}[\langle \Delta X_t^i, \partial_x f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i) + \widetilde{\mathbb{E}}^0[\partial_\mu \widetilde{f}_1^i(t, \widetilde{X}_t^i, \mu_t, \pi_t, \widetilde{\beta}_t^i)(X_t^i)] \rangle] \\ & \leq \mathbb{E}[\langle \Delta X_t^i, \partial_x f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) \rangle] + \mathbb{E}^\theta[\langle \Delta X_t^\theta, \partial_\mu f_1^i(X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i)(X_t^\theta) \rangle] + C\varepsilon_{N_1}. \end{aligned}$$

Lastly, the third line of  $V_{1,1}^i$  can be estimated as

$$\begin{aligned} & \mathbb{E}[\langle \mathbb{E}^0[\partial_\varpi f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i)], -\Delta y_t^j + \delta_n \Lambda_t \Delta \widehat{\beta}_t^i \rangle] = \mathbb{E}[\langle \mathbb{E}^0[\partial_\varpi f_1^i(t, X_t^i, \mu_t, \pi_t, \widehat{\beta}_t^i)], \Delta \varpi_t \rangle] \\ & \leq \frac{1}{N_1} \sum_{k=1}^{N_1} \mathbb{E}[\langle \partial_\varpi f_1^k(t, X_t^k, \mu_t, \pi_t, \widehat{\beta}_t^k), \Delta \varpi_t \rangle] + C/\sqrt{N_1} \\ & \leq \mathbb{E}[\langle \partial_\varpi f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i), \Delta \varpi_t \rangle] + C\varepsilon_{N_1}. \end{aligned}$$

Here, we have used (5.4) in the first equality, Lemma 5.1 in the second line, and finally the Lipschitz continuity of  $\partial_\varpi f_1$  in the last line. Combined with (5.5), the joint convexity of  $f_1$  in Assumption 3.3 (iv) gives

$$\begin{aligned} V_1^i & \geq \mathbb{E} \int_0^T \left[ f_1^i(t, X_t^{n,i}, \nu_t^{N_1}, \varpi_t, \widehat{\beta}_t^{n,i}) - f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) - \langle \Delta \widehat{\beta}_t^i, \partial_\beta f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) \rangle \right. \\ & \quad - \langle \Delta X_t^i, \partial_x f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) \rangle - \mathbb{E}^\theta[\langle \Delta X_t^\theta, \partial_\mu f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i)(X_t^\theta) \rangle] \\ & \quad \left. - \langle \Delta \varpi_t, \partial_\varpi f_1^i(t, X_t^i, \mu_t^{N_1}, \pi_t, \widehat{\beta}_t^i) \rangle \right] dt - C\varepsilon_{N_1} \\ & \geq \mathbb{E} \int_0^T \left[ \frac{\gamma_1^f}{2} |\Delta X_t^i|^2 + \frac{\lambda_\varpi}{2} |\Delta \widehat{\beta}_t^i|^2 + \frac{\lambda_\varpi}{2} |\Delta \varpi_t|^2 \right] dt - C\varepsilon_{N_1}. \end{aligned} \tag{5.6}$$

The conclusion follows from (5.3) and (5.6).  $\square$

We now consider the state process of the finite-agent market  $\underline{y}^n := (\underline{X}^n, \underline{x}^n, \underline{y}^n) \in \mathbb{S}^2(\mathbb{F}; \mathbb{R}^n)^{N_1} \times (\mathbb{S}^2(\mathbb{F}; \mathbb{R}^n))^{2N_2}$  with  $\underline{X}^n := (\underline{X}^{n,i})_{i=1}^{N_1}$ ,  $\underline{x}^n := (\underline{x}^{n,j})_{j=1}^{N_2}$ , and  $\underline{y}^n := (\underline{y}^{n,j})_{j=1}^{N_2}$  defined as the unique solution to the system of FBSDEs:  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ ,

$$\begin{aligned} d\underline{X}_t^{n,i} & = (\widehat{\beta}_t^i + \rho_1(t) \varpi_t(\underline{y}^n, \widehat{\beta}_t) + l_1^i(t)) dt + \sigma_1^{i,0}(t) dW_t^0 + \sigma_1^i(t) dW_t^i, \\ d\underline{x}_t^{n,j} & = (-\overline{\Lambda}_t(\underline{y}_t^{n,j} + \varpi_t(\underline{y}_t^n, \widehat{\beta}_t)) + \rho_2(t) \varpi_t(\underline{y}_t^n, \widehat{\beta}_t) + l_2^j(t)) dt + \sigma_2^{j,0}(t) dW_t^0 + \sigma_2^j(t) dB_t^j, \\ d\underline{y}_t^{n,j} & = -(\partial_x \overline{f}_2^j(t, \underline{x}_t^{n,j}) - b_t \varpi_t(\underline{y}_t^n, \widehat{\beta}_t)) dt + \underline{z}_t^{n,j,0} dW_t^0 + \sum_{k=1}^{N_1} \underline{z}_t^{n,j,k} dW_t^k + \sum_{k=1}^{N_2} \underline{z}_t^{n,j,k} dB_t^k, \end{aligned} \tag{5.7}$$

with the boundary conditions;  $\underline{X}_0^{n,i} = \xi^i, \underline{x}_0^{n,j} = \eta^j$  and  $\underline{y}_T^{n,j} = \partial_x g_2^j(\underline{x}_T^{n,j})$ . As in (3.4), we have  $\varpi_t(\underline{y}_t^n, \widehat{\beta}_t) = -\mathbf{m}_2(\underline{y}^n) + \delta_n \Lambda_t \mathbf{m}_1(\widehat{\beta}_t)$ . Recall that  $\widehat{\beta}^i$  denotes the optimal solution to the mean-field setup for the representative agents  $i$  in the first population and (arbitrary)  $j$  in the second population, which is specified by the solution of (4.7). In other words, the system of equations (5.7) describes the situation where each agent  $i$  in the first population behaves as if she is a representative agent and adopts  $\widehat{\beta}^i \in \mathbb{A}_1^i = \mathbb{H}^2(\mathbb{F}^{1,i}; A_1)$  as an approximation for the true optimal control  $\widehat{\beta}^{n,i} \in \mathbb{A}_1 := \mathbb{H}^2(\mathbb{F}; A_1)$ . Moreover,  $(\underline{x}^n, \underline{y}^n)$  describes the market clearing state process of the second population under the given order flow  $\widehat{\beta} := (\widehat{\beta}^i)_{i=1}^{N_1}$ . The unique existence of such a process  $(\underline{x}^n, \underline{y}^n)$  is guaranteed by Theorem 3.2 as discussed in Subsection 3.1.3. Note that the  $\mathcal{F}^0$ -conditional exchangeability among  $(\underline{X}^{n,i}, \widehat{\beta}^i, \xi^i, c^i, W^i)_{i=1}^{N_1}$  and  $(\underline{x}^{n,j}, \underline{y}^{n,j}, \eta^j, c^j, B^j)_{j=1}^{N_2}$  holds in this case, too. The cost functional for the member  $i$  in the first population under this setup is given by

$$J_1^i(\widehat{\beta}) = \mathbb{E} \left[ \int_0^T f_1^i(t, \underline{X}_t^{n,i}, \underline{\nu}_t^{N_1}, \varpi_t(\underline{y}_t^n, \widehat{\beta}_t), \widehat{\beta}_t^i) dt + g_1^i(\underline{X}_T^{n,i}, \underline{\nu}_T^{N_1}) \right],$$

where  $\underline{\nu}_t^{N_1} := \frac{1}{N_1} \sum_{i=1}^{N_1} \delta_{X_t^{n,i}}$ .

The following proof is inspired by the method used in [28, Theorem 4.2].



**Proposition 5.2.** *Let Assumptions 3.2-3.3 be in force and the ratio  $\delta_n \leq \delta_*$  be kept fixed. Then there exists some positive constant  $C$  independent of the population sizes that satisfies, for any  $1 \leq i \leq N_1$ ,*

$$|J_1^i(\widehat{\beta}) - \mathcal{J}_1^i(\widehat{\beta}^i)| \leq C\varepsilon_{N_1},$$

where  $\varepsilon_{N_1}$  is defined by (5.2).

*Proof.* Let us denote by  $\underline{u}^n := (\underline{X}^n, \underline{x}^n, \underline{y}^n)$  and  $u := (X^i, x^j, y^j)$  the unique solution to (5.7) and (4.7), respectively. For given processes  $\underline{u}^n, u$  and  $\widehat{\beta}$ , we just put

$$\begin{aligned} B_{\underline{X}^i}(t, \underline{u}_t^n) &:= \widehat{\beta}_t^i + \rho_1(t)\varpi_t(\underline{y}_t^n, \widehat{\beta}_t) + l_1^i(t), \\ B_{\underline{x}^j}(t, \underline{u}_t^n) &:= -\overline{\Lambda}_t(\underline{y}_t^{n,j} + \varpi_t(\underline{y}_t^n, \widehat{\beta}_t)) + \rho_2(t)\varpi_t(\underline{y}_t^n, \widehat{\beta}_t) + l_2^j(t), \\ F_{\underline{y}^j}(t, \underline{u}_t^n) &:= -\partial_x \overline{F}_2^j(t, \underline{x}_t^{n,j}) + b_t \varpi_t(\underline{y}_t^n, \widehat{\beta}_t), \quad G_{\underline{y}^j}(\underline{u}_T^n) := \partial_x g_2^j(\underline{x}_T^{n,j}), \end{aligned}$$

and also  $(B_{X^i}(t, u_t), B_{x^j}(t, u_t), F_{y^j}(t, u_t), G_{y^j}(u_T))$  as in (4.8). For notational ease, we shall use  $\Delta X_t^i := \underline{X}_t^{n,i} - X_t^i$ ,  $\Delta x_t^j := \underline{x}_t^{n,j} - x_t^j$ ,  $\Delta y_t^j := \underline{y}_t^{n,j} - y_t^j$ ,  $\Delta B_{X^i}(t) := B_{\underline{X}^i}(t, \underline{u}_t^n) - B_{X^i}(t, u_t)$ ,  $\Delta F_{y^j}(t) := F_{\underline{y}^j}(t, \underline{u}_t^n) - F_{y^j}(t, u_t)$ ,  $\Delta G_{y^j} := G_{\underline{y}^j}(\underline{u}_T^n) - G_{y^j}(u_T)$ ,  $\Delta \varpi_t := \varpi_t(\underline{y}_t^n, \widehat{\beta}_t) - \pi_t(y_t^j, \widehat{\beta}_t^i)$ . We have the following expansion for  $\Delta \varpi_t$ :

$$\Delta \varpi_t = -\mathbf{m}_2(\Delta y_t) - (\mathbf{m}_2(y_t) - \mathbb{E}^0[y_t^1]) + \delta_n \Lambda_t(\mathbf{m}_1(\widehat{\beta}_t) - \mathbb{E}^0[\widehat{\beta}_t^1]). \quad (5.8)$$

Using the exchangeability, (5.8) and the fact that  $\sum_{j=1}^{N_2} \mathbb{E}[\langle \overline{\Lambda}_t(\Delta y_t^j - \mathbf{m}_2(\Delta y_t)), \Delta y_t^j \rangle] \geq 0$ , we have

$$\begin{aligned} \mathbb{E}[\langle \Delta B_{x^j}(t), \Delta y_t^j \rangle] &= \frac{1}{N_2} \sum_{j=1}^{N_2} \mathbb{E}[\langle -\overline{\Lambda}_t(\Delta y_t^j + \Delta \varpi_t) + \rho_2(t)\Delta \varpi_t, \Delta y_t^j \rangle] \\ &\leq -\mathbb{E}[\rho_2(t)|\mathbf{m}_2(\Delta y_t)|^2] + \mathbb{E}[\langle -(\mathbf{m}_2(y_t) - \mathbb{E}^0[y_t^1]) + \delta_n \Lambda_t(\mathbf{m}_1(\widehat{\beta}_t) - \mathbb{E}^0[\widehat{\beta}_t^1]), (\rho_2(t) - \overline{\Lambda}_t)\mathbf{m}_2(\Delta y_t) \rangle]. \end{aligned}$$

Lemma 5.1 and Cauchy-Schwarz inequality give

$$\mathbb{E}[\langle \Delta B_{x^j}(t), \Delta y_t^j \rangle] \leq -\mathbb{E}[\rho_2(t)|\mathbf{m}_2(\Delta y_t)|^2] + C\varepsilon_{N_1} \mathbb{E}[|\mathbf{m}_2(\Delta y_t)|^2]^{\frac{1}{2}}.$$

From Assumption 3.2 (iv), (5.8) and Young's inequality, we also have

$$\begin{aligned} \mathbb{E}[\langle \Delta F_{y^j}(t), \Delta x_t^j \rangle] &\leq \mathbb{E}[-\gamma_2^f |\Delta x_t^j|^2 + b_t \langle -\mathbf{m}_2(\Delta y_t) - (\mathbf{m}_2(y_t) - \mathbb{E}^0[y_t^1]) + \delta_n \Lambda_t(\mathbf{m}_1(\widehat{\beta}_t) - \mathbb{E}^0[\widehat{\beta}_t^1]), \Delta x_t^j \rangle] \\ &\leq \mathbb{E}\left[-\frac{\gamma_2^f}{2} |\Delta x_t^j|^2 + \frac{b_t^2}{\gamma_2^f} |\mathbf{m}_2(\Delta y_t)|^2\right] + C\varepsilon_{N_1}^2. \end{aligned}$$

Hence,  $\frac{b_t^2}{\gamma_2^f} \leq \frac{\rho_2(t)}{2}$  from Assumption 3.3 (vi), we obtain

$$\mathbb{E}[\langle \Delta B_{x^j}(t), \Delta y_t^j \rangle + \langle \Delta F_{y^j}(t), \Delta x_t^j \rangle] \leq -\frac{\gamma_2^f}{2} \mathbb{E}[|\Delta x_t^j|^2] + C(\varepsilon_{N_1}^2 + \varepsilon_{N_1} \mathbb{E}[|\mathbf{m}_2(\Delta y_t)|^2]^{\frac{1}{2}}). \quad (5.9)$$

We also have, as a direct result of Assumption 3.2 (iv),

$$\mathbb{E}[\langle \Delta G_{y^j}, \Delta x_T^j \rangle] \geq \gamma_2^g \mathbb{E}[|\Delta x_T^j|^2]. \quad (5.10)$$

On the other hand, Itô formula applied to  $\langle \Delta y_t^j, \Delta x_t^j \rangle$  gives an equality

$$[\langle \Delta G_{y^j}, \Delta x_T^j \rangle] = \mathbb{E} \int_0^T [\langle \Delta B_{x^j}(t), \Delta y_t^j \rangle + \langle \Delta F_{y^j}(t), \Delta x_t^j \rangle] dt.$$

Applying (5.9) and (5.10) to the above equality, we obtain, with some constant  $C$ ,

$$\mathbb{E}\left[|\Delta x_T^j|^2 + \int_0^T |\Delta x_t^j|^2 dt\right] \leq C\left(\varepsilon_{N_1}^2 + \varepsilon_{N_1} \int_0^T \mathbb{E}[|\mathbf{m}_2(\Delta y_t)|^2]^{\frac{1}{2}} dt\right). \quad (5.11)$$

Next, a simple application of Itô formula to  $|\Delta y_t^j|^2$  gives

$$\begin{aligned}\mathbb{E}[|\Delta y_t^j|^2] &\leq \mathbb{E}\left[|\Delta G_{y^j}|^2 - 2 \int_t^T \langle \Delta F_{y^j}(s), \Delta y_s^j \rangle ds\right] \leq C \mathbb{E}\left[|\Delta x_T^j|^2 + \int_t^T (|\Delta x_s^j| + |\Delta \varpi_s|) |\Delta y_s^j| ds\right] \\ &\leq C \mathbb{E}\left[|\Delta x_T^j|^2 + \int_0^T |\Delta x_t^j|^2 dt\right] + C \varepsilon_{N_1}^2 + C \int_t^T \mathbb{E}[|\Delta y_s^j|^2] ds,\end{aligned}$$

where, in the last line, we used (5.8) and Lemma 5.1. Hence, from the backward Gronwall's inequality, exchangeability and (5.11), we get

$$\sup_{t \in [0, T]} \mathbb{E}[|\Delta y_t^j|^2] \leq C \varepsilon_{N_1}^2 + C \varepsilon_{N_1} \int_0^T \mathbb{E}[|\Delta y_t^j|^2]^{\frac{1}{2}} dt,$$

which gives  $\sup_{t \in [0, T]} \mathbb{E}[|\Delta y_t^j|^2] \leq C \varepsilon_{N_1}^2$  by Young's inequality. This in turn implies

$$\sup_{t \in [0, T]} \mathbb{E}[|\Delta x_t^j|^2 + |\Delta y_t^j|^2 + |\Delta \varpi_t|^2] \leq C \varepsilon_{N_1}^2.$$

Finally, since  $\Delta X_t^i = \int_0^t \rho_1(s) \Delta \varpi_s dt$ , we conclude, for any  $1 \leq i \leq N_1, 1 \leq j \leq N_2$ ,

$$\sup_{t \in [0, T]} \mathbb{E}[|\Delta X_t^i|^2 + |\Delta x_t^j|^2 + |\Delta y_t^j|^2 + |\Delta \varpi_t|^2] \leq C \varepsilon_{N_1}^2. \quad (5.12)$$

Form (5.12) and the local Lipschitz continuity of  $g_1$ , we have

$$\begin{aligned}&|\mathbb{E}[g_1^i(\underline{X}_T^{n,i}, \underline{\mathcal{L}}_T^{N_1}) - g_1^i(X_T^i, \mu_T)]| \\ &\leq C \mathbb{E}[(1 + |\underline{X}_T^{n,i}| + |X_T^i| + M_2(\underline{\mathcal{L}}_T^{N_1}) + M_2(\mu_T) + |c_T^0| + |c_T^i|)(|\Delta X_T^i| + W_2(\underline{\mathcal{L}}_T^{N_1}, \mu_T))] \\ &\leq C \mathbb{E}[|\Delta X_T^i|^2 + W_2(\mu_T^{N_1}, \mu_T)^2]^{\frac{1}{2}} \leq C \varepsilon_{N_1}.\end{aligned} \quad (5.13)$$

Here, the triangle inequality  $W_2(\underline{\mathcal{L}}_T^{N_1}, \mu_T) \leq W_2(\underline{\mathcal{L}}_T^{N_1}, \mu_T^{N_1}) + W_2(\mu_T^{N_1}, \mu_T)$  and the fact

$$\mathbb{E}[W_2(\underline{\mathcal{L}}_T^{N_1}, \mu_T^{N_1})^2] \leq \frac{1}{N_1} \sum_{k=1}^{N_1} \mathbb{E}[|\underline{X}_T^{n,k} - X_T^k|^2] = \mathbb{E}[|\Delta X_T^i|^2]$$

were used. Similar calculation using the local Lipschitz continuity also yields

$$\begin{aligned}&\left| \mathbb{E} \int_0^T \left[ f_1^i(t, \underline{X}_t^{n,i}, \underline{\mathcal{L}}_t^{N_1}, \varpi_t(\underline{y}_t^n, \widehat{\beta}_t), \widehat{\beta}_t^i) - f_1^i(t, X_t^i, \mu_t, \pi_t(y_t^j, \widehat{\beta}_t^i), \widehat{\beta}_t^i) \right] dt \right| \\ &\leq C \sup_{t \in [0, T]} \mathbb{E}[|\Delta X_t^i|^2 + |\Delta \varpi_t|^2 + W_2(\mu_t^{N_1}, \mu_t)^2]^{\frac{1}{2}} \leq C \varepsilon_{N_1}.\end{aligned} \quad (5.14)$$

The conclusion follows from inequalities (5.13) and (5.14).  $\square$

We arrived the last main result of this paper.

**Theorem 5.1.** *Let Assumptions 3.2-3.3 be in force and the ratio  $\delta_n \leq \delta_*$  be kept fixed. Then the equilibrium of the finite-agent market strongly converges to the mean-field equilibrium in the large population limit of  $N_1$  (and hence  $N_2$ )  $\rightarrow \infty$  in the sense that, for any  $N_1$ , there exists some positive constant  $C$  independent of population sizes that satisfies, with  $\varepsilon_{N_1}$  defined by (5.2),*

$$\begin{aligned}(i) : & |J_1^i(\widehat{\beta}^n) - \mathcal{J}^i(\widehat{\beta}^i)| \leq C \varepsilon_{N_1}, \\ (ii) : & \mathbb{E} \int_0^T \left[ |\widehat{\beta}_t^{n,i} - \widehat{\beta}_t^i|^2 + |\varpi_t(y_t^n, \widehat{\beta}_t^n) - \pi_t(y_t^1, \widehat{\beta}_t^1)|^2 \right] dt \leq C \varepsilon_{N_1}, \\ (iii) : & \mathbb{E} \left[ \sup_{t \in [0, T]} (|X_t^{n,i} - X_t^i|^2 + |x_t^{n,j} - x_t^j|^2 + |y_t^{n,j} - y_t^j|^2) \right] \leq C \varepsilon_{N_1}\end{aligned}$$

for any  $1 \leq i \leq N_1$  and  $1 \leq j \leq N_2$ .

*Proof.* Let us use the same conventions as in Proposition 5.1, i.e.,  $\Delta X_t^i := X_t^{n,i} - X_t^i$ ,  $\Delta \widehat{\beta}_t^i := \widehat{\beta}_t^{n,i} - \widehat{\beta}_t^i$ ,  $\varpi_t := \varpi_t(y_t^n, \widehat{\beta}_t^n)$ ,  $\pi_t := \pi_t(y_t^1, \widehat{\beta}_t^1) = \pi_t(y_t^j, \widehat{\beta}_t^j)$  and  $\Delta X_t^i := X_t^{n,i} - X_t^i$ ,  $\Delta y_t^j := y_t^{n,j} - y_t^j$ ,  $\Delta \widehat{\beta}_t^i := \widehat{\beta}_t^{n,i} - \widehat{\beta}_t^i$ ,  $\Delta \varpi_t := \varpi_t - \pi_t$ , etc. Note that, from the results of Propositions 5.1 and 5.2, we have

$$\begin{aligned} \mathcal{J}_1^i(\widehat{\beta}^i) + \mathbb{E} \int_0^T \left[ \frac{\gamma_1^f}{2} |\Delta X_t^i|^2 + \frac{\lambda_\beta}{2} |\Delta \widehat{\beta}_t^i|^2 + \frac{\lambda_\varpi}{2} |\Delta \varpi_t|^2 \right] dt + \frac{\gamma_1^g}{2} \mathbb{E} [|\Delta X_T^i|^2] - C\varepsilon_{N_1} \\ \leq \mathcal{J}_1^i(\widehat{\beta}^n) \leq \mathcal{J}_1^i(\widehat{\beta}) \leq \mathcal{J}_1^i(\widehat{\beta}^i) + C\varepsilon_{N_1}. \end{aligned}$$

This gives (i) and (ii). Since  $\Delta X_t^i = \int_0^t [\Delta \widehat{\beta}_t^i + \rho_1(t) \Delta \varpi_t] dt$ , it is easy to obtain

$$\mathbb{E} \left[ \sup_{t \in [0, T]} |\Delta X_t^i|^2 \right] \leq C \mathbb{E} \int_0^T [|\Delta \widehat{\beta}_t^i|^2 + |\Delta \varpi_t|^2] dt \leq C\varepsilon_{N_1}.$$

Moreover, applying the convexity of  $g_2, \overline{f}_2$  to the equality

$$\mathbb{E} [\langle \Delta y_T^j, \Delta x_T^j \rangle] = \mathbb{E} \int_0^T \left[ \langle -\overline{\Lambda}_t \Delta y_t^j + (\rho_2(t) - \overline{\Lambda}_t) \Delta \varpi_t, \Delta y_t^j \rangle + \langle -(\partial_x \overline{F}_2^j(t, x_t^{n,j}) - \partial_x \overline{F}_2^j(t, x_t^j)) + b_t \Delta \varpi_t, \Delta x_t^j \rangle \right] dt,$$

we obtain, with some constant  $C$ ,

$$\mathbb{E} \left[ |\Delta x_T^j|^2 + \int_0^T |\Delta x_t^j|^2 dt \right] \leq C \mathbb{E} \int_0^T [|\Delta \varpi_t|^2 + |\Delta \varpi_t| |\Delta y_t^j|] dt.$$

Following the same procedures used in Proposition 5.2, it is simple to obtain

$$\sup_{t \in [0, T]} \mathbb{E} [|\Delta x_t^j|^2 + |\Delta y_t^j|^2] \leq C \mathbb{E} \int_0^T |\Delta \varpi_t|^2 dt \leq C\varepsilon_{N_1}.$$

BDG inequality then provides the desired estimate.  $\square$

**Remark 5.2.** *If the law- $\mu$  dependence in  $(f_1, g_1)$  is just given by its first moment  $\int_{\mathbb{R}^n} x \mu(dx)$ , then we can replace  $\varepsilon_{N_1}$  by  $1/\sqrt{N_1}$  since the first part of Lemma 5.1 becomes unnecessary. Therefore, in this case, we have an explicit convergence speed  $\propto 1/\sqrt{N_1}$ .*

Theorem 5.1 tells that the market clearing price  $\varpi_t(y_t^n, \widehat{\beta}_t^n)$  converges to an  $\mathbb{F}^0$ -adapted process  $\pi_t(y_t, \widehat{\beta}_t)$ . This means that the securities prices only respond to the market-wide news and shocks, which is consistent with our intuition. This also allows each agent, when the population is large enough, to focus on the market-wide and her own idiosyncratic informations without taking care of the idiosyncratic informations of the others. Therefore, we can see that an awkward setup with the perfect information with  $\mathbb{F}$ -adapted controls is effectively resolved as the population size grows.

## 6 Conclusion and discussion

In this work, we developed an equilibrium model for price formation in a market composed of cooperative and non-cooperative populations. In the large population limit, we have seen that the problem for the central planner becomes an extended mean-field control over the FBSDEs of McKean-Vlasov type with common noise. In addition to the convexity assumptions, if the relative size of the cooperative population is small enough, then we were able to show the existence of a unique equilibrium for both the finite-agent and the mean-field models. The strong convergence to the mean-field model was also proved under the same conditions. By working in the linear-quadratic setting which has a semi-analytic solution, we may study how the equilibrium price process changes as the relative population size grows. Since the control domain  $A_1$  is an arbitrary closed convex subset of  $\mathbb{R}^n$ , we can fix the direction of trade if necessary. This will be useful when we consider a model of cooperative producers (or buyers) in the background of a large number of competitive agents. Extensions of the current model for these economic applications deserve future research.
