

# Firm-worker hypergraphs

## Abstract

A firm-worker hypergraph consists of edges in which each edge joins a firm and its possible staff. We show that a stable matching exists in both discrete many-to-one matching and many-to-one matching with continuous transfers and quasilinear utilities when the firm-worker hypergraph is *balanced*. Firms' preferences satisfying this condition arise in a problem of matching specialized firms with specialists.

*Keywords:* two-sided matching; many-to-one matching; stability; complementarity; integer programming; balanced hypergraph; firm-worker hypergraph

## 1 Introduction

The problem of two-sided matching considers how to match two groups of agents, such as men and women, workers and firms, and students and schools. A key solution concept is stable matching, which excludes incentives for agents to block the outcome. The literature on two-sided matching has developed into two parallel lines. The discrete matching problem originated with the stable marriage

problem (Gale and Shapley, 1962). This literature assumes no monetary transfers, discrete wages, or discrete contracts between two market sides. The problem of matching with continuous transfers originated with the assignment problem (e.g., Koopmans and Beckmann, 1957 and Shapley and Shubik, 1971). This literature assumes continuous monetary transfers between two market sides and often assumes agents have quasilinear utilities. Kelso and Crawford (1982) made an important observation for both lines: They found that stable matchings exist when firms and workers bargain over discrete or continuous wages, provided that firms' preferences satisfy the gross substitutes condition. The gross substitutes condition rules out complementarities in firms' preferences and enables a variant of the Gale-Shapley algorithm to produce a stable matching. Substitutability conditions of different forms have become crucial for market practice.<sup>1</sup> On the other hand, complementarities are prevalent in real life and have become a critical issue for market design.

This paper provides a condition compatible with complementarities and sufficient for the existence of a stable matching in both discrete many-to-one matching and many-to-one matching with continuous transfers and quasilinear utilities. Our condition rules out a specific cyclic structure in firms' preferences. We illustrate with two examples below. Consider the following discrete matching market from Che et al. (2019) with two firms  $f_1, f_2$ , and two workers  $w_1, w_2$ .

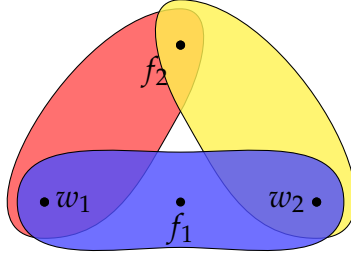

 f_2 : \{w_1\} \succ \{w_2\} \succ \emptyset & & w_2 : f_2 \succ f_1

This market has no stable matching. If firm  $f_1$  hires both workers, worker  $w_2$  will go to firm  $f_2$ ; then, firm  $f_1$  will drop worker  $w_1$ ; and then, firm  $f_2$  will drop worker

$w_2$  and hire worker  $w_1$ ; but we then return to the beginning: both workers will go to firm  $f_1$ . This cyclic blocking process coincides with the cycle in the following **firm-worker hypergraph**. A hypergraph is a generalization of a graph in which an edge can join any number of vertices. The firm-worker hypergraph uses edges to join each firm with its possible staff.



We then consider the market in which firms and workers have quasilinear utilities and bargain over continuous wages. We assume each firm and worker has a quasilinear utility in this problem throughout the paper, but we often call this problem matching with continuous transfers for convenience. Consider a parallel market of the above one. Firm  $f_1$  derives 6 from hiring both workers and does not want to hire only one worker. Firm  $f_2$  values each worker at 4 in the absence of the other but does not want to hire both. Both workers care only about their wages. This market is adapted from an exchange economy used as illustrative examples in [Azevedo et al. \(2013\)](#) and [Baldwin and Klemperer \(2019\)](#). There is no stable matching in this market either. If firm  $f_1$  hires both workers at an expenditure of no more than 6, then there must be a worker earning a wage no more than 3. This worker will go to firm  $f_2$  since firm  $f_2$  is willing to pay a wage between 3 and 4, then the other worker will be fired by firm  $f_1$  and come to compete for firm  $f_2$ 's offer. The competition will lead to a market wage of less than 3, and we then return to the beginning: Firm  $f_1$  will hire both workers at an expenditure of no more than 6. This market also has the above firm-worker hypergraph.

This paper shows that a stable matching exists in both discrete matching and

matching with continuous transfers and quasilinear utilities when the firm-worker hypergraph satisfies the following condition.

Every odd-length cycle has an edge containing at least  
three vertices of the cycle. (1.2)

A hypergraph satisfying (1.2) is called **balanced**. This notion is proposed by [Berge \(1970\)](#).<sup>2</sup> The above firm-worker hypergraph fails balancedness: The hypergraph itself is a cycle of length 3 with no edge containing more than two vertices.<sup>3</sup>

Our balancedness condition is compatible with various forms of complementarities. We provide an application of our existence theorems. In many real-life sectors, a firm often concentrates on one technology path; colleges and firms also train students and workers to be specialists rather than generalists. We study a problem of matching specialized firms with specialists, where specializations are captured in a structure called **technology roadmap**. A technology roadmap is a tree of technologies in which each technology demands a set of workers to implement. Each firm possesses some technologies and has a preference over its technologies, which induces the firm's preference order over the sets of workers demanded by the technologies. Workers are called specialists according to the scopes of technologies they undertake. Firms are called specialized according to the scopes of technologies they possess. We show that when firms and workers are specialized in a specific form, the firm-worker hypergraph is balanced. Hence, stable matchings always exist in related discrete matching markets and markets with continuous transfers.

## 1.1 Related literature

Our proofs for the balancedness condition utilize the integer programming methods of [Bikhchandani and Mamer \(1997\)](#) (henceforth, BM97) and [Huang \(2022a\)](#) (henceforth, H22a). Both methods construct a fictitious market in which each firm can hire a combination of fractions of its possible set of employees in the original market. BM97's integer and linear programs investigate the aggregate utilities of the original and fictitious markets, respectively. Their result implies that a stable matching exists in a market with continuous transfers if and only if the relaxation of the indivisibility constraint does not improve the maximum total welfare. We analyze a generalization of BM97's program studied by [Tran and Yu \(2019\)](#) and obtain our result by applying a result of [Conforti and Cornuéjols \(1995\)](#).

Our result in discrete matching follows from H22a's analysis. An existence theorem of [Che et al. \(2019\)](#) implies the existence of a stable matching in H22a's fictitious market. We obtain our result in discrete matching by applying a result of [Fulkerson et al. \(1974\)](#) to H22a's integer feasibility program, which investigates when a stable fractional matching can always be transformed into a stable integral one.

Economists have found similar results in discrete matching and matching with continuous transfers. For example, [Sun and Yang \(2006, 2009\)](#) and [Ostrovsky \(2008\)](#) both assume within-group substitutability and cross-group complementarity. It is interesting to remark that although the two methods we adopt are based on different features of the two markets, the two programs have similar constraints that yield similar results.

Our balancedness condition relates to the unimodularity conditions ([Danilov et al., 2001](#) and [Baldwin and Klemperer, 2019](#)) in matching with continuous transfers and the total unimodularity condition (H22a) in discrete matching. We show that our balancedness condition is independent of (totally) unimodular demand types

in both problems. Moreover, our application of matching specialized firms with specialists also allows demand types that are not unimodular.

## 1.2 Cyclic structure and cyclic blocking process

Because our analysis is based on sophisticated tools, our proofs do not provide a direct explanation for the existence theorems. Nonetheless, the following argument may provide some intuitions.

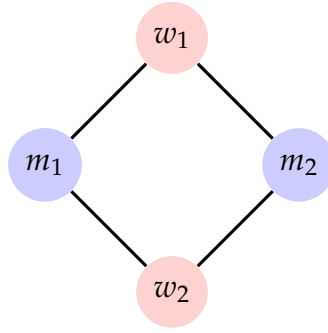
When no stable matching exists in a market, the agents will constantly block the current matching and never arrive at a static state. Since the possible states of a market are finite, the market will return to the same state from time to time. (1.3)

Intuitively, a cyclic blocking process should correspond to a cyclic structure in the preference profile.

The above two examples illustrate this argument. Our results further imply that neither odd-length cycles satisfying (1.2) nor even-length cycles cause instability. The following example may help us understand this phenomenon. Consider a marriage market with two men  $m_1, m_2$ , two women  $w_1, w_2$ , and the following preferences.

 m_1 : & w_1 \succ w_2 & w_1 : & m_2 \succ m_1 \\
 m_2 : & w_2 \succ w_1 & w_2 : & m_1 \succ m_2
 \end{array}
 \tag{1.4}$$

The firm-worker hypergraph reduces to the following woman-man graph if we view women as firms and men as workers.



There is a cycle of length 4, which gives rise to the following cyclic blocking process: Woman  $w_1$  divorces man  $m_1$  and marries man  $m_2$ ; man  $m_2$  divorces woman  $w_1$  and marries woman  $w_2$ ; woman  $w_2$  divorces man  $m_2$  and marries man  $m_1$ ; man  $m_1$  divorces woman  $w_2$  and marries woman  $w_1$ . However, unlike the above two examples, this cycle breaks into a stable marriage in which woman  $w_1$  marries man  $m_2$ , and woman  $w_2$  marries man  $m_1$  (or woman  $w_1$  marries man  $m_1$ , and woman  $w_2$  marries man  $m_2$ ).

While argument (1.3) may help us understand the balancedness condition, this argument essentially differs from existing methods and also applies to matching without a two-sided structure. For instance, the stable roommate problem is a typical example in which a particular cyclic structure (Tan, 1991) plays a critical role. The author's subsequent work, Huang (2022c), use argument (1.3) to provide an acyclicity condition independent of our balancedness condition. The differences between the two works are: Our condition is based on sophisticated tools, is imposed only on the structure of the firm-worker hypergraph, and does not use the information of firms' preference orders or values of firms' valuations. On the other hand, the results of Huang (2022c) depend only on the elementary argument stated in (1.3), use detailed information on agents' preferences, and apply to markets with and without a two-sided structure.

The remainder of this paper is organized as follows. Section 2 presents the model and our result for matching with continuous transfers. Section 3 presents the model and our result for discrete matching. Section 4 provides an application

for both existence theorems. Proofs are relegated to the Appendix.

## 2 Many-to-one matching with continuous transfers

In this section, we study the job matching problem with continuous transfers between firms and workers. We assume each firm and worker has a quasilinear utility.

### 2.1 Model

There is a finite set  $F$  of firms and a finite set  $W$  of workers. Let  $\emptyset$  be the null firm, representing not being matched with any firm; and let  $\tilde{F} \equiv F \cup \{\emptyset\}$ . Each firm  $f \in F$  has a valuation  $v_f : \mathcal{A}_f \rightarrow \mathbb{R}$ , where  $\mathcal{A}_f \subseteq 2^W$  and  $\emptyset \in \mathcal{A}_f$ . A nonempty set  $S \subseteq W$  is called **acceptable** to  $f$  if  $S \in \mathcal{A}_f$ . Each worker  $w \in W$  has a valuation  $v_w : A_w \rightarrow \mathbb{R}$ , where  $A_w \subseteq \tilde{F}$  and  $\emptyset \in A_w$ . Firm  $f \in F$  is called acceptable to  $w$  if  $f \in A_w$ . For normalization, we assume  $v_f(\emptyset) = v_w(\emptyset) = 0$  for each  $f \in F$  and each  $w \in W$ . Firms and workers have quasilinear utilities: Given a price  $\mathbf{p} \in \mathbb{R}^W$  where  $p(w)$  is the salary for hiring worker  $w$ , firm  $f$ 's utility of hiring  $A \in \mathcal{A}_f$  is given by  $U_f(A, \mathbf{p}) \equiv v_f(A) - \sum_{w \in A} p(w)$  for each  $f \in F$ , and worker  $w$ 's utility of working for  $f \in A_w$  is given by  $U_w(f, \mathbf{p}) \equiv v_w(f) + p(w)$  each  $w \in W$ . Let  $D_f(\mathbf{p})$  be the demand set for firm  $f$  at price  $\mathbf{p} \in \mathbb{R}^W$ :  $D_f(\mathbf{p}) \equiv \arg \max_{A \in \mathcal{A}_f} U_f(A, \mathbf{p})$ . A matching market with continuous transfers can be summarized as a tuple  $\Phi = (F, W, v_F, v_W)$ .

Our assumption differs from [Kelso and Crawford \(1982\)](#), who only assumes each worker's valuation to be strictly increasing and continuous in wages. We allow workers to be unemployed (i.e., matched with the null firm), while no worker will be unemployed in the Kelso-Crawford market. Consider a special case of our model in which  $A_w = F$  and  $v_w(f) = 0$  for all  $w \in W$  and all  $f \in F$ . This case



means that each worker cares only about her wage when choosing from different firms. In this case, we can view the matching market as an exchange economy in which the workers are goods demanded by the firms. This market resembles the exchange economy with indivisible heterogeneous goods in the literature (e.g., BM97, Ma, 1998, and Gul and Stacchetti, 1999). The difference is that this special case of our market has a null firm who is an agent without a quasilinear utility.

A matching is an assignment of workers to firms together with a wage schedule.

**Definition 1.** A **matching**  $(\mu, \mathbf{p})$  consists of a function  $\mu : \tilde{F} \cup W \rightarrow \tilde{F} \cup 2^W$  and a price  $\mathbf{p} \in \mathbb{R}^W$  such that for all  $f \in \tilde{F}$  and all  $w \in W$ ,

- (i)  $\mu(w) \in \tilde{F}$ , and  $\mu(w) = \emptyset$  implies  $p(w) = 0$ ;
- (ii)  $\mu(f) \in 2^W$ ;
- (iii)  $\mu(w) = f$  if and only if  $w \in \mu(f)$ .

The concept of stability includes two requirements. First, the matching should be weakly better than staying unmatched for all agents. Second, no firm and group of workers can negotiate an agreement that is weakly better than the current matching for all members involved in the negotiations and strictly better for at least one member.

**Definition 2.** A matching  $(\mu, \mathbf{p})$  is **stable** if

- (i) (Individual Rationality) for all  $f \in F$  and all  $w \in W$ ,  $\mu(w) \in A_w$  and  $U_w(\mu(w), \mathbf{p}) \geq 0$ ;  $\mu(f) \in \mathcal{A}_f$  and  $U_f(\mu(f), \mathbf{p}) \geq 0$ ;
- (ii) (No Blocking Coalition) there are no firm-set of workers combination  $(f, S)$  and price  $\mathbf{p}'$  such that
 
$$U_f(S, \mathbf{p}') \geq U_f(\mu(f), \mathbf{p}), \quad \text{and}$$

$$U_w(f, \mathbf{p}') \geq U_w(\mu(w), \mathbf{p}) \quad \text{for all } w \in S$$

with strict inequality holding for at least one member of  $\{f\} \cup S$ .

A firm has a gross-substitute valuation if increasing the salaries of some workers will not decrease the firm's demand for any other worker. More specifically, firm  $f$ 's valuation  $v_f$  satisfies the **gross substitutes** condition if for any two prices  $\mathbf{p}$  and  $\mathbf{p}'$  such that  $\mathbf{p} \leq \mathbf{p}'$  and any  $S \in D_f(\mathbf{p})$ , there exists  $S' \in D_f(\mathbf{p}')$  such that such that  $\{w \in S \mid p(w) = p'(w)\} \subseteq S'$ . [Kelso and Crawford \(1982\)](#) showed that a stable matching exists when each firm has a gross-substitute valuation.<sup>4</sup> Problems with complementarities are mostly unresolved except for a few cases. [Hatfield et al. \(2013\)](#) showed the existence of a stable outcome in a trading network that generalizes the result of [Sun and Yang \(2006\)](#). The market without a two-sided structure has an existence result at polar opposite: [Rostek and Yoder \(2020\)](#) showed that a stable outcome exists in multilateral matching when each agent has a complementary preference. Their result also holds for discrete matching.

## 2.2 Firm-worker hypergraph

A hypergraph is a generalization of a graph in which an edge can join any number of vertices. A **firm-worker hypergraph** is a hypergraph  $(F \cup W, \mathcal{E})$  in which each vertex  $j \in F \cup W$  is either a firm or a worker, and each edge contains one firm and its possible staff:  $\mathcal{E} = \{\{f\} \cup S \mid f \in F, S \neq \emptyset, \text{ and } S \in \mathcal{A}_f\}$ .<sup>5</sup> A cycle of length  $k \geq 2$  is a cyclic alternating sequence of distinct vertices and edges:

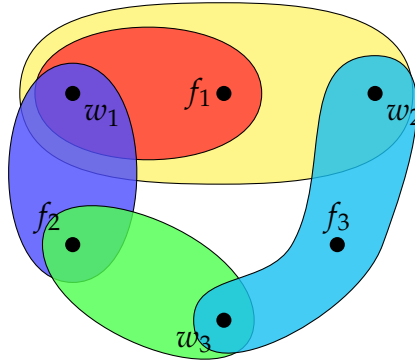
$(j^1, E^1, j^2, E^2, \dots, j^k, E^k, j^1)$ , where  $j^i, j^{i+1} \in E^i (i \in \{1, 2, \dots, k-1\})$  and  $j^k, j^1 \in E^k$ .<sup>6</sup> We call  $j^1, \dots, j^k$  vertices of this cycle. A hypergraph is called **balanced** if every odd-length cycle has an edge containing at least three vertices of the cycle.

**Theorem 1.** A stable matching exists in a market with continuous transfers and quasilinear utilities if the firm-worker hypergraph is balanced.

**Example 1.** Consider a market with three firms, three workers, and the following profile of firms' valuations. Worker sets not listed are unacceptable for the firm.

$$\begin{aligned}
 v_{f_1}(\{w_1, w_2\}) &= 3 & v_{f_1}(\{w_1\}) &= 1 & v_{f_1}(\emptyset) &= 0 \\
 v_{f_2}(\{w_1\}) &= 2 & v_{f_2}(\{w_3\}) &= 1 & v_{f_2}(\emptyset) &= 0 \\
 v_{f_3}(\{w_2, w_3\}) &= 2 & v_{f_3}(\emptyset) &= 0 & & 
 \end{aligned} \tag{2.1}$$

This market has a balanced firm-worker hypergraph as follows.



There is only one odd-length cycle:

$$(w_1, \{w_1, f_1\}, f_1, \{f_1, w_1, w_2\}, w_2, \{w_2, f_3, w_3\}, w_3, \{w_3, f_2\}, f_2, \{f_2, w_1\}, w_1) \tag{2.2}$$

in which  $\{f_1, w_1, w_2\}$  contains three vertices of the cycle. Therefore, there always exists a stable matching in this market.

## 2.3 Method

We elaborate on the method for the proof of Theorem 1 below. We follow Section 6.4 of [Baldwin and Klemperer \(2019\)](#) to describe the market  $\Phi$  of matching with continuous transfers as an exchange economy  $\bar{\Phi}$ . The set of agents  $J$  in  $\bar{\Phi}$  is the set of firms and workers from  $\Phi$ :  $J \equiv F \cup W$ . The set of goods  $H$  in  $\bar{\Phi}$  is the set of firm-worker pairs from  $\Phi$ :  $H \equiv \{fw | f \in F, w \in W\}$ . Let  $H_f$  be the set of goods associated with firm  $f$ , and  $H_w$  the set of goods associated with worker  $w$ . In the exchange economy, each worker  $w$  considers to sell at most one good from  $H_w$  to the related firm. Worker  $w$  selling  $fw$  to firm  $f$  at price  $p$  means  $w$  working for  $f$  at wage  $p$  in the matching market. Workers that do not sell any good in the exchange economy corresponds to unemployed workers in the matching market. Hence, the full set of bundles is a subset of  $\{-1, 0, 1\}^H$ , where  $-1$  refers to selling the good, and  $1$  refers to buying the good. For any bundle  $\mathbf{x} \in \{-1, 0, 1\}^H$ , let  $\mathbf{x}_F$  be the set of firms involved in  $\mathbf{x}$ :  $\mathbf{x}_F \equiv \{f | \mathbf{x}(fw) \neq 0 \text{ for some } w\}$ , and  $\mathbf{x}_W$  the set of workers involved in  $\mathbf{x}$ :  $\mathbf{x}_W \equiv \{w | \mathbf{x}(fw) \neq 0 \text{ for some } f\}$ .

Each agent  $f \in F$  has a valuation  $\bar{v}_f : \bar{A}_f \rightarrow \mathbb{R}$ , where  $\bar{A}_f \subseteq \{0, 1\}^H$  and  $\mathbf{0} \in \bar{A}_f$ .  $\bar{A}_f$  coincides with adjusted  $\mathcal{A}_f$ :  $\mathbf{x} \in \bar{A}_f$  if  $\mathbf{x}(f'w) = 0$  for all  $f' \neq f$ ,  $\mathbf{x}_W \in \mathcal{A}_f$ , and there is no  $w \in \mathbf{x}_W$  with  $f \notin A_w$ . The last requirement excludes those bundles that include goods the workers won't sell to  $f$ .<sup>7</sup> We then define  $\bar{v}_f$  as:  $\bar{v}_f(\mathbf{x}) = v_f(S)$  if  $\mathbf{x} \in \bar{A}_f$  and  $\mathbf{x}_W = S$ .

Each worker  $w \in W$  has a valuation  $\bar{v}_w : \bar{A}_w \rightarrow \mathbb{R}$ , where  $\bar{A}_w \subseteq \{-1, 0\}^H$  and  $\mathbf{0} \in \bar{A}_w$ .  $\bar{A}_w$  coincides with  $A_w$ :  $\mathbf{x} \in \bar{A}_w$  if and only if  $\mathbf{x}(fw') = 0$  for all  $w' \neq w$ ,  $|\mathbf{x}_F| \leq 1$ , and  $\mathbf{x}_F \subseteq A_w$ . The requirement  $|\mathbf{x}_F| \leq 1$  means that a worker can work for only one firm.  $\bar{v}_w$  coincides with  $v_w$ :  $\bar{v}_w(\mathbf{x}) = v_w(f)$  if  $\mathbf{x} \in \bar{A}_w$  and  $\mathbf{x}_F = \{f\}$ .

The demand set for agent  $j$  at price  $\bar{\mathbf{p}} \in \mathbb{R}^H$  is  $D_j(\bar{\mathbf{p}}) \equiv \arg \max_{\mathbf{x} \in \bar{A}_j} \{\bar{v}_j(\mathbf{x}) -$

$\bar{\mathbf{p}} \cdot \mathbf{x}$ .<sup>8</sup> An equilibrium consists of a price  $\bar{\mathbf{p}} \in \mathbb{R}^H$  and an allocation  $\{\mathbf{x}^j\}_{j \in J}$  such that  $\sum_{j \in J} \mathbf{x}^j = \mathbf{0}$  and  $\mathbf{x}^j \in D_j(\bar{\mathbf{p}})$  for each  $j \in J$ .

BM97 studied an exchange economy with indivisible heterogeneous goods. They relaxed the indivisibility constraint by allowing each agent to receive a combination of fractions of bundles. They showed that an equilibrium exists in the original market if and only if this relaxation cannot improve maximum total welfare. We use an adaption of their linear/integer program proposed by [Tran and Yu \(2019\)](#) as follows, where the decision variables are  $y(\mathbf{x}, j)$  for  $j \in J$  and  $\mathbf{x} \in \bar{A}_j$ .

$$\text{maximize} \quad \sum_{j \in J} \sum_{\mathbf{x} \in \bar{A}_j} y(\mathbf{x}, j) \bar{v}_j(\mathbf{x}) \quad (2.3)$$

$$\text{subject to} \quad y(\mathbf{x}, j) \geq 0 \text{ for all } j \in J \text{ and } \mathbf{x} \in \bar{A}_j \quad (2.4)$$

$$\sum_{\mathbf{x} \in \bar{A}_j} y(\mathbf{x}, j) = 1 \text{ for all } j \in J \quad (2.5)$$

$$\sum_{j \in J} \sum_{\mathbf{x} \in \bar{A}_j} y(\mathbf{x}, j) \mathbf{x} = \mathbf{0} \quad (2.6)$$

Constraints (2.4)-(2.6) require, respectively, that bundles are assigned in positive fractions, that each agent receives a total mass of one bundle, and that the quantities of labor sold by workers equal those bought by firms. Objective (2.3) asks for an assignment that maximizes the total valuation.

**Lemma 1.** The following statements are equivalent:

(i) A stable matching exists in matching market  $\Phi$ .

(ii) An equilibrium exists in exchange economy  $\bar{\Phi}$ .

(iii) The linear program has an optimal solution for which all  $y(\mathbf{x}, j)$  are integers.

(i) $\Leftrightarrow$ (ii) follows from the fact that the core is equivalent to the set of equilibria in an exchange economy when each agent has a quasilinear utility.<sup>9</sup> (ii) $\Leftrightarrow$ (iii) follows from Proposition 1 of [Tran and Yu \(2019\)](#), who further reformulated the above program with Cayley trick as follows. Let  $M$  be the matrix whose columns are the points in  $(\{\mathbf{e}^1\} \times \bar{A}_1) \cup \dots \cup (\{\mathbf{e}^{|J|}\} \times \bar{A}_{|J|})$ , where  $\{\mathbf{e}^1, \dots, \mathbf{e}^{|J|}\}$  is the set of  $|J|$ -dimensional unit vectors, and  $\{\bar{A}_1, \dots, \bar{A}_{|J|}\}$  is a permutation of the elements from  $\{\bar{A}_j\}_{j \in J}$ . (2.3)-(2.6) can be rewritten as:

$$\text{maximize } \mathbf{v} \cdot \mathbf{y} \quad (2.7)$$

$$\text{subject to } \mathbf{y} \geq 0 \quad \text{and} \quad M\mathbf{y} = \begin{pmatrix} \mathbf{1} \\ \mathbf{0} \end{pmatrix} \quad (2.8)$$

where  $\mathbf{1}$  is the all-one vector in  $\mathbb{Z}^J$ , and  $\mathbf{0}$  the all-zero vector in  $\mathbb{Z}^H$ . It is interesting to remark that polytope (2.8) resembles the polytope constructed by H22a in discrete matching.

**Example 2.** Consider a market  $\Phi$  with two firms and three workers. Workers and firms have the following acceptable firms/sets.

$$\begin{aligned} A_{w_1} = A_{w_2} &= \{f_1, f_2, \emptyset\}, & A_{w_3} &= \{f_1, \emptyset\}; \\ \mathcal{A}_{f_1} &= \{\{w_1, w_3\}, \{w_2, w_3\}, \emptyset\}, & \mathcal{A}_{f_2} &= \{\{w_1\}, \{w_2\}, \{w_2, w_3\}, \emptyset\}. \end{aligned}$$

The system of equations in (2.8) is as follows.

f_2 w_2 & & 0 & 0 & 0 & 0 & -1 & 0 & 0 & 0 & 0 & 0 & 0 & 1 & 0
\end{array}
\end{array}
\begin{pmatrix} y_1 \\ y_2 \\ y_3 \\ y_4 \\ y_5 \\ y_6 \\ y_7 \\ y_8 \\ y_9 \\ y_{10} \end{pmatrix} = \begin{pmatrix} 1 \\ 1 \\ 1 \\ 1 \\ 1 \\ 0 \\ 0 \\ 0 \\ 0 \\ 0 \end{pmatrix}$$

Each column of  $M$  represents an agent  $j$  and a bundle from  $\overline{A}_j$ . If  $f \notin A_w$  for some  $f$  and  $w$ , then the row for good  $fw$  must be all-zero according to our definition of  $\overline{A}_f$ . Thus, removing such trivial equations from the system leaves the polytope unchanged. Let  $M'$  denote the remaining matrix. For instance, we have removed the row for  $f_2 w_3$  in the above example: Since  $f_2 \notin A_{w_3}$ , bundle  $\{f_2 w_2, f_2 w_3\}$  is not in  $\overline{A}_{f_2}$ <sup>10</sup> and the row for  $f_2 w_3$  is all-zero. After removing the trivial equations, each of the rows below the  $|J|$ -th row of  $M'$  contains exactly one  $-1$ .

Balancedness can also be defined on matrices. A  $\{0, 1\}$ -matrix is balanced if it has no square submatrix of odd order with exactly two 1s in each row and column. The balancedness of a hypergraph is equivalent to the balancedness of the incidence matrix of the hypergraph. [Truemper \(1982\)](#) proposed the following definition that extends balanced  $\{0, 1\}$ -matrices: A  $\{0, \pm 1\}$ -matrix is balanced if, in every submatrix with two nonzero entries per row and column, the sum of the entries is a multiple of four. [Conforti and Cornu ejols \(1995\)](#) showed that for any balanced  $\{0, \pm 1\}$ -matrix  $B$ ,  $\{0 \leq \mathbf{z} \leq 1, B\mathbf{z} = 1 - n(B)\}$  determines an integral polytope, where  $n(B)$  is the vector whose  $i$ -th component is the number of negative entries

in the  $i$ -th row of  $B$ .<sup>11</sup> Therefore, balancedness of  $M$  implies balancedness of  $M'$ , and the latter further implies that all vertices of polytope (2.8) are integral.<sup>12</sup> We also find that  $M$  is balanced if the firm-worker hypergraph of the original market  $\Phi$  is balanced.

**Lemma 2.** Matrix  $M$  is balanced if the firm-worker hypergraph in  $\Phi$  is balanced.

Consequently, Theorem 1 follows from Lemma 1, Lemma 2, and the above discussion.

## 2.4 Relation to other conditions

Our balancedness condition is independent of the gross substitutes condition. [Huang \(2022b\)](#) provided a refinement of Theorem 1 when each firm has a superadditive valuation.<sup>13</sup> Superadditivity is a general notion of complementarity, subsuming gross complementarity and supermodularity. A stable matching exists if each firm has a superadditive valuation and the hypergraph whose edges are firms' acceptable sets is balanced.

We discuss below the relation between our balancedness condition and the unimodular demand types proposed by [Baldwin and Klemperer \(2019\)](#). Balancedness closely relates to unimodularity.<sup>14</sup> However, we assume balancedness on the firm-worker hypergraph while [Baldwin and Klemperer \(2019\)](#) assume unimodularity on demand types; thus, the difference between the two conditions is not merely due to the difference between balancedness and unimodularity. We illus-

trate this with examples below. We assume  $A_w = F$  and  $v_w(f) = 0$  for all  $w \in W$  and all  $f \in F$  and consider the matching market as an exchange economy in which the firms are agents and the workers are goods.<sup>15</sup>

**Definition 3. (i)** For each  $f \in F$ , the locus of indifference prices for firm  $f$  is  $\{\mathbf{p} \in \mathbb{R}^W \mid |D_f(\mathbf{p})| > 1\}$ . The  $(|W| - 1)$ -dimensional components of a firm's locus of indifference prices are called facets.

**(ii)** We say that firm  $f$  is of demand type  $\mathcal{D}_f$  if every facet of  $f$ 's locus of indifference prices is normal to a vector in  $\mathcal{D}_f$ . The demand type for the firms' preference profile is  $\mathcal{D} = \cup_{f \in F} \mathcal{D}_f$ .

Consider the following profile of firms' valuations.

$$\begin{aligned} v_{f_1}(\{w_1, w_2, w_3\}) &= 3, & v_{f_1}(\{w_1, w_3\}) &= 2, & v_{f_1}(\{w_3\}) &= 1 \\ v_{f_2}(\{w_2, w_3\}) &= 1 \end{aligned} \tag{2.9}$$

Roughly speaking, a firm's demand type considers how the firm's demand change as prices change. For example,  $\{\mathbf{p} \in \mathbb{R}^3 \mid p(w_1) + p(w_2) = 2, p(w_2) < 1, \text{ and } p(w_3) < 1\}$  is a facet of  $f_1$ 's locus of indifference prices at which  $f_1$  is indifferent between  $\{w_1, w_2, w_3\}$  and  $\{w_3\}$ ; thus, firm  $f_1$ 's demand type contains  $(1, 1, 0)$ , which is the change of  $f_1$ 's demand across this facet as  $p(w_1)$  or  $p(w_2)$  decreases. Similarly,  $(1, 0, 1)$  and  $(0, 1, 1)$  belong to  $f_1$ 's demand type<sup>16</sup> and  $f_2$ 's demand type, respectively. The firms' demand type  $\mathcal{D}$  is not unimodular since it contains  $(1, 1, 0)$ ,

$(1, 0, 1)$  and  $(0, 1, 1)$  (the matrix that has the three vectors as columns has determinant 2).<sup>17</sup> On the other hand, (2.9) has a balanced firm-worker hypergraph. This is because  $w_3$  belongs to each edge of the firm-worker hypergraph, and every length  $\geq 3$  cycle has  $w_3$  as a vertex. Thus, a length  $\geq 3$  cycle must have an edge containing at least three vertices of the cycle.

The above market shows that balancedness of the firm-worker hypergraph does not imply unimodularity of the firms' demand type. We show that the latter does not imply the former by another example. Consider the market with continuous transfers in Section 1, and we now assume that  $f_2$  values each worker at 4 in the absence of the other but derives 9 from hiring both. Firm  $f_1$ 's locus of indifference prices is line  $p(w_1) + p(w_2) = 6$ . Thus, firm  $f_1$  has a demand type  $\{(1, 1)\}$ . Firm  $f_2$  has a superadditive valuation and thus has a demand type  $\{(1, 1), (1, 0), (0, 1)\}$ .<sup>18</sup> The firms' demand type  $\mathcal{D}$  is  $\{(1, 1), (1, 0), (0, 1)\}$ , which is unimodular since any matrix formed by any two of these vectors has determinant 0 or  $\pm 1$ .<sup>19</sup> This market fails the balancedness condition since the firm-worker hypergraph contains the odd-length cycle in Section 1.

### 3 Discrete many-to-one matching

This section studies basic discrete many-to-one matching. We mostly follow the notations of Roth and Sotomayor (1990).

### 3.1 Model

There is a finite set  $F$  of firms and a finite set  $W$  of workers. Let  $\emptyset$  be the null firm, representing not being matched with any firm. Each worker  $w \in W$  has a strict, transitive, and complete preference  $\succ_w$  over  $\tilde{F} := F \cup \{\emptyset\}$ . For any  $f, f' \in \tilde{F}$ , we write  $f \succ_w f'$  when  $w$  prefers  $f$  to  $f'$  according to  $\succ_w$ . We write  $f \succeq_w f'$  if either  $f \succ_w f'$  or  $f = f'$ . Let  $\succ_W$  denote the preference profile of all workers. Each firm  $f \in F$  has a strict, transitive and complete preference  $\succ_f$  over  $2^W$ . For any  $S, S' \subseteq W$ , we write  $S \succ_f S'$  when  $f$  prefers  $S$  to  $S'$  according to  $\succ_f$ . We write  $S \succeq_f S'$  if either  $S \succ_f S'$  or  $S = S'$ . Let  $\succ_F$  be the preference profile of all firms. A matching market can be summarized as a tuple  $\Gamma = (W, F, \succ_W, \succ_F)$ .

Let  $\text{Ch}_f$  be the choice function of  $f$  such that for any  $S \subseteq W$ ,  $\text{Ch}_f(S) \subseteq S$  and  $\text{Ch}_f(S) \succeq_f S'$  for any  $S' \subseteq S$ . By convention, let  $\text{Ch}_\emptyset(S) = S$  for all  $S \subseteq W$ . For any  $f \in F$ , any  $w \in W$ , and any nonempty set  $S \subseteq W$ , firm  $f$  is called acceptable to  $w$  if  $f \succ_w \emptyset$ ; worker set  $S$  is called acceptable to  $f$  if  $S \succ_f \emptyset$ ; we say that  $S$  is **satisfactory** to  $f$  if  $S = \text{Ch}_f(S)$ . For each  $f \in F$ , let  $\mathcal{A}_f$  be the collection of  $f$ 's acceptable sets, and  $\mathcal{Y}_f$  the collection of  $f$ 's satisfactory sets. We have  $\mathcal{Y}_f \subseteq \mathcal{A}_f$ : worker set  $S$  is acceptable to  $f$  if  $S$  is satisfactory to  $f$ , but not vice versa. For example, if  $f$  has preference  $\{w\} \succ \{w, w'\} \succ \emptyset$ , then  $\{w, w'\}$  is acceptable but not satisfactory to  $f$ . Firm  $f$ 's possible sets of employees are  $f$ 's satisfactory sets when we take  $f$ 's individual rationality into account.

**Definition 4.** A **matching**  $\mu$  is a function from the set  $\tilde{F} \cup W$  into  $\tilde{F} \cup 2^W$  such that for all  $f \in \tilde{F}$  and  $w \in W$ ,

- (i)  $\mu(w) \in \tilde{F}$ ;
- (ii)  $\mu(f) \in 2^W$ ;
- (iii)  $\mu(w) = f$  if and only if  $w \in \mu(f)$ .

We say that a matching  $\mu$  is **individually rational** if  $\mu(w) \succeq_w \emptyset$  for all  $w \in W$  and  $\mu(f) = \text{Ch}_f(\mu(f))$  for all  $f \in F$ . We say that a firm  $f$  and a subset of workers  $S \subseteq W$  form a **blocking coalition** that blocks  $\mu$  if  $f \succeq_w \mu(w)$  for all  $w \in S$ , and  $S \succ_f \mu(f)$ . Individual rationalities for workers mean that each matched worker prefer her current employer to being unmatched. Individual rationalities for firms mean that no firm wish to unilaterally drop any of its employees. A blocking coalition  $(f, S)$  blocks matching  $\mu$  if forming the coalition is weakly better for all members of the coalition and strictly better for at least one member. However, since preferences are strict and  $\mu(f) \neq S$ , firm  $f$  must get strictly better.

**Definition 5.** A matching  $\mu$  is **stable** if it is individually rational and there is no blocking coalition that blocks  $\mu$ .<sup>20</sup>

A firm has a **substitutable** preference if a worker chosen by the firm from a set of available workers will be chosen by the firm if the available set shrinks. More specifically, firm  $f$  has a substitutable preference if for any  $S, S'$  with  $S' \subset S \subseteq W$ ,  $w \in \text{Ch}_f(S)$  implies  $w \in \text{Ch}_f(S')$ . A stable matching exists when each firm has a substitutable preference; see Section 6 of [Roth and Sotomayor \(1990\)](#).<sup>21</sup> Stable matchings have been characterized as fixed points of certain operators; see [Adachi \(2000\)](#), [Fleiner \(2003\)](#), [Echenique and Oviedo \(2004, 2006\)](#), and [Hatfield and Milgrom \(2005\)](#), among others.

Complementarities in firms' preferences have been a critical issue for market practice. For example, the problem of matching with couples proposed by [Roth \(1984\)](#) has been widely studied; see [Klaus and Klijn \(2005\)](#), [Kojima et al. \(2013\)](#), [Ashlagi et al. \(2014\)](#), and [Nguyen and Vohra \(2018\)](#), among others. Complementarities are found to be compatible with stable matchings when there is a contin-

uum of workers (Che et al., 2019) or a continuum of agents on both sides of the market (Azevedo and Hatfield, 2018). For complementarities of other forms, see Echenique and Yenmez (2007), Pycia (2012), Nguyen and Vohra (2019), and Huang (2021a), among others. On the other hand, complementarities are prevalent in real life. Numerous real-life matching problems with complementarities still remain unresolved.

### 3.2 Balancedness

A firm-worker hypergraph is a hypergraph  $(F \cup W, \mathcal{E})$  in which each vertex  $j \in F \cup W$  is either a firm or a worker, and each edge contains one firm and its possible employees:  $\mathcal{E} = \{\{f\} \cup S \mid f \in F \text{ and } S \in \mathcal{Y}_f\}$ . Notice that a set of a firm’s possible employees is a satisfactory set for this firm in discrete matching.

**Theorem 2.** A stable matching exists in a discrete matching market if the firm-worker hypergraph is balanced.

This result follows from H22a’s integer feasibility program.<sup>22</sup> H22a constructed a fictitious market with divisible workers and a continuous choice function for each firm. A stable matching (possibly fractional) is guaranteed to exist in this market according to an existence theorem of Che et al. (2019).<sup>23</sup> Each stable integral matching of the fictitious market corresponds to a stable matching of the original market. H22a showed that a stable fractional matching can always be transformed into a stable integral one if there is an integral vertex on a nonempty polytope  $\{\mathbf{z} \mid B\mathbf{z} = \mathbf{1}, \mathbf{z} \geq 0\}$  in which  $B$  is a 0-1 matrix, and each column of  $B$  with

at least two ones is the indicator vector of an edge in the firm-worker hypergraph. See Section 3 of H22a for the construction of the polytope. If the firm-worker hypergraph is balanced, the existence of a stable integral matching follows from a result of [Fulkerson et al. \(1974\)](#).<sup>24</sup> Therefore, a stable matching exists in the original market if the firm-worker hypergraph is balanced.

We have an immediate corollary from Theorem 2: A marriage market always has a stable matching due to the balancedness of the woman-man graphs (or man-woman graphs). As illustrated in Section 1.2, a woman-man graph of any marriage market does not have any odd-length cycle since each cycle of a woman-man graph consists of several man-woman-man paths.

**Example 3.** Consider the following firms' preference profile.

$$\begin{aligned}
 f_1 &: \{w_1, w_2\} \succ \{w_1\} \succ \emptyset \\
 f_2 &: \{w_1\} \succ \{w_3\} \succ \emptyset \\
 f_3 &: \{w_2, w_3\} \succ \emptyset
 \end{aligned} \tag{3.1}$$

This profile has the same balanced firm-worker hypergraph as market (2.1). We thus know that (3.1) admits a stable matching for all possible preferences of workers. The odd-length cycle (2.2) in this market seems to be an “instability cycle” as the cycle of (1.1) if we assume the following workers' preferences.

$$w_1 : f_1 \succ f_2 \qquad w_2 : f_3 \succ f_1 \qquad w_3 : f_2 \succ f_3$$

We can then construct a similar cycle of blocking process as illustrated in (1.1). However, this cycle breaks down if we match  $f_1$  with  $\{w_1, w_2\}$  and match  $f_2$  with  $\{w_3\}$  (or match  $f_2$  with  $\{w_1\}$  and match  $f_3$  with  $\{w_2, w_3\}$ ).

This section's basic model of discrete matching can be generalized to allow dis-

crete wages (Kelso and Crawford, 1982) or contracts (Hatfield and Milgrom, 2005) between firms and workers for real-life applications. The model of matching with contracts allows firms and workers to bargain over multidimensions such as wages, insurance, and retirement plans. Echenique (2012) showed that firms and workers essentially bargain over one dimension when contracts are not complements and that Hatfield and Kojima (2010) exploit the framework with contracts in full generality. The latter paper’s bilateral and unilateral substitutes conditions permit some patterns of complementarities among contracts and apply to cadet-branch matching (Sönmez, 2013 and Sönmez and Switzer, 2013) and affirmative actions in school choice (Kominers and Sönmez, 2016). See also Hatfield and Kominers (2015). H22a and this paper provide opportunities to study different patterns of complementarities among contracts.

### 3.3 Relation to other conditions

As illustrated by firms’ preference profile (3.1), our balancedness condition is independent of the substitutability condition. In a companion work (Huang, 2022b), we provide a refinement of Theorem 2 in a market with scale economies. We assume scale economies such that the union of any two disjoint satisfactory sets is also satisfactory for the firm. A stable matching exists in this setting if the hypergraph whose edges are firms’ satisfactory sets is balanced.

Balancedness of the firm-worker hypergraph relates to H22a’s total unimodularity condition because both conditions are obtained from H22a’s integer feasibility program. A matrix is totally unimodular if every square submatrix has determinant 0 or  $\pm 1$ . In particular, each entry in a totally unimodular matrix is 0 or  $\pm 1$ . A set of vectors is called totally unimodular if the matrix that has these vectors as columns is totally unimodular. H22a adopted the notion of demand type from Baldwin and Klempere (2019) to represent how a firm’s demand changes as its

available set expands; then, H22a showed that stable matchings exist when firms' demand type is totally unimodular. Let  $\text{ind}(S)$  be the indicator vector of set  $S$ .

**Definition 6.** For each  $f \in F$ , let  $\mathcal{D}_f = \{\mathbf{d} \in \{0,1\}^W \mid \mathbf{d} \neq \mathbf{0} \text{ and } \mathbf{d} = \text{ind}(\text{Ch}_f(S)) - \text{ind}(\text{Ch}_f(S')) \text{ for some } S, S' \text{ such that } S' \subset S \subseteq W\}$  be  $f$ 's demand type. The demand type for the firms' preference profile is  $\mathcal{D} = \cup_{f \in F} \mathcal{D}_f$ .

For example, consider the following firms' preference profile.

$$\begin{aligned} f_1 : \{w_1, w_2, w_3\} \succ \{w_1, w_3\} \succ \{w_3\} \succ \emptyset \\ f_2 : \{w_2, w_3\} \succ \emptyset \end{aligned} \tag{3.2}$$

Firm  $f_1$ 's demand changes from  $\{w_3\}$  to  $\{w_1, w_2, w_3\}$  when its available set expands from  $\{w_3\}$  to  $\{w_1, w_2, w_3\}$ , thus, firm  $f_1$ 's demand type contains  $(1, 1, 0)$ . A firm's demand type also contains all of the firm's satisfactory sets since each satisfactory set corresponds to the change of the firm's demand from  $\emptyset$  to this satisfactory set. Hence, the firms' demand type  $\mathcal{D}$  of (3.2) is not totally unimodular since it contains  $(1, 1, 0)$ ,  $(1, 0, 1)$ ,<sup>25</sup> and  $(0, 1, 1)$ <sup>26</sup> (the matrix formed by these vectors has determinant 2). However, (3.2) has the same balanced firm-worker hypergraph as (2.9).

The above example indicates that balancedness of the firm-worker hypergraph does not imply total unimodularity of the firms' demand type. We can see that the latter does not imply the former from the following firms' preferences.

$$f_1 : \{w_1, w_2\} \succ \emptyset \qquad f_2 : \{w_1, w_2\} \succ \{w_1\} \succ \{w_2\} \succ \emptyset \tag{3.3}$$

(3.3) has a totally unimodular demand type:  $\{(1, 1), (1, 0), (0, 1)\}$  (because any ma-

trix formed by two of these vectors has determinant 0 or  $\pm 1$ ), but its firm-worker hypergraph contains the odd-length cycle of the hypergraph in Section 1. Therefore, the above two examples indicate that balancedness of the firm-worker hypergraph is independent of total unimodularity of the firms' demand type.

We provide a more technical condition to subsume both the balancedness condition and the total unimodularity condition.

**Proposition 1.** A stable matching exists in a discrete matching market if the firm-worker hypergraph does not contain any odd-length cycle satisfying both the following two conditions.

- (i) Each edge of the cycle contains exactly two vertices of the cycle;
- (ii) For each  $f \in F$  and each pair  $S, S'$  such that both  $\{f\} \cup S$  and  $\{f\} \cup S'$  are edges of the cycle,  $S = \text{Ch}_f(S \cup S')$  or  $S' = \text{Ch}_f(S \cup S')$ .

This generalization is due to a feature of H22a's polytope  $\{\mathbf{z} \mid B\mathbf{z} = \mathbf{1}, \mathbf{z} \geq 0\}$  in which integral vertices correspond to stable matchings. According to Lemma 2.1 of [Fulkerson et al. \(1974\)](#), a stable matching exists if matrix  $B$  is balanced. Moreover, for each  $f \in F$  and each pair  $S, S'$  such that both  $\{f\} \cup S$  and  $\{f\} \cup S'$  are columns of  $B$ ,  $S = \text{Ch}_f(S \cup S')$  or  $S' = \text{Ch}_f(S \cup S')$  holds. This is because  $S$  and  $S'$  are the sets consumed in a consumption process of H22a; see Section 3 of H22a. We obtain Proposition 1 by applying this feature of matrix  $B$ .

The condition of Proposition 1 is obviously weaker than balancedness of the firm-worker hypergraph. It is also a generalization of total unimodularity of the firms' demand type.

**Proposition 2.** The firm-worker hypergraph satisfies the condition of Proposition 1 if the firms' demand type  $\mathcal{D}$  is totally unimodular.

For example, although the firm-worker hypergraph of preference profile (3.3) fails balancedness, this profile satisfies the condition of Proposition 1. The unique

odd-length cycle of its firm-worker hypergraph (which is the same as the cycle of the hypergraph in Section 1) contains  $\{f_2, w_1\}$  and  $\{f_2, w_2\}$ , however, neither  $\{w_1\} = \text{Ch}_{f_2}(\{w_1, w_2\})$  nor  $\{w_2\} = \text{Ch}_{f_2}(\{w_1, w_2\})$  holds.

## 4 Application

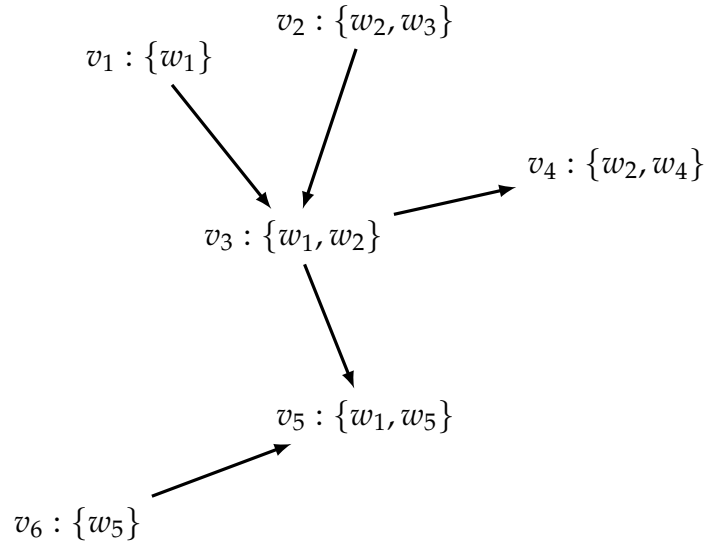
This section presents an application of our balancedness condition based on a structure called **technology roadmap**, which generalizes the structure of H22a’s technology tree. A technology roadmap is a directed tree<sup>27</sup> in which each vertex represents a technology, and each edge is an upgrade from one technology to another. Each technology demands a set of workers to implement. The technology roadmap generalizes H22a’s technology tree in two aspects: (i) A technology tree is a rooted tree, whereas a technology roadmap does not necessarily have a root. (ii) An upgrade in a technology tree requires more workers such that the worker set expands along with the edge direction, whereas a technology roadmap does not impose restrictions on worker sets demanded by the technologies.<sup>28</sup> In a technology tree of H22a, there is only one evolutionary path toward a technology. However, the technology roadmap allows multiple evolutionary paths toward a technology. We illustrate this with the following example.

**Example 4.** Consider a market with three firms and five workers. A technology roadmap is depicted as follows.

Each vertex from  $\{v_1, \dots, v_6\}$  represents a technology. A technology can have multiple evolutionary paths: Technology  $v_3$  can be upgraded from technology  $v_1$  or  $v_2$ ; technology  $v_5$  can be upgraded from technology  $v_3$  or  $v_6$ . Each technology requires the set of workers on the right to implement. Unlike H22a's technology tree, there is no restriction on worker sets demanded by the two technologies of an upgrade. Each firm possesses some of the technologies and has a preference order over the technologies it possesses, which induces its preference over the sets of workers required for the technologies.

H22a and [Huang \(2021b, 2022b\)](#) assume each worker to be a specialist in different forms over a technology tree. We instead assume that both firms and workers are specialized in a technology roadmap. Specializations of workers and firms are captured by the scopes of technologies they engage in and possess, respectively. A **technology path** in a technology roadmap is either a directed path or a single vertex.<sup>29</sup> We say that a worker engages in a technology path if each technology of the path demands her. We assume each worker to be a specialist in the following

<sup>29</sup>A directed path in a directed graph is a path whose edges are all oriented in the same direction.

form.

Each worker is a specialist who engages in only one  
technology path. (4.1)

For instance, in the above technology roadmap, worker  $w_1$  engages in the technology path that has technologies  $v_1$ ,  $v_3$ , and  $v_5$  as vertices. Worker  $w_2$  engages in the technology path that has technologies  $v_2$ ,  $v_3$ , and  $v_4$  as vertices. Condition (4.1) also holds for other workers. A technology path is said to be possessed by firm  $f$  if firm  $f$  possesses all the technologies of the technology path. We assume firms to be specialized over the technology roadmap in the following form.

Firms are specialized such that each firm possesses only one  
technology path, and different firms possess disjoint technology  
paths. (4.2)

For instance, suppose there are three firms: Firm  $f_1$  possesses technologies  $v_1$ ,  $v_3$ , and  $v_4$ ; firm  $f_2$  possesses technology  $v_2$ ; and firm  $f_3$  possesses technologies  $v_5$  and  $v_6$ . Then, condition (4.2) holds for all firms. We allow each firm to have an arbitrary preference over its technologies, which induces the firm's preference in the matching market. In the framework of discrete matching, each firm can have an arbitrary preference order over the worker sets demanded by its technologies.

For example, the firms may have the following preferences in Example 4.<sup>30</sup>

$$\begin{aligned}
f_1 &: \{w_1, w_2\} \succ \{w_2, w_4\} \succ \{w_1\} \succ \emptyset \\
f_2 &: \{w_2, w_3\} \succ \emptyset \\
f_3 &: \{w_1, w_5\} \succ \{w_5\} \succ \emptyset
\end{aligned} \tag{4.3}$$

In the framework of matching with continuous transfers, each firm can have an arbitrary valuation on the collection of worker sets demanded by its technologies. This section shows that the firm-worker hypergraphs in both markets are balanced if the firms are specialized over a technology roadmap where each worker is a specialist. For instance, our result indicates that market (4.3) admits a stable matching for all possible preferences of workers; we also know that the market with continuous transfers and the same acceptable sets as (4.3) has a stable matching. To see the roles of (4.1) and (4.2), consider the following two roadmaps.

$$v_1 : \{w_1\} \longrightarrow v_2 : \{w_2\} \longrightarrow v_3 : \{w_1, w_2\}$$

$$v_1 : \{w_1\} \longrightarrow v_2 : \{w_1, w_2\} \longrightarrow v_3 : \{w_2\}$$

The first roadmap fails (4.1) since worker  $w_1$  engages in two technology paths that are two single technologies. This roadmap can induce the firm-worker hypergraph in Section 1 when firm  $f_1$  possesses technology  $v_3$  and firm  $f_2$  possesses technologies  $v_1$  and  $v_2$ . The second roadmap satisfies (4.1), but firms are not specialized in the roadmap if (i) firm  $f_1$  possesses technology  $v_2$ , and firm  $f_2$  possess technologies  $v_1$  and  $v_3$ , or (ii) firm  $f_1$  possesses technology  $v_2$ , and firm  $f_2$  possess all three technologies. In case (i), firm  $f_2$  possesses two technology paths. In case (ii), firms  $f_1$  and  $f_2$  share a common technology  $v_2$ . Both (i) and (ii) can give rise to

<sup>30</sup>We also allow a worker set demanded by a technology to be unacceptable to a firm who possesses this technology. See Definition 8.

the cycle of the firm-worker hypergraph in Section 1.

Although we assume that no two firms share a common technology, firms can still have common acceptable sets since the same set of workers can implement multiple technologies. For example, consider the following technology roadmap.

$$v_1 : \{w_1, w_2\} \longrightarrow v_2 : \{w_1, w_2\}$$

Suppose  $f_1$  possesses  $v_1$ , and  $f_2$  possesses  $v_2$ , then  $\{w_1, w_2\}$  can be acceptable to both firms.

Formally, a **technology roadmap**  $RM = (T, W)$  is a directed tree  $T = (V, E)$  defined on a set of workers  $W$ .  $V$  is a finite set of vertices in which each vertex represents a **technology**. Each technology demands a subset of workers  $W^v \subseteq W$  to implement. We say that worker  $w$  engages in technology  $v$  if  $w \in W^v$ . A **technology path**  $P = (V^P, E^P)$  of a technology roadmap  $RM = (T, W)$  is either a directed path or a vertex (i.e.,  $|V^P| = 1$  and  $E^P = \emptyset$ ) of  $T$ . A worker is called a **specialist** if she engages in only one technology path.

**Definition 7.** In a technology roadmap  $RM = (T, W)$ , let  $G^w = (V^w, E^w)$  be the subgraph of  $T = (V, E)$  with  $V^w = \{v | w \in W^v\}$  and  $E^w = \{vv' | v, v' \in V^w \text{ and } vv' \in E\}$ . Worker  $w$  is called a **specialist** in  $RM$  if  $G^w$  is a technology path.

Given a discrete matching market  $\Gamma$  or a market  $\Phi$  with continuous transfers, we assume the firms to be specialized over a technology roadmap in form (4.2).

**Definition 8.** Firms are **specialized** over a technology roadmap  $RM = (T, W)$  if there is a collection of technology paths  $\{P^f = (V^f, E^f)\}_{f \in F}$  of  $T$  such that<sup>31</sup>

<sup>31</sup>Such collection may not be unique. For example, suppose there is only one firm with only one acceptable set  $\{w\}$ . The firm is specialized over the technology roadmap  $v_1 : \{w\} \rightarrow v_2 : \{w\}$  where the firm may possess  $v_1$  or  $v_2$ .

- (i) for each  $f \in F$ ,  $S \neq \emptyset$  and  $S \in \mathcal{A}_f$  implies  $S = W^v$  for some  $v \in V^f$ ;
- (ii)  $V^f \cap V^{f'} = \emptyset$  for any  $f \neq f'$ .

Condition (i) requires each firm to possess only one technology path. Notice that this condition allows each firm to have an arbitrary preference over the technologies it possesses. For example, firm  $f_1$  is allowed to have only one acceptable set  $\{w_1\}$  in Example 4 when it possesses technologies  $v_1$ ,  $v_2$ , and  $v_4$ . Condition (ii) requires different firms to possess disjoint technology paths; thus, no two firms possess a common technology.

**Theorem 3.** The firm-worker hypergraph is balanced if the firms are specialized over a technology roadmap in which each worker is a specialist.

This result applies to both discrete matching and matching with continuous transfers. According to Theorem 1 and 2, a stable matching exists in both problems when firms are specialized over a technology roadmap in which each worker is a specialist. Moreover, this application allows demand types that are not unimodular. For example, consider the following technology roadmap.

$$v_1 : \{w_3\} \longrightarrow v_2 : \{w_1, w_3\} \longrightarrow v_3 : \{w_1, w_2, w_3\} \longrightarrow v_4 : \{w_2, w_3\}$$

Firms' preference profiles (2.9) and (3.2) can be induced from this roadmap if firm  $f_1$  possesses technologies  $v_1, v_2$ , and  $v_3$ , and firm  $f_2$  possesses technology  $v_4$ . All workers are specialists in this roadmap, and the two firms are specialized over this roadmap in both markets (2.9) and (3.2). Recall that the two markets have the same balanced firm-worker hypergraph, but neither has a unimodular demand type.

## 5 Appendix

### 5.1 Proofs for Section 2

*Proof of Lemma 1*

(ii) $\Leftrightarrow$ (iii) follows from Proposition 1 of [Tran and Yu \(2019\)](#). (i) $\Leftrightarrow$ (ii) follows from the fact that the core is equivalent to the set of equilibria in an exchange economy when each agent has a quasilinear utility. We provide a formal proof of (i) $\Leftrightarrow$ (ii) below.

(i) $\Rightarrow$ (ii). Let  $(\mu, \mathbf{p})$  be a stable matching in  $\Phi$ . Let  $\bar{\mathbf{p}} \in R^H$  be the price such that

$$\bar{\mathbf{p}}(fw) = \begin{cases} \mathbf{p}(w), & \text{if } \mu(w) = f; \\ U_w(\mu(w), \mathbf{p}) - v_w(f), & \text{if } \mu(w) \neq f \text{ and } f \in A_w; \\ 0, & \text{otherwise.} \end{cases} \quad (5.1)$$

Let  $\{\mathbf{x}^j\}_{j \in J}$  be the allocation such that

$$\mathbf{x}^j(fw) = \begin{cases} 1, & \text{if } j = f \text{ and } w \in \mu(f); \\ -1, & \text{if } j = w \text{ and } \mu(w) = f; \\ 0, & \text{otherwise.} \end{cases}$$

We have  $\sum_{j \in J} \mathbf{x}^j = \mathbf{0}$  since  $w \in \mu(f)$  if and only if  $\mu(w) = f$ .  $\bar{\mathbf{p}}$  is constructed in a way such that each worker obtains the same utility no matter which acceptable firm she matches; and thus,  $\mathbf{x}^j \in D_j(\bar{\mathbf{p}})$  for each  $j \in W$ . Suppose there exists  $f \in F$  such that  $\mathbf{x}^f \notin D_f(\bar{\mathbf{p}})$ . Let  $\mathbf{x}'$  be an element in  $D_f(\bar{\mathbf{p}})$ , then  $\bar{v}_f(\mathbf{x}') - \bar{\mathbf{p}} \cdot \mathbf{x}' > \bar{v}_f(\mathbf{x}^f) - \bar{\mathbf{p}} \cdot \mathbf{x}^f$ . According to our definition of  $\bar{A}_f$ ,  $f \in A_w$  for each  $w \in \mathbf{x}'_W$ . Let  $\mathbf{p}' \in \mathbb{R}^W$  be the price such that  $\mathbf{p}'(w) = \bar{\mathbf{p}}(fw)$  for each  $w \in \mathbf{x}'_W$ . Thus,  $f$  and  $\mathbf{x}'_W$  form a blocking coalition under price  $\mathbf{p}'$  for  $(\mu, \mathbf{p})$  in  $\Phi$ :  $f$  is strictly better off and utilities remain unchanged for each worker from  $\mathbf{x}'_W$ . A contradiction. Therefore,



$\mathbf{x}^j \in D_j(\bar{\mathbf{p}})$  for each  $j \in F$ , and we know that  $\bar{\mathbf{p}}$  and  $\{\mathbf{x}^j\}_{j \in J}$  form an equilibrium in  $\bar{\Phi}$ .

(ii) $\Rightarrow$ (i). Let  $(\bar{\mathbf{p}}, \{\mathbf{x}^j\}_{j \in J})$  be an equilibrium in  $\bar{\Phi}$ . We increase  $\bar{\mathbf{p}}(fw)$  of  $\bar{\mathbf{p}}$ , where  $f \in A_w$  and  $fw$  is not sold at this equilibrium, such that selling  $fw$  is in  $D_w(\bar{\mathbf{p}}')$ .

$$\bar{\mathbf{p}}'(fw) = \begin{cases} \bar{\mathbf{p}}(fw), & \text{if } \mathbf{x}_F^w = \{f\}; \\ \bar{v}_w(\mathbf{x}^w) - \bar{\mathbf{p}} \cdot \mathbf{x}^w - v_w(f), & \text{if } f \in A_w \text{ and } f \notin \mathbf{x}_F^w. \\ 0, & \text{if } f \notin A_w. \end{cases}$$

then  $(\bar{\mathbf{p}}', \{\mathbf{x}^j\}_{j \in J})$  is also an equilibrium in  $\bar{\Phi}$ . Let  $(\mu, \mathbf{p})$  be the matching in  $\Phi$  such that  $\mu(f) = \mathbf{x}_W^f$  for each  $f \in F$ , and

$$\mu(w) = \begin{cases} f, & \text{if } \mathbf{x}_F^w = \{f\}, \\ \emptyset, & \text{if } \mathbf{x}^w = \mathbf{0}, \end{cases} \quad \mathbf{p}(w) = \begin{cases} \bar{\mathbf{p}}(fw), & \text{if } \mathbf{x}_F^w = \{f\}, \\ 0, & \text{if } \mathbf{x}^w = \mathbf{0}, \end{cases}$$

for each  $w \in W$ .

For each  $j \in F \cup W$ ,  $\mathbf{x}^j \in D^j(\bar{\mathbf{p}})$  implies that  $(\mu, \mathbf{p})$  is individually rational for  $j$  in  $\Phi$ . Suppose  $(f, S)$  blocks  $(\mu, \mathbf{p})$  under price  $\mathbf{p}^*$ . We know that  $S \neq \mu(f)$  since the aggregate utility from coalition  $(f, \mu(f))$  is the same under all prices and thus can not improve on  $(\mu, \mathbf{p})$ .

Since workers from  $S$  are weakly better in coalition  $(f, S)$  at  $\mathbf{p}^*$  than in matching  $(\mu, \mathbf{p})$ , we have  $\mathbf{p}^*(w) \geq \bar{\mathbf{p}}'(fw)$  for each  $w \in S$ . Let  $\mathbf{p}' \in \mathbb{R}^W$  be the price with  $\mathbf{p}'(w) = \bar{\mathbf{p}}'(fw)$  for all  $w \in W$ . The aggregate utility from coalition  $(f, S)$  at  $\mathbf{p}'$  is the same as at  $\mathbf{p}^*$  while all workers from  $S$  have the same utilities in coalition  $(f, S)$  at  $\mathbf{p}'$  as in matching  $(\mu, \mathbf{p})$ . Thus, firm  $f$  is strictly better in coalition  $(f, S)$  at  $\mathbf{p}'$  than in matching  $(\mu, \mathbf{p})$ . We thus know that  $(f, S)$  also blocks  $(\mu, \mathbf{p})$  at  $\mathbf{p}'$ . Consequently, in exchange economy  $\bar{\Phi}$  at price  $\bar{\mathbf{p}}'$ , firm  $f$  would be strictly better off by purchasing labors from  $S$  than from  $\mu(f)$ . We then have  $\mathbf{x}^f \notin D_f(\bar{\mathbf{p}}')$  in  $\bar{\Phi}$ . A contradiction. Therefore,  $(\mu, \mathbf{p})$  is a stable matching.

### *Proof of Lemma 2*

We define the agent-good hypergraph in  $\overline{\Phi}$  as a hypergraph  $(J, \overline{\mathcal{E}})$  in which the vertex set is  $J$ , and each edge contains one agent and one of the agent's acceptable bundles:  $\overline{\mathcal{E}} \equiv \{\{j\} \cup S \mid j \in J, S \neq \emptyset, \text{ and } \text{ind}(S) \in \overline{A}_j\}$ , where  $\text{ind}(S)$  is the indicator vector of  $S$ .

Every submatrix of  $M$  with two nonzero entries per row and column corresponds to a cycle in the agent-good hypergraph with no edge containing more than two vertices of the cycle. A cycle of this type in the agent-good hypergraph consists of the following three types of paths.

(i) Length-1 path  $(fw, \{f, fw, \dots, fw'\}, fw')$ . A path of this type corresponds to a length-1 path  $(w, \{f, w, \dots, w'\}, w')$  in the firm-worker hypergraph of  $\Phi$ .

(ii) Length-2 path  $(fw, \{fw, w\}, w, \{w, f'w\}, f'w)$ . A path of this type is not shown in the firm-worker hypergraph of  $\Phi$ .

(iii) Length-2 path  $(fw, \{fw, \dots, f\}, f, \{f, \dots, fw'\}, fw')$ . A path of this type corresponds to a length-2 path  $(w, \{w, \dots, f\}, f, \{f, \dots, w'\}, w')$  in the firm-worker hypergraph of  $\Phi$ .

If a submatrix of  $M$  with two nonzero entries per row and column corresponds to a cycle in the agent-good hypergraph with  $l$  type-(i) paths,  $m$  type-(ii) paths, and  $n$  type-(iii) paths, then the sum of the entries of the submatrix is  $2l + 4n$ , and the cycle corresponds to a length- $(l + 2n)$  cycle of the firm-worker hypergraph with no edge containing more than 2 vertices. If the firm-worker hypergraph is balanced,  $l + 2n$  must be even and  $2l + 4n$  must be a multiple of 4. Therefore, balancedness of the firm-worker hypergraph implies balancedness of  $M$ .

## **5.2 Proofs for Section 3**

### *Proof of Proposition 2*

Suppose the firm-worker hypergraph contains an odd-length cycle satisfying

the two conditions in Proposition 1. Let  $M$  be the incidence matrix of the cycle. For example,  $M$  is the following matrix for the cycle in market (1.1).

	$\{f_1, w_1\}$	$\{f_1, w_2\}$	$\{w_1, w_2\}$
$f_1$	1	1	0
$w_1$	1	0	1
$w_2$	0	1	1

Condition (i) of Proposition 1 implies that  $M$  is a matrix of odd order with exactly two 1s in each row and column, and thus, we have  $|M| = 2$  or  $-2$ . For each  $f$ , let  $M_f$  be the submatrix whose columns have a component 1 for  $f$ , let  $m_f^1, m_f^2, \dots$  denote the columns of  $M_f$ , and let  $S_f^1, S_f^2, \dots$  denote  $f$ 's satisfactory sets corresponding to  $m_f^1, m_f^2, \dots$ , respectively. According to Condition (ii) of Proposition 1, we assume  $S_f^j = Ch_f(S^j \cup S^k)$  if  $j > k$ . For example, for the above matrix,

$$M_{f_1} = \begin{pmatrix} 1 & 1 \\ 0 & 1 \\ 1 & 0 \end{pmatrix} \text{ in which } m_{f_1}^1 = \begin{pmatrix} 1 \\ 0 \\ 1 \end{pmatrix} \text{ and } m_{f_1}^2 = \begin{pmatrix} 1 \\ 1 \\ 0 \end{pmatrix}, \quad M_{f_2} = \begin{pmatrix} 0 \\ 1 \\ 1 \end{pmatrix}.$$

For each  $f$ , let  $M'_f$  be the matrix that consists of columns  $m_f^1, m_f^2 - m_f^1, m_f^3 - m_f^1, \dots$ , and  $M'$  the matrix that consists of all  $M'_f$ . For example, for the above matrices,

$$M'_{f_1} = \begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 1 & -1 \end{pmatrix}, \quad M'_{f_2} = \begin{pmatrix} 0 \\ 1 \\ 1 \end{pmatrix}, \quad \begin{array}{c|ccc} & \{f_1, w_1\} & \{f_1, w_2\} & \{w_1, w_2\} \\ \hline f_1 & 1 & 0 & 0 \\ w_1 & 0 & 1 & 1 \\ w_2 & 1 & -1 & 1 \end{array} = M'.$$

We have  $|M'| = |M|$  since subtracting one column from another column leaves the determinant unchanged. For each  $f$ , if column  $m_f^1$  contains a component 1 for firm  $f$ , we remove both the column and the row containing this component from  $M'$ . The remaining matrix  $M''$  is a submatrix of the matrix formed by the elements

of the firms' demand type  $\mathcal{D}$ . Since  $|M''| = |M'| \neq \pm 1$ ,<sup>32</sup> the firms' demand type  $\mathcal{D}$  is not totally unimodular. For instance, in the above example, we remove the first row and the first column from  $M'$ , both containing the component for  $f_1$ . We obtain the remaining matrix:

$$M'' = \begin{pmatrix} 1 & 1 \\ -1 & 1 \end{pmatrix}$$

The firms' demand type  $\mathcal{D}$  is  $\{(1,1), (1,0), (0,1), (1,-1)\}$  in market (1.1). The columns of  $M''$  are from  $\mathcal{D}$ .

### 5.3 Proofs for Section 4

*Proof of Theorem 3*

Suppose there exists the following cycle of length  $k \geq 3$  in the firm-worker hypergraph:

$$(j(1), E^1, j(2), E^2, \dots, j(k), E^k, j(1)) \tag{5.2}$$

where  $k$  is odd, and no edge of the cycle contains more than two vertices of the cycle. For each  $i \in \{1, 2, \dots, k\}$ , let  $P^{j(i)}$  be the directed path of  $T$  for  $j(i)$  defined in Definition 7 if  $j(i)$  is a worker; let all  $P^{j(i)}$  with  $j(i) \in F$  be from one collection of technology paths defined in Definition 8. Based on this collection of technology paths we select, we can use different technologies of  $T$  to represent different edges of the firm-worker hypergraph: Since no two firms possess a common technology, edge  $E^i$  that involves firm  $f$  corresponds to a vertex on firm  $f$ 's technology path.<sup>33</sup>

<sup>32</sup> $|M''| = |M'|$  holds since each row we remove contains exactly one 1 and these 1s lie on a diagonal of  $M'$  after permutating the columns of  $M'$  properly.

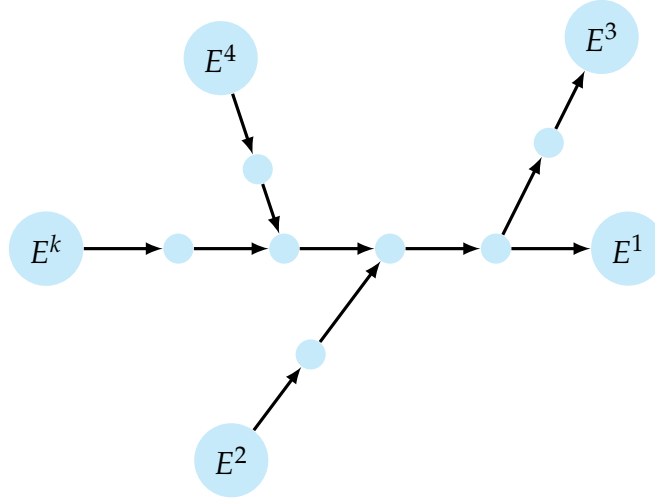
<sup>33</sup>Recall that the firm-worker hypergraph in discrete matching is defined on firms' satisfactory sets. Since each firm's satisfactory sets are also acceptable to the firm, each edge of the firm-worker hypergraph corresponds to a vertex of the roadmap.

Thus, we use the term vertex  $E^i$  to mean the vertex corresponding to  $E^i$  on  $T$  for each  $i \in \{1, \dots, k\}$ . Since  $j(1)$  belongs to both  $E^k$  and  $E^1$ , vertex  $E^k$  and vertex  $E^1$  both lie on  $P^{j(1)}$ . Without loss of generality, we assume that the directed path between vertex  $E^k$  and vertex  $E^1$  points from vertex  $E^k$  to vertex  $E^1$ . Since  $T$  is a tree in which any two vertices are connected by exactly one path, the other half of cycle (5.2),  $(E^1, j(2), E^2, \dots, j(k), E^k)$ , must go through vertex  $E^1$  to reach vertex  $E^k$  in  $P^{j(1)}$  and in the opposite direction of  $P^{j(1)}$ . Thus, we know that there is  $(E^t, j(t+1), E^{t+1})$  with  $t \in \{1, \dots, k-1\}$  such that vertex  $E^1$  lies on the  $E^t E^{t+1}$  segment of  $P^{j(t+1)}$ . If  $t \neq 1$ , then  $j(t+1)$  belongs to  $E^1$ ,  $E^t$ , and  $E^{t+1}$ . A contradiction. Hence,  $t = 1$ , and we have  $t+1 = 2 \neq k$  since  $k \geq 3$ . We also know that vertex  $E^1$  is the terminal vertex of the  $E^1 E^2$  segment of  $P^{j(2)}$ .

If vertex  $E^2$  lies on  $P^{j(1)}$ , then  $j(1)$  belongs to  $E^1$ ,  $E^2$ , and  $E^k$ . A contradiction. If vertex  $E^k$  lies on  $P^{j(2)}$ , then  $j(2)$  belongs to  $E^1$ ,  $E^2$ , and  $E^k$ . A contradiction. Hence, the  $E^1 E^2$  segment of  $P^{j(2)}$  is a directed path from vertex  $E^2$  to vertex  $E^1$  and joining the  $E^k E^1$  segment of  $P^{j(1)}$  at some vertex other than vertex  $E^k$  or  $E^1$ . We thus know that vertex  $E^2$  and vertex  $E^k$  are connected by a path that is not a directed path. Since  $j(k)$  belongs to both  $E^{k-1}$  and  $E^k$ , vertex  $E^{k-1}$  and vertex  $E^k$  both lie on  $P^{j(k)}$  and are thus connected by a directed path. Therefore,  $k-1 \neq 2$ , and  $k \geq 5$ . The structure of the technology roadmap is illustrated below.<sup>34</sup>

<sup>34</sup>This figure shows one possible structure for the roadmap under the assumption that there is cycle (5.2) in the firm-worker hypergraph. There are also other possible structures for the roadmap.



Let  $T^t$  be the union of the segment  $E^k E^1$  of  $P^{j(1)}$  and all the segments  $E^{x-1} E^x$  of  $P^{j(x)}$  for all  $x \in \{2, \dots, t\}$ . We assume inductively that, for some  $s \in \{2, \dots, k-3\}$  and  $s$  is even,  $T^s$  is a directed tree that has  $E^k, E^1, E^2, \dots, E^s$  as leaves where  $E^x$  with odd  $x \in \{1, \dots, s-1\}$  are the terminal vertices of the edges that connect them, and  $E^k$  and  $E^x$  with even  $x \in \{2, \dots, s\}$  are the initial vertices of the edges that connect them.

Since vertex  $E^k$  and vertex  $E^s$  is connected by a path in  $T^s$  where  $E^s$  is a leaf and the initial vertex of the edge that connects  $E^s$ , the other half of cycle (5.2),  $(E^s, j(s+1), E^{s+1}, \dots, j(k), E^k)$ , must go through vertex  $E^s$  in  $P^{j(s)}$  and in the same direction of  $P^{j(s)}$ . Thus, we know that there is  $(E^x, j(x+1), E^{x+1})$  with  $x \in \{s, \dots, k-1\}$  such that vertex  $E^s$  lies on  $P^{j(x+1)}$ . If  $x \neq s$ , then  $j(x+1)$  belongs to  $E^s, E^x$ , and  $E^{x+1}$ . A contradiction. Hence,  $x = s$  and we know that vertex  $E^s$  is the initial vertex of the  $E^s E^{s+1}$  segment of  $P^{j(s+1)}$ .

If vertex  $E^{s+1}$  lies on  $P^{j(x)}$  with  $x \in \{1, \dots, s\}$ , then  $j(x)$  belongs to  $E^{x-1}$  (or  $E^k$  if  $x = 1$ ),  $E^x$ , and  $E^{s+1}$ . A contradiction. If vertex  $E^x$  with  $x \in \{1, \dots, s-1\} \cup \{k\}$  lies on  $P^{j(s+1)}$ ,  $j(s+1)$  belongs to  $E^x, E^s$ , and  $E^{s+1}$ . A contradiction. Hence, the  $E^s E^{s+1}$  segment of  $P^{j(s+1)}$  leaves  $T^s$  at some vertex other than  $E^1, E^2, \dots, E^s$  or  $E^k$ . Thus,  $T^{s+1}$  is a directed tree that has  $E^k, E^1, E^2, \dots, E^{s+1}$  as leaves where  $E^x$  with odd  $x \in \{1, \dots, s+1\}$  are the terminal vertices of the edges that connect them, and

$E^k$  and  $E^x$  with even  $x \in \{2, \dots, s\}$  are the initial vertices of the edges that connect them.

Since vertex  $E^k$  and vertex  $E^{s+1}$  is connected by a path in  $T^{s+1}$  where  $E^{s+1}$  is a leaf and the terminal vertex of the edge that connects  $E^{s+1}$ , the other half of cycle (5.2),  $(E^{s+1}, j(s+2), E^{s+2}, \dots, j(k), E^k)$ , must go through vertex  $E^{s+1}$  in  $P^{j(s+1)}$  and in the opposite direction of  $P^{j(s+1)}$ . Thus, we know that there is  $(E^y, j(y+1), E^{y+1})$  with  $y \in \{s+1, \dots, k-1\}$  such that vertex  $E^{s+1}$  lies on  $P^{j(y+1)}$ . If  $y \neq s+1$ , then  $j(y+1)$  belongs to  $E^{s+1}$ ,  $E^y$ , and  $E^{y+1}$ . A contradiction. Hence,  $y = s+1$  and we know that vertex  $E^{s+1}$  is the terminal vertex of the  $E^{s+1}E^{s+2}$  segment of  $P^{j(s+1)}$ .

If vertex  $E^{s+2}$  lies on  $P^{j(x)}$  with  $x \in \{1, \dots, s+1\}$ , then  $j(x)$  belongs to  $E^{x-1}$  (or  $E^k$  if  $x = 1$ ),  $E^x$ , and  $E^{s+2}$ . A contradiction. If vertex  $E^x$  with  $x \in \{k\} \cup \{1, \dots, s\}$  lies on  $P^{j(s+2)}$ ,  $j(s+2)$  belongs to  $E^x$ ,  $E^{s+1}$ , and  $E^{s+2}$ . A contradiction. Hence, the  $E^{s+1}E^{s+2}$  segment of  $P^{j(s+2)}$  joins  $T^{s+1}$  at some vertex other than  $E^1, E^2, \dots, E^{s+1}$  or  $E^k$ . Thus,  $T^{s+2}$  is a directed tree that has  $E^k, E^1, E^2, \dots, E^{s+2}$  as leaves where  $E^x$  with odd  $x \in \{1, \dots, s+1\}$  are the terminal vertices of the edges that connect them, and  $E^k$  and  $E^x$  with even  $x \in \{2, \dots, s+2\}$  are the initial vertices of the edges that connect them.

Notice that the inductive assumption holds for  $s = 2$ . According to the above inductive argument, for any even  $t \leq k-1$ ,  $T^t$  is a directed tree that has  $E^k, E^1, E^2, \dots, E^t$  as leaves where  $E^x$  with odd  $x \in \{1, \dots, t-1\}$  are the terminal vertices of the edges that connect them, and  $E^k$  and  $E^x$  with even  $x \in \{2, \dots, t\}$  are the initial vertices of the edges that connect them. Then,  $E^t$  is a leaf of  $T^t$  and the initial vertex of the edge that connects  $E^t$ , and  $E^k$  is also a leaf of  $T^t$  and the initial vertex of the edge that connects  $E^k$ ; thus,  $E^t$  and  $E^k$  is connected by a path that is not a directed path. Since vertex  $E^{k-1}$  and vertex  $E^k$  are connected by a directed path in  $P^{j(k)}$ , we know that  $k-1$  is not even, and  $k$  is not odd. A contradiction. Therefore, the firm-worker hypergraph is balanced.
